State Board of Education – Freedom Schools Grant Program (23 Ill. Adm. Code 269; 46 Ill. Reg. 19312)

Sen. Fowler moved, seconded by Rep. Tarver, that JCAR, with the concurrence of the State Board of Education, extend the Second Notice period for this rulemaking for an additional 45 days. The motion passed unanimously (10-0-0).

Department of Financial and Professional Regulation – Rules for the Licensed Certified Professional Midwife Practice Act (68 Ill. Adm. Code 1345; 46 Ill. Reg. 20475)

Sen. Castro moved, seconded by Sen. DeWitte, that JCAR, with the concurrence of the Department of Financial and Professional Regulation, extend the Second Notice period for this rulemaking for an additional 45 days. The motion passed unanimously (10-0-0).

State Board of Investment – State (of Illinois) Employees' Deferred Compensation Plan (80 Ill. Adm. Code 2700; 47 Ill. Reg. 2641)

Rep. Delgado moved, seconded by Rep. Vella, that JCAR, with the concurrence of the State Board of Investment, extend the Second Notice period for this rulemaking for an additional 45 days. The motion passed unanimously (10-0-0).

Law Enforcement Training and Standards Board – Illinois Police Training Act (20 Ill. Adm. Code 1720; 47 Ill. Reg. 65), Intern Training Program (20 Ill. Adm. Code 1725; 47 Ill. Reg. 68), and Part-Time Basic Training (20 Ill. Adm. Code 1770; 47 Ill. Reg. 70)

John Keigher, Chief Legal Counsel, represented LETSB.

Rep. Vella: With the rulemaking you've proposed now, there's obviously pieces of legislation that we've talked about that may have repercussions on that rule. Would you be willing to come back within a 6-month period of time to discuss the rule repercussions of those bills?

Mr. Keigher: Absolutely. We've been having stakeholder discussions over the summer, and we believe we will have the rules ready to be presented in the fall.
