MINUTES

December 11, 2023

MEETING CALLED TO ORDER

Co-Chair Spain called the meeting to order and announced that the policy of the Committee is to allow only representatives of State agencies to testify orally on any rule under consideration at Committee meetings. APPROVAL OF THE MINUTES OF THE NOVEMBER 7, 2023 MEETING

Sen. Castro moved, seconded by Rep. Reick, that the minutes of the November 7, 2023 meeting be approved. The motion passed unanimously (9-0-0).

REVIEW OF AGENCY RULEMAKINGS

Department of Financial and Professional Regulation – Credit Union Community Reinvestment (38 Ill. Adm. Code 185; 46 Ill. Reg. 19726); Bank Community Reinvestment (38 Ill. Adm. Code 345; 46 Ill. Reg. 19794); Rules Governing the Request for Reconsideration of Examination Findings (38 Ill. Adm. Code 385; 46 Ill. Reg. 19856); Mortgage Community Reinvestment (38 Ill. Adm. Code 1055; 46 Ill. Reg. 19861)

Discussion.

Department of Healthcare and Family Services – Medical Payment (89 Ill. Adm. Code 140; 47 Ill. Reg. 315)

Omar Shaker and Christine Herman represented DHFS.

Discussion.

Rep. Haas moved, seconded by Sen. Castro, that JCAR recommend that the Department be more timely in implementing statute in rule. Public Act 101-10 required treatment of autism spectrum disorder through Applied Behavior Analysis to be covered under the Medical Assistance Program for children with a diagnosis of autism spectrum disorder and stated that the Department shall submit rules regarding provision of services and providers by September 1, 2019. The Department did not propose these rules until January 13, 2023. The motion passed unanimously (9-0-0).

Department of Healthcare and Family Services – Special Eligibility Groups (Emergency) (89 Ill. Adm. Code 118; 47 Ill. Reg. 9114)

Omar Shaker represented DHFS.

Discussion.

Department of Public Health – Hospital Licensing Requirements (77 Ill. Adm. Code 250; 47 Ill. Reg. 9134)

Rep. Delgado moved, seconded by Sen. DeWitte, that JCAR, with the concurrence of the Department of Public Health, extend the second notice period for this rulemaking for an additional 45 days. The motion passed unanimously (9-0-0).

Illinois State Police – Firearm Owner's Identification Card Act (20 Ill. Adm. Code 1230; 47 Ill. Reg. 13846)

Suzanne Bond and Capt. Jeffrey Yenchko represented ISP.

Discussion.

Department on Aging – Community Care Program (Emergency) (89 Ill. Adm. Code 240; 47 Ill. Reg. 15675)

Sen. Castro moved, seconded by Rep. Haas, that JCAR object to the emergency rulemaking because it does not meet the criteria for emergency rulemaking in 1 Ill. Adm. Code 230.400(a)(1)(C) and (D). The emergency situation did not arise through no fault of the agency and the emergency rule is not limited to those matters that are required to meet the emergency situation. Beginning March 1, 2020, the federal Centers for Medicare and Medicaid Services, in response to the COVID-19 public health emergency, waived a federal requirement that prohibited legally responsible individuals from serving as home care aides for program participants. After this flexibility was granted, the Department permitted legally responsible individuals to serve as

home care aides despite this practice being strictly prohibited in its own administrative rules. The Department could have easily made this change through a proposed rulemaking and allowed for public notice and comment at some point over the last three years. Further, this rulemaking contains general clean-up and style changes that are not necessary to address the emergency situation. The motion passed unanimously (7-0-0; Rep. Delgado and Rep. Reick left the meeting).

Illinois Environmental Protection Agency – Procedures for Issuing Loans from the Public Water Supply Loan Program to Provide Funding for Lead Service Line Replacement (35 Ill. Adm. Code 663; 47 Ill. Reg. 11879)

Sen. Fowler moved, seconded by Rep. Hass, that JCAR, with the concurrence of the Illinois Environmental Protection Agency, extend the second notice period for this rulemaking for an additional 45 days. The motion passed unanimously (7-0-0).
