63 **Section 305.350 Extension of Jurisdiction After Effective Date of Amendments to the**
 64 **Personnel Code**

66 For all positions for which the Director of the Department of Central Management Services
 67 approves extension of Personnel Code jurisdiction on or after June 28, 2023, the Department
 68 shall maintain records of the extension but need not promulgate administrative rules reflecting
 69 that extension. Records of extension of jurisdiction shall be shared with the Civil Service
 70 Commission.
