## Proposed Rulemakings

### DEER HUNTING

The DEPARTMENT OF NATURAL RESOURCES proposed an amendment to White-Tailed Deer Hunting By Use of Firearms (17 IAC 650; 41 Ill Reg 11707) adding Johnson-Sauk Trail State Park and Spoon River State Forest to the list of sites hosting special deer hunts for disabled hunters.

### STATE EMPLOYEES

The DEPARTMENT OF CENTRAL MANAGEMENT SERVICES proposed amendments to Pay Plan (80 IAC 310; 41 Ill Reg 11645) implementing new job titles, pay grades, and bargaining unit assignments. The titles of insurance

performance examiner trainee and juvenile justice vocational instructor are added to the list of merit compensation system (MS) titles and pay grades, while the title of research economist is added, and the now-abolished title of Research Economist I is removed, from a list of titles assigned to an AFSCME bargaining unit.

## Emergency Rulemaking

### PREPAID TUITION

The ILLINOIS STUDENT ASSISTANCE COMMISSION adopted an emergency amendment to Illinois Prepaid Tuition Program (23 IAC 2775; 41 Ill Reg 11715) effective 9/8/17 for a maximum of 150 days. An identical proposed amendment appears in this week's *Illinois Register* at 41 Ill Reg 11713. The rulemakings implement Public Act 100-43, effective 8/9/17, which exempts from the Illinois Procurement Code ISAC contracts that are paid from private funds deposited into the Illinois Prepaid Tuition Trust Fund.

**NEW RULES:** Rules adopted by agencies this week. **EMERGENCY RULES:** Adopted for a temporary period not to exceed 150 days.

**PROPOSED RULES:** Rules proposed by agencies this week, commencing a 45-day First Notice period during which public comments must be accepted.

**PEREMPTORY RULES:** Rules adopted without prior public notice or JCAR review as authorized by 5 ILCS 100/5-50.

■ Designates rules of special interest to small businesses, small municipalities, and not-for-profit corporations. Agencies are required to consider comments from these groups and minimize the regulatory burden on them.
