Illinois Regulation is a summary of the weekly regulatory decisions of State agencies published in the Illinois Register and action taken by the Illinois General Assembly's Joint Committee on Administrative Rules. Illinois Regulation, also titled The Flinn Report in memory of founding JCAR member Rep. Monroe Flinn, is designed to inform and involve the public in changes taking place in agency administration.

New Rules

■ CORPORATE RECORDS

The SECRETARY OF STATE adopted an amendment to General Not For Profit Corporations (14 IAC 160; 42 Ill Reg 4552) effective 9/5/18 that updates rules for purchasing copies of certain corporate records. References to twice-annual sales of microfiche lists are removed. The master list of condominium associations will be made available once a year in CD-ROM form for a fee of \$150 per disc (instead of \$150 per microfiche set). The rulemaking also removes a requirement that the computer-accessible master list of not for profit corporations include the microfilm roll and image number for each file.

■ BAIID PROVIDERS

SOS also adopted amendments to Procedures and Standards (92 IAC 1001; 42 Ill Reg 5785) effective 9/5/18 requiring providers of Breath Alcohol Ignition Interlock Devices (BAIID) to indicate on their solicitations to prospective customers (persons who hold restricted driving permits due to alcohol-related offenses) that the document is from a private entity that is not owned, operated or endorsed by SOS and is not the sole BAIID provider authorized by SOS. BAIID providers are also prohibited from attaching their materials to official SOS correspondence or using the same print font that SOS uses in its correspondence to permittees.

Proposed Rulemakings

■ REAL ESTATE

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION proposed amendments to the Part titled Real Estate License Act of 2000 (68 IAC 1450; 42 Ill Reg 16804) implementing Public Act 100-188. The rulemaking consolidates the licenses for providers of pre-license education and continuing education into a single education provider license, effective 7/1/19; update various pre-license and continuing education requirements; permit pre-license and continuing education to be delivered via webinars and other alternate means, in addition to in-person classes; and establish a process for reviewing applications from persons with prior criminal convictions. Current pre-license and continuing

NEW RULES: Rules adopted by agencies this week. **EMERGENCY RULES:** Adopted for a temporary period not to exceed 150 days.

PROPOSED RULES: Rules proposed by agencies this week, commencing a 45-day First Notice period during which public comments must be accepted.

PEREMPTORY RULES: Rules adopted without prior public notice or JCAR review as authorized by 5 ILCS 100/5-50.

■ Designates rules of special interest to small businesses, small municipalities, and not-for-profit corporations. Agencies are required to consider comments from these groups and minimize the regulatory burden on them.

education licenses will continue in effect through 6/30/19. Real estate brokers and providers of pre-license and continuing education for real estate agents and brokers are affected.

UTILITIES

The ILLINOIS COMMERCE COMMISSION proposed an amendment to Reports of Accidents by Fixed Public Utilities Other Than Pipelines Transporting Liquids (83 IAC 220; 42 Ill Reg 16785) increasing the monetary damage threshold for required reporting of accidents not involving death or serious injury from \$1,000 to \$20,000. ICC also proposed amendments to Qualifying Infrastructure Plant Surcharge (83 IAC 656; 42 Ill Reg

16789) and Telecommunications Access for Persons with Disabilities (83 IAC 755; 42 Ill Reg 16796) updating the incorporated edition of the Prospective Financial Information Guide published by the American Institute of Certified Public Accountants to the 2017 edition. The Part 656 rulemaking also corrects a technical error in the formula used to calculate qualifying infrastructure plant costs.

■ NON-PROFITS

The OFFICE OF THE STATE TREASURER proposed an amendment to Rules for Charitable Trust Stabilization

Committee (74 IAC 550; 42 Ill Reg 16913) applying the criteria for identifying a depressed area in the Illinois Enterprise Zone Act to the determination of preferences for grants to non-profit entities with operating budgets of less than \$1 million. Applicants will be given “special attention” if they are located in a census tract that meets at least one of the following criteria: an unemployment rate 20% or more above the State average, a poverty rate of at least 20%, at least 20% of households receiving SNAP benefits, or at least 50% of children qualifying for free or reduced-price school meals. Non-profit organizations will be affected by this rulemaking.

JCAR Meeting Action

At its 9/18/18 meeting, the Joint Committee on Administrative Rules approved the following actions:

RECOMMENDATION

With respect to the Governor's Office of Management and Budget rulemaking titled Grant Accountability and Transparency Act (44 IAC 7000; 42 III Reg 12265), JCAR recommends that GOMB be more timely in enacting statutorily required rules and take care to not implement its policies prior to adoption of the underlying rule. Section 25 of the Grant Accountability and Transparency Act [30 ILCS 708] required that rules for the second tier of GATA implementation be adopted by 7/1/17.

JCAR postponed action on the Department of Revenue rulemaking titled Invest in Kids Act (86 IAC 1000; 42 III Reg 7448), currently on extended Second Notice, until the 10/16 meeting.
