

*Illinois Regulation is a summary of the weekly regulatory decisions of State agencies published in the Illinois Register and action taken by the Illinois General Assembly's Joint Committee on Administrative Rules. Illinois Regulation, also titled The Flinn Report in memory of founding JCAR member Rep. Monroe Flinn, is designed to inform and involve the public in changes taking place in agency administration.*

## New Rules

### ■ EGG PRODUCTS

The DEPARTMENT OF AGRICULTURE adopted amendments to the Part titled Egg and Egg Products Act (8 IAC 65; 42 Ill Reg 24323), effective 4/15/19, implementing changes to the Act. Expiration dates on consumer-size containers must be no later than 45 days (formerly, 30) from the candling date (when eggs are examined to determine their grade and size) for Grade A eggs and no later than 30 (formerly 15) days from the candling date for Grade AA eggs. A full producer-dealer license is required for anyone who sells eggs from other than his or her own flock, and a limited license is required for producers-dealers who sell only eggs of their own production. (Formerly, a full license was required for producers with 3,000 or more birds and a limited license was required for persons who sell

only their own eggs from a flock of fewer than 3,000 birds.) Retailers who consolidate egg lots must notify DOA of the locations where they will perform this action, keep records of who performs each consolidation and the date, must use only clean cartons, and allow only trained personnel to perform consolidation. A second inspection fee will not be charged for eggs that are consolidated. A packer is no longer required to notify DOA in writing if he or she elects to use a State egg license number or USDA plant number in place of the packer's name and address. Egg producers and retail outlets that sell or package eggs are affected.

## Proposed Rulemakings

### WATER POLLUTION

The POLLUTION CONTROL BOARD proposed amendments to General Provisions (35 IAC 401; 43 Ill Reg 4730), Definitions (35 IAC 402; 43 Ill Reg 4737), NPDES Permits (35 IAC 403; 43 Ill Reg 4749), State Permits (35 IAC 404; 43 Ill Reg 4756), State and NPDES Permits (35 IAC 405; 43 Ill Reg 4766) and Mine Waste Effluent and Water Quality Standards (35 IAC 406; 43 Ill Reg 4781). These rulemakings update the Parts to remove or change obsolete or otherwise unnecessary language.

**NEW RULES:** Rules adopted by agencies this week. **EMERGENCY RULES:** Adopted for a temporary period not to exceed 150 days.

**PROPOSED RULES:** Rules proposed by agencies this week, commencing a 45-day First Notice period during which public comments must be accepted.

**PEREMPTORY RULES:** Rules adopted without prior public notice or JCAR review as authorized by 5 ILCS 100/5-50.

■ Designates rules of special interest to small businesses, small municipalities, and not-for-profit corporations. Agencies are required to consider comments from these groups and minimize the regulatory burden on them.

III Reg 24335) and Diseased Animals (8 IAC 85; 42 Ill Reg 24340), both effective 4/15/19, updating livestock ear tag requirements to reflect current practices and federal regulations. DOA also repealed the Part titled Animal Disease Laboratories Act (8 IAC 110; 42 Ill Reg 24348), effective 4/15/19, which contained rules for the now-closed Galesburg Animal Disease Laboratory. Livestock owners are affected by these rulemakings.

## DNR LICENSES

The DEPARTMENT OF NATURAL RESOURCES adopted

amendments to Revocation Procedures for Conservation Offenses (17 IAC 2530; 43 Ill Reg 115), effective 4/11/19, implementing Public Act 98-752. The PA and the rulemaking give DNR authority to revoke hunting, trapping, fishing, and other licenses for violations of the Herptiles-Herps Act that regulates hunting and possession of various species of amphibians and reptiles.

## CAMPING

DNR also adopted amendments to Camping on Department of Natural Resources Properties (17 IAC 130; 43 Ill Reg 1351), effective 4/11/19, raising the cost of individual cabin rentals at Dixon Springs State Park (Pope County) from \$30 to \$60 and establishing a \$45 rental fee for barracks units. Fees for day use of group camps at Dixon Springs, Horseshoe Lake State Fish and Wildlife Area (Alexander County)

and Pere Marquette State Park (Jersey County) are also increased from \$50 to \$75 per day. Since 1<sup>st</sup> Notice, DNR has clarified that where campgrounds are laid out in defined sites, groups of two or more tent trailers, travel trailers, self-propelled mobile campers, pick-up campers, or any combination thereof are not considered a single camp. If campgrounds are not laid out in sites, the number of camps will be based on capacity of sanitary facilities, parking areas, soil and turf conditions, crowding, and other factors as determined by DNR staff.
