HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 212

Offered by Representative Gabel:

WHEREAS, Building an Illinois that can thrive now and in the future requires a steady commitment to supporting the physical, mental, and emotional well-being of all of the State's residents; and

WHEREAS, Equitable strategies are needed to ensure that all residents have the supports at home and in their communities that build a well-being, buffer against negative experiences, foster resilience, and make it possible to thrive; and

WHEREAS, Trauma, which may include adverse childhood experiences and other experiences across the life-course, disrupts health and well-being, making it more difficult for people to reach their potential and participate fully in their communities; and

WHEREAS, The landmark Adverse Childhood Experiences (ACEs) Study identified a profound connection between poor health during a person's adulthood and ACEs, which include physical, emotional, and sexual abuse, physical and emotional neglect, and household stressors such as domestic violence, separation or divorce involving household members, substance abuse, untreated mental illness, or incarceration of a household member; and

WHEREAS, ACEs studies have also found a strong correlation between the number of ACEs and a person's risk for health and social outcomes that include cancer, cardiovascular disease, diabetes, smoking, substance abuse, depression, obesity, unplanned pregnancies, low birth weight, suicide attempts, workplace absenteeism, unemployment, lower educational achievement, and lower wages; and

WHEREAS, Individuals with six or more ACEs are at risk, on average, to live 20 years less than those individuals with zero ACEs; and

WHEREAS, Findings from the Illinois 2017 Behavioral Risk Factor Surveillance Survey (BRFSS) Illinois ACEs Response Collaborative found that almost 60% of non-institutionalized adults in Illinois say they had at least one ACE; this number equates to almost five million Illinois residents; approximately 16% of Illinois adults reported four or more ACEs; and

WHEREAS, BRFSS data also showed that approximately 20% of African American adults in Illinois report four or more ACEs, compared to 15% of white residents; and

WHEREAS, ACEs are not the only potentially traumatic experiences that can influence health across the lifespan; extensive research demonstrates that community experiences such as gun violence, lack of educational or economic opportunities, poor or unaffordable housing, and lack of community cohesion can have the same detrimental effects on later health outcomes in individuals as ACEs; and

WHEREAS, These adverse community experiences are the result of historical traumas, such as slavery and genocides, and subsequent systemic inequities and oppression, such as racism; racism, which can include power inequalities, prejudices, stereotypes, discrimination, beliefs, and a systemic lack of access to essential supports including healthcare, has been directly linked to reduced physical and mental health in communities and individuals; and

WHEREAS, As a result of these historical traumas and subsequent systemic inequities, Black and Latinx residents in Illinois are more likely to live in neighborhoods with restricted access to essential resources such as education and economic opportunities, healthy food choices, safe and affordable housing, and behavioral and physical healthcare; like adverse childhood experience, these have all been linked to health and social outcomes that include reduced life expectancy, higher rates of infant and maternal mortality, high rates of asthma, higher rates of lead poisoning, and higher vulnerabilities to public health pandemics, including COVID-19; and

WHEREAS, These health inequities have been compounded and exacerbated by the COVID-19 Pandemic, which has disproportionately affected Black and Latinx communities in Illinois; Black and Latinx residents are more likely to contract and more likely to die from the disease than white residents; Black and Latinx Americans are also significantly more likely to have COVID-19 be a "major threat to their general health and well-being" than the overall population; and

WHEREAS, Immigrant and refugee populations have been under the additional strain of stigmatizing rhetoric and an immigration system that fosters fear, mistrust, isolation, and injustice; and

WHEREAS, Robust research demonstrates that positive supports and experiences, such as stable and nurturing relationships and equitable access to food, housing, health care, financial resources, and other fundamentals of lifelong health and well-being can buffer against the effects of adversity and build resilience; and

WHEREAS, Resilience, the capacity to adapt and thrive in the face of adversity through strengths-based methods, can be built in individuals throughout the lifespan through trauma-informed, healing-centered care principles and practices such as trustworthiness and reliability, establishing physical and emotional safety, and providing opportunities for empowered decision-making; and

WHEREAS, Trauma-informed, healing-centered care is not a therapy or an intervention but is a principle-based, culture change process aimed at recognizing strengths and resiliency as well as helping people who have experienced trauma heal; and

WHEREAS, Healthy and thriving communities are also fostered through these same trauma-informed, healing-centered, resilience-building principles; and

WHEREAS, It has been shown to be cost effective and sustainable to build programs and policies that foster positive experiences and are dedicated to the prevention and mitigation of traumatic experiences and their potential effects on physical and mental well-being and health, particularly in childhood; and

WHEREAS, This can be seen in allocated resources, as well as the creation of policies that acknowledge trauma and its effects on the health of individuals and communities, and how historical and contemporary systemic oppression may lead to potentially traumatic events such as adverse childhood experiences and adverse community experiences; and

WHEREAS, The State of Illinois has previously recognized the impact of ACEs on its residents' health and how trauma-informed, healing-centered principles, policies, and practices can prevent and mitigate the adverse health outcomes associated with trauma, such as Trauma-Informed Awareness Day in 2019, the passage of the Children of Incarcerated Parents Bill of Rights, and the creation of the Whole Child Task Force introduced by the Illinois Legislative Black Caucus, as well as local resolutions recognizing Trauma-Informed Awareness Day in communities such as Winnebago County and the City of Chicago; and

WHEREAS, These same trauma-informed, healing-centered principles, policies, and practices must also recognize the detrimental effect that systemic oppressions such as racism can have on the health of individuals and communities and how these are, in fact, traumatic experiences with the same potential adverse health outcomes as ACEs; and

WHEREAS, The COVID-19 pandemic has made these systemic inequities more apparent and impactful, and a comprehensive response must recognize the role of racism and other oppressions in contraction of the disease, patient outcomes, and vaccine and treatment distribution; and

WHEREAS, The State's commitment to the support of a trauma-informed Illinois must be expanded to include recognition of the role that systemic policies and oppression have played in the creation and impact of trauma and communities; and

WHEREAS, This recognition must include a racially-just and healing-centered approach with an acknowledgment of the additional potential burden of trauma faced by Black and Latinx residents in Illinois and the United States; and

WHEREAS, The inclusion of recognizing the issue of systemic oppression and its impact on the creation of historical, community, and individual trauma will allow for a more thorough and effective response to reduce and eliminate health disparities in Illinois; and

WHEREAS, A trauma-informed, healing-centered Illinois can work to dismantle these systemic inequities and address the effects of racism and poverty, while working to prevent continued disparities; and

WHEREAS, This expanded definition of a trauma-informed, healing-centered Illinois enhances the ability of individuals and communities to adapt, cope, and thrive, including during difficult times, supporting the physical and mental well-being of everyone in Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare May 25, 2021 as Trauma-Informed Awareness Day in Illinois to highlight the impact of trauma and the importance of prevention of adversity and fostering individual and community resilience through trauma-informed, healing-centered care; and be it further

RESOLVED, That we encourage all officers, agencies, and employees of the State of Illinois whose responsibilities include individuals throughout the life course and communities, including the Office of the Governor, the State Board of Education, the Department of Human Services, the Department of Children and Family Services, the Department of Public Health, the Department of Juvenile Justice, and Department of Corrections to become informed regarding well-documented, short-term, long-term, and multi-generational impacts of adverse childhood experiences, toxic stress, systemic racism, and other potentially traumatic experiences for children, adults, and communities and to become aware of and implement evidence-based and racially-just, trauma-informed, healing-centered care practices, tools, and interventions that promote positive experiences and racial justice to build resilience in individuals and communities so that they will be able to maximize their well-being and thrive.

HOUSE RESOLUTION 215

Offered by Representative Avelar:

WHEREAS, Illinois is home to 1.8 million immigrants who have traveled to the State of Illinois from around the world to seek a better life and to 1.7 million U.S.-born citizens who have at least one immigrant parent; and

WHEREAS, Our nation's immigration system should uphold our basic values of family, economic opportunity, fairness, and second chances; and

WHEREAS, The U.S. immigration system, which has resulted in long backlogs and deaths on the border, is unjust and inequitable and is in dire need of reforms, including a pathway to citizenship for all undocumented immigrants; and

WHEREAS, The current coronavirus pandemic has highlighted the importance of immigrants, including the undocumented, as "essential workers" who have sustained, for both our State and our nation, our health care system, food chain, and other vital services, often at great risk to their own and their families' health and well-being; and

WHEREAS, The administration of Donald Trump further aggravated the flaws within our immigration system by unleashing immigration enforcement, separating children and parents at the southern border, gutting refugee and asylum processing, further complicating legal immigration through such policies as the new public charge rule, attempting to end protective programs such as DACA and Temporary Protected Status (TPS), imposing a new naturalization test, further complicating the process to apply for citizenship,

and instituting many other policies that have created fear, confusion, and pain among families throughout our State and nation; and

WHEREAS, The election and inauguration of Joe Biden as president provides an opportunity to not only undo his predecessor's harmful policies but to also address the more basic inequities and racial disparities within our immigration system and to enact a pathway to citizenship that would protect DACA and TPS recipients, essential workers, and all undocumented immigrants, currently numbering approximately 11 million nationwide and 450,000 in Illinois; and

WHEREAS, Current immigration proposals in Congress would exclude those convicted of prior felonies and misdemeanors, provisions that exclude approximately one-third of potential applicants, disproportionately affecting Black immigrants; and

WHEREAS, Excluding those who have already served their time and are currently contributing to their communities is a form of double punishment, which is antithetical to our values as a state and as a nation; and

WHEREAS, The State of Illinois has historically welcomed immigrants, and elected officials of both major political parties have supported legislation, policies, and programs that have enabled immigrants to work, learn, raise families, build businesses and communities, and express their voice in the civic life of our State; and

WHEREAS, The State of Illinois has more recently taken national leadership on welcoming policies for immigrants, including funding for citizenship and community outreach programs, educational aid for immigrant students, driver's licenses for immigrant motorists, and protections against federal immigration enforcement policies that undermine relations between immigrant communities and local police; and

WHEREAS, These policies adopted by the State of Illinois intend to separate state law enforcement from federal immigration enforcement and are designed to protect all immigrants in our State regardless of prior interaction with the legal system; and

WHEREAS, At this moment when our nation faces a reckoning on racial justice, prompted by the deaths of George Floyd, Breonna Taylor, and so many other Black Americans but reflecting historic discrimination and disinvestment against Black, Indigenous, and other communities of color, we need to ensure that our immigration laws and policies and other laws that affect immigrant communities must be grounded in racial equity; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we call upon the Biden Administration to take immediate steps, including executive orders, administrative policy changes, and regulatory changes, to undo the harmful immigration policies of the Trump Administration, including but not limited to halting and dismantling the immigration enforcement machinery that has harmed and separated thousands of Illinois families; and be it further

RESOLVED, That we call upon the Biden Administration, Senator Richard Durbin, Senator Tammy Duckworth, and the Illinois U.S. House Delegation to enact legislation to create a pathway to citizenship for all undocumented immigrants, fix other provisions of our immigration laws that exclude and otherwise harm immigrants, address the root causes of international migration, and ground our immigration laws in justice and equity; and be it further

RESOLVED, That suitable copies of this resolution be delivered to President Biden, the Majority Leader and Minority Leader of the United States Senate, the Speaker and Minority Leader of the United States House of Representatives, Senators Durbin and Duckworth, and all members of the Illinois U.S. House Delegation.

HOUSE JOINT RESOLUTION 33

Offered by Representative Harper:

WHEREAS, The State of Illinois has identified the need to create a local, sustainable, accessible, fair, and healthy food system in order to provide healthy food choices in State-funded facilities; and

WHEREAS, The State of Illinois is committed to improving the health of all its residents and to promoting a safe, healthy, and fair work environment for its workforce; and

WHEREAS, The Good Food Purchasing Program (GFPP) was developed in 2012 to provide an incentive to public institutions to procure Good Food produced through values-driven purchasing standards; and

WHEREAS, GFPP defines Good Food as food that is healthy, affordable, fair, and sustainable and is produced, processed, distributed, and recycled locally using the principles of environmental stewardship, meets the Dietary Guidelines for Americans, and is available to purchase for all income levels; and

WHEREAS, Good Food values prioritize nutrition, affordability, locality, and sustainable production practices, including sound environmental practices, fair prices for producers, safe and fair working conditions for employees, and humane conditions for animals; and

WHEREAS, All participants in the GFPP food supply chain receive fair compensation and fair treatment and are free from exploitation; and

WHEREAS, Good Food Purchasing refers to the sourcing and purchasing of foods and beverages and food and beverage service contracts procured by the State of Illinois; and

WHEREAS, In practicing Good Food Purchasing policies, the State of Illinois will help support a regional food system that is ecologically sound, economically viable, and racially and socially equitable and has an impact on the availability of local, sustainable food; and

WHEREAS, It is recognized that the significant buying power of public institutions across the country can reform the food system, create opportunities for smaller farmers and low-income entrepreneurs to thrive, provide just compensation and fair treatment for food chain workers, support sustainable farming practices, reward good environmental stewardship, and increase access to fresh and healthy foods; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we embrace the principles of the Good Food Purchasing Program as a strategy to help improve our region's food system through the adoption and implementation of Good Food Purchasing Standards; and be it further

RESOLVED, That there is created the Illinois Good Food Purchasing Policy Task Force to study the current procurement of food within the State and explore how Good Food Purchasing can be implemented to maximize the procurement of healthy foods that are sustainably, locally, and equitably sourced; and be it further

RESOLVED, That the Task Force shall consist of the following members, who shall serve without compensation:

- (1) The Lieutenant Governor or his or her designee;
- (2) The Speaker of the House of Representatives or his or her designee;
- (3) The Minority Leader of the House of Representatives or his or her designee;
- (4) The Senate President or his or her designee;
- (5) The Senate Minority Leader or his or her designee;
- (6) One member nominated by a statewide local food advocacy organization and appointed by the Lt. Governor;
- (7) One member nominated by a national multi-sector food advocacy organization and appointed by the Lt. Governor;
- (8) One member nominated by a Chicago-based food advocacy organization and appointed by the Lt. Governor;
- (9) One member nominated by a statewide environmental advocacy organization and appointed by the Lt. Governor;
- (10) One member nominated by a statewide labor organization that represents food workers and appointed by the Lt. Governor;
- (11) One member nominated by a national farm-animal welfare organization and appointed by the Lt. Governor;
- (12) The Director of the Department of Commerce and Economic Opportunity or his or her designee;
- (13) The Director of the Environmental Protection Agency or his or her designee;
- (14) The Director of the Department of Public Health or his or her designee;
- (15) The Director of the Department of Natural Resources or his or her designee;
- (16) The Chief Procurement Officer for General Services or his or her designee;
- (17) The Chief Procurement Officer for Higher Education or his or her designee;

- (18) The Chief Procurement Officer for the Secretary of State's Office or his or her designee;
- (19) The Chief Procurement Officer for the Department of Corrections or his or her designee;
- (20) The Chief Procurement Officer for the Department of Human Services or his or her designee;
- (21) The Chief Procurement Officer for Central Management Services or his or her designee; and
- (22) The Director of the Department of Agriculture or his or her designee; and be it further

RESOLVED, That the Department of Agriculture shall provide administrative support for the Task Force; and be it further

RESOLVED, That the Task Force members shall select a chairperson at the first meeting; and be it further

RESOLVED, That the Task Force shall submit an interim report to the Governor and the General Assembly no later than January 1, 2022; and be it further

RESOLVED, That the Task Force shall submit its final report to the Governor and the General Assembly no later than January 1, 2023 and is dissolved upon the filing of its final report.
