# **HOUSE RESOLUTIONS**

The following resolutions were offered and placed in the Committee on Rules.

#### HOUSE RESOLUTION 362

Offered by Representative Buckner:

WHEREAS, May 31 through June 1, 2021 marks 100 years since one of the worst instances of racial violence in American history known as the Tulsa Race Massacre; and

WHEREAS, The massacre began during Memorial Day weekend after 19-year-old Dick Rowland, a Black shoeshiner, was accused of assaulting Sarah Page, a 17-year-old White elevator operator of the nearby Drexel Building; he was taken into custody, and a mob of hundreds of White men gathered around the jail where Rowland was being kept, determined to lynch him; in response, a group of 75 Black men arrived at the jail in order to protect Rowland, and violence broke out between the two groups; and

WHEREAS, As news of the confrontation spread across Tulsa, more violence erupted; on the evening of May 31 through the afternoon of June 1, 1921, a violent mob of hundreds of White people attacked Tulsa's Greenwood District; the district was, at that time, the wealthiest Black community in the United States and was referred to as "Black Wall Street"; and

WHEREAS, The mob destroyed 35 square blocks, burned businesses and an estimated 1,250 homes to the ground, and murdered as many as 300 Black Tulsans; the damage done is estimated to equal \$27 million in today's dollars; and

WHEREAS, Many of the dead were buried in mass graves that were only recently discovered; approximately 10,000 Black people were left homeless, and many Black survivors left the city and never returned; and

WHEREAS, A 2001 state commission report found that the City of Tulsa had conspired with the mob of White citizens, including deputizing them and giving them weapons; and

WHEREAS, The massacre has not been included in many local, state, and national histories and was widely forgotten until recent pushes to have the massacre recognized; and

WHEREAS, Oklahoma recently passed legislation in order to establish scholarships for the descendants of survivors, encourage the economic development of Greenwood, and develop a park in

memory of the victims of the massacre in Tulsa; in 2020, the massacre became a part of the Oklahoma school curriculum; and

WHEREAS, Recently, 107-year-old massacre survivor Viola Fletcher testified before members of a U.S. House Judiciary subcommittee and called for justice and for the country to officially acknowledge the massacre ahead of the 100th anniversary; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize May 31, 2021 through June 1, 2021 as the 100th anniversary of the Tulsa Race Massacre.

#### HOUSE RESOLUTION 363

Offered by Representative Morgan:

WHEREAS, Dyslexia is a specific learning disability that is neurobiological in origin and is characterized by difficulties with accurate and/or fluent word recognition and by poor spelling and decoding abilities; and

WHEREAS, Secondary consequences of dyslexia may include problems in reading comprehension and reduced reading experience that can impede growth of vocabulary and background knowledge; and

WHEREAS, Social emotional concerns and long-term consequences, including lower academic achievement and higher dropout rates, can arise from the negative impact of dyslexia and poor reading abilities if not properly addressed with appropriate intervention; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge public and private schools and the Illinois State Board of Education to recognize that dyslexia has significant educational implications that can be addressed with appropriate intervention and supports; and be it further

RESOLVED, That public and private schools are urged to utilize the resources from the Illinois State Board of Education's Reading Improvement Advisory Group and the Illinois State Board of Education Dyslexia Handbook to assist them in addressing the needs of students with dyslexia with appropriate screening at an early age followed by appropriate interventions; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Illinois State Board of Education.

#### HOUSE RESOLUTION 365

Offered by Representative Ford:

WHEREAS, With the ongoing police shootings and the post-George Floyd movement, it is imperative Congress makes federal grants available for President Biden's push for teaching critical race theory in schools and to law enforcement; and

WHEREAS, Critical race theory critiques how the social construction of race and institutionalized racism perpetuate a racial caste system that relegates people of color to the bottom tiers of society; it also recognizes that race intersects with other identities, including sexuality, gender identity, and others; critical race theory acknowledges that the legacy of slavery, segregation, and the imposition of second-class citizenship on Black Americans and other people of color continues to permeate the social fabric of this nation; and

WHEREAS, 70 years after Brown V. Board of Education, many children still attend segregated schools; there are continual funding disparities between majority Black and majority White schools; BIPOC, or Black, Indigenous, and people of color, students are disproportionately suspended and funneled into special education programs; and

WHEREAS, The majority of principals and teachers are White, even as their students are not; this means that many administrators are unable to fully perceive how racism operates without specific training; and

WHEREAS, Critical race theory calls upon principals and teachers to examine how history, politics, culture, and economics inform our understanding of race, racism, and other forms of marginalization;

without this framework, principals and teachers may be committed to racial justice but be unable to translate their commitments into action; and

WHEREAS, By recognizing how race and racism shape our institutions, principals and teachers can find innovative ways to value the lived experiences of BIPOC families, prioritize the recruitment and retention of BIPOC faculty and staff, elevate the voices and experiential knowledge of BIPOC, adopt culturally responsive teaching practices and historically accurate U.S. history curriculum, and embrace the traditions of the communities in which they work; and

WHEREAS, As in the field of education, teaching critical race theory to law enforcement officers would have incredible benefits; many of our nation's systems and structures, including the legal system, were created when people of color were denied full participation in American society; many law enforcement officers do not understand how the justice system was shaped and continues to work against people of color; and

WHEREAS, Taking critical race theory courses helps law enforcement officers come face-to-face with the reality that, not too long ago, police officers played an active role in the enforcement of many of the discriminatory and racist laws of the time; and

WHEREAS, Many law enforcement departments do not reflect the diverse population they serve; with critical race theory, law enforcement officers can understand the history of BIPOC citizens and see how they were and are viewed by the people in the community they serve; and

WHEREAS, A new rule proposed by the U.S. Education Department states financial grants could be used to encourage schools to "incorporate teaching and learning practices that reflect the diversity, identities, histories, contributions, and experiences of all students"; and

WHEREAS, The use of federal grants to encourage the teaching of critical race theory to students and to law enforcement would be a critical step forward in the fight to dismantle racist structures and systems that are still present in our nation; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Congress of the United States to make available to schools and law enforcement agencies federal grants which support the teaching of critical race theory; and be it further

RESOLVED, That suitable copies of this resolution be presented to U.S. House of Representatives Speaker Nancy Pelosi, Senate Majority Leader Chuck Schumer, and all members of Congress.
