#### HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

#### **HOUSE RESOLUTION 401**

Offered by Representative Spain:

WHEREAS, Since March of 2020, Governor JB Pritzker has issued over 80 executive orders pertaining to the COVID-19 pandemic with very little legislative and local government input; and

WHEREAS, There have been several executive orders issued governing schools, including the use of Personal Protective Equipment (PPE) by students and school staff; and

WHEREAS, Executive Order 2021-11, issued by Governor Pritzker on May 28, 2021, maintains the requirement that students, staff, and visitors use face coverings if they are over the age of two and able to medically tolerate a face covering; and

WHEREAS, Since EO 2020-11 was issued, Illinois has moved to Phase 5 of Restore Illinois due to the number of new COVID-19 cases dramatically decreasing over the last several weeks and public health metrics showing that it was time for Illinois to begin reopening; and

WHEREAS, In addition to lower case rates and fewer hospitalizations, vaccination rates are also on the rise with nearly 54 percent of Illinoisans now fully vaccinated and 70 percent having at least one dose of the vaccination; and

WHEREAS, All kids ages 12 and above have been eligible for the COVID-19 vaccine since May; and WHEREAS, The Illinois State Board of Education and the Illinois Department of Public Health have yet to issue updated guidance for the 2021-2022 school year as it relates to the pandemic and the use of masks even though school districts must start planning for the upcoming school year; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Governor JB Pritzker, the Illinois State Board of Education, and the Illinois Department of Public Health to allow for local control by duly elected school board members regarding decisions on COVID-19 mitigation efforts that best fit the community and school districts in which they serve; and be it further

RESOLVED, That duly elected school board members have the ability to set parameters and issue guidance on the use of masks in schools and on other COVID-related safety precautions due to lower COVID-19 case numbers throughout the State and the rise in vaccinations; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor JB Pritzker, State Superintendent Dr. Carmen Ayala, and the Director of the Illinois Department of Public Health, Dr. Ngozi Ezike.

# **HOUSE RESOLUTION 404**

Offered by Representative Ford:

WHEREAS, More than 40 professional sports franchises have relocated since 1960; some moves of this sort are widely anticipated and leave no major scars; other relocations, however, are still bemoaned decades later as civic and economic wounds of historic proportions; and

WHEREAS, While there are many financial reasons why the Chicago Bears are unlikely to leave Soldier Field for Arlington Heights any time soon, the fact that the team has expressed exploring buying property in the suburbs is disconcerting as many fans consider the Chicago Bears to be part of Chicago's identity and a source of unity born of civic pride; and

WHEREAS, Even as many of us make regular pilgrimages to Soldier Field, fans also readily acknowledge that the stadium isn't the most comfortable or modern of NFL venues; in fact, in a recent informal survey held on patch.com, over 70 percent of 6,000 readers responded that they would like to see the team move; despite the survey's informality, results like this merit our attention; and

WHEREAS, The economics of major professional sports leagues have been changing dramatically in recent years; from television and streaming rights to team-sanctioned legalized sports betting to worldwide merchandising deals and massive media empires, teams have become huge corporate conglomerates with wide-ranging interests far beyond the stadium; and

WHEREAS, The Chicago Bears are an important source of economic activity and civic pride for the City of Chicago; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the city of Chicago and the State of Illinois to work with the owners of the Chicago Bears in order to reach an agreement that both parties see as equitable and beneficial to keep the team in Chicago; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to Chicago Mayor Lori Lightfoot.

# **HOUSE RESOLUTION 405**

Offered by Representative Robinson:

WHEREAS, Bronzeville is a center of African-American life and culture in Chicago and is historically known as the city's "Black Metropolis"; and

WHEREAS, Bronzeville is home to a diverse business community, historic landmarks, and lively events, including the annual Bud Billiken Parade that draws more than one million spectators each August; and

WHEREAS, Bronzeville is known for its rich history and flourishing modern-day renaissance; its cultural contributions are vast, and it brought the world Pulitzer Prize-winner Gwendolyn Brooks, civil rights activist Ida B. Wells, legendary musician Louis Armstrong, founder and publisher of what was the country's most prominent African-American newspaper, the Chicago Defender, and the creator of the Bud Billiken Parade Robert Abbott, and more; and

WHEREAS, Bronzeville's remaining historic remnants attract many to the area; notable surviving structures are the old Chicago Defender Building, the Overton Hygienic Building, the Supreme Life Building, and the Eighth Regiment Armory; and

WHEREAS, An African-American Cultural Center is a gathering place for the safe, creative, and critical exploration and celebration of black life, culture, and history; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the General Assembly to create an African American Cultural Center in the Bronzeville neighborhood in Chicago.

#### **HOUSE RESOLUTION 416**

Offered by Representative Spain:

WHEREAS, Throughout the COVID-19 pandemic, Governor JB Pritzker has acted unilaterally and has repeatedly failed to include the General Assembly in his pandemic response decision-making; and

WHEREAS, Since March of 2020, Governor Pritzker has issued over 80 executive orders pertaining to the COVID-19 pandemic with very little legislative and local government input; and

WHEREAS, Executive Order 2021-18, issued by Governor Pritzker on August 4, 2021, requires all persons who are over the age of two and able to medically tolerate a face covering to wear a mask in all public and nonpublic schools; and

WHEREAS, Once again, Governor Pritzker failed to seek input from the General Assembly, a co-equal branch of government, in issuing EO 2021-18; and

WHEREAS, Governor Pritzker did not consider local school board decision-making authority and what is best for the schools and students they serve when issuing the new executive order; and

WHEREAS, Governor Pritzker has the authority to call the General Assembly into special session to take action on his COVID-19 response but has refused to do so; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Governor JB Pritzker, the Illinois State Board of Education, and the Illinois Department of Public Health to reinstate local control and allow duly elected school board members to make decisions on COVID-19 mitigation efforts that best fit the community and school districts in which they serve; and be it further

RESOLVED, That we believe duly elected school board members have the ability to set parameters and issue guidance on the use of masks in schools and on other COVID-related safety precautions; and be it further

RESOLVED, That we urge Governor JB Pritzker to call the General Assembly into special session to consider his COVID-19 response and mitigation efforts as a co-equal branch of government; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor JB Pritzker, State Superintendent Dr. Carmen Ayala, and the Director of the Illinois Department of Public Health, Dr. Ngozi Ezike.

# **HOUSE RESOLUTION 418**

Offered by Representative Welch:

WHEREAS, The members of the Illinois House of Representatives wish to recognize the 50th anniversary of the passing of Specialist Gary Lee Holian, who died for his country on July 12, 1971; and

WHEREAS, Specialist Holian was born in Chicago to Joseph R. and Elaine J. Holian on December 8, 1950; and

WHEREAS, Specialist Holian began his tour in Vietnam on October 23, 1970 as part of the Aero Rifle Platoon, D Troop, 3rd Squadron, 5th Cavalry Regiment, 101st Airborne Division and achieved the rank of Specialist Four before the time of his passing; and

WHEREAS, Specialist Holian received numerous awards for his service, including the Purple Heart Medal, the Combat Infantry Badge, the Vietnam Service Medal with One Service Star, the Vietnam Campaign Medal, and the National Defense Service Medal; and

WHEREAS, Specialist Holian fought bravely for his country in the Quang Tri Province, South Vietnam before he was killed in action by a 122MM rocket that was fired at his helicopter on July 12, 1971; and

WHEREAS, Specialist Holian's final resting place is in the Mount Emblem Cemetery in Elmhurst; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the passing of Specialist Gary Lee Holian on the 50th anniversary of his death and express our sincere gratitude for his service to those who mourn his loss, his family, his friends, and all who knew and loved him; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the family of Spec. Holian.

# **HOUSE RESOLUTION 434**

Offered by Representative Flowers:

WHEREAS, The American Society of Civil Engineers (ASCE) stated in its 2021 report card that the United States received a grade of C- regarding the current state of infrastructure and that more than six trillion dollars would be needed to restore the nation's infrastructure to a state of good repair; an amount totaling over two and a half trillion dollars is currently not funded, and the remainder is inadequately funded; new, 21st century projects are unfunded; and

WHEREAS, Illinois received a grade of C- from the ASCE in 2018; Illinois roadways were ranked third worst nationally for travel delay, excess fuel consumed, truck congestion cost, and total congestion cost; this cost Illinois' motorists \$566 per year for a total of \$4.8 billion; transit systems in Illinois are in need of funding; and

WHEREAS, Current multi-year capital needs for transit in the Chicagoland area require an annual funding level of between \$2 and \$3 billion to reach a state of good repair, and funding has not been identified; Chicago has 400,000 lead service lines and has the worst documented lead line problem in the nation; the cost of replacement will be at least \$11 billion; and

WHEREAS, Illinois is home to one of the most important rail hubs in the country, and rail revenue is integral to the State's economy; over \$17.5 billion of substantial investments to the railroad infrastructure in Illinois are needed to accommodate just the expected 30 percent future growth in freight rail traffic; Chicago should also be a hub for increased passenger rail and a high speed rail for the entire Midwest; and

WHEREAS, A new National Infrastructure Bank (NIB) could directly help finance all of these projects; U.S. H.R. 3339, "The National Infrastructure Bank Act," which is sponsored by U.S. Representative Danny Davis of Illinois and supported by U.S. Representative Bobby Rush of Illinois, has been introduced to Congress; this resolution would create a \$5 trillion bank that could help finance all infrastructure projects and provide higher paying infrastructure and related employment to those who lost their jobs during the pandemic; and

WHEREAS, The NIB is modeled on previous successful institutions, which built much of the nation's infrastructure including the infrastructure of Illinois; under Presidents George Washington, James Madison, Abraham Lincoln, and Franklin D. Roosevelt, similar institutions financed the roads, bridges, dams, railroads, canals, and other projects that made us the envy of the world; the last NIB-like institution helped bring us out of the Great Depression and win World War Two; and

WHEREAS, The NIB will be capitalized by existing Treasury debt and will require no new federal spending and no new taxes; it will be authorized to spend \$5 trillion in urgently needed infrastructure projects and will create over twenty million new jobs, pay Davis-Bacon wages, and ensure Buy American policies; it will direct spending into disadvantaged business enterprises and ensure substantial minority hiring; experts state that the NIB will increase Gross Domestic Product to the five per cent annual level, as did all previous institutions; and

WHEREAS, The NIB is supported by many organizations; 21 state legislatures have introduced or passed resolutions, and dozens of city and county councils have done the same, including the Chicago City Council; other endorsements include The National Congress of Black Women, the National Association of Counties, the Public Banking Institute, the National Federation of Federal Employees, the American Sustainable Business Council, the National Association of Minority Contractors, the National Latino Farmers and Ranchers, and many other labor and community organizations; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Congress of the United States to pass U.S. House Resolution 3339 to create a National Infrastructure Bank to finance urgently needed infrastructure projects; and be it further

RESOLVED, That suitable copies of this resolution be delivered to every member of the Illinois Congressional Delegation, Governor JB Pritzker, and President Joe Biden.

# **HOUSE RESOLUTION 451**

Offered by Representative Durkin:

WHEREAS, Governor JB Pritzker issued Executive Order 2021-18 on August 4, 2021, requiring that all persons over the age of two who can medically tolerate a face mask to wear a face covering when inside any public or nonpublic school serving students in grades pre-kindergarten through 12; and

WHEREAS, Throughout the COVID-19 pandemic, Governor Pritzker and his State agencies have governed over the people of Illinois through executive order, seeking very little input from the General Assembly, a co-equal branch of government; and

WHEREAS, Once again, under E.O. 2021-18, Governor Pritzker and the Illinois State Board of Education have taken it upon themselves to exert their control over local school boards and private schools; and

WHEREAS, Since Governor Pritzker issued E.O. 2021-18, State Superintendent Dr. Carmen Ayala and the Illinois State Board of Education have pushed the boundaries of their authority by placing public school districts "on probation" and removing private school's recognition status for failing to comply with the executive orders that have been issued; and

WHEREAS, As of August 27, 2021, the Illinois State Board of Education has placed 47 public school districts on probation and removed the recognition status of 12 private schools for making local decisions; and
