WHEREAS, Sen. Carroll was an active participant in the Democratic Party and contributed to the success and viability of the Democratic Party in the State of Illinois; he served as committeeman for the 50th Ward in Chicago, as treasurer and finance chairman of the Chicago and Cook County Democratic Central Committee, and as a member of the Democratic State Platform Committee; his list of political activities spanned from meeting with presidents, prime ministers, and Mother Teresa to helping to try and stop the Nazis from marching in Skokie; and

WHEREAS, Deeply devoted to his Jewish faith, Sen. Carroll will be remembered as a family man, a born leader, a statesman, a voice for the voiceless, and a storyteller extraordinaire who devoted his energy and talents to improving the well-being of the people of Illinois; and

WHEREAS, Sen. Carroll was preceded in death by his parents and his brothers, Ira L. and Earl A. Carroll; and

WHEREAS, Sen. Carroll is survived by his wife, Eda (Stagman) Carroll; his daughters, Jacqueline Carroll (Louis Bernstein) and Barbara (Dan) Carroll Delano; and his granddaughters, Lillian and Alyssa; therefore, be it

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 458

Offered by Representative Marron:

WHEREAS, The family farm is the historic heart of American culture; through World War I, most of the men who defended America were sons of American farms, and some our country's most beloved holidays, led by Thanksgiving, celebrate the hard work and productivity of the American family farm; and

WHEREAS, In America and in Illinois, the family farm is currently under serious threat from a wide variety of global trends and factors; and

WHEREAS, A fast-moving proposal is making its way through the U.S. Congress that would impose a step-up tax on the capital gains enjoyed by an estate at the time of probate; this proposed tax hike would cover a wide variety of capital assets, including farmland and farm infrastructure; and

WHEREAS, Owners of American family farms, whose farms are treated as probate assets, would have to pay this tax when the owner of the farm passes away; and

WHEREAS, In contrast to family farms and with respect to farm assets owned by corporations and trusts, the corporation or trust would not, as an entity, have to pay capital gains taxes under this defined set of circumstances; and

WHEREAS, The implications of this tilted playing field, with respect to the future of the family farm in America and in Illinois, are obvious; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we oppose any plan or suggestion to impose a step-up tax on capital gains upon probate assets; and be it further

RESOLVED, That we believe that this tax, if imposed, would be a "double death tax" imposed on top of existing estate taxes upon the assets of people who have passed away; and be it further

RESOLVED, That we stand behind the family farms of the United States and Illinois as foundational units of the American way of life and believe that the public sector should do everything it can to defend the American family farm rather than take deliberate steps to damage and destroy it in the vestiges of space where it remains; and be it further

RESOLVED, That suitable copies of this resolution be delivered to U.S. Senators Richard Durbin and Tammy Duckworth and all members of the Illinois Congressional Delegation.

HOUSE RESOLUTION 467

Offered by Representative Evans:

WHEREAS, Reducing our carbon footprint is a priority for the people of Illinois; the need to reduce the use of fossil fuels is an ever-increasing reality and is an achievable goal, not only for the citizens of Illinois today but also for the generations going forward; and

WHEREAS, Solar and wind are viable sources that can make the goal possible; however, Illinois should also focus on what can be done with our present infrastructure to achieve the goal of a zero-carbon footprint and to ensure that new technology savings are optimized; and

WHEREAS, Upgrading and insulating mechanical systems is a long-term cost savings system used in construction and is an often-overlooked way to greatly reduce the carbon emissions from projects; and

WHEREAS, Mechanical insulation helps the system to perform its function of heating or cooling using as little energy as necessary; more insulation on the mechanical system means less energy is needed for the system to perform at its optimal functions; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge all government entities to consider, in all their buildings, updating insulation for mechanical systems or insulating non-insulated mechanical systems in order to lower energy costs, save taxpayer money, and reduce carbon emissions in total; and be it further

RESOLVED, That all State agencies consider insulating the hydronic pipes of new and current public buildings to reduce energy use and cost using an insulation thickness standard that is reflective of the 2018 International Energy Conservation Code.

HOUSE RESOLUTION 471

Offered by Representative Ozinga:

WHEREAS, Illinois has a long history of supporting nonpublic elementary and secondary schools; and WHEREAS, In 2017, the General Assembly created the Invest in Kids Act to provide low-income students with scholarship monies to attend nonpublic schools due in large part to the strong academic prowess of nonpublic schools; and

WHEREAS, Nonpublic schools also have a long tradition of competing in elementary and high school athletics often as strong contenders for state championships in a variety of sports; and

WHEREAS, The Illinois School Code allows nonpublic schools to voluntarily register with the Illinois State Board of Education; and

WHEREAS, The Illinois School Code also allows nonpublic schools to seek recognition status through the Illinois State Board of Education; doing so shows parents and students that a particular nonpublic school meets the academic and safety standards of public schools in Illinois; and

WHEREAS, This voluntary registration and recognition status has helped to keep nonpublic schools across Illinois as independent entities for several years; and

WHEREAS, During the COVID-19 pandemic, Governor JB Pritzker and the Illinois State Board of Education have sought several times to supersede the tradition of nonpublic education in Illinois by placing several COVID-related mandates onto nonpublic schools; and

WHEREAS, As of September 10, 2021, the Illinois State Board of Education has removed the recognition status of 15 nonpublic schools for failing to abide by Governor Pritzker's mask mandate at schools; and

WHEREAS, The governing boards of nonpublic schools should have the right to make decisions in the best interest of their students and staff as they see fit; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support nonpublic school autonomy and the voluntary process that allows nonpublic schools to seek registration and recognition with the Illinois State Board of Education; and be it further

RESOLVED, that we urge Governor JB Pritzker and the Illinois State Board of Education to support nonpublic school autonomy when it comes to making decisions for their schools, including decisions related to COVID-19; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor JB Pritzker and State Superintendent Dr. Carmen Ayala.

HOUSE RESOLUTION 480

Offered by Representative Zalewski:

WHEREAS, The cost of construction of new state of the art professional sport stadiums has increased over time; the cost of recently built state of the art professional football stadiums has often exceeded \$1 billion and obliterated original financial estimates; these stadiums are funded through a variety of methods, including private investors as well as taxpayer funding from state and local governments; and

WHEREAS, Public funding has been used as a tactic for professional sports teams to leverage state and local governments against each other in order to get a better deal on stadium financing; and

WHEREAS, Low income and minority communities in Illinois have been historically underfunded and have lacked sufficient investment; and

WHEREAS, The COVID-19 pandemic has reaffirmed the need to use taxpayer dollars to reinvest in communities, health care, schools, and infrastructure; and

WHEREAS, Public funding has been used in the construction or maintenance of most stadiums in the National Football League; only SoFi Stadium, home of the Los Angeles Rams and Chargers, and MetLife Stadium, home of the New York Giants and Jets, were completed with 100% private funding; recently, over \$750 million in public funds was used to finance Allegiant Stadium in Las Vegas, and \$498 million in public funds was used to finance US Bank Stadium in Minneapolis; and

WHEREAS, Public funding has also been used for professional baseball, basketball, and soccer stadiums; for example, Cincinnati taxpayers funded over 86% of the Red's Great American Ball Park; and

WHEREAS, There is no assurance that residents of a taxpayer-funded stadium will remain at their new home; history has shown that professional sports clubs move across country lines as in MLB's Montreal Expos moving and becoming the Washington Nationals, state lines as in the NFL's Oakland/Los Angeles Raiders moving from California to Nevada and the NFL's St. Louis Rams moving from Missouri to California, and intrastate relocations as well as in MLS's Chicago Fire leaving their soccer-specific stadium in Bridgeview to return to Chicago's Soldier Field; and

WHEREAS, As Illinois edges closer and closer to financial solvency, we cannot afford to spend taxpayer funds on stadiums when funding for critical social services remains uncertain; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the General Assembly is urged to take all necessary steps to ensure that no state or local taxpayer money is used in the construction of new professional sport stadiums.

WHEREAS, Even the shortest lives are valuable, and the grief of those who mourn the loss of these lives should not be trivialized; and

WHEREAS, This devastating tragedy often occurs suddenly and without warning as a result of miscarriage, stillbirth, Sudden Infant Death Syndrome (SIDS), congenital birth defects, accident, or other causes or complications; and

WHEREAS, These parents and families require support and understanding during their time of grief; and

WHEREAS, The 15th day of October is recognized in parts of the United States and in many other jurisdictions around the world as a day of remembrance and awareness of pregnancy and infant loss; in unity and support, The Trickster Cultural Center, a Native American and cultural arts center, is hosting a Baby Loss Journey Exhibit, curated by Native Veteran Jen Debouver, opening October 2, 2021; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare October 15, 2021 as Pregnancy and Infant Loss Awareness Day in the State of Illinois.

HOUSE RESOLUTION 492

Offered by Representative Lewis:

WHEREAS, Hinduism is the third largest religion in the world with more than one billion followers worldwide and six million in the United States; and

HOUSE RESOLUTION 493

Offered by Representative Zalewski:

WHEREAS, Gang violence throughout the State of Illinois is a threat to the public safety and the well-being of its citizens; and

WHEREAS, The Illinois Streetgang Terrorism Omnibus Prevention Act defines "gang" as any combination, confederation, alliance, network, conspiracy, understanding, or other similar conjoining, in law or in fact, of three or more persons with an established hierarchy that through its membership or through the agency of any member engages in a course or pattern of criminal activity and are not constitutionally protected; and

WHEREAS, The State of Illinois has a responsibility to ensure that every family is safe from harm's way, especially when our court system has extensive records of previous convictions, violations, and offenses from suspected gang members; and

WHEREAS, Chicago Police Superintendent David Brown attributes the recent data from the Federal Bureau of Investigation that shows homicides in Chicago increased 56% from 2019 to 2020 to gangs fighting over turf; and

WHEREAS, Gang activity extends beyond the City of Chicago, with several hundred gangs operating in Illinois, affecting the well-being and safety of citizens in the entire state; and

WHEREAS, The federal Racketeer Influenced and Corrupt Organizations Act (RICO) allows for federal prosecution and civil penalties for racketeering activity performed as part of an ongoing criminal enterprise, including, but not limited to, kidnapping, bribery, murder, money laundering, and drug trafficking; and

WHEREAS, In 2012, Illinois passed the Illinois Street Gang and Racketeer Influenced and Corrupt Organizations Law (Illinois RICO) to empower local and state officials to prosecute gang members and charge them as members of criminal organizations; and

WHEREAS, Gang activity often involves the racketeering activity that the federal RICO law and Illinois RICO are designed to combat; and

WHEREAS, There is an urgent need to aggressively protect Illinois families from gang activity, their racketeering efforts, and the violence that their behavior breeds from Chicago to Cairo, from Rockford to Champaign, and from the Metro East to Bourbonnais; and

WHEREAS, It is in the best interests of the citizens of Illinois to target and prosecute gang activity to the full extent of the law because gang activity increases violence and crime across the state; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois State's Attorneys to prosecute gang activity under Illinois RICO across the entirety of Illinois.

HOUSE RESOLUTION 500

WHEREAS, The people of Haiti have demonstrated resilience throughout history and have fought on the front lines for freedom and human dignity; and

WHEREAS, Haiti was the first nation in the world to abolish slavery and the slave trade after the Haitian Revolution; this acted as a beacon for Africans and people of African descent who were enslaved in racial chattel slavery around the world; and

WHEREAS, The recent assassination of the president of Haiti has caused further economic, political, and social instability; and

WHEREAS, An unstable economic and political system in Haiti has caused the government of Haiti to be unable to respond to natural disasters in a manner that provides relief, rebuilding, and reinvestment; and

WHEREAS, Many Haitians have come to view the United States as a compassionate nation that can help them realize freedom, self-determination, and economic success in the modern world; this belief exists despite the historical treatment of Haitian people by the U.S. government and despite the failures, current and historical, in the treatment of African Americans, Black Americans, and other people of African descent in the United States; and

WHEREAS, Recently, brave groups of Haitian people sought refuge in the United States in order to build a better life; these brave groups were treated in an unfair, undignified, and inhumane manner by some members of the Border Patrol, including being charged on horseback, having the reins of horses used as lashes and whips against them, and being shouted at with demeaning and xenophobic language; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we condemn the actions of the members of the U.S. Border Patrol who treated Haitian migrants and refugees with disrespect and in an inhumane manner; and be it further

RESOLVED, That we condemn United States policies that have undermined the people of Haiti and their ability to build a stable economic and political system and have helped cause thousands of Haitian people to look elsewhere for a better life; and be it further

RESOLVED, That we urge President Biden and the United States Congress to adopt a compassionate and humane immigration system that respects the dignity and value of each human life, including the Haitian people who wish to make a life in the United States; and be it further

RESOLVED, That suitable copies of this resolution be delivered to President Joe Biden, Vice President Kamala Harris, Speaker of the House Nancy Pelosi, Senate President Chuck Schumer, and all members of the Illinois Congressional delegation.

HOUSE RESOLUTION 501

WHEREAS, Family Court Awareness Month (FCAM) was created to shine a spotlight on the dark topic of family court while honoring the children who have been murdered by separating or divorcing parents since 2008; and

WHEREAS, The mission of the Family Court Awareness Month Committee is to educate judges and other family court professionals on the empirical data and research that is currently available, as such research is a critical component to making decisions that are truly in the best interest of children; this research includes The Adverse Childhood Experiences (ACE) Study by the CDC-Kaiser Permanente, the Saunder's Study by the U.S. Department of Justice, The Meier Study: Child Custody Outcomes in Cases Involving Abuse Allegations, and the Santa Clara Law Study titled Confronting the Challenge of High-Conflict Personality in Family Court; and

WHEREAS, The mission of the Family Court Awareness Month Committee is fueled by the desire for awareness and change in the family court system while honoring the more than 100 children in the United States who have been murdered by a parent after a custody court rejected the other parent's plea for protection, as noted by the Center for Judicial Excellence; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the month of November 2021 as Family Court Awareness Month in the State of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be presented to One Mom's Battle and the Family Court Awareness Month Committee with our sincere appreciation for their efforts.

HOUSE RESOLUTION 504

Offered by Representative Demmer:

WHEREAS, The Prairie Band Potawatomi Nation is a federally-recognized Indian tribe that originally occupied homelands in southern Wisconsin, northern Illinois, and northwestern Indiana; and

WHEREAS, Members of the Prairie Band Potawatomi Nation were signatories to the 1829 Treaty of Prairie du Chien, which reserved two sections of land near Paw Paw Grove, Illinois for Potawatomi Chief Shab-eh-nay and his band; and

WHEREAS, Shortly thereafter, the Potawatomi people of northern Illinois were removed from their homelands in connection with the U.S. Indian Removal Policy of the 1830s; and

WHEREAS, The Prairie Band Potawatomi Nation relinquished nearly all of their initial 28 million-acre homeland in the Great Lakes area when the Treaty of Chicago was signed only three years later; and

WHEREAS, The 1833 Treaty of Chicago did not cede the Shab-eh-nay Reservation to the U.S., but instead it reaffirmed the reservation established for Chief Shab-eh-nay and his band in the 1829 Treaty of Prairie du Chien; and

WHEREAS, Because the land reserved for Chief Shab-eh-nay and his band in Illinois was expressly reserved by the U.S. Senate when it ratified the Treaty of Prairie du Chien in 1829, the land belonged to Chief Shab-eh-nay and his band despite the removal of most of his tribe to lands in Kansas; and

WHEREAS, In 1849, while Chief Shab-eh-nay was away visiting relatives in Kansas, the U.S. General Land Office illegally sold the land and passed the title to non-natives; and

WHEREAS, Since then, individuals, the State of Illinois, the DeKalb county government, and corporate entities assumed ownership of lands within the Shab-eh-nay Reservation and continue to occupy Shab-eh-nay's lands to the present day; and

WHEREAS, The current non-Indian occupants within the Shab-eh-nay Reservation should not be held liable for occupying the land; and

WHEREAS, The federal government has admitted that it violated federal law when it sold the Shab-eh-nay Reservation in 1849; and

WHEREAS, Only congress can affirm the Prairie Band Potawatomi Nation's authority within the reservation, resolve any damages owed to them, and clear the land title of the state, county, and local residents; and

WHEREAS, The Prairie Band Potawatomi Nation seeks a complete resolution of all issues relating to the Shab-eh-nay Reservation through congressional recognition of its land ownership and the taking of land by the federal government; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support the Prairie Band Potawatomi Nation's efforts to regain possession of Chief Shab-eh-nay and his band's land that was illegally sold by the federal government in 1849; and be it further

RESOLVED, That we encourage the federal government to enact legislation to address the ownership of the Shab-eh-nay Reservation reserved for Chief Shab-eh-nay and his descendants under the Treaty of Chicago in 1833.
