WHEREAS, The menopausal transition most often begins between ages 45 and 55; and

WHEREAS, Perimenopause marks the years leading up to menopause, which may include menopausal signs and symptoms as menstruation continues but may become irregular and pregnancy is possible but less likely; and

WHEREAS, Some women are impacted by symptoms, including hot flashes, night sweats, sleep disturbances, and others, which may impact physical or emotional health; and

WHEREAS, There are many treatments available for symptoms related to menopause, including hormone replacement therapy, holistic solutions, and lifestyle adjustments; and

WHEREAS, Increased awareness of menopause will lead to an improvement in the understanding of this phase of reproductive health and improved treatment and outcomes for those impacted; and

WHEREAS, The International Menopause Society (IMS), in collaboration with the World Health Organization (WHO), has designated October as World Menopause Awareness Month; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the month of October 2021 as Menopause Awareness Month in the State of Illinois; and be it further

RESOLVED, That we support raising awareness of menopause as it is critical to dispelling the myths and ensuring that the symptoms of menopause are recognized and that treatment is identified and secured where needed; and be it further

RESOLVED, That we support raising awareness of all aspects of a woman's reproductive cycle as it is critical to ensuring understanding, compassion, and support for those experiencing menopause while dispelling the myths and shattering the stigma associated with menopause.

HOUSE RESOLUTION 537

Offered by Representative Nichols:

WHEREAS, The members of the Illinois House of Representatives wish to commemorate the contribution Mark Aguirre has made to Illinois basketball; and

WHEREAS, Mark Aguirre was born in Chicago on December 10, 1959; and

WHEREAS, Mark Aguirre attended George Westinghouse College Prep in Chicago, becoming a Third-team Parade All-American and McDonald's All-American; he was named Mr. Basketball USA in 1978 by Ballislife.com; and

WHEREAS, Mark Aguirre attended DePaul University in Chicago; he led the Blue Devils to three consecutive NCAA Tournament appearances and was named the Naismith College Player of the Year and awarded the Adolph Rupp Trophy; and

WHEREAS, Mark Aguirre earned a number of honors while playing at DePaul University, including being named a two-time consensus first-team All-American, Sporting News College Basketball Player of the Year, UPI College Basketball Player of the Year, and AP College Basketball Player of the Year and receiving the USBWA Oscar Robertson Trophy during his time with the Blue Devils, which led to his number being retired and his induction into the National Collegiate Basketball Hall of Fame; and

WHEREAS, Mark Aguirre was part of the 1980 U.S. Olympic Basketball Team and received a Congressional Gold Medal; and

WHEREAS, Mark Aguirre was drafted first overall in the 1981 NBA Draft by the Dallas Mavericks; and

WHEREAS, Mark Aguirre played in the NBA for 13 seasons, winning two NBA Championships and earning selection to the NBA All-Star Team three times; and

WHEREAS, Mark Aguirre coached in the NBA for six seasons; therefore, be it
