HOUSE RESOLUTION 549

Offered by Representative Collins:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Task Force on Foster Youth Transitioning Out of Care is hereby created; and be it further

RESOLVED, That the Task Force is charged with the task of investigating the decline in foster youth living successful lives after transitioning out of care and with developing recommendations for DCFS on how to improve the transition for people leaving foster care, as well as a time frame for DCFS to implement these recommendations; and be it further

RESOLVED, That the Task Force shall consist of the following 10 members, who shall serve without compensation:

- (1) The Director of DCFS or his or her designee, who shall serve as Chair of the Task Force;
- (2) The Chairman of the Office of the State Appellate Defender Board of Commissioners or his or her designee;
- (3) Two previous foster children who have transitioned out of care appointed by the Governor;
- (4) Three members of the Illinois House of Representatives appointed by the Speaker of the House; and
- (5) Three members of the Illinois House of Representatives appointed by the House Minority Leader; and be it further

RESOLVED, That the Department of Children and Family Services shall provide administrative support for the Task Force; and be it further

RESOLVED, That the Task Force shall meet once a month following the appointment of the members and shall continue to meet once a month for the duration of the 102nd General Assembly; and be it further

RESOLVED, That the Task Force shall submit its final report no later than the final day of the 102nd General Assembly and is dissolved upon the filing.

HOUSE RESOLUTION 564

Offered by Representative Kifowit:

WHEREAS, FIRST is For the Inspiration and Recognition of Science and Technology; and

WHEREAS, Robotics is rapidly proving to be one of the most effective, compelling, and engaging means for teaching and reinforcing fundamental science, technology, engineering, and mathematics (STEM) concepts as well as inspiring the nation's youth to pursue STEM-related careers, thereby helping to create a highly skilled, 21st-century American workforce; and

WHEREAS, There is a strong need to recognize America's leadership in robotics technology, educate the public on robotics technology's broad potential, growing importance, and future impact on American society, underscore the need for increased investment in robotics technology research and development, and inspire the nation's youth to pursue careers in robotics and other STEM-related fields; and

WHEREAS, The United States has the largest number of academic and research organizations with dedicated programs focused on the advancement of robotics technology; and

WHEREAS, Aptitude in mathematics, science, and engineering is essential for a knowledge-based society; and

WHEREAS, The State of Illinois must continue to make deep, hands-on STEM experiences a true priority in school districts around the country by unlocking increased funding for programming that builds

strong foundations for STEM literacy, increases diversity, equity, and inclusion in STEM, and prepares the STEM workforce for the future; and

WHEREAS, Not all STEM jobs of the 21st century require a traditional four-year degree, so greater pathways toward STEM education must be encouraged; and

WHEREAS, Robotics has matured into an all-encompassing and enabling technology that, as a pillar of 21st-century American innovation, is positioned to fuel a broad array of next generation products and applications and transform our society; and

WHEREAS, The emerging market for robotics and related technology in various sectors, including health care, national defense, homeland security, energy, manufacturing, logistics, transportation, agriculture, education, consumer goods, and others, is expected to grow at a compound annual growth rate of nearly 20 percent over the next few years to become a worldwide \$27,000,000,000 industry; and

WHEREAS, Robotics is a critical technology capable in the near term of contributing to the economic recovery by creating new jobs, increasing productivity, improving quality, and increasing worker safety; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the third Friday in March 2021 and March 2022 as "FIRST Robotics Day" in the State of Illinois; and be it further

RESOLVED, That we recognize the continuing importance of the National Science Foundation's math and science education programs and encourage local school districts and other educational agencies to fund afterschool robotics programs; and be it further

RESOLVED, That we encourage schools and educators to observe the day with appropriate activities that teach students about robotics and engage them with the study of mathematics and science.

HOUSE RESOLUTION 574

Offered by Representative McCombie:

WHEREAS, Advocates are constantly looking to extract more money from working U.S. men and women to spend on what they consider to be good causes; and

WHEREAS, A proposal, currently moving rapidly through the U.S. Congress, would direct U.S. financial institutions to open virtually all of their customers' account books and papers to the federal Internal Revenue Service (IRS); and

WHEREAS, This proposal would subject all transactions over \$600 to federal IRS investigation and scrutiny; and

WHEREAS, Although this proposal is being sold to supporters as a weapon against alleged "tax evasion," it would also open the books of the great majority of American households, on a month-by-month basis, to federal investigators; and

WHEREAS, The great majority of American households who have mortgaged a home or who pay rent on a home participate in monthly transactions of more than \$600; and

WHEREAS, The great majority of American households who have and use credit cards participate in monthly transactions of more than \$600; and

WHEREAS, The great majority of working Americans who work for pay have their pay deposited in accounts held in financial institutions, and whenever a deposited pay stub would be greater than \$600, the transaction would be open to federal investigation and scrutiny; and

WHEREAS, Enacting a financial institution open-books law with a transaction trigger of \$600 will virtually end the financial privacy of the American people; and

WHEREAS, Every American who values their financial standing and privacy must stand in total opposition to this misguided proposal, and this opposition is urgently needed because this privacy can never be recovered once it is gone; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we totally and urgently oppose the \$600 transaction financial inspection and reporting proposal being considered in the United States Congress as of October 2021; and be it further

RESOLVED, That suitable copies of this resolution be delivered to members of the Illinois Congressional delegation.

HOUSE RESOLUTION 575

Offered by Representative Miller:

WHEREAS, Following World War II, the Soviet Union occupied Hungary and forced an anti-democratic and brutal government upon the people of Hungary; and

WHEREAS, On October 23, 1956, over 100,000 ordinary citizens became "Freedom Fighters" and revolted against their Soviet communist government in what started as a peaceful protest but turned violent when protestors were fired upon by security police, triggering a bloody fight for freedom; and

WHEREAS, The Soviet Union launched a military counter-offense to suppress the revolt, but not before thousands gave their lives for freedom; more than 200,000 Hungarians fled their country in the aftermath of the Soviet suppression of the Hungarian Uprising, and over 47,000 of these people eventually settled in the United States; and

WHEREAS, On October 23, 1989, the Republic of Hungary declared its independence, which contributed to the collapse of the Soviet Union and communism in Eastern Europe; Hungarians led the first revolt against communist occupiers and inspired other captive nations to defend their freedom; and

WHEREAS, On March 12, 1999, Hungary became a member of NATO, and on May 1, 2004, Hungary become a member of the European Union; as a former Warsaw Pact nation, Hungary has proven itself as a reliable military ally in support against the global war on terrorism and as a provider of humanitarian aid in the pandemic fight against COVID-19; and

WHEREAS, The State of Illinois is proud to be called home to a large number of Hungarians, Hungarian Americans, and their descendants, who have contributed greatly to the economic development, multicultural diversity, and enrichment of all aspects of life in the State; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the 65th anniversary of the Hungarian Revolution and the sacrifices of the brave Hungarian freedom fighters and the great contributions of Hungarian-Americans in Illinois, and we reaffirm the friendship between the people and government of Illinois and the country of Hungary; and be it further

RESOLVED, That we declare October 23, 2022 as "Hungarian Freedom Fighters Day" and declare October 2022 as "Hungarian Freedom Month" in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Stephen Szigethy.

HOUSE RESOLUTION 578

Offered by Representative Moeller:

WHEREAS, Cervical cancer is a disease that strikes over 13,000 American women each year; and

WHEREAS, Cervical cancer most often affects women in the prime of life; and

WHEREAS, Regular cervical cancer screening tests are effective in detecting the disease early when it can be effectively treated; and

WHEREAS, Cervical cancer disproportionately impacts vulnerable communities lacking access to health care and proven life-saving tools; and

WHEREAS, Cervical cancer screening tests and vaccines are available that together provide a formidable and effective means of preventing this disease; and

WHEREAS, Increasing awareness among patients and healthcare providers alike regarding the best use of these prevention tools is a key component in safeguarding women's health; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare January 2022 as Cervical Health Awareness Month in the State of Illinois; and be it further

RESOLVED, That we encourage all citizens to recognize that cervical cancer is preventable and to encourage the women in their lives to avail themselves of the tests and vaccines that have proven so effective in preventing cervical cancer, as we have the means to prevent this disease, and it is incumbent on

all of us to insure we have the will to do so.

HOUSE RESOLUTION 580

Offered by Representative Stuart:

WHEREAS, On December 10, 2021, severe storms and tornadoes ripped through the Southern and Midwestern United States, damaging homes and businesses in Edwardsville; six employees tragically lost their lives, and one employee sustained serious injuries at the Edwardsville Amazon warehouse; and

WHEREAS, Severe weather and tornado warnings were issued, giving notice to residents to take cover and seek shelter; and

WHEREAS, The victims of this natural disaster deserve to be recognized; they are Deandre S. Morrow, 28, of St. Louis, Kevin D. Dickey, 62, of Carlyle, Clayton Lynn Cope, 29, of Alton, Etheria S. Hebb, 34, of St. Louis, Larry E. Virden, 46, of Collinsville, and Austin J. McEwen, 26, of Edwardsville; and

WHEREAS, Craig Yost, 39, deserves support during his recovery from injuries sustained while trapped due to storm damage at the Amazon warehouse; and

WHEREAS, The health and safety of workers must be a priority for all employers, especially as severe weather events increase; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the victims of the December 10, 2021 storms and honor their memories; and be it further

RESOLVED, That we urge the Occupational Safety and Health Administration to thoroughly conduct their investigation into the Edwardsville Amazon warehouse to ensure that proper safety protocols were followed before and during the severe weather event, that the warehouse was built to code and offered proper storm shelter for employees, and that OSHA and the other proper authorities can immediately implement proper protocols where needed; and be it further

RESOLVED, That we urge Amazon to review their personnel policies to compensate workers that lost income due to the severe weather event, as well as the families of those who lost their loved ones and those who were injured.

HOUSE RESOLUTION 582

Offered by Representative West:

WHEREAS, Illinois employers report the increasing need for secondary and postsecondary graduates with essential and technical employability skills necessary to succeed in high-demand and growing occupational areas; and

WHEREAS, Regional college and career readiness systems develop essential and technical employability skills that are transferable to numerous careers and allow students to explore career options and find a pathway while still in the K-12 system; and

WHEREAS, Access to high-quality systems and programming varies extensively across Illinois; and

WHEREAS, Aligning support from State agencies, school districts, postsecondary education providers, employers, and other public and private organizations will lead to the development and implementation of a robust and coordinated college and career readiness system in Illinois; and

WHEREAS, Career and Technical Education (CTE) links academic learning directly to workplace competencies through hands-on learning, career exploration, on-site instruction, and credentialing to give students a jump-start on their postsecondary education or meaningful career; and

WHEREAS, The Illinois General Assembly enacted the Postsecondary and Workforce Readiness Act in 2016 to launch four evidence-based strategies to prepare more students for meaningful career opportunities by supporting postsecondary and career planning, promoting and incentivizing competency-based learning programs, reducing remedial education rates, increasing alignment between K-12 and postsecondary education systems, and implementing college and career pathway systems; and

WHEREAS, The Dual Credit Quality Act and Education and Workforce Equity Act were built from existing State policy to emphasize strategic opportunities for alignment between secondary, postsecondary,

and workforce education that promotes equitable access and accelerates student progression through robust college and career pathway coursework and systems; and

WHEREAS, The Illinois Community College Board (ICCB) has published Perkins Model Programs of Study to define strategies for systems alignment and student acceleration in accordance with the principles of the State Perkins Plan, the State Workforce Innovation and Opportunity Act (WIOA) Plan, the Postsecondary and Workforce Readiness Act, the Dual Credit Quality Act, the Education and Workforce Equity Act, and other State policies; and

WHEREAS, According to the Integrated Public Use Microdata Series (IPUMS USA) data using 2019 American Community Survey estimates, significant gaps in postsecondary attainment for Illinois adults age 25+ persist across demographic groups, with 29.4% of Black adults and 19.7% of Latinx adults possessing an associate degree or higher compared to 46.6% of their white peers; the Lumina Foundation estimates that an additional 8.2% of Illinois adults have a sub-associate postsecondary degree or credential, resulting in an overall attainment rate of 55.2%; and

WHEREAS, Individuals with a postsecondary credential, whether it is a college degree or technical certificate, are more likely to be employed and on average can earn 62% more than peers with a high school diploma; and

WHEREAS, The State has demonstrated a commitment to addressing equity gaps in access and attainment through the State Perkins Plan, Higher Education Strategic Plan, Every Student Succeeds Act State Plan, and the Education and Workforce Equity Act, which reiterates the charge to the P-20 Council to update the State's postsecondary attainment goals to include equity-focused targets aimed at closing gaps in postsecondary attainment; and

WHEREAS, The Illinois State Board of Education (ISBE) has initiated an external evaluation of the State's Education for Employment (EFE) CTE funding system to assess its efficiency and efficacy; and

WHEREAS, The State's education and workforce agencies have demonstrated a commitment to seeking opportunities for greater alignment across governance and funding structures that will incentivize greater alignment and integration of secondary and postsecondary education; and

WHEREAS, Emerging State activities, policies, and plans present a valuable chance for Illinois to consider how college and career readiness systems and structures can incentivize greater alignment and enhance student experiences in equitably accessing and progressing along robust college and career pathways; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the P-20 Council is urged to convene a geographically representative College and Career Readiness (CCR) Funding and Governance Task Force and produce a report addressing:

(1) Local and national best practices pertaining to regional college and career readiness system governance and funding, including the roles of regional partners including secondary districts, community colleges, and employers;

(2) Recommendations for a regional college and career readiness governance model inclusive of Career and Technical Education, the Postsecondary and Workforce Readiness Act, the Dual Credit Quality Act, and the Education and Workforce Equity Act and addressing the State's equity-based postsecondary attainment targets;

(3) Recommendations to ensure the State's Career and Technical Education fund disbursement methodology supports the State's CTE vision as outlined in the State's Perkins V plan to "empower and support all students to achieve their life and career goals through an aligned, equitable, and high-quality career pathway system"; and

(4) Recommendations to clarify and affirm the role of regional college and career readiness systems in addressing State goals as outlined in State agency plans, including the State Perkins Plan, the Every Student Succeeds Act (ESSA) State Plan, the Higher Education Strategic Plan, and any plan emerging from the P-20 Council's work to meet the requirements of HB2170; and be it further

RESOLVED, That the CCR Funding and Governance Task Force should be comprised of representatives from, at a minimum, secondary education districts, community college, university, and statewide professional teachers' association(s), statewide school management association(s), EFE system leadership, Career and Technical Student Organizations (CTSOs), employers and/or industry groups, local workforce boards, State education and workforce agencies, local and national advocacy and research organizations with relevant expertise; and be it further

RESOLVED, That the CCR Funding and Governance Task Force should meet at the call of the Illinois P-20 Council, which should provide administrative and other support to the task force through a committee focused on college and career readiness; members of the task force should serve without compensation; and be it further

RESOLVED, That ISBE is urged to report to the P-20 Council the findings of their external evaluation of the EFE system upon completion for the P-20 Council's task force to consider in addition to their own research; and be it further

RESOLVED, That the P-20 Council is urged to present its findings and recommendations for governance or funding improvements necessary to provide equitable and high-quality college and career readiness preparation across Illinois on or before October 31, 2022 to the Illinois State Board of Education, the Illinois Board of Higher Education, the Illinois Community College Board, the Illinois Department of Commerce and Employment Opportunity, the Illinois P-20 Council, the General Assembly, the Illinois Asian American Legislative Caucus, the Illinois Legislative Black Caucus, the Illinois Legislative Latino Caucus, and the Illinois Women's Caucuses; and be it further

RESOLVED, That the P-20 Council is urged to dissolve the CCR Funding and Governance Task Force after it submits its report.

HOUSE RESOLUTION 585

Offered by Representative Smith:

WHEREAS, Breast cancer is among the most commonly diagnosed types of cancer and is the second leading cause of cancer death among women in the United States; and

WHEREAS, Approximately 281,550 women will be diagnosed with breast cancer, and nearly 43,600 will die with this malignancy in 2021; and

WHEREAS, Triple Negative Breast Cancer is one of many forms of breast cancer and accounts for approximately 15-30% of all diagnosed invasive breast cancer cases in the United States; and

WHEREAS, Of the new breast cancer cases diagnosed in 2019 in the United States, more than 53,700 were Triple Negative Breast Cancer with higher prevalence among younger women, Black and Hispanic women, women with type 2 diabetes or carrying excess weight in the abdomen area, and those with BRCA1 mutations; and

WHEREAS, Due to its aggressive behavior, Triple Negative Breast Cancer grows quickly and is more likely to have spread at the time it is found and more likely to return after treatment than other types of breast cancer; and

WHEREAS, People diagnosed with metastatic Triple Negative Breast Cancer have a less than 30% chance of surviving past five years; and

WHEREAS, Triple Negative Breast Cancer cells do not contain and are considered negative for the three key receptors that medicines typically target in other types of breast cancers; therefore, there are limited treatment options that can be used to treat this type of cancer; and

WHEREAS, Patients with an early diagnosis can often be treated with chemotherapy, radiation, and surgery; however, the limited therapies available that specifically address the management of Triple Negative Breast Cancer have made treating this disease a challenge for clinicians; and

WHEREAS, Recent innovations in targeted therapies have fueled advances in the fight against Triple Negative Breast Cancer; and

WHEREAS, Studies have shown that Triple Negative Breast Cancer disease-specific mortality rates are often higher if patients have Medicaid or Medicare or are lower socio-economic status, and compared with non-Hispanic white women, Black women are 48% less likely to receive guideline adherent care and have an approximate two-fold higher mortality incidence, resulting in a disproportionately higher risk of death from Triple Negative Breast Cancer; and

WHEREAS, Advances in breast cancer screening and treatment over the last few decades have reduced the overall breast cancer mortality rate, yet the disproportionate impact of Triple Negative Breast Cancer on racial and ethnic minority communities raises the need for consideration of the underlying determinants driving the disparities; and

WHEREAS, It is necessary to promote Triple Negative Breast Cancer education, to raise awareness about the disease-related disparities, and to tackle inequities within the health care delivery, such as

inadequate access to screening, diagnostic testing, and care, to improve early detection and survival; therefore, be it

RESOLVED, That additional legislative provisions should be examined to safeguard affordable, continuous, and equitable patient access to Triple Negative Breast Cancer related care, services, and medicines along the entire continuum of care.

HOUSE RESOLUTION 592

WHEREAS, An estimated 54 million Americans have osteoporosis or low bone mass; studies suggest that approximately one in two women and up to one in four men age 50 and older will break a bone due to osteoporosis; and

WHEREAS, Osteoporosis-related bone fractures are responsible for more hospitalizations than heart attacks, strokes, or breast cancer; in a recent yearly total, approximately 1.8 million Medicare beneficiaries suffered approximately 2.1 million osteoporotic fractures; and

WHEREAS, In Illinois, 67,000 Medicare beneficiaries suffered over 79,500 osteoporotic fractures in 2016; and

WHEREAS, The cost for Illinois citizens who suffered an initial and subsequent fracture was estimated at over \$261.9 million; and

WHEREAS, Osteoporosis is often called a silent disease because one cannot feel bones weakening; a broken bone is often the first sign of osteoporosis; timely bone health screening, diagnosis, and treatment can help prevent fractures that can lead to hospitalizations and nursing home stays; and

WHEREAS, Cost-effective post fracture care, which improves care coordination, has been demonstrated to reduce the number of subsequent or repeat fractures yet is not widely available or properly incentivized by Medicare; and

WHEREAS, Osteoporosis and the broken bones it can cause are not a part of normal aging; building strong bones begins in childhood and is essential to the prevention of osteoporosis; care for our bones is vital throughout our lives, but we reach our peak bones mass by early adulthood; and

WHEREAS, Optimum bone health and prevention of osteoporosis can be maximized by a balanced diet rich in calcium and vitamin D, weight-bearing and muscle-strengthening exercise, and a healthy lifestyle with no smoking or no excessive alcohol intake; and

WHEREAS, We must raise awareness about bone health among the public, health professionals, and policymakers; therefore, be it

Roe's great-grandfather, Dr. John Roe, was born near Philadelphia, Pennsylvania in 1800 and moved to Ogle County in 1836; he was the first doctor in the Rock River Valley; he established a farm and medical practice on a hill, which later became known as "Lighthouse Point" because Dr. Roe and his wife kept a light burning in a window as a beacon so that all knew how to find the doctor; that land now houses the Lighthouse Church and Cemetery and was donated by the Roe family; and

WHEREAS, Sen. Roe was born to Jane Gilbert and John B. Roe II on November 21, 1942; he graduated from Oregon Community High School in 1960 and Center College in Danville, Kentucky in 1964 with a Bachelor of Arts in Political Science and History; and

WHEREAS, Sen. Roe attended the University of Illinois, where he graduated from law school in 1967 and began his practice of law in Ogle County; he served as a public defender for the county and was then elected the youngest state's attorney in Illinois in 1968; and

WHEREAS, Sen. Roe was elected State Senator of the 35th District of Illinois in 1972 and was the first freshman senator to be appointed to the Committee of Committees; he also served on the Legislative Investigative Commission; and

WHEREAS, Sen. Roe sponsored the Illinois Campaign Disclosure Act, requiring candidates for public office to disclose their contributors and their expenditures; and

WHEREAS, Sen. Roe sponsored and passed legislation that appropriated the necessary funds for the first leg of the North-South Freeway from Rockford to the west tollway extension of Rochelle and legislation allocating money for the U.S. 20 Freeway Bypass system to be built from Lena to east of Freeport; and

WHEREAS, In 1976, Sen. Roe was approached by Robert "Bob" Hultgren, a local businessman and entrepreneur, and Mayor Bill Cipolla to obtain assistance and funding to place an overpass on then U.S. Route 51 through Rochelle; at that time, U.S. Route 51 was the major north-south thoroughfare through the state; Rochelle had two sets of railroad tracks, the Chicago Northwestern and Burlington Northern; as many as 80 trains a day went through Rochelle, creating delays of 15 to 20 minutes for each train; the city had become known as Jamtown and Delaysville by truckers; and

WHEREAS, Sen. Roe obtained the money necessary to construct the Rochelle overpass; and

WHEREAS, Sen. Roe was appointed Chief Justice of the Illinois Court of Claims by Governor Jim Thompson in 1979; he was a member of the Rochelle Grade School Board of District 230 from 1982 to 1984; and

WHEREAS, Sen. Roe practiced law in Rochelle from 1973 to 1995; he was appointed a circuit judge in 1995 by the Illinois Supreme Court and was elected as a circuit judge in 1996; and

WHEREAS, Sen. Roe retired as a judge in 2000 and was a member of the Governor's Commission to Revise and Rewrite The Illinois Criminal Code; he was also a member of the board of the Abraham Lincoln Presidential Library and Museum and served on the faculty at Stetson University College of Law in St. Petersburg, Florida as an adjunct professor; he was a Certified Florida County Circuit and Family Mediator and a Certified Mediator of the U.S. District Court Middle District of Florida and U.S. District Court Northern District of Illinois; he was a Florida Bar Association arbitrator and mediator and was a certified mediator and arbitrator of the 12th Circuit of Florida and the 15th Circuit of Illinois; he was a Manatee County Florida administration hearing officer and was an arbitrator for the New York and Nasdaq Stock Exchanges; and

WHEREAS, Sen. Roe was preceded in death by his parents; and

WHEREAS, At the time of his passing, Sen. Roe was survived by his wife of 47 years, Phyllis, who was his companion, love, best friend, and caretaker; his son, John B. "Ben" (Irene) Roe IV; his stepdaughter, Julie (Jim) Watt; his grandchildren, John Benjamin Roe V, Mary Margaret Roe, Justin Watt, and Emma Watt; his sister, Ruth Roe Arth; and many nieces and nephews and extended family members; and

(6) one member of a statewide organization that represents principals, appointed by the State Superintendent of Education;

(9) one member of a statewide organization that represents rural school districts, appointed by the State Superintendent of Education;

(10) two members representing teacher education preparation programs at in-state colleges and universities, appointed by the State Superintendent of Education;

(11) one member of the House of Representatives appointed by the Speaker of the House;

(12) one member of the House of Representatives appointed by the House Minority Leader;

(13) one member of the Senate appointed by the Senate President; and

(14) one member of the Senate appointed by the Senate Minority Leader; and be it further

RESOLVED, That the Task Force shall have all appointments made within 30 days of the adoption of this resolution; and be it further

RESOLVED, That the Task Force members shall serve without compensation; and be it further

RESOLVED, That the Task Force shall first meet at the call of the State Superintendent of Education within 30 days following all appointments being made; at which meeting, the Task Force shall elect a chairperson and vice-chairperson from among its members; at which time, meetings of the Task Force shall then be at the call of the chairperson; and be it further
