## HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.
HOUSE RESOLUTION 699
Offered by Representative Halpin:
WHEREAS, The Illinois Department of Transportation, in conjunction with the Federal Highway Administration (FHWA) and partnered with the Iowa Department of Transportation, desired to replace the I-80 bridge over the Mississippi River in Rock Island County; and

WHEREAS, It was determined that the Illinois Department of Transportation will be the lead agency, with Iowa and Illinois sharing costs equally; the job number for the project is P-92-013-15; the structure number is 081-0011; and

WHEREAS, On October 21, 2020, the Illinois Department of Transportation selected Parsons Transportation Group, Inc. to prepare a combined design report and environmental impact statement (EIS) for the structure that carries I-80 over the Mississippi River; and

WHEREAS, Parsons Transportation Group, Inc. was additionally tasked with determining, as part of the design report and EIS, whether it is possible that the proposed improvements could include total replacement and widening of the structure and whether that should be on new alignment; various alternatives will be studied to determine the most viable solution for this corridor; impacts to the interchanges of I-80/IL 84 (IL side), which also crosses the Canadian Pacific (CP) Railroad, and I-80/US 67 (IA side) may need to be explored as the project develops; and

WHEREAS, As part of the phase 1 process, the Illinois Department of Transportation has been asked by the Bison Bridge Foundation to consider as an alternative the repurposing of the existing I-80 structure; a potential savings of over $\$ 30$ million is possible by the elimination of the removal of the existing structure and not having to implement a multi-use facility on the proposed new structure; and

WHEREAS, By repurposing the existing structure, in addition to offering savings to taxpayers, the Project has the potential to generate additional funds from increased tourism, economic development, improved quality of life, and the retention of the younger workforce in the area; and

WHEREAS, The Bison Bridge Foundation has shown the willingness to accept the existing structure at no cost to the Department and is willing to work with both the Illinois and Iowa Departments of Transportation and the FHWA to provide a facility that is conducive to the promotion of its goals of attracting tourism, increasing economic development, providing a multi-use facility, and promoting the Mississippi River area; and

WHEREAS, The Bison Bridge Foundation proposes this project at no cost to the departments of transportation or the FHWA; instead, funding for this project will be accomplished by private and corporate donations; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Governor and the Secretary of the Department of Transportation to develop plans for the new I-80 bridge structure that includes the incorporation of the Bison Bridge structure; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor, the Secretary of the Department of Transportation, and the Bison Bridge Foundation.

## HOUSE RESOLUTION 700

WHEREAS, Over 100 million operations and procedures are performed every year with anesthesia, and physician anesthesiologists play a critical role, before, during, and after procedures, making patient safety their top priority; and

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare January 30 through February 5, 2022 as Physician Anesthesiologists Week in the State of Illinois and ask all citizens to join us in recognizing physician anesthesiologists, who have developed the techniques and protocols that have greatly improved the safety of anesthesiology and the well-being of surgical patients each day; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Illinois Society of Anesthesiologists as a symbol of our respect and esteem.

## HOUSE RESOLUTION 701

Offered by Representative Stuart:
WHEREAS, All over the world, persons who menstruate face numerous challenges in managing their menstruation, including pads and other supplies being unavailable or unaffordable, a lack of access to safe toilet facilities with clean water where they can clean themselves in privacy, discriminatory cultural norms or practices that make it difficult to maintain good menstrual hygiene, a lack of education for all on the topic of menstruation, and other struggles; and

WHEREAS, Poor menstrual hygiene undermines the educational and occupational opportunities, health, and overall social status of persons who menstruate; and

WHEREAS, As a result, millions of persons who menstruate are kept from reaching their full potential; and

WHEREAS, Menstrual Hygiene Day was initiated by the German nonprofit WASH United in 2013; and

WHEREAS, Menstrual Hygiene Day is a global advocacy platform that brings together the voices and actions of nonprofits, government agencies, individuals, the private sector, and the media to promote good menstrual hygiene management for all persons who menstruate; and

WHEREAS, Menstrual Hygiene Day breaks the silence, raises awareness, and changes negative social norms around menstrual hygiene management; and

WHEREAS, Menstrual Hygiene Day engages decision-makers to increase the political priority of and sparks action for menstrual hygiene management at global, national, and local levels; and

WHEREAS, This movement has increased its support and impact each year, resulting in organizers managing to reach a record-breaking 566 million people globally in 2021 with their stigma-breaking and positive health messaging utilizing virtual and physical resources; and

WHEREAS, Menstrual Hygiene Day organizers have set a number of goals to be accomplished by 2030, including ensuring all persons who menstruate have affordable access to menstrual products of their choice, ending period stigma, ensuring access to accurate and useful educational information on menstruation and menstrual health for all, and providing clean water for all to aid in menstrual hygiene; and
