CHANGE OF SPONSORSHIP

With the consent of the affected members, Representative Zalewski was removed as principal sponsor, and Representative Guzzardi became the new principal sponsor of SENATE BILL 3895.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 751

Offered by Representative Moeller:

WHEREAS, The future of our nation's productivity and competitiveness in the global marketplace depends on the success of all men and women; and

WHEREAS, Women have been discriminated against in education, the workplace, and society as a whole; and

WHEREAS, Nationally, women working full time and year round continue to earn no more than 83 cents on the dollar compared to men working full time and year round; and

WHEREAS, The wage gap is even greater for most women of color; Asian American and Pacific Islander women earn 75 cents on the dollar; Black women earn 58 cents on the dollar; Native American women earn 50 cents on the dollar; Latina women earn 49 cents on the dollar; and

WHEREAS, The pay gap has been shown to start as soon as one year after college; this inequality affects not only women but also their families and society as a whole; and

WHEREAS, The pay gap between women and men has long-term effects on women's economic security; such a gap affects women's Social Security earnings, their ability to save for retirement, and their children's education; and

WHEREAS, Pay equity is closely linked to the eradication of poverty and is essential to having a highly-motivated workforce; and

WHEREAS, Equal Pay Day was originated by the National Committee on Pay Equity in 1996 as a public awareness event to illustrate the gap between men's and women's wages; the day symbolizes how far into the year a woman must work, on average, to earn as much as a man earned the previous year, with Tuesday being the day in which women's wages catch up to men's wages from the previous week; because women earn less on average than men, they must work longer for the same amount of pay; this wage gap is even greater for most women of color; and

WHEREAS, Although Equal Pay Day represents all women, Asian American, Native Hawaiian, and Pacific Islander Women's Equal Pay Day is May 3, 2022, Black Women's Equal Pay Day is September 21, 2022, Native American Women's Equal Pay Day is November 30, 2022, and Latina Equal Pay Day is December 8, 2022; and

WHEREAS, Equal pay is a priority for all women and for our society at large; therefore, be it RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March 15, 2022 as Equal Pay Day in the State of Illinois in order to raise awareness about this endemic inequity.

HOUSE RESOLUTION 753

Offered by Representative Demmer:

WHEREAS, The State of Illinois currently exempts State taxation of retirement income; and

WHEREAS, House Joint Resolution Constitutional Amendment 1, passed by the 101st General Assembly, put what proponents call the "Fair Tax" on the 2020 ballot; this would have allowed for graduated income tax rates and could have created an avenue for taxation on retirement income; and

WHEREAS, The "Fair Tax" proposal was rejected by the residents of Illinois in the 2020 election with 53.27 percent of the voters disapproving; and

WHEREAS, Retirees are often least equipped to shoulder the burden of additional taxation due to the fact that the vast majority live on fixed income; and

WHEREAS, Current inflation levels are already diminishing the fixed income upon which retirees in Illinois rely; and

WHEREAS, Retirees already contribute a fair share of taxes, whether it be through federal income taxation or other state imposed taxes such as sales taxes and property taxes; and

WHEREAS, Not taxing retirement income is one of the only friendly tax policies Illinois residents currently enjoy; and

WHEREAS, Imposing an income tax on retirement could drive residents away from Illinois or deter people from across the nation from choosing to spend retirement in Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we trust the decision Illinoisans made when they rejected the path to taxing retirement income by prohibiting the "Fair Tax" from becoming enacted in the 2020 election; and be it further

RESOLVED, That we affirm our belief that another ballot question or any policy change allowing for the Illinois Income Tax Act to potentially tax retirement income should not be permitted to pass the Illinois House of Representatives; and be it further

RESOLVED, That suitable copies of this resolution be delivered to all Illinois constitutional officers, the Speaker and Minority Leader of the Illinois House of Representatives, and the President and Minority Leader of the Illinois Senate.

HOUSE RESOLUTION 754

Offered by Representative Demmer:

WHEREAS, Prescribed fire provides multiple ecological, economic, and cultural benefits to the State of Illinois; and

WHEREAS, Prescribed fire has been practiced for thousands of years and was a primary tool used by Indigenous peoples to attract game, stimulate a rich ground layer of plants for harvesting, and keep woodlands and grasslands open and easy to traverse; and

WHEREAS, Prescribed fire is a traditional land management practice and public safety tool that helps prevent and lessen the severity of wildfires; and

WHEREAS, Prescribed fire is a valuable tool used by forest landowners and managers in reducing hazardous fuels, reducing the risk of destructive wildfires, preparing sites for both natural and artificial forest regeneration, improving access to and the appearance of land, and controlling detrimental insects and forest diseases; and

WHEREAS, Prescribed fire is an effective natural tool for controlling invasive species; and

WHEREAS, Prescribed fire is one of the most important land management practices in maintaining and restoring healthy landscapes, but only approximately 6% of conservation lands in Illinois are currently being managed with prescribed fire; and

WHEREAS, Prescribed fire is used to restore and maintain fire-dependent ecosystems and to manage wildlife habitat for many species; it is a vital tool to maintain economic, biological, and aesthetic resources across Illinois; and

WHEREAS, The Illinois Prescribed Fire Council is an organization of both public and private partners with a mission to promote the safe and continued use of prescribed fire on the Illinois landscape; and

WHEREAS, The Illinois General Assembly passed the Illinois Prescribed Burning Act in 2007 defining prescribed fire as "the planned application of fire to naturally occurring vegetative fuels under specified environmental conditions and following appropriate precautionary measures, which causes the fire to be confined to a predetermined area and accomplish the planned land management objectives."; and

WHEREAS, Prescribed fire helps keep Illinois grasslands and forests healthy, which, in return, provides ecological services such as clean air and clean water and contributes to the quality of life of the State's citizens and to local economies; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April 11-15, 2022 as "Prescribed Burning Awareness Week" in the State of Illinois; and be it further

RESOLVED, That we support the appropriate and continued use of prescribed fire in Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Illinois Prescribed Fire Council as a symbol of our respect and esteem.

HOUSE RESOLUTION 758

Offered by Representative Greenwood:

WHEREAS, The Covid-19 pandemic has created a hidden epidemic of deferred care; and

WHEREAS, The widespread patient hesitancy to return to healthcare services combined with closed and limited availability of healthcare services during the pandemic has resulted in underdiagnosis and a gap in care, with missed opportunities to provide timely and appropriate treatments, consequently leading to increased chronic disability and mortality; and

WHEREAS, The long-term impact of the collateral negative effects of pandemic-related deferred care is staggering and may be felt for a generation; and

WHEREAS, A study reported in the New York Times found that blood pressure readings increased significantly from April 2020 through December 2020 compared with the same period in 2019; and

WHEREAS, Another study showed that while test volume for non-prescribed fentanyl fell during the early months of the pandemic and through 2020, the percentage of positive test results rose indicating that patients with Opioid Use Disorder were underdiagnosed during the early months of the pandemic and through 2020; and

WHEREAS, The pandemic has disrupted the utilization of women's preventive health services and may be associated with increased disparities in access to these services; a University of Michigan study found that rates of breast cancer screenings, cervical cancer screenings, and sexually transmitted infection screenings all significantly declined in 2020 compared with 2019; and

WHEREAS, Another study showed new diagnoses of eight common types of cancer declined by 46 percent during most of the first 13 months of the pandemic, and, according to data presented during the American Urological Association's 2021 Virtual Experience, weekly prostate cancer screening rates declined by as much as 43 percent during the COVID-19 pandemic; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March of 2022 as Back to Care Month in the State of Illinois to educate and promote patients to return to a routine of preventative care and screening.
