WHEREAS, The members of the Illinois House of Representatives are saddened to learn of the death of former State Representative, gubernatorial Chief of Staff, Metropolitan Pier and Exposition Authority CEO, and Regional Transportation Authority Chair Jim Reilly, who passed away on Monday, April 4, 2022; and

WHEREAS, Jim Reilly was born on January 31, 1945 in Springfield, a native of Illinois and a graduate of the Springfield public school system; he graduated from Springfield High School in 1962; and

WHEREAS, Jim Reilly's college years were spent at Illinois College in Jacksonville, and his law school years were spent at the University of Chicago in Chicago; he received his law degree in 1972; and

WHEREAS, During his time in law school, Jim Reilly also spent two gap years teaching language arts to eighth-graders in Winchester; and

WHEREAS, During his time in Winchester and inspired by his father, who had been a Springfield lawyer in general practice as well as a staunch Republican, Jim Reilly did district office work for a local state representative, Thomas C. Rose; during this time, he made many friends and local connections throughout the Jacksonville area; and

WHEREAS, After graduating from law school in 1972 and passing the bar, Jim Reilly was invited to work with a practice in Jacksonville and served as a lawyer in Morgan County, moving laterally to become the first full-time city attorney of Jacksonville; and

WHEREAS, When Tom Rose decided not to run for re-election as state representative in 1976, Jim Reilly ran to be one of the three representatives of the Jacksonville-centered 49th District, one of the former multi-member districts that the Illinois House used to have, and he was elected; and

WHEREAS, Jim Reilly joined a large class of freshmen Republicans in the 80th General Assembly in January 1977, headed by future Governor Jim Edgar; and

WHEREAS, When Jim Edgar became the legislative liaison for Governor Jim Thompson in 1979, Thompson and Edgar began working closely with Jim Reilly as a gubernatorial ally and lawmaker in the Illinois House of Representatives; and

WHEREAS, Jim Reilly then became Governor Thompson's chief counsel in 1983; after the Governor's then-Chief of Staff Art Quern left a few months later, Gov. Thompson promoted Jim Reilly to be his chief of staff; and

WHEREAS, In 1985, one of the major events in public policy of that year was a major cost overrun in a construction project in Chicago, the structure that became the McCormick Place North Building with 705,500 square feet of exhibit space; built to maintain what was then McCormick Place's identity as the world's largest convention center, the construction project developed a major cost overrun that required a State bailout; and

WHEREAS, Jim Reilly's chief-of-staff leadership helped develop bipartisan support for the bailout; the governmental structure of McCormick Place was reorganized, and the new law achieved a record of cooperation between the State of Illinois, the City of Chicago, and the Chicago area on infrastructure issues; and

WHEREAS, In his fourth campaign for the Governor's chair in 1986, Jim Thompson made "Build Illinois" infrastructure a key plank in his election effort and was re-elected; and

WHEREAS, Jim Reilly left Springfield in 1989 to become the chief executive officer of the Metropolitan Pier and Exposition Authority, the governing authority over McCormick Place; under his leadership, State and Chicago-area infrastructure issues had a common point of intersection; and

WHEREAS, In 1993, Governor Jim Edgar asked Jim Reilly to return to the gubernatorial chief of staff office; and

WHEREAS, In his second term as chief of staff, Jim Reilly helped lead negotiations and put together the first Hospital Assessment Program to close the growing gap in Medicaid funding between State general revenues and medical care costs; and

WHEREAS, After working in 1994 through Governor Edgar's successful re-election that year, Jim Reilly returned to the Metropolitan Pier and Exposition Authority (MPEA); from 1995-1999, the MPEA oversaw construction and completion of the McCormick Place South Building and the renovation of Chicago's Navy Pier; and

WHEREAS, In 1999, Jim Reilly joined the private sector, becoming the CEO of the Chicago Convention and Tourism Bureau, continuing until 2004 in his role as a coordinator of what has become one of northeastern Illinois's largest industries; and

WHEREAS, Cutting back from full-time service, Jim Reilly became the non-executive chairperson of the Regional Transportation Authority (RTA) in 2005, continuing his record of prioritizing infrastructure and bringing people from all regions and political parties together; he helped lead the financial and governmental restructuring of the RTA and served in this role for five years until 2010; and

WHEREAS, When the Metropolitan Pier and Exposition Authority ran into a new funding crisis similar to that of 1985, Jim Reilly was there; returning to the MPEA as CEO once again in 2012 and serving until 2015; and

WHEREAS, Continuing his lifelong interest in infrastructure, Jim Reilly also chaired the Capital Development Board, the senior panel overseeing State-financed non-transportation capital projects; and

WHEREAS, Although his final decades were spent in Chicago, Jim Reilly remained a downstater in his heart; to his last day, he maintained his lifelong loyalty to the St. Louis Cardinals; and

WHEREAS, A tower of strength to Jim Reilly in his final decades, as he worked to bring people together, was his wife Veronica Lynch, who has her own ties and history with the highest levels of Illinois politics; and

WHEREAS, On the opposite side of Lake Michigan from McCormick Place and Navy Pier, Jim Reilly and Veronica Lynch owned the Sandpiper Inn in Union Pier, Michigan, which they operated as a bed and breakfast inn for guests during their ownership; and

WHEREAS, During their ownership, guests could go to the Sandpiper Inn and, on weekends, eat downstate Illinois-style pancake breakfasts cooked personally by the former two-time gubernatorial chief of staff; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we mourn the death of Jim Reilly, a major figure in the history of Chicago and in the history of the entire State of Illinois; and be it further

RESOLVED, That we recognize the heritage that Jim Reilly and other men and women like him leave behind them as forgers of consensus and agreement on challenging issues of public policy; instead of tearing things apart, he put things together like sections of track in the model train sets that he loved; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Jim Reilly's wife, Veronica Lynch, as a token of our esteem and gratitude for the life of Jim Reilly of Illinois.

Offered by Representative Robinson:

WHEREAS, Chicago is the ideal city for hosting the 2024 Democratic National Convention (DNC); and

WHEREAS, Chicago has an abundance of hotel rooms and restaurants and a plethora of arts and culture for guests, and it has a track record of successfully hosting such large-scale events; and

WHEREAS, In addition to Chicago's established ability to host large gatherings, the city and State have strong Democratic credentials and are located near several Midwestern presidential battleground states, such as Wisconsin, Michigan, and Iowa; and

WHEREAS, Illinois is at the center of some of the key policies for the party, including infrastructure, broadband access, and codifying Roe v. Wade, and our city and state, consisting of a vibrant and diverse metropolis, thriving suburbs, and strong rural communities, offer proof that the Democratic party's policies deliver for American families; and

WHEREAS, Hosting the DNC in 2024 would be a great opportunity to promote the city and state on an international stage and would be the first political convention held in Chicago since 1996; therefore, be it

## HOUSE RESOLUTION 817

Offered by Representative Hirschauer:

WHEREAS, School nurses are the healthcare experts in schools and are often the only healthcare provider that many students encounter; and

WHEREAS, School nurses have demonstrated their essential role in the school system as they mitigated the impact of the COVID-19 pandemic; and

WHEREAS, School nurses have been on the front lines of bridging health care and education, providing care coordination, and advocating for quality student-centered care; and

WHEREAS, Students turn to the school nurse for both physical and emotional safety needs; and

WHEREAS, School nurses are often the first to identify a medical issue that is impacting a student's learning; and

WHEREAS, School nurses promote access to services in underserved communities, often times not only providing services to individual school children but also serving as a resource to students and families in addressing social determinants of health such as homelessness; and

WHEREAS, According to the National Survey on Children's Health, 40% of school aged children have at least one chronic health condition, which are often discovered and managed daily by school nurses; and

WHEREAS, There are no requirements for school districts to employ school nurses, and therefore, the hiring requirements and parameters around the roles of school nurses vary widely; and

WHEREAS, This lack of formalized hiring practices and parameters equates to a lack of information about schools that hire school nurses, such as how school nurses are utilized and the number of schools that school nurses are required to oversee; and

WHEREAS, The Illinois State Board of Education provides oversight to schools in Illinois and already collects data from these schools; and

WHEREAS, The Illinois State Board of Education has a department that focuses on coordinated reporting, data collection, data implementation sharing, and analyzing data for policy and strategic planning; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the vital role of school nurses in providing health care to the students of Illinois; and be it further

RESOLVED, That we urge the Illinois State Board of Education to partner with the Illinois Association of School Nurses to complete a School Nursing Capacity Study in Illinois; and be it further

RESOLVED, That we recommend that the School Nursing Capacity Study in Illinois should include, but not be limited to, ascertaining who is providing health care to school children in Illinois schools, determining credentials of the nurses currently providing care, determining the number of schools in which each nurse is required to provide healthcare services in each school district, and determining what policies are in place to provide healthcare services and by whom if a school nurse is not present in the building; and be it further

RESOLVED, That we recognize that the purpose of this study is to provide more in-depth data with the overall goal of utilizing the data to develop a model for healthcare services provided in schools that can address specific needs of each community, focusing on students that do not have access to care outside of the schools; and be it further

RESOLVED, That we urge the Illinois State Board of Education to report its findings to the General Assembly no later than January 10, 2023.

#### HOUSE RESOLUTION 819

Offered by Representative Lewis:

WHEREAS, The rates of unintentional injuries and deaths in the United States remain at unacceptable levels; and

WHEREAS, Addressing musculoskeletal disorders, educating on impairment, providing employers with tools to prevent injuries, and mitigating falls remain critical to preventing injuries and deaths in the United States; and

WHEREAS, The cost of unintentional injuries to Americans and their employers exceeds \$1,097.9 billion each year and causes great suffering among individuals and their families; and

WHEREAS, Illinois residents and all Americans deserve to live in communities that promote safe and healthy living; and

WHEREAS, Preventing unintentional injuries and deaths requires the cooperation of all levels of government, employers, and the general public; and

WHEREAS, The National Safety Council, founded in 1913, was congressionally chartered in 1953 to lead this nation in injury prevention through safety and health information, education, training, and advocacy in the United States; and

WHEREAS, The National Safety Council and the Iowa-Illinois Safety Council work to promote policies, practices, and procedures leading to increased safety, protection, and health in business and industry, in schools and colleges, on roads and highways, and in homes and communities; and

WHEREAS, In 2022, The National Safety Council and the Iowa-Illinois Safety Council will provide this nation with a month-long public education campaign; and

WHEREAS, The summer season is a time of increased rates of unintentional injuries and deaths; it is an appropriate time to focus attention on injury risks and preventions; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we express our support of National Safety Month in June 2022, and we strongly urge the citizens and businesses of Illinois to observe National Safety Month by practicing safe and healthy behaviors in all aspects of their lives.

#### HOUSE RESOLUTION 824

Offered by Representative Weber:

WHEREAS, The Illinois Department of Children and Family Services (DCFS) was established on January 1, 1964 as the nation's first cabinet-level state child welfare agency; until that time, the State's child welfare responsibilities were housed in the Department of Mental Health; approximately 4,000 children were served during the department's first year of operation, compared to a peak of 51,000 children in foster care in 1997 and the 15,000 children it serves today; and

WHEREAS, Illinois is home to the nation's first juvenile court, counts itself as the birthplace of social work, was among one of the first states to establish child protection laws, was an early signatory to laws mandating the reporting of child abuse and neglect, and created one of the nation's first statewide child abuse hotlines; and

WHEREAS, The mission of Illinois' DCFS is to protect children who are reported to be abused or neglected and to increase their families' capacity to safely care for them; and

WHEREAS, On February 11, 2019, police found two year old Ta'Naja Barnes unresponsive and wrapped in a urine-soaked blanket inside her home; medical staff said her core temperature was so low that it would not register on their device; she later died at a Decatur hospital; an autopsy revealed she died from dehydration, malnourishment, and neglect despite the involvement of DCFS during her short life; and

WHEREAS, On April 24, 2019, authorities found Andrew "AJ" Freund wrapped in plastic in a shallow grave near Woodstock; DCFS had received at least 10 prior hotline calls concerning the care of children by his parents dated before he was even born; in addition to the hotline calls, five years' worth of police reports exist that paint a picture of unsanitary and unsafe conditions that include animal feces, lack of electricity, and alleged drug use; an autopsy concluded that the he died from injuries to his skull and brain due to multiple blunt-force injuries; and

WHEREAS, On March 29, 2022, yet another child, eight year old Navin Jones, died despite extensive involvement by DCFS in his life; while the child's grandmother was his legal guardian, both his older brother and he were residing with their parents throughout February and March; records show that DCFS was facilitating a transfer of guardianship for him in the weeks before he was found unresponsive; the Peoria County Coroner ruled the death a homicide, and police reports said the child was extremely malnourished with a skeletal appearance; further, authorities said he had numerous bruises, scrapes, abrasions, and scars spread across his body; he also had what appeared to be ligature injuries to both wrists; at the time of his death, he weighed just 38 pounds at eight years of age; and

WHEREAS, The previously detailed deaths span several years but are eerily similar in detail and have one common denominator, which is the involvement and failure of DCFS; and

WHEREAS, DCFS is responsible for the safety of our State's most vulnerable; additionally, the agency is responsible for the well-being of children in care and is tasked with providing appropriate and permanent placement for children who cannot safely return home; and

WHEREAS, Over the last year, more than 350 children in DCFS care were languishing in psychiatric hospitals for an average of 55 days because DCFS failed to identify appropriate placement options; and

WHEREAS, DCFS Director Marc Smith has been held in contempt for failure to properly place DCFS youth eight times in eleven weeks in 2022 alone; and

WHEREAS, Youths in psychiatric facilities can go outside for approximately one hour per day, do not receive schooling, and have limited contact with family and friends; and

WHEREAS, Holding the director of a State agency in contempt of court is extraordinarily rare; and

WHEREAS, The court has levied a \$1,000 fine per day for each case where Director Smith has been found in contempt; and

WHEREAS, Psychiatric hospitals and emergency shelters are much more expensive than other placements and are not eligible for federal reimbursement; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct a performance audit of the Department of Children and Family Services' response to the tragic deaths of any and all children who have died as a result of the agency's failure to live up to its own mission statement as well as the Department's actions to identify appropriate placement options and avoid further contempt citations; and be it further

RESOLVED, That this performance audit include, but not be limited to, the following determinations:

(1) The nature of changes made by the Department in operating protocols and staff training thereon, intended to prevent further deaths of DCFS-involved youth, better serve the best interests of system-involved youth, and prevent any unnecessary stays in psychiatric facilities and temporary shelters;

(2) The nature and extent of monitoring conducted by the Department to determine whether the improvements, safeguards, and protocols in place are effective to ensure the safety of children in care;

(3) The amount of State moneys received and the amount of State moneys expended by DCFS or any other State agency during State fiscal years 2020 and 2021 to address preventable deaths and unwarranted stays in psychiatric facilities and temporary shelters;

(4) The efforts of DCFS to come into compliance with court orders holding Director Marc Smith in contempt and why DCFS continues to repeatedly be held in contempt on additional cases and fails to properly place these youths; and

(5) The amount of funds spent defending lawsuits and legal matters and coming into court-mandated compliance over issues with failing to properly place DCFS youths; and be it further

RESOLVED, That the Illinois Department of Children and Family Services and any other State agency or other entity or person that may have information relevant to this audit cooperate fully and promptly with the Auditor General's Office; and be it further

RESOLVED, That the Auditor General is best equipped to conduct an investigation given their understanding of the policies and procedures associated with the Department of Children and Family Services; and be it further

RESOLVED, That the Auditor General commence this audit as soon as practical and report its findings and recommendations upon completion in accordance with the provisions of Section 3-14 of the Illinois State Auditing Act; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Auditor General.

### **SENATE BILLS ON SECOND READING**

SENATE BILL 1534. Having been read by title a second time on May 31, 2021, and held on the order of Second Reading, the same was again taken up.

### **ACTION ON MOTIONS**
