WHEREAS, Thomas Lyons was born May 24, 1931 in Chicago; he was raised on Chicago's Northwest Side in our Lady of Victory Parish; he was the son of Marian (Daniels) and Thomas V. Lyons, the former Chicago Chief of Uniformed Police; and

WHEREAS, Mr. Lyons was a graduate of Campion Jesuit High School, Xavier University, Loyola University Chicago, and the Loyola University Chicago School of Law; and

WHEREAS, Mr. Lyons followed in his father's footsteps as a Chicago Police officer; he became an attorney in 1957 and served as the chief attorney for the Cook County Assessor's Office from 1958 to 1960 before joining the office of the Illinois Attorney General; and

WHEREAS, Mr. Lyons was elected State Senator in 1964; the next year he was elected to serve in a leadership role for the State commission studying the need for a new State constitution; he was later elected a delegate to the 1970 Constitutional Convention, serving as vice president during the drafting of the 1970 Illinois Constitution; and

WHEREAS, While a member of the Illinois Senate Mr. Lyons served as chairman of the Appropriations and the Constitutional Implementation committees; and

WHEREAS, Mr. Lyons, the 45th Ward Democratic Committeeman since 1968, was first elected chairman of the Cook County Democratic Party in 1990, a position he held for nearly seventeen years; he also served as a delegate to every Democratic National Convention from 1968 to 2000; and

WHEREAS, Mr. Lyons was named a Knight of the Holy Sepulchre by the late Joseph Cardinal Bernardin and was awarded a Medal of Excellence by his alma mater, the Loyola University Chicago School of Law; and

WHEREAS, Mr. Lyons was named by former President Bill Clinton to the American Battle Monuments Commission as a reflection of his dedication to military service and to the men and women who have worn our country's uniform; Mr. Lyons served in the United States Army achieving the rank of Captain in the Army Rangers; and

WHEREAS, Mr. Lyons was a practicing attorney as a named partner in the firm of O'Keefe, Ashenden, Lyons & Ward, later O'Keefe, Lyons and Hynes; a man of many diverse interests, Mr. Lyons was an avid scholar of American history, as well as a devout fan of Notre Dame, the Chicago White Sox and the Chicago Bears (and in that order!); and

WHEREAS, Mr. Lyons is survived by his loving wife, Ruth (Tobin); his children, Alexandra (Thomas) Cooney, Thomas V. (Margo), Francis X. (Mary Pat), and Rachel (James) Cooper; his grandchildren Anne Marie, Thomas and Sheila Lyons, Caroline, Elizabeth and Frances Lyons, and Alexandra and William Cooper; his sister, Patricia Breen; his cousin and dear friend, State Representative Joseph Lyons; and his many good friends and admirers; therefore, be it

ARTICLE X EDUCATION

SECTION 1. FUNDAMENTAL RIGHT GOAL - FREE SCHOOLS

A fundamental <u>right goal</u> of the People of the State is the educational development of all persons to the limits of their capacities.

<u>It is the paramount duty of the The State to shall provide for a an thorough and efficient system of high</u> quality public educational institutions and services <u>and to guarantee equality of educational opportunity as</u> <u>a fundamental right of each citizen</u>. Education in public schools through the secondary level shall be free. <u>The State has the preponderant financial responsibility for financing the system of public education</u>. There may be such other free education as the General Assembly provides by law.

The State has the primary responsibility for financing the system of public education. (Source: Illinois Constitution.)

WHEREAS, America's present Postal Service descends in an unbroken line from the system Franklin planned and placed in operation; history rightfully accords him major credit for establishing the basis of the system that has well served the growing and changing needs of the American people; and

WHEREAS, Today, the United States Postal Service is the third largest employer in the nation, employing about 619,000 individuals; the workers include clerks, mail carriers, mail sorters, processors, and processing machine operators; and

WHEREAS, The Postal Service operates the largest civilian vehicle fleet in the world, with an estimated 260,000 vehicles, most recognized and identified as the Grumman LLV, or "mail truck"; and

WHEREAS, The motto of the Post Office "neither snow nor rain nor heat nor gloom of night stays these couriers from the swift completion of their appointed rounds" still tells us today how hard the men and women of the United States Postal Service work to ensure the smooth delivery of the mail to over 141 million addresses; therefore, be it

WHEREAS, The Comprehensive Lifespan Respite Care Act of 2006 authorizes \$289 million to be provided to the states for the purpose of developing lifespan respite care at the state and local level, providing respite care services for family caregivers caring for children and adults, recruiting and training respite care volunteers and workers, providing information to respite caregivers about available respite or support services, and assisting caregivers in gaining access to such services; therefore, be it

WHEREAS, All women should learn their own personal risk for heart disease, using tools such as the American Heart Association's Go Red For Women Heart Checkup and by talking to their healthcare providers; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that in recognition of the importance of the ongoing fight against heart disease and stroke we proclaim February 2007 and each February hereafter to be "Go Red for Women Month" in the State of Illinois; and be it further

RESOLVED, We urge all citizens to show their support for women and the fight against heart disease and stroke and to increase their awareness and empower women to reduce their risk for cardiovascular disease and stroke so that thousands of lives can be saved each year.

HOUSE JOINT RESOLUTION 1

Offered by Representative Meyer:

WHEREAS, The provision of a free appropriate public education (FAPE) for a student with hearing loss can only occur with full communication access to education; and

WHEREAS, Full communication access depends upon a language-rich environment that fosters age-appropriate communication and language development, utilizes language-proficient educational staff, and provides for direct communication with staff and peers; and

WHEREAS, Children and youth who are deaf or hard of hearing face unique and significant barriers related to language and communication that profoundly affect most aspects of the educational process; and

WHEREAS, Attending to a student's communication needs and language development is a vital prerequisite for access to educational opportunities that lead to literacy and academic achievement; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there is created the Joint Task Force on Deaf and Hard of Hearing Education Options, consisting of fifteen members appointed as follows: the Speaker of the House of Representatives, Minority Leader of the House of Representatives, President of the Senate, and Minority Leader of the Senate shall each appoint one member; the following entities shall each appoint one member: the Illinois Deaf and Hard of Hearing Commission, the Illinois State Board of Education, the Illinois Supervisors of Programs for Individuals who are Deaf or Hard of Hearing, the Helen Keller National Center, the Early Intervention System, the Hearing and Vision Connections, the Illinois School for the Deaf, the Illinois Hands and Voices parent organization, and the Newborn Hearing Screening Program; the Deaf Education Program in Illinois at MacMurray College and the Illinois State University shall each appoint one member; and be it further

RESOLVED, That all members of the Task Force shall serve without compensation; and be it further

RESOLVED, That all members of the Communication Options Committee established by the Deaf and Hard of Hearing Commission with the collaboration of the State Board of Education shall continue in their representation on the Joint Task Force on Deaf and Hard of Hearing Education Options; and be it further

RESOLVED, That the Task Force can appoint members as it sees fit to serve as representatives of the deaf and hard of hearing population of Illinois or parents of children with hearing loss representing each of the following communication options: Oral/aural, Cued Speech, Total Communication, and American Sign Language; and be it further

RESOLVED, That the duty of the Task Force is to undertake a comprehensive and thorough review of education and services available to the deaf or hard of hearing children in Illinois with the intent of making recommendations that would recognize communication as fundamental to a deaf or hard of hearing child's most basic of needs; ensure communication-driven service delivery of the early intervention system and the public education system with programs and services addressing the unique communication needs of each child through communication assessment, development, and access; establish uniform methods and procedures within the early intervention system and the public education system that shall be non-biased and well-informed when sharing information with children and their families on the available communication options and community resource awareness; and be it further

RESOLVED, That the Task Force, working with the Illinois Deaf and Hard of Hearing Commission, the Illinois State Board of Education, the Early Intervention System, the Illinois School for the Deaf, and the Newborn Hearing Screening Program, shall assist those entities in developing interagency agreements and programs and procedures regarding universal, early identification of hearing loss and effective interface between medical and educational services; and be it further

RESOLVED, That the Task Force may request assistance from any entity necessary or useful for the performance of its duties; and be it further

RESOLVED, That the Task Force shall issue a report with its recommendations to the General Assembly on or before December 31, 2007.

HOUSE JOINT RESOLUTION 2

Offered by Representative Granberg:

WHEREAS, During the 94th General Assembly, the Wooded Land Assessment Task Force was established, pursuant to House Joint Resolution 95, to gather information and make recommendations regarding procedures and policies for the assessment of wooded land and of property under a certified forestry management program; and

WHEREAS, The Task Force requires further time to complete its work; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Wooded Land Assessment Task Force is extended; and be it further

RESOLVED, That the Task Force must submit a report, as established in its authorizing resolution, on or before March 31, 2007; and be it further

RESOLVED, That, with this reporting extension, the Task Force shall continue to operate pursuant to its enabling resolution.

HOUSE JOINT RESOLUTION 3

Offered by Representative Krause:

WHEREAS, Recent ethics scandals have uncovered the flow of special interest money into the hands of elected officials and have included the arrest of current and former lawmakers on charges of racketeering

and mail fraud; and

WHEREAS, American voters think our political system is broken due to excessive influence of campaign contributors; 70% of Americans believe that the political system cannot respond to the country's real needs because of the influence of special interests over our lawmakers; and

RESOLVED, That the Campaign Finance Reform Task Force also may include 2 members of the general public appointed by the Governor who represent campaign finance reform organizations, and the chairperson of the Task Force may be designated by the Governor from among its members; and be it further

RESOLVED, That the Task Force shall study the newly enacted campaign reform laws in other states, as well as the issues and problems associated with excessive moneys that are being raised and spent by candidates for elective office in the State of Illinois, and shall report its findings and recommendations to the General Assembly on or before December 31, 2007.

HOUSE JOINT RESOLUTION 4

Offered by Representative Reis:

WHEREAS, Robert Ridgway was an internationally known scientist, explorer, ornithologist, naturalist, inventor, author, and artist; and

WHEREAS, Robert Ridgway served with the Smithsonian Institution for 62 years and was Zoologist for the USGS 40th Parallel Expedition and the Harriman Expedition in Alaska; and

WHEREAS, Robert Ridgway ranks with John James Audubon, Daniel Boone, Thomas Edison, the Wright Brothers, and John C. Fremont for his accomplishments and explorations for America and the world; and

WHEREAS, The Illinois State Historical Society and the Illinois Department of Transportation in 1967 erected a historical sign 1.5 miles east of the Fox River Bridge, along U.S. Route 50, to honor Robert Ridgway; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the U.S. Route 50 Fox River Bridge, west of the City of Olney in Richland County, be designated the Robert Ridgway Bridge; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name; and be it further

RESOLVED, That copies of this resolution be delivered to the Secretary of the U.S. Department of Transportation; the Secretary of the Illinois Department of transportation; the mayor of the City of Olney; and the Richland County Board.

HOUSE JOINT RESOLUTION 5

Offered by Representative Flowers:

WHEREAS, Hospital infections, which account for an estimated 100,000 deaths every year, kill more than five times as many Americans as AIDS; and

WHEREAS, The federal Centers for Disease Control and Prevention (C.D.C.), which are calling for voluntary blood testing of all patients to stem the spread of AIDS, have chosen not to recommend a test that is essential to stop the spread of another killer sweeping through our nation's hospitals: M.R.S.A., or methicillin-resistant Staphylococcus aureus; the C.D.C. guidelines to prevent hospital infections, released in October 2006, conspicuously omit universal testing of patients for M.R.S.A.; and

WHEREAS, The C.D.C.'s omission is unfortunate; research shows that the only way to prevent M.R.S.A. infections is to identify which patients bring the bacteria into the hospital; the M.R.S.A. test costs no more than the H.I.V. test and is less invasive, a simple nasal or skin swab; and

WHEREAS, Staph bacteria are the most prevalent infection-causing germs in most hospitals, and increasingly these infections cannot be cured with ordinary antibiotics; sixty percent of staph infections are now drug resistant (that is, M.R.S.A.), up from 2 percent in 1974; and

WHEREAS, Some people carry M.R.S.A. germs in their noses or on their skin without realizing it; the bacteria do not cause infection unless they get inside the body -- usually via a catheter, a ventilator, or an incision or other open wound; once admitted to a hospital, these patients shed the germs on bedrails, wheelchairs, stethoscopes, and other surfaces, where M.R.S.A. can live for many hours; and

WHEREAS, Doctors and other caregivers who lean over an M.R.S.A.-positive patient often pick up the germ on their hands, gloves, or lab coats and carry it along to their next patient; and

WHEREAS, The blood-pressure cuffs that nurses wrap around patients' bare arms frequently carry live bacteria, including M.R.S.A.; in a recent study at a French teaching hospital, 77 percent of blood-pressure cuffs wheeled from room to room were contaminated; another study linked contaminated blood-pressure cuffs to several infected infants in the nursery at the University of Iowa hospital; and

WHEREAS, Among developed nations, the United States has one of the worst records of curbing drug-resistant infections, according to the Sentry Antimicrobial Surveillance Program, an international effort to monitor drug-resistant germs; in this country, M.R.S.A. hospital infections increased 32-fold from 1976 to 2003, according to the C.D.C.; and

WHEREAS, In the 1980s, Denmark, Finland, and the Netherlands faced similarly soaring rates of M.R.S.A., but nearly eradicated it by screening patients and requiring health care workers treating patients with M.R.S.A. to wear gowns and gloves and use dedicated equipment to prevent the spread; the Dutch called their strategy "search and destroy"; and

WHEREAS, A growing number of hospitals in the United States have proved that such precautions work here, too; recently, a pilot program using screening at Presbyterian University Hospital, in Pittsburgh, reduced M.R.S.A. infections by 90 percent; at a Yale-affiliated hospital in New Haven, screening reduced M.R.S.A. infections in intensive care by two-thirds; and

WHEREAS, A recently completed nine-year study at the Brigham and Women's Hospital, in Boston, found that screening led to a 75 percent drop in M.R.S.A. bloodstream infections among intensive-care patients and a 67 percent decline throughout the hospital; earlier efforts to stop these infections by installing many more dispensers of hand cleanser and conducting a yearlong educational campaign on hand hygiene had no effect; and

WHEREAS, Some public health advocates recommend screening only "high-risk" patients -- those who recently have been hospitalized, live in nursing homes, or have kidney disease; partial screening is somewhat effective, but universal screening prevents the most infections; and

WHEREAS, Hospitals cannot afford not to screen for M.R.S.A.; infections wipe out hospital profits; when a patient develops an infection and has to spend many additional weeks hospitalized, Medicare does not pay for most of that additional care; and

WHEREAS, Treating hospital infections costs an estimated \$30.5 billion a year in the United States; prevention, on the other hand, is inexpensive and requires no capital outlays; a pilot program at the University of Pittsburgh found that screening tests, gowns, and other precautions cost only \$35,000 a year, and saved more than \$800,000 a year in infection costs; a review of similar cost analyses, published in The Lancet in September, concluded that M.R.S.A. screening increases hospital profits -- as it saves lives; and

WHEREAS, For a decade, in spite of this evidence, the C.D.C. has rebuffed calls for screening, most recently from a committee of the Society for Healthcare Epidemiologists of America; C.D.C. officials

claim that more research is needed to prove the benefits of screening; more research cannot hurt, but we know enough already to move ahead; and

WHEREAS, Some hospitals are leading the way, including Evanston Northwestern, in Illinois; the Veterans Affairs medical centers; New England Baptist Hospital, in Boston; and Johns Hopkins Hospital, in Baltimore; and

WHEREAS, The C.D.C.'s lax guidelines give many other hospitals an excuse to do too little; every year of delay costs thousands of lives and billions of dollars; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge the Centers for Disease Control and Prevention to adopt guidelines for universal testing of hospital patients for methicillin-resistant Staphylococcus aureus (M.R.S.A.) without further delay; and be it further

RESOLVED, That a copy of this resolution be delivered to the Director of the Centers for Disease Control and Prevention.

Offered by Representative Washington:

WHEREAS, The Illinois General Assembly wishes to present this resolution as a tribute to and acknowledgment of Oprah Winfrey's contributions to the State of Illinois, the nation, and the world; we benefit immensely from her presence in Illinois; and

WHEREAS, Oprah Gail Winfrey was born on January 29, 1954 in Kosciusko, Mississippi; and

WHEREAS, She began her broadcasting career at WVOL radio in Nashville while still in high school; at the age of 19, she became the youngest person and the first African-American woman to anchor the news at Nashville's WTVF-TV; and

WHEREAS, In 1976, she moved to Baltimore, Maryland to join WJZ-TV news as a co-anchor of the Six O'Clock News, and in 1978, discovered her talent for hosting talk shows when she became co-host of WJZ-TV's talk show "People Are Talking", while continuing to serve as anchor and news reporter; in January 1984, she moved to Chicago to host WLS-TV's morning talk show "AM Chicago", which became the number one local talk show just one month after she began; in less than a year, the show expanded to one hour and, in September 1985, was renamed "The Oprah Winfrey Show"; in 1986, "The Oprah Winfrey Show" was syndicated and aired in 107 countries with 23 million viewers; and

WHEREAS, She has impacted the media of television, publishing, film, philanthropy, education, and health and fitness; and

WHEREAS, In the television medium, the film medium, and the print medium, she serves as chairperson of HARPO, Inc., HARPO Productions, Inc.; HARPO Studios Inc., HARPO Films, Inc., HARPO Print, LLC, and HARPO Video, Inc.; and

WHEREAS, She has received numerous awards, including the George Foster Peabody Individual Achievement Award (1996); the International Radio and Television Society's "Broadcaster of the Year" Award (1996); Newsweek's "Most Important Person" in books and media, TV Guide's "Television Performer of the Year" (1997); Time magazine's "100 Most Influential People of the 20th Century", the National Academy of Television Arts and Sciences' Lifetime Achievement Award (1998); the National Book Foundation's 50th Anniversary Gold Medal (1999); the Bob Hope Humanitarian Award, Broadcasting & Cable's Hall of Fame (2002); Association of American Publishers AAP Honors award (2003); National Association of Broadcasters Distinguished Service Award; and Time Magazine's "100 Most Influential People in the World" (2004); and

WHEREAS, After receiving 39 Daytime Emmy Awards, seven for Outstanding Host, nine for Outstanding Talk Show, 21 in the Creative Arts categories, and one for Oprah's work as supervising producer of the ABC After School Special "Shades of Single Protein", Oprah removed herself from future Emmy consideration in 1999, and the show followed suit in 2000; and

WHEREAS, Her never-ending philanthropy has been exemplified by such activities as ChristmasKindness South Africa 2002; Oprah Winfrey Leadership Academy for Girls-South Africa; and the Oprah Winfrey Scholars Program; among her many ventures that have improved the lives of countless individuals are Oprah's Angel Network; Oprah's Book Club; the Live Your Best Life Tour; her service as national spokesperson for "A Better Chance"; and her service as an advocate for the National Child Protection Act, which was signed on December 20, 1993 by President Clinton and declared the "Oprah

Bill"; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the first week of September in 2007 and each subsequent year shall be known as Oprah Winfrey Week to recognize the innumerable achievements of Ms. Winfrey, as well as her mark on the world as an African-American woman; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Oprah Winfrey as an expression of our utmost respect and esteem.

HOUSE JOINT RESOLUTION 8

Offered by Representative Howard:

WHEREAS, House Joint Resolution 107 which established a Legislative Task Force on Employment of Persons with Past Criminal Convictions was adopted unanimously by both houses of the Ninety-Fourth General Assembly; and

WHEREAS, The Legislative Task Force on Employment of Persons with Past Criminal Convictions was directed to: examine the barriers faced by persons with past criminal convictions with respect to obtaining employment; conduct public hearings; evaluate those recommendations made by the Governor's Statewide Community Safety and Reentry Working Group; and report its findings and recommendations to the Governor and the General Assembly in a final report which was to be filed on or before January 1, 2007; and

WHEREAS, The Legislative Task Force on Employment of Persons with Past Criminal Convictions did not have sufficient time to carry out its duties before the January 1, 2007 date set for its Report and Recommendations and before the final adjournment of the Ninety-Fourth General Assembly on January 9, 2007; and

WHEREAS, The Ninety-Fifth General Assembly needs to reauthorize the Legislative Task Force on Employment of Persons with Past Criminal Convictions with the same membership and charge as the Task Force authorized by HJR 107 of the Ninety-Fourth General Assembly and set the date for the Report and Recommendations as on or before October 31, 2007; and

WHEREAS, As stated in HJR 107, the barriers to employment and job promotion for persons with criminal convictions remain extremely complex issues, involving, among others, public employers at all levels of government, private employers, labor organizations, education and training institutions, public safety officials, public and private licensing and certification bodies, insurers, employment placement agencies, custodians of and users of arrest and conviction records, drug treatment agencies, and persons with criminal records; and

WHEREAS, As stated in HJR 107, a thorough examination of the barriers to employment for people with criminal conviction records and a thorough study of ways in which such barriers could be lowered or eliminated without exposing employers, individuals, the general public, or property to unreasonable risk is warranted; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there is hereby established a Legislative Task Force on Employment of Persons with Past Criminal Convictions; and be it further

RESOLVED, That the Task Force shall have the following members: 12 voting members, as follows: 3 members of the Senate appointed by the President of the Senate, 3 members of the Senate appointed by the Senate Minority Leader, 3 members of the House of Representatives appointed by the Speaker of the House of Representatives appointed by the House Minority Leader; and be it further

RESOLVED, That any member of the Ninety-Fifth General Assembly who was previously appointed to the Legislative Task Force established by HJR 107 of the Ninety-Fourth General Assembly shall remain as member of the Task Force, unless the individual who holds the position responsible for making the appointment determines otherwise; and be it further

RESOLVED, That all actions of the Task Force require the affirmative vote of at least 7 voting members; and be it further

RESOLVED, That the following persons shall serve without compensation as ex-officio, non-voting

members of the Task Force:

- (A) The Director of the Illinois Department of Corrections, or his or her designee;
- (B) The Director of the Illinois Department of Employment Security, or his or her designee;
- (C) The Secretary of the Illinois Department of Human Services, or his or her designee;
- (D) The Director of the Illinois Department of Children and Family Services, or his or her designee;
- (E) The Secretary of the Illinois Department of Financial and Professional Regulation, or his or her designee;
- (F) The Director of the Department of Commerce and Economic Opportunity, or his or her designee; and
- (G) The Chairman of the Illinois Human Rights Commission, or his or her designee; and be it further

RESOLVED, That the departments of State government and the Illinois Human Rights Commission represented on the Task Force shall work cooperatively to provide administrative support for the Task Force, and the Department of Employment Security shall be the primary agency in providing that support; and be it further

RESOLVED, That the voting members of the Task Force shall select a chairperson; and be it further

RESOLVED, That the Task Force shall conduct public hearings and examine the barriers faced by persons with past criminal convictions with respect to obtaining employment; and be it further

RESOLVED, That the Task Force shall evaluate those recommendations made by the Governor's Statewide Community Safety and Reentry Working Group; and be it further

RESOLVED, That the Task Force shall report its findings and recommendations to the Governor and the General Assembly in a final report which shall be filed on or before October 31, 2007; the requirement for reporting to the General Assembly shall be satisfied by filing copies of the report with the Speaker, the Minority Leader and the Clerk of the House of Representatives and the President, the Minority Leader and the Secretary of the Senate and the Legislative Research Unit, as required by Section 3.1 of the General Assembly Organization Act, and filing additional copies with the State Government Report Distribution Center for the General Assembly as required under paragraph (t) of Section 7 of the State Library Act; and be it further

RESOLVED, That the report shall include, but need not be limited to, the following:

(1) An assessment of those collateral consequences of a criminal conviction which impede

employment of persons with past criminal convictions, and the experiences of other states in addressing this issue;

(2) An assessment of the preparation for gainful employment provided to those

incarcerated in Illinois correctional facilities, and the experiences of other states in addressing this issue; (3) An identification of the barriers which impede those with criminal records from

obtaining stable employment; and

(4) Recommendations for legislative changes necessary to facilitate the employment of

persons with past criminal convictions which, if implemented, would not expose the employer, an individual, the general public, or property to unreasonable risks; and be it further

RESOLVED, That within 60 days after the filing of the report, the appropriate standing committees of both the House and the Senate shall hold hearings to consider the recommendations made by the Task Force; and be it further

RESOLVED, That suitable copies of this Resolution be transmitted to the ex-officio members of the Task Force.

WHEREAS, Americans are increasingly unwilling to participate in the political process because they believe large campaign contributions are the only way to influence our political leaders; and

WHEREAS, Candidates for elective office in Illinois are forced to raise large sums of money in order to run effective campaigns; time spent raising contributions could more effectively be spent on serving constituents; and

WHEREAS, Improving the restructuring of Illinois campaign finance laws will open opportunities for more citizen involvement and foster more dialogue among elected officials and their challengers on various political issues; it will enable voters to have more trust in the process and their representatives; and

WHEREAS, The State of Illinois must take action to restore public confidence by adopting stricter ethics rules; Illinois must eliminate campaign finance excesses by enacting comprehensive campaign finance laws that establish public financing of State campaigns and establish campaign contribution limits; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there is created a Campaign Finance Reform Task Force consisting of 4 Representatives, appointed 2 each by the Speaker and Minority Leader of the House of Representatives, and 4 Senators, appointed 2 each by the President and Minority Leader of the Senate; and be it further

RESOLVED, That the Campaign Finance Reform Task Force also may include 2 members of the general public appointed by the Governor who represent campaign finance reform organizations, and the chairperson of the Task Force may be designated by the Governor from among its members; and be it further

RESOLVED, That the Task Force shall study the newly enacted campaign reform laws in other states, as well as the issues and problems associated with excessive moneys that are being raised and spent by candidates for elective office in the State of Illinois, and shall report its findings and recommendations to the General Assembly on or before December 31, 2007.

HOUSE JOINT RESOLUTION 10

Offered by Representative John Bradley:

WHEREAS, The reaction time of motorists using cellular phones slows dramatically, increasing the risk of automobile accidents and tying up traffic generally; and

WHEREAS, Cell phone distraction causes 2,600 deaths and 330,000 injuries in the United States every year; and

WHEREAS, The numbers of fatalities and injuries may be higher because data on cell phone use by motorists is limited; and

WHEREAS, Increasing cell phone use can be expected to cause the annual death estimate to rise; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that State, county, and municipal law enforcement personnel are requested to include in their police reports of automobile accidents information pertaining to if an accident involved the use of a cellular phone; and be it further

RESOLVED, That the Department of Transportation shall request from State, county, and municipal law enforcement agencies statistics on the use of cellular phones leading to automobile accidents over a one-year period beginning July 1, 2006, and report the findings to the General Assembly no later than December 1, 2007; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Department of Transportation and appropriate county and municipal law enforcement agencies. Offered by Representative Howard:

WHEREAS, The series of debates between Stephen A. Douglas and Abraham Lincoln in their 1858 bid for a United States Senate seat from Illinois is a significant example of the role of public discussion and debate of issues by candidates before the electorate; and

WHEREAS, 2008 will mark the 150th anniversary of what are now seen as the greatest political debates in the United States in the nineteenth century, leading as they did to the eventual election of Abraham Lincoln to the office of President of the United States; and

WHEREAS, The 7 Illinois communities that hosted the original debates, Ottawa, Freeport, Jonesboro, Charleston, Galesburg, Quincy, and Alton, meeting together as the Lincoln-Douglas Debates Sesquicentennial Collation and with the assistance of the Looking for Lincoln Heritage Coalition, have and are making coordinated and comprehensive plans for fitting commemorative activities during the Sesquicentennial year, including: (i) traveling museum exhibits, (ii) a program of Lincoln and Douglas portrayers to present background on the debates with a modern political context as a means of explication for today's citizens that is to be presented in the 7 debates cities, plus Springfield, Chicago, and Bement, (iii) a coordinated calendar of activities to be promulgated to the general public through a single brochure and a single website, (iv) the issuance of commemorative collector coins, and (v) the hosting of a commemorative national high school debate tournament; and

WHEREAS, Several State agencies, the Abraham Lincoln Presidential Library and Museum, the Governor's Rural Affairs Council, the Illinois Bureau of Tourism, the Illinois Historic Preservation Agency, as well as several non-governmental organizations, both national and State, the Lincoln-Douglas Society, the Stephen A. Douglas Association, the Abraham Lincoln Association, the National Forensic League, the Illinois High School Association, and the Illinois Speech and Theater Association, have already engaged in assisting the Lincoln-Douglas Debates Sesquicentennial Collation in planning activities for the Sesquicentennial year; and

WHEREAS, A well-coordinated series of activities and programs during 2008 will serve as preliminary attractions for tourism in and to Illinois in anticipation of the 2009 programming being planned for the bicentennial of Abraham Lincoln's birth; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Illinois Department of Commerce and Economic Opportunity shall be designated as the agency within the State's executive branch to work with the Lincoln-Douglas Debates Sesquicentennial Collation for the purposes of:

1. Further planning and implementation of Sesquicentennial activities, and

2. Recommending to the Illinois General Assembly such budget and funding requests as shall

be deemed appropriate to ensure the smooth implementation of the previously developed, as well as any future, plans for commemorating the Sesquicentennial of the Lincoln-Douglas Debates in Illinois; and be it further

RESOLVED, That copies of this resolution be transmitted to all of the communities, agencies, and non-governmental organizations identified within it, as well as to all of the constitutional officers of the State of Illinois, and the Governor's Illinois Abraham Lincoln Bicentennial Commission.
