### HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

### **HOUSE RESOLUTION 96**

Offered by Representative Meyer:

WHEREAS, In the last 5 years, according to a United States Department of Labor report presented to Congress in 2005, 5,690 veterans have lost their jobs in both the private and the public employment sectors while activated to serve a tour of duty; those numbers are expected to increase because, of the 300,000 deployed reservists, as many as 25,000 veterans were expected to return home in 2005 to reintegrate themselves back into civilian life after a tour of duty in the global war against terrorism; and

WHEREAS, Employment discrimination against veterans based on the extended lengths of time for which they have been deployed has been reported in Illinois as well as throughout the United States; and

WHEREAS, Incidents of discrimination have included loss of yearly pay raises, loss of position within the workplace, and loss of employment altogether; and

WHEREAS, Federal law already prohibits the loss of status or position for returning members of the military under the Uniformed Services Employment and Reemployment Rights Act (USERRA); the Act protects service members' reemployment rights when they return from a period of service in the uniformed services, including the rights of those who are called up from the reserves or the National Guard, and prohibits discrimination by employers based on military service or obligation; the Act is administered by the United States Department of Labor's Veterans' Employment and Training Service; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois Department of Veterans' Affairs (i) to inform employers of members of the armed forces who are called to active duty of the employment rights of those service members as veterans upon their return from active duty and (ii) to inform those employers of the consequences of not following the law in regard to the employment rights of returning veterans.

### HOUSE RESOLUTION 97

Offered by Representative Poe:

WHEREAS, In the last 5 years, according to a United States Department of Labor report presented to Congress in 2005, 5,690 veterans have lost their jobs in both the private and the public employment sectors

while activated to serve a tour of duty; those numbers are expected to increase because, of the 300,000 deployed reservists, as many as 25,000 veterans were expected to return home in 2005 to reintegrate themselves back into civilian life after a tour of duty in the global war against terrorism; and

WHEREAS, In 2006, many reports of possible violations of the Veterans Preference Act and other laws providing for hiring preferences for service members were heard; and

WHEREAS, State of Illinois hiring practices should be monitored for compliance with State hiring preference laws; and

WHEREAS, State of Illinois hiring practices should be open to observation by the general public to curb violations of those hiring preference laws and to protect the integrity of veterans preference programs; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that in an attempt to improve our returning veterans' reintegration into civilian society, we urge the Department of Central Management Services and the Department of Employment Security to provide a monthly list of State job openings to the Department of Veterans' Affairs and the Department of Military Affairs; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor, the Director of Central Management Services, the Director of Employment Security, the Director of Veterans' Affairs, and the Adjutant General.

### HOUSE JOINT RESOLUTION 16

Offered by Representative Joyce:

WHEREAS, The generation born between 1946 and 1964 is rapidly approaching retirement age; a Baby Boomer turns 50 every 7.5 seconds; in 2006 the first Baby Boomers turned 60; by 2011, the first Baby Boomers will turn 65; and people turning 50 today have half of their adult lives ahead of them; and

WHEREAS, This growth trend will hit its peak in 2030, when the number of people over age 65 in the United States will soar to 71.5 million - twice their number in 2000, or 1 in every 5 Americans; and

WHEREAS, The number of people over age 60 in the State of Illinois is projected to increase by 87% from 1,966,236 in 2000 to 3,676,295 in 2030 - 1 in every 5 Illinoisans; and

WHEREAS, Older persons age 60 and older belonging to minority groups will increase from 307,137 in 2000 to 983,396 in 2030 - a 220% increase; and

WHEREAS, The number of persons over 85 in the State of Illinois is projected to increase by 109% from 192,346 in 2000 to 402,311 in 2030, representing 11% of the over-60 population; and

WHEREAS, A national survey of U.S. counties and cities finds that only 46% of American communities have begun planning to address the needs of the exploding population of Baby Boomers; and

WHEREAS, The Illinois General Assembly finds that State and community preparedness for the aging of the population will require long-range planning, dialogue across generations, and collaboration among State and local governments and organizations in the private sector; and

WHEREAS, The Older Americans Act Amendments of 2006 authorize the Illinois Department on Aging and the thirteen Area Agencies on Aging to begin the process of assessing the preparedness of the State and communities for the aging of the citizenry, and to formulate recommendations to government officials at the State, county, and local levels in the areas of health and human services, land use, housing, transportation, public safety, workforce and economic development, recreation, education, civic engagement, and emergency preparedness; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the Illinois Department on Aging and the thirteen Area Agencies on Aging, with the advice of the Illinois Council on Aging, and in collaboration with other departments and offices of State government, advocacy organizations on behalf of older adults, local units of government, and organizations in the private sector, shall assess the preparedness of the State of Illinois and counties and communities within the thirteen Planning and Service Areas of Illinois for the aging of the population and shall submit a report with recommendations for the planning and development of livable communities for all ages in Illinois to the Illinois General Assembly, the Office of the Governor, and local officials by January 1, 2009; and be it further

RESOLVED, That a copy of this resolution be delivered to the Director of Aging.

### HOUSE JOINT RESOLUTION 17

Offered by Representative Washington:

WHEREAS, The Illinois General Assembly wishes to present this resolution as a tribute to and acknowledgment of Oprah Winfrey's contributions to the State of Illinois, the nation, and the world; we benefit immensely from her presence in Illinois; and

WHEREAS, Oprah Gail Winfrey was born on January 29, 1954 in Kosciusko, Mississippi; and

WHEREAS, She began her broadcasting career at WVOL radio in Nashville while still in high school; at the age of 19, she became the youngest person and the first African-American woman to anchor the news at Nashville's WTVF-TV; and

WHEREAS, In 1976, she moved to Baltimore, Maryland to join WJZ-TV news as a co-anchor of the Six O'Clock News, and in 1978, discovered her talent for hosting talk shows when she became co-host of WJZ-TV's talk show "People Are Talking", while continuing to serve as anchor and news reporter; in January 1984, she moved to Chicago to host WLS-TV's morning talk show "AM Chicago", which became the number one local talk show just one month after she began; in less than a year, the show expanded to one hour and, in September 1985, was renamed "The Oprah Winfrey Show"; in 1986, "The Oprah Winfrey Show" was syndicated and aired in 107 countries with 23 million viewers; and

WHEREAS, She has impacted the media of television, publishing, film, philanthropy, education, and health and fitness; and

WHEREAS, In the television medium, the film medium, and the print medium, she serves as chairperson of HARPO, Inc., HARPO Productions, Inc.; HARPO Studios Inc., HARPO Films, Inc., HARPO Print, LLC, and HARPO Video, Inc.; and

WHEREAS, She has received numerous awards, including the George Foster Peabody Individual Achievement Award (1996); the International Radio and Television Society's "Broadcaster of the Year" Award (1996); Newsweek's "Most Important Person" in books and media, TV Guide's "Television Performer of the Year" (1997); Time magazine's "100 Most Influential People of the 20th Century", the National Academy of Television Arts and Sciences' Lifetime Achievement Award (1998); the National Book Foundation's 50th Anniversary Gold Medal (1999); the Bob Hope Humanitarian Award, Broadcasting & Cable's Hall of Fame (2002); Association of American Publishers AAP Honors award (2003); National Association of Broadcasters Distinguished Service Award; and Time Magazine's "100 Most Influential People in the World" (2004); and

WHEREAS, After receiving 39 Daytime Emmy Awards, seven for Outstanding Host, nine for Outstanding Talk Show, 21 in the Creative Arts categories, and one for Oprah's work as supervising producer of the ABC After School Special "Shades of Single Protein", Oprah removed herself from future Emmy consideration in 1999, and the show followed suit in 2000; and

WHEREAS, Her never-ending philanthropy has been exemplified by such activities as ChristmasKindness South Africa 2002; Oprah Winfrey Leadership Academy for Girls-South Africa; and the Oprah Winfrey Scholars Program; among her many ventures that have improved the lives of countless individuals are Oprah's Angel Network; Oprah's Book Club; the Live Your Best Life Tour; her service as national spokesperson for "A Better Chance"; and her service as an advocate for the National Child Protection Act, which was signed on December 20, 1993 by President Clinton and declared the "Oprah Bill"; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the last week of February in 2007 and each subsequent year shall be known as Oprah Winfrey Week to recognize the innumerable achievements of Ms. Winfrey, as well as her mark on the world as an African-American woman; and be it further

RESOLVED, That a suitable copy of this resolution be presented to Oprah Winfrey as an expression of our utmost respect and esteem.

### HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 18

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article VIII of the Illinois Constitution by changing Section 2 as follows:

### ARTICLE VIII FINANCE

### **SECTION 2. STATE FINANCE**

- (a) The Governor shall prepare and submit to the General Assembly, at a time prescribed by law, a State budget for the ensuing fiscal year. The budget shall set forth the estimated balance of funds available for appropriation at the beginning of the fiscal year, the estimated receipts, and a plan for expenditures and obligations during the fiscal year of every department, authority, public corporation and quasi-public corporation of the State, every State college and university, and every other public agency created by the State, but not of units of local government or school districts. The budget shall also set forth the indebtedness and contingent liabilities of the State and such other information as may be required by law. Proposed expenditures shall not exceed funds estimated to be available for the fiscal year as shown in the budget.
- (b) The General Assembly by law shall make appropriations for all expenditures of public funds by the State. Appropriations for a fiscal year shall not exceed funds estimated by the General Assembly to be available during that year.
- (c) Except upon a record vote of three-fifths of the members elected to each house of the General Assembly, the total aggregate appropriations for each fiscal year shall not exceed the previous fiscal year's total aggregate appropriations by the greater of 4% of the previous fiscal year's total aggregate appropriations or a percentage representing the sum of the percentage rate of inflation and the percentage rate of the State's population growth since the previous fiscal year. State revenues in excess of a fiscal year's total aggregate appropriations as calculated under this subsection shall be deposited into a rainy day fund within the State treasury established and to be used for purposes provided by law.
