**HOUSE RESOLUTIONS**

The following resolutions were offered and placed in the Committee on Rules.

**HOUSE RESOLUTION 406**

Offered by Representative Cross:

WHEREAS, The week of April 22 through April 28, 2007 is recognized as National Victims' Rights Week; and

WHEREAS, In October of 1985 former DuPage County State's Attorney James E. Ryan convened a Task Force on Child Sexual Abuse to design a comprehensive plan for the investigation, prosecution, and treatment of child sex abuse in DuPage County; as a result of the task force recommendation, the DuPage County Children's Sex Abuse Center, now known as the Children's Advocacy Center, was founded in March of 1987; and

WHEREAS, The DuPage County Children's Advocacy Center provides a multi-disciplinary approach to addressing the special needs of children who are victims of sexual or serious physical abuse in DuPage County; the first of such centers in Illinois and only the second in the nation; and

WHEREAS, The DuPage County Children's Advocacy Center is observing its 20th anniversary of fulfilling a vital service to the children and families of DuPage County, Illinois; the Center is a nationally recognized model for other jurisdictions; and

WHEREAS, Currently, Illinois has 20 plus centers addressing the special needs of young victims of abuse; and

WHEREAS, The DuPage County Children's Advocacy Center is comprised of criminal investigators, case managers, and Department of Children and Family Services child protection investigators; and

WHEREAS, The DuPage County Children's Advocacy Center is committed and shall remain committed to minimizing the trauma experienced by the child victim of sexual abuse or serious physical abuse during the investigation; to seeking justice from those responsible for the commission of sexual abuse or serious physical abuse; to providing support and facilitating treatment to the child victim and the non-offending caregivers; and to promoting prevention of child victimization through community education; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we proclaim the week of April 22 through April 28, 2007 as National Victims' Rights Week in the State of Illinois and honor the DuPage County Children's Advocacy Center and those programs across the State of Illinois working to reduce and ultimately eliminate sexual abuse and serious physical abuse of children; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the DuPage County Children's Advocacy Center as a symbol of our respect.

HOUSE RESOLUTION 412

Offered by Representative Pihos:

WHEREAS, According to the Brain Aneurysm Foundation (BAF), studies show that about 2% of the population of the United States has a brain aneurysm; studies also show that approximately 3 to 6 million people have unruptured brain aneurysms; and the number of people from the State of Illinois who suffer annually are estimated to be between 1,200 and 1,400 cases; and

WHEREAS, The BAF points out that brain aneurysms form from continuous wear and tear on the arterial walls over an extended period of time; the constant stress to the artery wall can sometimes, but not always, lead to hemorrhage causing severe damage or death; and

WHEREAS, People who have been diagnosed with a brain aneurysm need support and help to get through this frightening time; many people are unaware of the facts and have questions that need answered; and

WHEREAS, The Brain Aneurysm Foundation has a website open to people looking for answers and support; and

WHEREAS, The Brain Aneurysm Foundation spearheads research, aids in education and training of physicians, helps survivors, and informs the general public through their efforts; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we proclaim September of 2007 as Brain Aneurysm Awareness Month in Illinois to make people aware of this medical issue and encourage the general public to become knowledgeable about brain aneurysms; and be it further

RESOLVED, That a suitable copy of this resolution be presented to The Brain Aneurysm Foundation.

HOUSE RESOLUTION 413

Offered by Representative Pihos:

WHEREAS, On behalf of the citizens of Illinois, the members of the Illinois House of Representatives are pleased to join the American Stroke Association, a division of the American Heart Association, in celebrating May 2007 as American Stroke Month in the State of Illinois; and

WHEREAS, Stroke Survivors Empowering Each Other (SSEEO), a first-of-its-kind-in-the-nation group of stroke survivors from all parts of Illinois is meeting in Springfield May 15-16, 2007; and

WHEREAS, The themes for American Stroke Month 2007 are "Young People and Stroke" to educate the public and policymakers about the devastating effects of stroke in young people under age 30, and "Igniting the Power" to end stroke in African Americans, who are at particularly high risk of the disease, by empowering them to reduce their risk, recognize the warning signs, and respond quickly; and

WHEREAS, Stroke is the third leading cause of death in the United States, killing about 150,000 Americans each year; and

WHEREAS, Stroke is a leading cause of serious long-term disability with more than 1.1 million American adults experiencing functional limitations or difficulty with activities of daily living resulting from a stroke; and

WHEREAS, Americans are more aware of the risk factors and warning signs for stroke than in the past, but still less than one in five adults can correctly classify all stroke symptoms; and

WHEREAS, Warning signs of stroke include sudden numbness or weakness of the face, arm or leg, especially on one side of the body; sudden confusion, trouble speaking or understanding; sudden trouble seeing in one or both eyes; sudden trouble walking, dizziness, loss of balance or coordination; and sudden severe headache with no known cause; and

WHEREAS, Stroke leads to the death of more than 7,500 citizens of Illinois each year and disables thousands more; and

WHEREAS, New and effective treatments have been developed to treat and minimize the severity and damaging effects of strokes, but much more research is needed; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we proclaim May 2007 to be American Stroke Month in the State of Illinois and urge all the citizens of our State to familiarize themselves with the warning signs,

symptoms, and risk factors associated with stroke so that we might begin to reduce the devastating effects of stroke on our population.

#### HOUSE RESOLUTION 414

Offered by Representative Brauer:

WHEREAS, The Y-ME National Breast Cancer Organization Illinois Affiliate is a vital lifeline providing hope, empowerment, education, and perseverance in the face of a disease that touches millions; and

WHEREAS, Founded in Chicago in 1978 by two breast cancer patients, Y-ME now serves as the nation's premier resource for breast cancer information, education, and support; and

WHEREAS, With nearly 20,000 women expected to be diagnosed with breast cancer this year alone, the demand for services and support of Y-ME is critical; and

WHEREAS, The Y-ME Organization provides immediate, relevant, and free-of-charge services to people who have been touched by breast cancer either personally or through a loved one; and

WHEREAS, Y-ME has successfully reached thousands of women and their families throughout the State of Illinois and is committed to increasing access to breast cancer resources in under-served communities; and

WHEREAS, Y-ME Illinois continues to provide the leadership necessary to fulfill its mission of lessening the impact of breast cancer, creating breast cancer awareness, and ensuring that no one faces breast cancer alone; and

WHEREAS, On June 3, 2007, Y-ME Illinois will hold its first annual Breast Cancer Walk in Springfield, Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare June 3, 2007 to be "Y-ME Illinois Day".

#### HOUSE RESOLUTION 416

Offered by Representative Saviano:

WHEREAS, According to data published in 1990 and again in 1997 in the Journal of the American Medical Association by David Eisenberg, MD of Harvard Medical School, over 40% of Americans use at least one alternative therapy; over 70% of the patients using alternative therapies in Dr. Eisenberg's study did not disclose this use to their medical doctors; and

WHEREAS, The provision of complementary and alternative therapies is increasing by practitioners who have varied to no training, testing, or legitimate certification; and

WHEREAS, In recognizing the demand for natural medicine, the challenge for regulators is to identify those practitioners who have the appropriate education and training to safely practice complementary and alternative therapies; and

WHEREAS, Naturopathic physicians are among the highest trained practitioners in the broadest scope of complementary and alternative medicine; and

WHEREAS, Prior to 1987, naturopathic physicians were eligible for licensure in Illinois under the Medical Practice Act; and

WHEREAS, Legislative recognition in the form of State licensure creates a climate for patients to trust the credentials of naturopathic physicians providing complementary and alternative therapies; and

WHEREAS, Fifteen states, the District of Columbia, and the U.S. territories of Puerto Rico and the U.S. Virgin Islands have licensing laws for Naturopathic Physicians; and

WHEREAS, The licensing of naturopathic physicians assures the public of a high standard of education and training of these practitioners while providing consumers access to evidence based natural therapies; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that there is created the Task Force on the Licensure of Naturopathic Physicians to (i) evaluate whether the standards of naturopathic medical education and training are adequate to protect the public and (ii) make recommendations as to the extent to which

regulation of naturopathic physicians will benefit the health of the citizens of Illinois; and be it further

RESOLVED, That the Task Force shall be composed of the Chairperson of the House Registration and Regulation Committee, who shall serve as the Task Force Chairperson; the Minority Spokesperson of the House Registration and Regulation Committee; 3 members of the House of Representatives appointed by the Speaker of the House; and 2 members of the House of Representatives appointed by the Minority Leader of the House; and be it further

RESOLVED, That the Task Force shall hold hearings to determine the public demand for appropriately educated and trained naturopathic physicians and the risk and detriment to the public welfare in the absence of regulation; the Task Force shall also examine naturopathic medical education institutions in order to establish the adequacy of naturopathic medical education and training; and be it further

RESOLVED, That the Task Force shall present a written report of its findings to the House of Representatives no later than December 31, 2007.

#### HOUSE JOINT RESOLUTION 60

Offered by Representative Eddy:

WHEREAS, All-Terrain Vehicles (ATVs) have become popular for work and recreation on many farms and ranches; and

WHEREAS, Reported cases of serious injury have increased along with their increased use; and

WHEREAS, Most of these injuries and deaths can be attributed to improper use of ATVs; and

WHEREAS, Approximately 6,500 ATV related deaths have been reported since 1982; and

WHEREAS, According to the U.S. Consumer Product Safety Commission, an estimated 44,700 children age 16 and under sustained ATV related injuries in 2004 alone; and

WHEREAS, Approximately 155 children age 16 and under died from ATV related injuries in 2004, according to the Consumer Product Safety Commission; and

WHEREAS, Nearly 38% of all St. Louis Children's Hospital ATV injuries involve a rider not wearing an approved helmet; and

WHEREAS, Nearly 95% of children involved in ATV accidents were riding on an ATV that was larger than recommended for their age; and

WHEREAS, Education should be promoted for children and their parents about the proper use of ATVs; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the month of October 2007 and the October of each succeeding year shall be known as ATV Safety Month, to promote the safe operation of ATVs in Illinois and to promote education on ATV safety; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the Governor, the Director of Natural Resources, the Secretary of State, and the Secretary of Transportation.
