Pursuant to Rule 60(b), I move to table HOUSE BILL 4122.

CHANGE OF SPONSORSHIP

With the consent of the affected members, Representative Howard was removed as principal sponsor, and Representative Graham became the new principal sponsor of HOUSE RESOLUTION 628.

With the consent of the affected members, Representative Holbrook was removed as principal sponsor, and Representative Currie became the new principal sponsor of HOUSE BILL 664.

With the consent of the affected members, Representative May was removed as principal sponsor, and Representative Currie became the new principal sponsor of SENATE BILL 77.

AGREED RESOLUTIONS

HOUSE RESOLUTIONS 641 and 642 were taken up for consideration. Representative Currie moved the adoption of the agreed resolutions. The motion prevailed and the agreed resolutions were adopted.

SUSPEND POSTING REQUIREMENTS

Pursuant to the motion submitted previously, Representative Currie moved to suspend the posting requirements in Rule 25 in relation to Senate Bills 77, 198 and 381.

SENATE BILL ON SECOND READING

SENATE BILL 211. Having been read by title a second time on August 2, 2007, and held on the order of Second Reading, the same was again taken up and advanced to the order of Third Reading.

SENATE BILL ON THIRD READING

The following bill and any amendments adopted thereto were reproduced. Any amendments still pending upon the passage or defeat of a bill on Third Reading are automatically tabled pursuant to Rule 40(a).

On motion of Representative Hassert, SENATE BILL 211 was taken up and read by title a third time. A three-fifths vote is required.

And the question being, "Shall this bill pass?" it was decided in the affirmative by the following vote: 83, Yeas; 0, Nays; 0, Answering Present. (ROLL CALL 2)

This bill, as amended, having received the votes of three-fifths of the Members elected, was declared passed.

Ordered that the Clerk inform the Senate thereof and ask their concurrence in the House amendment/s adopted thereto.

At the hour of 9:45 o'clock a.m., Representative Currie moved that the House do now adjourn until Saturday, August 4, 2007, at 9:00 o'clock a.m.
