AMENDMENT NO. 2. Amend House Bill 4454, AS AMENDED, by replacing everything after the enacting clause with the following:

"Section 5. The Illinois Income Tax Act is amended by changing Section 404 as follows:

(35 ILCS 5/404) (from Ch. 120, par. 4-404)

Sec. 404. Reallocation of Items.

(a) ~~If it appears to~~ the Director determines that any agreement, understanding or arrangement exists between any persons which causes any person's base income allocable to this State to be improperly or inaccurately reflected, the Director may adjust ~~such~~ items of income and deduction, and any related apportionment factor taken into account in allocating that income to this State, to such extent as may reasonably be required to determine the base income of such person properly allocable to this State.

(b) Unless the principal purpose of the agreement, understanding, or arrangement is for the avoidance of a tax on or measured by net income imposed by any State, any adjustment under this Section must be made in accordance with Section 482 of the Internal Revenue Code, as amended, and any applicable federal regulations. For any taxable year, unless established by a preponderance of the evidence to the contrary, an agreement, understanding, or arrangement for the principal purpose of avoidance of a tax on or measured by net income imposed by any State is presumed to exist between one or more members of a unitary business group and a person who would be a member of that unitary business group if not for the prohibitions in item (27) of subsection (a) of Section 1501 of this Act against including in a unitary business group persons who apportion their business incomes under different subsections of Section 304 of this Act or against inclusion in any unitary business group of a person who conducts 80% or more of his or her business activity outside the United States, if that excluded person:

(1) has de minimis real or tangible personal property or payroll for the taxable year, as determined for purposes of subsection (a) of Section 304 of this Act;

(2) earns a return for the taxable year on all of its real and tangible personal property that is substantially more than the aggregate return earned by the members of the unitary business group on all of real and tangible personal property of the unitary business group; for purposes of this paragraph (2) the return on real and tangible personal property of a person for a taxable year is equal to the base income of that person for that taxable year, divided by that person's real and tangible personal property for that taxable year, as determined for purposes of subsection (a) of Section 304 of this Act; or

(3) conducts substantially all of its business activity, as shown by gross receipts for the taxable year, with one or more persons who are members of the unitary business group or who would be members of that unitary business group if not for the prohibitions in item (27) of subsection (a) of Section 1501 of this Act against including in a unitary business group persons who apportion their business incomes under different subsections of Section 304 of this Act or against inclusion in any unitary business group of a person that conducts 80% or more of its business activity outside the United States.

(c) The Director may not make an adjustment to base income under this Section that has the same effect as retroactively applying any amendments to this Act made by Public Act 93-0840, Public Act 95-0233, or Public Act 95-0707.

(d) Notwithstanding any other rulemaking authority that may exist, neither the Governor nor any agency or agency head under the jurisdiction of the Governor has any authority to make or promulgate rules to implement or enforce the provisions of this amendatory Act of the 95th General Assembly. If, however, the Governor believes that rules are necessary to implement or enforce the provisions of this amendatory Act of the 95th General Assembly, the Governor may suggest rules to the General Assembly by filing them with the Clerk of the House and the Secretary of the Senate and by requesting that the General Assembly authorize such rulemaking by law, enact those suggested rules into law, or take any other appropriate action

in the General Assembly's discretion. Nothing contained in this amendatory Act of the 95th General Assembly shall be interpreted to grant rulemaking authority under any other Illinois statute where such authority is not otherwise explicitly given. For the purposes of this paragraph, "rules" is given the meaning contained in Section 1-70 of the Illinois Administrative Procedure Act, and "agency" and "agency head" are given the meanings contained in Sections 1-20 and 1-25 of the Illinois Administrative Procedure Act to the extent that such definitions apply to agencies or agency heads under the jurisdiction of the Governor.

Representative Mendoza offered the following amendments and moved their adoption.

AMENDMENT NO. 2. Amend House Bill 4943, AS AMENDED, by replacing everything after the enacting clause with the following:

"Section 5. The Covering ALL KIDS Health Insurance Act is amended by changing Section 30 as follows:

(215 ILCS 170/30)

(Section scheduled to be repealed on July 1, 2011)

Sec. 30. Program outreach and marketing. The Department may provide grants to application agents and other community-based organizations to educate the public about the availability of the Program. The Department shall adopt rules regarding performance standards and outcomes measures expected of organizations that are awarded grants under this Section, including penalties for nonperformance of contract standards. The Department shall permit private employers, as defined in the Day and Temporary Labor Services Act and doing business in Illinois, to enroll as unpaid application agents.

Notwithstanding any other rulemaking authority that may exist, neither the Governor nor any agency or agency head under the jurisdiction of the Governor has any authority to make or promulgate rules to implement or enforce the provisions of this amendatory Act of the 95th General Assembly. If, however, the Governor believes that rules are necessary to implement or enforce the provisions of this amendatory Act of the 95th General Assembly, the Governor may suggest rules to the General Assembly by filing them with the Clerk of the House and the Secretary of the Senate and by requesting that the General Assembly authorize such rulemaking by law, enact those suggested rules into law, or take any other appropriate action in the General Assembly's discretion. Nothing contained in this amendatory Act of the 95th General Assembly shall be interpreted to grant rulemaking authority under any other Illinois statute where such authority is not otherwise explicitly given. For the purposes of this amendatory Act of the 95th General Assembly, "rules" is given the meaning contained in Section 1-70 of the Illinois Administrative Procedure Act, and "agency" and "agency head" are given the meanings contained in Sections 1-20 and 1-25 of the Illinois Administrative Procedure Act to the extent that such definitions apply to agencies or agency heads under the jurisdiction of the Governor.

Having been reproduced, the following bill was taken up, read by title a second time and advanced to the order of Third Reading: HOUSE BILL 4814.

Having been reproduced, the following bill was taken up, read by title a second time and held on the order of Second Reading: HOUSE BILL 5213.

Having been reproduced, the following bill was taken up, read by title a second time and advanced to the order of Third Reading: HOUSE BILL 5928.

HOUSE BILL 5399. Having been reproduced, was taken up and read by title a second time.

The following amendment was offered in the Committee on Elementary & Secondary Education, adopted and reproduced:

AMENDMENT NO. 1. Amend House Bill 5399 by replacing everything after the enacting clause with the following:

"Section 5. The School Code is amended by changing Section 11E-35 as follows:

(105 ILCS 5/11E-35)

Sec. 11E-35. Petition filing.

(a) A petition shall be filed with the regional superintendent of schools of the educational service region in which the territory described in the petition or that part of the territory with the greater percentage of equalized assessed valuation is situated. The petition must do the following:

- (1) be signed by at least 50 legal resident voters or 10% of the legal resident voters, whichever is less, residing within each affected district; or
- (2) be approved by the school board in each affected district.

(b) The petition shall contain all of the following:

- (1) A request to submit the proposition at a regular scheduled election for the purpose of voting:
  - (A) for or against a high school - unit conversion;
  - (B) for or against a unit to dual conversion;
  - (C) for or against the establishment of a combined elementary district;
  - (D) for or against the establishment of a combined high school district;
  - (E) for or against the establishment of a combined unit district;
  - (F) for or against the establishment of a unit district from dual district territory exclusively;
  - (G) for or against the establishment of a unit district from both dual district and unit district territory;
  - (H) for or against the establishment of a combined high school - unit district from a combination of one or more high school districts and one or more unit districts;
  - (I) for or against the establishment of a combined high school - unit district and one or more new elementary districts through a multi-unit conversion;
  - (J) for or against the establishment of an optional elementary unit district from a combination of a substantially coterminous dual district; or
  - (K) for or against dissolving and becoming part of an optional elementary unit district.

(2) A description of the territory comprising the districts proposed to be dissolved and those to be created, which, for an entire district, may be a general reference to all of the territory included within that district.

(3) A specification of the maximum tax rates for various purposes the proposed district or districts shall be authorized to levy for various purposes and, if applicable, the specifications related to

the Property Tax Extension Limitation Law, in accordance with Section 11E-80 of this Code.

(4) A description of how supplementary State deficit difference payments made under subsection (c) of Section 11E-135 of this Code will be allocated among the new districts proposed to be formed.

(5) Where applicable, a division of assets and liabilities to be allocated to the proposed new or annexing school district or districts in the manner provided in Section 11E-105 of this Code.

(6) If desired, a request that at that same election as the reorganization proposition a school board or boards be elected on a separate ballot or ballots to serve as the school board or boards of the proposed new district or districts. Any election of board members at the same election at which the proposition to create the district or districts to be served by the board or boards is submitted to the voters shall proceed under the supervision of the regional superintendent of schools as provided in Section 11E-55 of this Code.

(7) If desired, a request that the referendum at which the proposition is submitted for the purpose of voting for or against the establishment of a unit district (other than a partial elementary unit district) include as part of the proposition the election of board members by school board district rather than at large. Any petition requesting the election of board members by district shall divide the proposed school district into 7 school board districts, each of which must be compact and contiguous and substantially equal in population to each other school board district. Any election of board members by school board district shall proceed under the supervision of the regional superintendent of schools as provided in Section 11E-55 of this Code.

(7.5) If desired, a request that the referendum at which the proposition is submitted for the purpose of voting for or against the establishment of a combined unit district include as part of the proposition the election of board members by a combination of members representing each of the forming unit districts and members at large rather than solely members at large. The format for the election of the new unit district school board must be defined in the petition. When 4 or more unit school districts are involved and a combination of board members representing each of the forming unit school districts and at-large formats are used, one member must be elected from each of the forming unit school districts. The remaining members may be elected on an at-large basis, provided that none of the forming unit school districts have a majority on the resulting unit district school board. When 3 unit school districts are involved and a combination of board members representing each of the forming unit school districts and at-large formats are used, 2 members must be elected from each of the forming unit school districts. The remaining member must be elected at large. When 2 unit school districts are involved and a combination of board members representing each of the forming unit school districts and at-large formats are used, 3 members must be elected from each of the forming unit school districts. The remaining member must be elected at large.

(8) If desired, a request that the referendum at which the proposition is submitted for the purpose of voting for or against the establishment of a unit to dual conversion include as part of the proposition the election of board members for the new high school district (i) on an at large basis, (ii) with board members representing each of the forming elementary school districts, or (iii) a combination of both. The format for the election of the new high school board must be defined in the petition. When 4 or more unit school districts and a combination of board members representing each of the forming elementary school districts are involved and at large formats are used, one member must be elected from each of the forming elementary school districts. The remaining members may be elected on an at large basis, provided that none of the underlying elementary school districts have a majority on the resulting high school board. When 3 unit school districts and a combination of board members representing each of the forming elementary school districts are involved and at large formats are used, 2 members must be elected from each of the forming elementary school districts. The remaining member must be elected at large.

(9) If desired, a request that the referendum at which the proposition shall be submitted include a proposition on a separate ballot authorizing the issuance of bonds by the district or districts when organized in accordance with this Article. However, if the petition is submitted for the purpose of voting for or against the establishment of an optional elementary unit district, the petition may request only that the referendum at which the proposition is submitted include a proposition on a separate ballot authorizing the issuance of bonds for high school purposes (and not elementary purposes) by the district when organized in accordance with this Article. The principal amount of the bonds and the purposes of issuance, including a specification of elementary or high school purposes if the proposed issuance is to be made by a combined high school - unit district, shall be stated in the petition and in all

notices and propositions submitted thereunder.

(10) A designation of a committee of ten of the petitioners as attorney in fact for all petitioners, any 7 of whom may at any time, prior to the final decision of the regional superintendent of schools, amend the petition in all respects (except that, for a unit district formation, there may not be an increase or decrease of more than 25% of the territory to be included in the proposed district) and make binding stipulations on behalf of all petitioners as to any question with respect to the petition, including the power to stipulate to accountings or the waiver thereof between school districts.

(c) The regional superintendent of schools shall not accept for filing under the authority of this Section any petition that includes any territory already included as part of the territory described in another pending petition filed under the authority of this Section.

(d)(1) Those designated as the Committee of Ten shall serve in that capacity until such time as the regional superintendent of schools determines that, because of death, resignation, transfer of residency from the territory, failure to qualify, or any other reason, the office of a particular member of the Committee of Ten is vacant. Upon determination by the regional superintendent of schools that these vacancies exist, he or she shall declare the vacancies and shall notify the remaining members to appoint a petitioner or petitioners, as the case may be, to fill the vacancies in the Committee of Ten so designated. An appointment by the Committee of Ten to fill a vacancy shall be made by a simple majority vote of the designated remaining members.

(2) Failure of a person designated as a member of the Committee of Ten to sign the petition shall not disqualify that person as a member of the Committee of Ten, and that person may sign the petition at any time prior to final disposition of the petition and the conclusion of the proceedings to form a new school district or districts, including all litigation pertaining to the petition or proceedings.

(3) Except as stated in item (10) of subsection (b) of this Section, the Committee of Ten shall act by majority vote of the membership.

(4) The regional superintendent of schools may accept a stipulation made by the Committee of Ten instead of evidence or proof of the matter stipulated or may refuse to accept the stipulation, provided that the regional superintendent sets forth the basis for the refusal.

(5) The Committee of Ten may voluntarily dismiss its petition at any time before the petition is approved by either the regional superintendent of schools or State Superintendent of Education.

Section 99. Effective date. This Act takes effect January 1, 2009."

Representative Verschoore offered the following amendment and moved its adoption:

AMENDMENT NO. 2. Amend House Bill 5399, AS AMENDED, by replacing everything after the enacting clause with the following:

"Section 5. The School Code is amended by changing Section 11E-35 as follows:

(105 ILCS 5/11E-35)

Sec. 11E-35. Petition filing.

(a) A petition shall be filed with the regional superintendent of schools of the educational service region in which the territory described in the petition or that part of the territory with the greater percentage of equalized assessed valuation is situated. The petition must do the following:

- (1) be signed by at least 50 legal resident voters or 10% of the legal resident voters, whichever is less, residing within each affected district; or
- (2) be approved by the school board in each affected district.

(b) The petition shall contain all of the following:

- (1) A request to submit the proposition at a regular scheduled election for the purpose of voting:
  - (A) for or against a high school - unit conversion;
  - (B) for or against a unit to dual conversion;
  - (C) for or against the establishment of a combined elementary district;
  - (D) for or against the establishment of a combined high school district;
  - (E) for or against the establishment of a combined unit district;
  - (F) for or against the establishment of a unit district from dual district territory exclusively;
  - (G) for or against the establishment of a unit district from both dual district and

unit district territory;

(H) for or against the establishment of a combined high school - unit district from a combination of one or more high school districts and one or more unit districts;

(I) for or against the establishment of a combined high school - unit district and one or more new elementary districts through a multi-unit conversion;

(J) for or against the establishment of an optional elementary unit district from a combination of a substantially coterminous dual district; or

(K) for or against dissolving and becoming part of an optional elementary unit district.

(2) A description of the territory comprising the districts proposed to be dissolved and those to be created, which, for an entire district, may be a general reference to all of the territory included within that district.

(3) A specification of the maximum tax rates for various purposes the proposed district or districts shall be authorized to levy for various purposes and, if applicable, the specifications related to the Property Tax Extension Limitation Law, in accordance with Section 11E-80 of this Code.

(4) A description of how supplementary State deficit difference payments made under subsection (c) of Section 11E-135 of this Code will be allocated among the new districts proposed to be formed.

(5) Where applicable, a division of assets and liabilities to be allocated to the proposed new or annexing school district or districts in the manner provided in Section 11E-105 of this Code.

(6) If desired, a request that at that same election as the reorganization proposition a school board or boards be elected on a separate ballot or ballots to serve as the school board or boards of the proposed new district or districts. Any election of board members at the same election at which the proposition to create the district or districts to be served by the board or boards is submitted to the voters shall proceed under the supervision of the regional superintendent of schools as provided in Section 11E-55 of this Code.

(7) If desired, a request that the referendum at which the proposition is submitted for the purpose of voting for or against the establishment of a unit district (other than a partial elementary unit district) include as part of the proposition the election of board members by school board district rather than at large. Any petition requesting the election of board members by district shall divide the proposed school district into 7 school board districts, each of which must be compact and contiguous and substantially equal in population to each other school board district. Any election of board members by school board district shall proceed under the supervision of the regional superintendent of schools as provided in Section 11E-55 of this Code.

(7.5) For the combining of Westmer Community Unit School District 203 and Aledo Community Unit School District 201, if desired, a request that the referendum at which the proposition is submitted for the purpose of voting for or against the establishment of a combined unit district include as part of the initial proposition the election of board members by a combination of members representing each of the forming unit districts and members at large rather than solely members at large and the election of all board members at large for each election thereafter. The format for the election of the new unit district school board must be defined in the petition. When a combination of board members representing each of the forming unit school districts and at-large formats are used, 3 members must be elected from each of the forming unit school districts and the remaining member must be elected at large.

(8) If desired, a request that the referendum at which the proposition is submitted for the purpose of voting for or against the establishment of a unit to dual conversion include as part of the proposition the election of board members for the new high school district (i) on an at large basis, (ii) with board members representing each of the forming elementary school districts, or (iii) a combination of both. The format for the election of the new high school board must be defined in the petition. When 4 or more unit school districts and a combination of board members representing each of the forming elementary school districts are involved and at large formats are used, one member must be elected from each of the forming elementary school districts. The remaining members may be elected on an at large basis, provided that none of the underlying elementary school districts have a majority on the resulting high school board. When 3 unit school districts and a combination of board members representing each of the forming elementary school districts are involved and at large formats are used, 2 members must be elected from each of the forming elementary school districts. The remaining member must be elected at large.

(9) If desired, a request that the referendum at which the proposition shall be submitted include a proposition on a separate ballot authorizing the issuance of bonds by the district or districts when organized in accordance with this Article. However, if the petition is submitted for the purpose of voting for or against the establishment of an optional elementary unit district, the petition may request only that the referendum at which the proposition is submitted include a proposition on a separate ballot authorizing the issuance of bonds for high school purposes (and not elementary purposes) by the district when organized in accordance with this Article. The principal amount of the bonds and the purposes of issuance, including a specification of elementary or high school purposes if the proposed issuance is to be made by a combined high school - unit district, shall be stated in the petition and in all notices and propositions submitted thereunder.

(10) A designation of a committee of ten of the petitioners as attorney in fact for all petitioners, any 7 of whom may at any time, prior to the final decision of the regional superintendent of schools, amend the petition in all respects (except that, for a unit district formation, there may not be an increase or decrease of more than 25% of the territory to be included in the proposed district) and make binding stipulations on behalf of all petitioners as to any question with respect to the petition, including the power to stipulate to accountings or the waiver thereof between school districts.

(c) The regional superintendent of schools shall not accept for filing under the authority of this Section any petition that includes any territory already included as part of the territory described in another pending petition filed under the authority of this Section.

(d)(1) Those designated as the Committee of Ten shall serve in that capacity until such time as the regional superintendent of schools determines that, because of death, resignation, transfer of residency from the territory, failure to qualify, or any other reason, the office of a particular member of the Committee of Ten is vacant. Upon determination by the regional superintendent of schools that these vacancies exist, he or she shall declare the vacancies and shall notify the remaining members to appoint a petitioner or petitioners, as the case may be, to fill the vacancies in the Committee of Ten so designated. An appointment by the Committee of Ten to fill a vacancy shall be made by a simple majority vote of the designated remaining members.

(2) Failure of a person designated as a member of the Committee of Ten to sign the petition shall not disqualify that person as a member of the Committee of Ten, and that person may sign the petition at any time prior to final disposition of the petition and the conclusion of the proceedings to form a new school district or districts, including all litigation pertaining to the petition or proceedings.

(3) Except as stated in item (10) of subsection (b) of this Section, the Committee of Ten shall act by majority vote of the membership.

(4) The regional superintendent of schools may accept a stipulation made by the Committee of Ten instead of evidence or proof of the matter stipulated or may refuse to accept the stipulation, provided that the regional superintendent sets forth the basis for the refusal.

(5) The Committee of Ten may voluntarily dismiss its petition at any time before the petition is approved by either the regional superintendent of schools or State Superintendent of Education.

There being no further amendments, the foregoing Amendment No. 2 was ordered engrossed; and the bill, as amended, was again advanced to the order of Third Reading.

### HOUSE JOINT RESOLUTIONS CONSTITUTIONAL AMENDMENTS SECOND READING

HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 42 was taken up and read in full a second time and held on the order of Second Reading.

### INTRODUCTION AND FIRST READING OF BILL

The following bills were introduced, read by title a first time, ordered reproduced and placed in the Committee on Rules:

HOUSE BILL 6331. Introduced by Representative Poe, AN ACT concerning appropriations.

### HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

#### HOUSE RESOLUTION 1150

Offered by Representative Lindner:

WHEREAS, Chemistry is essential to human life, through applications such as agriculture, the protection of public health, and innovative technologies that save energy and improve quality of life; and

WHEREAS, The products of chemistry can pose risks that, if improperly controlled or regulated, can threaten human health or the environment; and

WHEREAS, The Toxic Substances Control Act (TSCA) of 1976 was enacted by Congress to give the

United States Environmental Protection Agency the authority to require testing and to impose restrictions on industrial chemicals produced or imported into the United States; and

WHEREAS, Under its TSCA authority the U.S. EPA has required testing of chemicals that may pose a risk to the environment or to human-health, requires reporting of substantial risks to human health and the environment from chemicals, and can ban the manufacture and import of those chemicals that pose such risks; and

WHEREAS, Advances in technology now allow the detection of chemicals at very low levels in the environment and the human body, at levels that until recently were unable to be detected; and

WHEREAS, Analytical testing has become so sophisticated that a National Academy of Sciences/National Research Council Committee on Human Biomonitoring has declared that tremendous challenges surround the use of biomonitoring information because the ability to detect chemicals in the body far exceeds the ability to determine what such data means to public health; and

WHEREAS, The U.S. Centers for Disease Control has cautioned that the mere presence of a chemical in the human body is not an indication that the chemical causes disease; that toxicity of a chemical is related to its dose or concentration in addition to a person's individual susceptibility; and

WHEREAS, Regulations on the production and import of chemicals is best addressed at the federal level to avoid disruptions in trade and commerce; and

WHEREAS, TSCA provides U.S. EPA the authority and flexibility to adapt regulatory controls on chemicals as the science of detection and risk evolves; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the U.S. EPA and the Congress of the United States ensure that the Toxic Substances Control Act of 1976 provides the necessary statutory and regulatory controls necessary to protect human health and the environment from the risks of industrial chemicals; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Majority Leader of the United States Senate, the Minority Leader of the United States Senate, the Speaker of the United States House of Representatives, the Minority Leader of the United States House of Representatives, and to each member of the Illinois Congressional delegation.

#### HOUSE JOINT RESOLUTION 122

Offered by Representative Holbrook:

WHEREAS, It is in our society's best interest to protect the health, safety and standard of living of its citizens; and

WHEREAS, Too many of us have directly experienced or know about the consequences of our flawed trade system: massive job losses, devastated communities and staggering national deficits; and

WHEREAS, The price of cheap imports is too expensive when those imports unfairly take away millions of jobs, outsource production and lower our quality of life by lowering wages, harming the environment and now even threatening our very health and safety; and

WHEREAS, Not only have cheap imports from bad trade deals lowered our living standards here but cheap and toxic imports also harm workers and the environment in developing countries like China, where workers often toil in dangerous, sweatshop conditions; and

WHEREAS, Our markets have been overflowing with an influx of harmful products like toxic toys, defective passenger tires, poisoned pet-foods and other tainted goods, in particular from countries like China, where there are few, if any, effective labor, environmental or health and safety standards; and

WHEREAS, The current Administration has failed to adequately enforce health, safety, labor or environmental standards on imported products that may cause harm to the American public and has not adequately addressed the risk of such harm by requiring importers to show that they have sufficient financial resources to cover the costs of product recalls and the damages caused to the public resulting from defective products that they bring into the United States; and

WHEREAS, The current Administration has failed to adequately enforce our trade laws to protect our jobs and communities from the devastating consequences of imports from developing countries like China who do not play by fair competition rules; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-FIFTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we implore the United States Congress to meaningfully address the unsafe toxic imports that threaten our families and

communities; and be it further

RESOLVED, That corporations producing and importing products should be held accountable if they place greater value on profits over the health and safety of our families and communities, and at the expense of our jobs, labor and environmental standards and our living standards; and be it further

RESOLVED, That tougher trade laws are needed to prevent the further loss of American jobs and the further erosion of our standard of living; and be it further

RESOLVED, That a copy of this resolution be delivered to the Majority Leader of the United States Senate, the Minority Leader of the United States Senate, the Speaker of the United States House of Representatives, the Minority Leader of the United States House of Representatives, and to each member of our State's congressional delegation.
