#### HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

#### **HOUSE RESOLUTION 43**

Offered by Representative Chapa LaVia:

WHEREAS, Autism spectrum disorder (ASD) is a complex developmental disability that causes problems with social interaction and communication; symptoms usually start before age 3 and can cause delays or problems in many different skills that develop from infancy to adulthood; and

WHEREAS, One of the primary characteristics of ASD is its interference with a person's ability to communicate, interact socially with others, or develop peer relationships; and

WHEREAS, Parents and teachers of children with disabilities recognize the social isolation these children face, isolation that is well-documented by researchers; and

WHEREAS, While the severity of the disorder and social impairment varies widely, in some cases, certain symptoms of the disorder may be relieved by pairing a public school student with ASD with a student "peer buddy" whom the school staff has identified as a good match and a positive role model for other students; and

WHEREAS, Peer buddy programs have been successful in many school districts in this State, and their use should be encouraged throughout this State; and

WHEREAS, Pairing a student with ASD with a student partner whose role is to facilitate interactions with school staff and new peer groups may promote academic and social inclusion; and

WHEREAS, At the same time that researchers are proving the need children with disabilities have for more and better social contacts, they are also finding that interaction with peers with disabilities has positive impacts on those who do not have disabilities; and

WHEREAS, It is appropriate to urge the State Board of Education to encourage the establishment of peer buddy programs in school districts to pair students with ASD and other developmental disabilities with appropriate student partners; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the State Board of Education, in consultation with the Executive Director of the Illinois Council on Developmental Disabilities and representatives of entities that promote awareness about autism and provide programs and services to people with autism, to encourage the establishment of a peer buddy program in each school district for children with autism spectrum disorder enrolled in elementary, middle, and high school, including training for students and staff affiliated with the program; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the State Board of Education, the Autism Society of Illinois, Giant Steps, Little Friends Center for Autism-Naperville, and the Illinois

Council on Developmental Disabilities.

#### **HOUSE RESOLUTION 45**

Offered by Representative Ford:

WHEREAS, The United States continues to experience an unprecedented number of mortgage foreclosures and these, in turn, have contributed to a real estate market that has declined in a precipitous fashion; and

WHEREAS, When a residential mortgagor defaults on his or her mortgage, it is common for the lending institution involved to obtain the property back from the mortgagor by way of receiving a deed in lieu of foreclosure or by foreclosing and then purchasing the property at a foreclosure judicial sale; and

WHEREAS, In recent years, it is not unusual for a lending institution to have a large inventory of foreclosed properties and this has often led to a lending institution repeatedly resorting to selling a foreclosed property at a "short sale" price, which means that the sale price for the individual home is significantly less than the mortgagor's purchase price or even the amount of the mortgagor's outstanding loan at the time of the foreclosure; and

WHEREAS, The credit rating of a person whose home has been foreclosed is often very low and this means that even if the person could afford a more modestly priced property than the foreclosed home, the former homeowner is unable to qualify for a loan under today's standards; and

WHEREAS, If a lending institution that expects to sell a foreclosed residential property at a "short sale" price were compelled to offer to the mortgagor modifications in the terms of the mortgagor's home mortgage loan, the mortgagor would, in many cases, be able to afford the home under the modified loan terms and remain in his or her home; in that case, the lending institution would avoid adding to its foreclosed properties inventory, the residential mortgagor might be able to remain in his or her home, the real estate market would be improved because fewer "short sale" properties would be depressing home prices on the market, neighborhood blight and crime would be reduced due to the decline in empty and vandalized homes, and all of these circumstances would tend to stem the tide of neighborhood deterioration that is due to the large number of foreclosures and vacancies; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress to pass legislation that would compel any lending institution, before foreclosing on a residential property occupied by a mortgagor, to provide the mortgagor with modifications to the home loan that are reasonable for the mortgagor and that include, but are not limited to, an interest rate reduction, a term extension, or other changes to the elements of the home loan, provided that the homeowner is interested in remaining in the home and qualified for the modified loan terms; and be it further

RESOLVED, That suitable copies of this resolution be presented to President Barack Obama, the Speaker of the United States House of Representatives, the President pro tempore of the United States Senate, and each member of the Illinois congressional delegation.

#### **HOUSE RESOLUTION 47**

Offered by Representative D'Amico:

WHEREAS, According to the World Health Organization, 1.1 billion people do not have access to safe water supplies, 2.6 billion people do not have access to improved sanitation, and 3.1 million children die each year from water-related diseases; and

WHEREAS, All people and all countries are impacted by access to water and sanitation; and

WHEREAS, Plumbing is vital to global health and improved quality of life; and

WHEREAS, Plumbers play an important role in ensuring the safety of the citizens of Illinois and all people; and

WHEREAS, Water conservation is critical in helping to ensure access to water in the future; and

WHEREAS, The United Nations has set a goal to reduce by half the number of people without access to

safe drinking water and basic sanitation by 2015; and

WHEREAS, Increased education and awareness of water and sanitation issues are needed; and

WHEREAS, The World Plumbing Council is an organization comprised of plumbing industry professionals around the globe; and

WHEREAS, The World Plumbing Council has designated March 11, 2011 as World Plumbing Day to help the general public better understand the vital role the plumbing industry plays in protecting public health and safety, the extent to which it helps limit mankind's environmental footprint, and the other important work performed by contractors, inspectors, installers, engineers, and manufacturers that is often taken for granted; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate March 11, 2011 as "World Plumbing Day" in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the World Plumbing Council as a symbol of our respect and esteem.

#### HOUSE JOINT RESOLUTION 6

Offered by Representative Chapa LaVia:

WHEREAS, Studies have shown that school districts operate more efficiently with a set ideal enrollment of students, whether it is deconsolidating large districts or consolidating small districts; and

WHEREAS, The State of Illinois currently has 869 public school districts, the third most school districts in the nation next to California and Texas; and

WHEREAS, City of Chicago School District 299 has an enrollment of 404,589 students and 611 schools in one district; and

WHEREAS, There are 82 school districts in the State of Illinois with an enrollment of less than 200 students; and

WHEREAS, During this time of fiscal crisis, school district reorganization has the potential to save valuable State dollars and use that money more effectively; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there is created the School District Realignment and Consolidation Task Force within the State Board of Education; and be it further

RESOLVED, That the task force is charged with examining the number of school districts in this State, the optimal amount of enrollment for a school district, where consolidation and realignment would be beneficial, reducing the money spent on duplication of efforts, improving the education of students by having less obstacles between qualified teachers and their students, and lowering the property tax burden; and be it further

RESOLVED, That the task force shall be comprised of the following members, all of whom shall serve without compensation, but shall be reimbursed for their reasonable and necessary expenses from funds appropriated for that purpose:

- (1) members appointed by the State Board of Education;
- (2) a representative appointed by the Speaker of the House of Representatives;
- (3) a representative appointed by the Minority Leader of the House of Representatives;
- (4) a representative appointed by the President of the Senate;
- (5) a representative appointed by the Minority Leader of the Senate;
- (6) a representative of a statewide professional teachers' organization appointed by the head of that organization;
- (7) a representative of a different statewide professional teachers' organization appointed by the head of that organization;
- (8) a representative of a statewide organization that represents school boards appointed by the head of that organization;
- (9) a representative of a statewide organization representing principals appointed by the head of that organization;
- (10) a representative of City of Chicago School District 299 appointed by the general

superintendent of schools;

- (11) a representative of an association representing school business officials appointed by the head of that association;
- (12) a representative of an association representing school administrators appointed by the head of that association;
- (13) a representative from an organization representing large unit school districts appointed by the head of that organization;
- (14) a representative from the Chicago Board of Education appointed by the Chicago Board of Education; and
- (15) a representative from an organization representing administrators of special education appointed by the head of that organization; and be it further

RESOLVED, That the members of the task force shall be reimbursed for their travel expenses from appropriations to the State Board of Education available for that purpose and subject to the rules of the appropriate travel control board; and be it further

RESOLVED, That the State Board of Education shall provide administrative and other support to the task force; and be it further

RESOLVED, That the task force shall hold public hearings and shall report its findings and recommendations to the General Assembly on or before July 1, 2012; and that upon filing its report the task force is dissolved.

#### HOUSE JOINT RESOLUTION 7

Offered by Representative William Davis:

WHEREAS, During the 96th General Assembly, the School Success Task Force was established pursuant to House Joint Resolution 5 for the purpose of examining issues and making recommendations related to current State Board of Education policies regarding suspensions, expulsions, and truancies and identifying different strategies and approaches, promoting professional development and other learning opportunities, and supporting community-based organizations and parents; and

WHEREAS, Further work is needed on these issues; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the School Success Task Force is extended; and be it further

RESOLVED, That the School Success Task Force shall submit a report, as established in its authorizing resolution, before December 31, 2011; and be it further

RESOLVED, That with this reporting extension, the School Success Task Force shall continue to operate pursuant to its enabling resolution.

#### HOUSE JOINT RESOLUTION 8

Offered by Representative Bradley:

WHEREAS, The reaction time of motorists using cellular phones slows dramatically, increasing the risk of automobile accidents and tying up traffic generally; and

WHEREAS, Cell phone distraction causes 2,600 deaths and 330,000 injuries in the United States every year; and

WHEREAS, The numbers of fatalities and injuries may be higher because data on cell phone use by motorists is limited; and

WHEREAS, Increasing cell phone use can be expected to cause the annual death estimate to rise; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that State, county, and municipal law enforcement personnel are requested to include in their police reports of

automobile accidents information pertaining to if an accident involved the use of a cellular phone; and be it further

RESOLVED, That the Department of Transportation shall request from State, county, and municipal law enforcement agencies statistics on the use of cellular phones leading to automobile accidents over a two-year period beginning January 1, 2012, and report the findings to the General Assembly no later than September 1, 2014; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Department of Transportation and appropriate county and municipal law enforcement agencies.
