With the consent of the affected members, Representative Bellock was removed as principal sponsor, and Representative Durkin became the new principal sponsor of HOUSE RESOLUTION 122.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 106

Offered by Representative Feigenholtz:

WHEREAS, The Illinois Department of Human Services (DHS) has notified the Illinois Alcoholism and Drug Dependence Association (IADDA) that all GRF funds for addiction prevention and treatment will be eliminated as of March 15, 2011; and

WHEREAS, Providers of addiction prevention and treatment services have been notified of these impending cuts with less than 30 days' notice; and

WHEREAS, Nearly 80% of the clients in the addiction treatment system are not eligible for Medicaid services and will not be able to access addiction treatment; and

WHEREAS, These cuts will result in an immediate loss of services for 55,830 treatment clients, and 229,536 youth will lose prevention services; and

WHEREAS, These cuts will shut down the State-funded addiction prevention and treatment system, resulting in a loss of more than 5,000 jobs; and

WHEREAS, The residual impact to the State's economy far exceeds the immediate impact that will occur on March 15, 2011; and

WHEREAS, 5,000 new unemployed staff will be an additional burden on the State's unemployment system; and

WHEREAS, The Alcoholism and Other Drug Abuse and Dependency Act mandates that DHS design, coordinate, and fund a comprehensive and coordinated community-based and culturally and gender-appropriate array of services throughout the State for the prevention, intervention, treatment, and rehabilitation of alcohol and other drug abuse and dependency that is accessible and addresses the needs of at-risk or addicted individuals and their families; and

WHEREAS, The Alcoholism and Other Drug Abuse and Dependency Act mandates that offenders have the right to an assessment and can be sentenced to treatment services in the community instead of being sent to prison; and

WHEREAS, Since 69% of African-Americans and 76% of Latinos rely on publicly funded treatment, these cuts will disproportionately affect minority communities; and

WHEREAS, These cuts will force Illinoisans with no access to addiction services to turn to local hospital emergency departments flooding emergency rooms, increasing wait times, and swelling medical costs; and

WHEREAS, Local law enforcement will bear the burden of coping with Illinoisans who need treatment but will instead end up in local jails or homeless because they have nowhere to turn; and

WHEREAS, Already overburdened local justice and social service systems will become overwhelmed with people locked out of critical treatment services; and

WHEREAS, The average cost of addiction treatment in Illinois is \$4,425 per person; the average annual cost of incarceration is \$21,911 per person; and

WHEREAS, Without funding for addiction prevention and treatment, costs associated with corrections will drastically increase; and

WHEREAS, Cuts will escalate domestic violence, child abuse, accidents, and fatalities; and

WHEREAS, DHS estimates 9,000 to 10,000 Illinois residents die each year from accidental injuries and 40% of these deaths are related to the use of alcohol; and

WHEREAS, \$907 million (73%) of the total spending on child welfare is spent as a result of untreated addiction; and

WHEREAS, Fetal Alcohol Spectrum Disorder costs the State of Illinois an estimated \$329 million dollars annually or \$27 million per month; and

WHEREAS, DHS estimates the annual Illinois statewide economic costs associated with alcohol, tobacco, and other drug-related mortality is in excess of \$3.5 billion; and

WHEREAS, DHS estimates that over 60% of all State-funded addiction prevention programs are classified as evidence-based; and

WHEREAS, DHS has found the following outcomes are achieved in the prevention system:

- (1) Increased alcohol, tobacco, and other drug resistance skills among program participants;
- (2) Increased perceptions that alcohol, tobacco, and other drug use is harmful;
- (3) Increased drug knowledge;
- (4) Delayed alcohol use;
- (5) Delayed intent to use alcohol and inhalants;
- (6) Decreased perceptions that peers are using illicit drugs;
- (7) Decreased perceptions that adults are using illicit drugs; and

WHEREAS, DHS has implemented a system of performance-based contracts for addiction treatment that focuses on client engagement, retention in treatment, and continuity of care; and

WHEREAS, DHS has data confirming that more than 97% of all clients discharged from Illinois' treatment system are arrest-free as opposed to the national average of only 89% at discharge; and

WHEREAS, DHS has data confirming that more than 81% of all clients discharged from Illinois' treatment system are alcohol-free at discharge as compared to the national average of 80%; and

WHEREAS, DHS has data confirming that more than 74% of all clients discharged from Illinois' treatment system are drug-free at discharge, which is the same as the national average; and

WHEREAS, For every dollar spent on prevention, states save up to \$10 in treatment and recovery costs alone; and

WHEREAS, For every dollar spent on treatment, the State saves up to \$14 in healthcare, criminal justice, and child welfare costs; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the General Assembly deems that these draconian cuts eliminating all non-Medicaid addiction treatment and prevention will decimate the Illinois system and are a violation of Section 25-5 of the Alcoholism and Other Drug Abuse and Dependency Act which provides that DHS "shall develop, fund and implement a comprehensive, statewide community-based system for the provision of a full array of intervention, treatment and aftercare for persons suffering from alcohol and other drug abuse and dependency"; and be it further

RESOLVED, That the elimination of State funding for addiction treatment and prevention shall be immediately halted; and be it further

RESOLVED, That suitable copies of this resolution shall be delivered to the Governor and the Secretary of the Department of Human Services.

HOUSE RESOLUTION 107

Offered by Representative Rose:

WHEREAS, Local communities are facing a budget crisis for critical services; and

WHEREAS, The Illinois Emergency Management Agency determines the amount of funding available for the Emergency Management Agency grant program prior to the award of any grants, based on the level of funding provided by the Federal Emergency Management Agency; and

WHEREAS, Some local communities receive very little compensation from this grant; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Illinois Emergency Management Agency examine the way it distributes these funds to insure equitable distribution of the funds; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Illinois Emergency Management Agency.

HOUSE RESOLUTION 108

Offered by Representative Flowers:

WHEREAS, The mission of the Illinois Professionals Health Program (IPHP) is to support and guide Illinois health care professionals to wellness and healing, thereby promoting safe professional practice and enriching the lives of healers and their patients; and

WHEREAS, IPHP is available to assist and advocate for a number of health care professionals, including physicians, nurses, dentists, pharmacists, and chiropractors; and

WHEREAS, The types of problems that referrals and participants typically face include allegations or actual instances of addictions of all kinds, disruptive behavior, boundary violations, sexual misconduct, and physical and emotional illness; and

WHEREAS, The IPHP, which was initially developed by the Illinois State Medical Society, has no disciplinary authority; and

WHEREAS, The Illinois Department of Financial and Professional Regulation has approved the IPHP as a monitoring and support service and routinely refers health care professionals for participation in the IPHP; and

WHEREAS, According to news reports, the IPHP has received \$234,275 from the Illinois Department of Financial and Professional Regulation since fiscal year 2009 to monitor nurses and pharmacists and the Illinois Department of Financial and Professional Regulation has more than 100 confidential "Agreements of Care, Counseling, or Treatment" in place that allow physicians and other health workers to submit to private monitoring instead of public discipline; and

WHEREAS, Concerns have been raised as to whether adequate accountability and oversight exists over the IPHP to ensure patient safety; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Auditor General is directed to conduct a management audit of the Illinois Department of Financial and Professional Regulation's use and monitoring of the Illinois Professionals Health Program during fiscal years 2009 through 2011; and be it further

RESOLVED, That the audit shall include, but need not be limited to, the following determinations:

(1) whether the IPHP is providing the services contracted for by the Department and is adequately monitoring the health professionals' compliance with treatment and rehabilitation plans;

(2) whether other requirements established by the contract between the Department and the IPHP are being met;

(3) whether health professionals who do not comply with treatment and rehabilitation plans established by the IPHP are appropriately referred to the Department and whether the Department takes disciplinary action, if applicable; and

(4) whether the Department has assessed how well the IPHP is performing, such as by determining that the health professionals receiving treatment and rehabilitation services through the IPHP do not pose a risk to the safety and well-being of patients; and be it further

RESOLVED, That the Department of Financial and Professional Regulation, the Illinois Professionals Health Program, and any other entity having information relevant to this audit cooperate fully and promptly with the Auditor General's Office in the conduct of this audit; and be it further

RESOLVED, That the Auditor General commence this audit as soon as possible and report findings and recommendations upon completion in accordance with the provisions of Section 3-14 of the Illinois State Auditing Act.

HOUSE RESOLUTION 111

Offered by Representative Nekritz:

WHEREAS, Social workers are highly skilled and motivated professionals who dedicate their careers to helping people make positive changes in their lives; and

WHEREAS, There are more than 640,000 trained social work professionals in the United States and more than 12,000 in Illinois who work tirelessly in private and public social services agencies, hospitals, hospices, schools, universities, legislatures, private practices, corporations, and the military; and

WHEREAS, The social work profession works to change systems and customs that limit the ability of vulnerable individuals and groups to lead fulfilling and productive lives; and

WHEREAS, Schools of social work train socially-conscious people to make a real difference in the world through service and leadership; and

WHEREAS, Social workers strengthen communities, expand options, and work to facilitate humane changes in policies and legislation that improve the lives of everyone; and

WHEREAS, Social workers begin each day believing they will give an individual, a family, or a community renewed hope in the future; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the month of March as Social Work Month in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the National Association of Social Workers-Illinois Chapter with our sincere appreciation for their efforts.

HOUSE RESOLUTION 112

Offered by Representative Senger:

WHEREAS, Current federal law allows a home mortgage interest deduction for the interest paid on a taxpayers primary and secondary homes, and current proposals to reform or eliminate the mortgage interest deduction are being debated; and

WHEREAS, Deductions for mortgage interest have been part of the tax code since its inception in 1913, and eliminating the mortgage interest deduction would have a negative impact on the Illinois economy, job creation, and home ownership; and

WHEREAS, Eliminating the deduction would be harmful to current home owners and future home buyers; the mortgage interest deduction is a cornerstone of the American housing policy; and

WHEREAS, When purchasing a home, buyers often rely on the benefits of the mortgage interest deduction; without the deduction, many families would not be able to afford their homes; and

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Congress to insure that the mortgage interest tax credit is not eliminated and that working families continue to receive this benefit to support economic growth and encourage home ownership; and be it further

RESOLVED, That suitable copies of this resolution be provided to the President of the United States, the Majority Leader and Minority Leader of the United States Senate, the Speaker and Minority Leader of the United States House of Representatives, and each member of the Illinois congressional delegation.

RESOLVED, That all Illinois residents and visitors are encouraged to celebrate this week by visiting the Historical Markers Web site at www.historyillinois.org, learning about historic sites in their locales, visiting those sites, reflecting on their importance in history, communicating with others about them, and

attending ceremonies commemorating them; and be it further

RESOLVED, That the members of the Illinois House of Representatives are encouraged to participate in the events of this week with their colleagues in the Illinois State Capitol and their constituents in their home districts.

HOUSE JOINT RESOLUTION 15

Offered by Representative Pritchard:

WHEREAS, The State is confronted with an unprecedented fiscal crisis, including a massive structural deficit, which threatens to restrict the State's future ability to maintain essential services for the public health, safety, and welfare of its residents and its present ability to meet its prior obligations with regard to essential services already provided; and

- (2) one member of the Senate and one Illinois resident appointed by the President of the Senate;
- (3) one member of the House of Representatives and one Illinois resident appointed by the House Minority Leader;
- (4) one member of the Senate and one Illinois resident appointed by the Senate Minority Leader; and
- (5) two Illinois residents appointed by the Governor; and be it further

RESOLVED, That the Task Force shall elect two co-chairpersons from their membership, one from each party, and shall meet not less often than once per month at the call of the co-chairs; and be it further

RESOLVED, That the members of the Task Force shall serve without compensation but shall be reimbursed for their reasonable and necessary expenses from funds appropriated for that purpose; and be it further

RESOLVED, That the Task Force shall develop a package of proposals that is revenue neutral, as verified by the Commission on Government Forecasting and Accountability; and be it further

RESOLVED, That the Task Force shall consider:

- (1) how to reduce dependency on the property tax to fund Illinois schools;
- (2) recent changes in the revenue strategies enacted by other states;
- (3) broadening the sales tax schedule in a manner that balances new goods and services with a reduction in the overall tax rate;
- (4) how to reduce dependency on the estate tax; and
- (5) the implementation of a progressive income tax; and be it further

RESOLVED, That the Department of Revenue shall provide administrative and other support to the Task Force; and be it further

RESOLVED, That the Task Force shall report its findings to the General Assembly on or before December 31, 2011, and shall cease to exist thereafter.

Representative May introduced the following:

**HOUSE JOINT RESOLUTION
CONSTITUTIONAL AMENDMENT 21**

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 8 to Article III of the Illinois Constitution as follows:

ARTICLE III

SUFFRAGE AND ELECTIONS

SECTION 8. RECALL OF EXECUTIVE OFFICERS, MEMBERS OF THE GENERAL ASSEMBLY, AND LOCAL OFFICERS

(a) Electors may petition for the recall of an executive branch officer as identified in Section 1 of Article V except for the Governor, a member of the General Assembly, or a salaried elected officer of a unit of local government. If the recall petition is valid, on a separate ballot the question "Shall (name of person) be recalled from the office of (office)" must be submitted to the electors, along with the names of any candidates certified for the successor election, at a special election called by the State Board of Elections or at a regularly scheduled election to occur not more than 100 days after the date of certification of the recall petition. The officer or member subject to recall may be a candidate in the successor election.

(b) An executive branch officer, a member of the General Assembly, or a salaried elected officer of a unit of local government is immediately removed upon certification of the recall election results if a majority of the electors voting on the question vote to recall the officer or member. If an officer or member is recalled, the candidate who receives the highest number of votes in the successor election is elected successor for the balance of the term. Once a recall election petition is certified, the petition may not be withdrawn and another recall petition may not be initiated against that officer or member during the remainder of his or her current term of office.

(c) Any elector of the State, or the applicable Legislative or Representative District or unit of local government, may file an affidavit with the State Board of Elections providing notice of intent to circulate a petition to recall an officer or member no sooner than 6 months after the beginning of the officer's or member's current term of office. An affidavit must be filed by an elector of the Legislative or Representative District or unit of local government for which the recall petition will be circulated. The affidavit must identify the name of the officer or member and the office to be recalled, the name and address of the proponents of the recall petition, and the date of filing with the State Board of Elections. A recall petition shall not be circulated prior to filing the affidavit, and a recall petition must be filed with the State Board of Elections no later than 160 days after filing the affidavit.

(d) A petition to recall an executive branch officer must include signatures of electors of the State equal to at least 12% of the total votes cast for the office in the election at which the officer or member was elected, with signatures equal to at least 1% of the vote for the office from at least 5 separate counties. A petition to recall a member of the General Assembly must be signed by electors of the applicable Legislative District or Representative District equal to at least 20% of the total votes cast for the office in

the election at which the member was elected. A petition to recall a salaried officer of a unit of local government must be signed by electors of the unit of local government equal to at least 20% of the total votes cast for the office in the election at which the officer was elected. The form, circulation, and manner of filing a recall petition shall comply with the requirements provided by law for a statewide advisory public question, except the deadlines set forth in this Section.

(e) A recall petition is valid unless an objection is made within 45 days after the date the petition is filed, and an objection to the recall petition may be made in the same manner as to a candidate for the office subject to recall. The State Board of Elections shall certify the recall petition not more than 105 days after the date the recall petition is filed. Any recall petition or election pending on the date of the next general election at which a candidate for the office subject to recall is elected is moot.

(f) If a recall election is initiated, the name of no successor candidate may appear on the ballot unless a nominating petition has been filed with the State Board of Elections no more than 40 days after filing of the recall petition. The nominating petition of an established party candidate must contain the same number of signatures and be circulated in the same manner as an established party candidate for nomination to the office subject to recall, except the petition must be circulated no more than 40 days prior to the last day for filing nomination petitions. The nominating petition of an independent or new party candidate must contain the same number of signatures and be circulated in the same manner as an independent or new party candidate, respectively, for election to the office subject to recall, except the petition must be circulated no more than 40 days prior to the last day for filing nomination petitions. A nominating petition may be objected to in the same manner as a candidate for the office subject to recall, unless otherwise provided by law. The State Board of Elections shall certify a valid nominating petition not more than 105 days after the date the recall petition is filed.

(g) An election to determine whether to recall an executive officer, a member of the General Assembly, or an officer of a unit of local government and to elect a successor shall be proclaimed by the State Board of Elections and held not less than 60 days and no more than 100 days after the date of certification of the recall petition.

(h) The provisions of this Section are self-executing and judicially enforceable.

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act.

The foregoing HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 21 was taken up, read in full a first time, ordered reproduced and placed in the Committee on Rules.

Representative Brown introduced the following:

HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 22

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article V of the Illinois Constitution by changing Sections 1, 2, 3, 6, and 7 and by repealing Sections 4 and 14 as follows:

ARTICLE V THE EXECUTIVE

SECTION 1. OFFICERS

The Executive Branch shall include a Governor, ~~Lieutenant Governor~~, Attorney General, Secretary of State, Comptroller and Treasurer elected by the electors of the State. They shall keep the public records and maintain a residence at the seat of government during their terms of office.

SECTION 2. TERMS

These elected officers of the Executive Branch shall hold office for four years beginning on the second Monday of January after their election and, ~~except in the case of the Lieutenant Governor~~, until their successors are qualified. They shall be elected at the general election in 1978 and every four years

thereafter.

SECTION 3. ELIGIBILITY

To be eligible to hold the office of Governor, ~~Lieutenant Governor~~, Attorney General, Secretary of State, Comptroller or Treasurer, a person must be a United States citizen, at least 25 years old, and a resident of this State for the three years preceding his or her election.

SECTION 4. JOINT ELECTION ~~(REPEALED)~~

~~In the general election for Governor and Lieutenant Governor, one vote shall be cast jointly for the candidates nominated by the same political party or petition. The General Assembly may provide by law for the joint nomination of candidates for Governor and Lieutenant Governor.~~

SECTION 6. GUBERNATORIAL SUCCESSION

(a) In the event of a vacancy, the order of succession to the office of Governor or to the position of Acting Governor shall be ~~the Lieutenant Governor~~, the elected Attorney General, the elected Secretary of State, and then as provided by law.

(b) If the Governor is unable to serve because of death, conviction on impeachment, failure to qualify, resignation or other disability, the office of Governor shall be filled by the officer next in line of succession for the remainder of the term or until the disability is removed.

(c) Whenever the Governor determines that he may be seriously impeded in the exercise of his or her powers, he or she shall so notify the Secretary of State and the officer next in line of succession. The latter shall thereafter become Acting Governor with the duties and powers of Governor. When the Governor is prepared to resume office, he or she shall do so by notifying the Secretary of State and the Acting Governor.

(d) The General Assembly by law shall specify by whom and by what procedures the ability of the Governor to serve or to resume office may be questioned and determined. The Supreme Court shall have original and exclusive jurisdiction to review such a law and any such determination and, in the absence of such a law, shall make the determination under such rules as it may adopt.

SECTION 7. VACANCIES IN OTHER ELECTIVE OFFICES

If the Attorney General, Secretary of State, Comptroller or Treasurer fails to qualify or if his or her office becomes vacant, the Governor shall fill the office by appointment. The appointee shall hold office until the elected officer qualifies or until a successor is elected and qualified as may be provided by law and shall not be subject to removal by the Governor. ~~If the Lieutenant Governor fails to qualify or if his office becomes vacant, it shall remain vacant until the end of the term.~~

SECTION 14. LIEUTENANT GOVERNOR - DUTIES ~~(REPEALED)~~

~~The Lieutenant Governor shall perform the duties and exercise the powers in the Executive Branch that may be delegated to him by the Governor and that may be prescribed by law.~~

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to add Section 8.1 to Article IV and to add Sections 2.1 and 2.2 to Article VIII of the Illinois Constitution as follows:

ARTICLE IV
THE LEGISLATURE

SECTION 8.1. PASSAGE OF REVENUE BILLS

A bill that would result in the increase of revenue to the State by an increase of a tax on or measured by

income or by an increase of a tax on or measured by the selling price of any item of tangible personal property may become law only with the concurrence of three-fifths of the members elected to each house of the General Assembly.

ARTICLE VIII
FINANCE

SECTION 2.1. LIMITATIONS ON APPROPRIATIONS AND TRANSFERS

(a) For the fiscal year ending in 2014 and each fiscal year thereafter, aggregate appropriations and transfers from the general funds are limited as provided in this Section. "General funds" include the General Revenue Fund, the Common School Fund, the General Revenue Common School Special Account Fund, and the Education Assistance Fund and any fund utilized for general or operating expenses. "Appropriations and transfers" do not include (i) reappropriations from a previous fiscal year, (ii) those made for debt service payments, and (iii) those made to a budget stabilization fund.

(b) Aggregate fiscal year appropriations and transfers from the general funds may not exceed the limitation amount. For the fiscal year ending in 2014, the limitation amount is the aggregate amount of appropriations and transfers from the general funds in the fiscal year ending in 2010, as adjusted as provided in this subsection (b) for the fiscal years ending in 2011, 2012, and 2013. For the fiscal year ending in 2015 and each fiscal year thereafter, the limitation amount is the aggregate amount of appropriations and transfers from the general funds in the previous fiscal year, as adjusted as provided in this subsection (b).

For the fiscal year after a fiscal emergency is declared under subsection (c) of this Section, the limitation amount is the aggregate amount of appropriations and transfers from the general funds in the fiscal year in which the fiscal emergency is declared minus the specific dollar amount by which the limitation amount was increased for the fiscal emergency, as adjusted as provided in this subsection (b).

The adjustment is the average annual percentage change in the average per capita personal income for Illinois for the 5 most recent calendar years for which data is available, as defined and reported by the United States Department of Commerce, or its successor.

(c) The Governor may declare a fiscal emergency by filing a declaration with the Secretary of State and copies with the Senate and House of Representatives. The declaration must be limited to only one State fiscal year, set forth compelling reasons for declaring a fiscal emergency, and request that the limitation amount for that fiscal year be increased by a specific dollar amount. If the Comptroller and Treasurer advise the General Assembly that they concur in the Governor's declaration, then by a record vote of three-fifths of the members elected to each house, the General Assembly, by law conditioned upon the approval of a majority of voters in the next general, primary, or special election, may authorize increased appropriations and transfers in a specific dollar amount that is no more than the increased amount requested by the Governor in the declaration. "Emergency" means extraordinary circumstances outside the control of the General Assembly, including catastrophic events, such as a natural disaster, terrorism, fire, war, and riot, and court orders or decrees.

(d) If the general funds revenues for a fiscal year exceed the limitation amount for that fiscal year, then those excess revenues must be deposited into the Past Due Paydown Fund, State Budget Stabilization Fund, and the Taxpayer Relief Fund as provided in subsections (e), (f), and (g).

(e) The Past Due Paydown Fund is established as a special fund in the State treasury and must be administered for the purposes identified in this Section. At the close of the lapse period for each fiscal year beginning in 2011, the State Comptroller shall identify the amount of General Fund unappropriated surplus above the Spending Growth Index limitation and transfer to the fund any amount necessary up to the total past due operating debt owed by the State as of the close of fiscal year 2010.

The General Assembly may authorize transfers, appropriations, and allocations from the fund only to fund the costs of paying down the remaining past due debt until such debt is zero. Any remaining funds shall be transferred to the State Budget Stabilization Fund.

(f) The State Budget Stabilization Fund is established as a special fund in the State treasury and must be administered for the purposes identified in this Section. At the close of the lapse period of each fiscal year, the State Comptroller shall identify the amount of General Fund unappropriated surplus above the expenditure limitation described in subsection (b) of this Section and above the amount necessary to fully fund and pay down the past due operating debt to zero. The fund may not exceed 8% of the total General Fund revenues received in the immediately preceding fiscal year.

The General Assembly may authorize transfers, appropriations, and allocations from the fund only to fund the costs of State government up to the expenditure limit calculated by law in years when State revenues are less than the amount necessary to finance the level of expenditures permitted by law.

Transfers require a three-fifths supermajority vote of the General Assembly.

The money in the fund may be invested as provided by law, with the earnings credited to the fund. At the close of every month during which the fund is at the 8% limitation, the State Comptroller shall transfer the excess to the Taxpayer Relief Fund.

(g) The Taxpayer Relief Fund is established as a special fund in the State treasury and must be administered for the purposes identified in this Section. At the close of the lapse period of each fiscal year, the State Comptroller shall identify the amount of General Fund unappropriated surplus above the State expenditure limitation and above the amount necessary to fully fund the Past Due Paydown Fund and the Budget Stabilization Fund.

By September 1st annually, the State Comptroller shall notify the Commission on Government Forecasting and Accountability and the Department of Revenue of the amount in the fund as a result of the transfers.

If the amount in the fund exceeds 1% of General Fund expenditures, then the General Assembly shall, by September 15th, enact legislation to provide for the refund to taxpayers of amounts in the fund. Refunds may take the form only of temporary or permanent broad-based tax rate reductions.

If the General Assembly does not enact legislation by September 15th to provide refunds, then the State Comptroller shall, by September 30th, notify the Department of Revenue of the amount in the fund. The Department of Revenue shall calculate a one-time bonus personal exemption refund. The amount of the personal exemption refund must be calculated by dividing the amount in the fund identified by the State Comptroller by the number of personal exemptions claimed on income tax returns filed for tax year beginning in the previous calendar year. The Department of Revenue shall issue a refund by October 30th to a taxpayer who filed an income tax return by April 15th of the same calendar year based on the number of exemptions claimed (times refund per exemption) on the taxpayer's return without regard to the taxpayer's tax liability for the year.

SECTION 2.2. OBLIGATIONS TO RETIREMENT SYSTEMS AND PENSION FUNDS

In each fiscal year, obligations of the State to retirement systems and pension funds created under the Illinois Pension Code must be met as provided in that Code.

(b) Changes, but changes in the salary of a member shall not take effect during the term for which he or she has been elected. An increase in the cost of living adjustment of a member shall not take effect during the term of which he or she has been elected.

(c) The salary or cost of living adjustment of members of the General Assembly may be increased by a joint resolution adopted by two-thirds of the members elected to each house of the General Assembly. The joint resolution must also be approved by a majority of the electors voting on the question at the next general election following the adoption of the joint resolution.

A petition shall have been signed by the petitioning electors not more than 150 days after an affidavit has been filed with the State Board of Elections providing notice of intent to circulate a petition to recall the officer ~~Governor~~. The affidavit may be filed no sooner than 6 months after the beginning of the officer's ~~Governor's~~ term of office. The affidavit shall have been signed by the proponent of the recall petition, at least 20 members of the House of Representatives, and at least 10 members of the Senate, with no more than half of the signatures of members of each chamber from the same established political party.

(a-5) In addition, electors may petition for the recall of a member of the General Assembly. A petition to recall a member of the General Assembly must be signed by electors of the respective Legislative District or Representative District equal to at least 20% of the total votes cast for the office in the election at which the member was elected. The form, circulation, and manner of filing a recall petition shall comply with the requirements provided by law for a statewide advisory public question, except the deadlines set forth in this Section.

(b) The form of the petition, circulation, and procedure for determining the validity and sufficiency of a petition shall be as provided by law. If the petition is valid and sufficient, the State Board of Elections shall certify the petition not more than 100 days after the date the petition was filed, and the question "Shall (name) be recalled from (office) ~~the office of Governor~~?" must be submitted to the electors at a special election called by the State Board of Elections, to occur not more than 100 days after certification of the petition. A recall petition certified by the State Board of Elections may not be withdrawn and another recall petition may not be initiated against the member or officer ~~Governor~~ during the remainder of the current term of office. Any recall petition or recall election pending on the date of the next general election at which a candidate for the office subject to recall ~~Governor~~ is elected is moot.

(c) If a recall petition ~~petition to recall the Governor~~ has been filed with the State Board of Elections, a person eligible to serve in the office with respect to which the recall petition has been filed ~~as Governor~~ may propose his or her candidacy by a petition signed by a number of electors equal in number to the requirement for petitions for an established party candidate for the office ~~of Governor~~, signed by petitioning electors not more than 50 days after a recall petition has been filed with the State Board of Elections. The form of a successor election petition, circulation, and procedure for determining the validity and sufficiency of a petition shall be as provided by law. If the successor election petition is valid and sufficient, the State Board of Elections shall certify the petition not more than 100 days after the date the recall ~~petition to recall the Governor~~ was filed. Names of candidates for nomination to serve as the

candidate of an established political party must be submitted to the electors at a special primary election, if necessary, called by the State Board of Elections to be held at the same time as the special election on the question of recall established under subsection (b). Names of candidates for the successor election must be submitted to the electors at a special successor election called by the State Board of Elections, to occur not more than 60 days after the date of the special primary election or on a date established by law.

(d) The Executive Branch officer or member of the General Assembly ~~Governor~~ is immediately removed upon certification of the recall election results if a majority of the electors voting on the question vote in favor of recall ~~to recall the Governor~~. If the Governor is removed, then (i) an Acting Governor determined under subsection (a) of Section 6 of Article V shall serve until the Governor elected at the special successor election is qualified and (ii) the candidate who receives the highest number of votes in the special successor election is elected Governor for the balance of the term. If an Executive Branch officer other than the Governor is removed, then the Governor shall appoint a successor as provided in Section 7 of Article V to serve until a successor is elected at the special successor election and qualified. If a member of the General Assembly is removed, then a successor shall be appointed as provided in Section 2 of Article IV to serve until a successor is elected at the special successor election and qualified.
