#### TUESDAY, MARCH 8, 2011

WHEREAS, After arriving in the colonies, Marquis de Lafayette was appointed to serve as an aide to General George Washington; and

WHEREAS, Marquis de Lafayette was appointed as a major general of American militia troops by General Washington; and

WHEREAS, Marquis de Lafayette was wounded by British musket fire while fighting alongside General Washington during the Battle of Brandywine in 1777; and

WHEREAS, This gallant French officer became a war hero in both France and the newly-formed United States; and

WHEREAS, Of all the leading heroes of the American Revolution, Marquis de Lafayette's name ranks fourth in the most common geographical site names in the United States, after George Washington, Benjamin Franklin, and Thomas Jefferson; and

WHEREAS, Following the birth of his first-born son on Christmas Eve of 1779, Marquis de Lafayette named the child George Washington Lafayette in honor of his friend and brother-in-arms; and

WHEREAS, Marquis de Lafayette revisited the United States and the State of Illinois at the invitation of President James Monroe in 1824; during his visit, he was offered citizenship by numerous U.S. states; and

WHEREAS, Marquis de Lafayette was the author of the French Declaration of the Rights of Man, a document based upon the Declaration of Independence; he was also the man who ordered the destruction of the hated French Bastille during the French Revolution; and

WHEREAS, In honor of Marquis de Lafayette, U.S. soldiers during World War I created the battle cry, "Lafayette, we are here"; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate June 7, 2011 as a fete a jour day in honor of Marquis de Lafayette and his courageous efforts to help our nation gain independence.

WHEREAS, It is estimated that 8,000 to 10,000 children and adolescents nationwide are living with multiple sclerosis; and

WHEREAS, The exact cause of multiple sclerosis is still unknown; and

WHEREAS, The symptoms of multiple sclerosis are unpredictable and vary from person to person; and

WHEREAS, There is no laboratory test available for multiple sclerosis that precisely defines a diagnosis; and

WHEREAS, Multiple sclerosis is not genetic, contagious, or directly inherited, but studies show that there are genetic factors that indicate certain individuals are susceptible to the disease; and

WHEREAS, Multiple sclerosis symptoms occur when an immune system attack affects the myelin in nerve fibers of the central nervous system, damaging or destroying it and replacing it with scar tissue, thereby interfering with or preventing the transmission of nerve signals; and

WHEREAS, In rare cases, multiple sclerosis is so progressive that its effects are fatal; and

WHEREAS, There is no known cure for multiple sclerosis; and

WHEREAS, The National Multiple Sclerosis Society, Greater Illinois and its Gateway Area Chapter join with other national, state, and regional multiple sclerosis organizations to celebrate Multiple Sclerosis Awareness Week during one week in March every year; and

WHEREAS, The mission of the National Multiple Sclerosis Society, Greater Illinois and its Gateway Area Chapter is to increase opportunities for cooperation and provide greater opportunity to leverage the effective use of resources for the benefit of the multiple sclerosis community; and

WHEREAS, Multiple Sclerosis Awareness Week was created to invite people to join the movement to end multiple sclerosis, encourage everyone to do something to demonstrate their commitment to moving toward a world free of multiple sclerosis, and acknowledge those who have dedicated their time and talent to help promote multiple sclerosis research and programs; and

WHEREAS, This year, Multiple Sclerosis Awareness Week is recognized during the week of March 7 through March 13, 2011; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we show our support for the goals and ideals of Multiple Sclerosis Awareness Week; and be it further

RESOLVED, That we encourage the citizens of this State to support the goals and ideals of Multiple Sclerosis Awareness Week and commend the efforts of all who support its goals and ideals; and be it further

RESOLVED, That we recognize and reaffirm our commitment to combating multiple sclerosis by promoting awareness about its causes and risks and by promoting new education programs, supporting research, and expanding access to medical treatment; and be it further

WHEREAS, Cervical cancer rates vary, but occur more often in African-American women and Hispanic women than in non-Hispanic white women; and

WHEREAS, Cervical cancer is usually a slow-growing cancer that may not have symptoms; cervical cancer is primarily caused by the human papillomavirus (HPV), but can be detected by Papanicolaou test (Pap tests) or other early detection tests; and

WHEREAS, The Illinois Breast and Cervical Cancer Program provides access to screening and treatment options, including free pelvic exams and Pap tests for qualifying uninsured women; and

WHEREAS, Detecting cervical cancer in its earliest stages greatly improves survival rates; and

WHEREAS, Over 90% of women diagnosed with cervical cancer can survive when the cancer is localized and is caught in its early stages; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the month of January as Cervical Health Awareness Month in the State of Illinois and encourage the citizens of this State to recognize the importance of good cervical health and of detecting cervical cancer in its earliest stages; and be it further

RESOLVED, That we recognize the patients and survivors of cervical cancer for their tremendous courage and determination.

#### HOUSE RESOLUTION 148

Offered by Representative Bellock:

WHEREAS, There are nearly 24 million people in the United States with diabetes and 57 million people with pre-diabetes; and

WHEREAS, Diabetes contributed to the deaths of over 300,000 people in the United States in 2007, making diabetes the seventh leading cause of death; and

WHEREAS, Every minute, three people are diagnosed with diabetes; and

WHEREAS, Each day, approximately 4,384 people were diagnosed with diabetes and approximately

1,600,000 new cases of diabetes were diagnosed in people 20 years or older in 2007; and

WHEREAS, Between 1990 and 2001, diabetes prevalence in the United States increased by more than 60%; and

WHEREAS, Over 24% of people with diabetes are undiagnosed, down from 30% in 2005 and 50% in 2000; and

WHEREAS, Over 10% of adults and 23.1% of people age 60 and older in the United States have diabetes; and

WHEREAS, Diabetes is a serious chronic condition that affects people of every age, race, income level, and ethnicity; and

WHEREAS, Persons who are Hispanic, African, Asian, Pacific Islander, or Native American are disproportionately affected by diabetes and suffer at rates much higher than the general population; and

WHEREAS, 15,000 youths in the United States are diagnosed with type 1 diabetes annually; about 3,700 youths are diagnosed with type 2 diabetes annually; and

WHEREAS, One in three people in the United States born in the year 2000 will develop diabetes in their lifetime; this statistic grows to nearly one in two for minority populations; and

WHEREAS, Diabetes cost the United States an estimated \$174 billion in 2007; \$1 in every \$10 spent on health care is attributed to diabetes and its complications; and

WHEREAS, Approximately one out of every four Medicare dollars is spent on the care of people with diabetes; and

WHEREAS, Every day, 230 people with diabetes undergo an amputation, 120 people enter end-stage kidney disease programs, and 55 people go blind from diabetes; and

WHEREAS, There is not yet a cure for diabetes; and

WHEREAS, There are proven means to reduce the incidence of and delay the onset of type 2 diabetes; and

WHEREAS, People with diabetes live healthy and productive lives with proper management and treatment; and

WHEREAS, National Diabetes Month is celebrated in the month of November; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate November of 2011 as Diabetes Awareness Month in the State of Illinois in order to raise public awareness about stopping diabetes and increase education about the disease; and be it further

RESOLVED, That we recognize the importance of early detection, awareness of the symptoms of diabetes, and the risk factors for type 2 diabetes, which include being over the age of 45, coming from certain ethnic backgrounds, being overweight, having a low physical activity level, high blood pressure, and a family history of diabetes or a history of diabetes during pregnancy; and be it further

RESOLVED, That we support efforts to decrease the prevalence of diabetes, develop better treatments, and work toward an eventual cure for type 1 and type 2 diabetes through increased research, treatment, and prevention.

#### HOUSE RESOLUTION 149

WHEREAS, The Illinois public pension systems are estimated to have an unfunded liability of over \$80 billion, and the State's contribution to those systems is increasing each year; and

RESOLVED, That the Commission on Government Forecasting and Accountability release its report, report to the General Assembly and Governor, and publish on its website all findings by July 1, 2011.

WHEREAS, Our servicemen and women continue to risk and sacrifice a great deal, both at home and abroad; this small act would show some part of Illinois' respect and appreciation for our veterans; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the segment of U.S. 62 that touches the southern tip of our state as the "National Veterans Highway" and encourage the 9 other states along the route to adopt similar measures to show support for veterans groups and the men and women serving our country today; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect, consistent with State and federal regulations, signs displaying the ceremonial designation of U.S. 62 as the "National Veterans Highway"; and be it further
