HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 371

Offered by Representative Bellock:

WHEREAS, Heroin is an illegal and highly addictive drug that is both the most abused and the most rapidly acting of the opiates; and

WHEREAS, Heroin was first synthesized in 1874 from morphine, a naturally occurring substance extracted from the seed pods of certain varieties of poppy plants; and

WHEREAS, Heroin is typically sold as a white or brownish powder or as the black sticky substance known as "black tar heroin"; and

WHEREAS, Although purer heroin is becoming more common, most heroin is "cut" with other drugs or with substances such as sugar, starch, and powdered milk, as well as strychnine or other poisons; and

WHEREAS, Because heroin abusers do not know the actual strength of the drug or its true contents, they are at risk of overdose and death; and

WHEREAS, Heroin also poses special problems because of transmission of HIV and other diseases that can occur from sharing needles or other injection equipment, and because of the medical and social consequences of abuse, including fetal effects, crime, violence, and disruptions to the family, workplace, and educational environments; and

WHEREAS, According to "Heroin Use in Illinois: A Ten-Year Multiple Indicator Analysis, 1998 to 2008", the Chicago metropolitan area ranked among the worst nationally for heroin-related problems, including ranking first in the number of individuals admitted to the emergency room for heroin abuse and first in the percentage of arrestees testing positive for heroin; and

WHEREAS, The study also found a large increase in deaths from heroin overdoses in the collar counties, including a 130% increase in Lake County from 2000 to 2009, a 150% increase in McHenry County in just a three-year period, a doubling of heroin-related deaths in Will County in a period of just two years, and a total of 78 heroin-related deaths in DuPage County over a three-year period, indicating that heroin remains a continuing problem in DuPage County; and

WHEREAS, The study also found the increase in suburban heroin abuse has resulted from increased heroin use among teens, including a 27% increase in suburban Cook County and a 46% increase in the collar counties; in 2008, over 100 individuals in the Chicago Metropolitan Area under the age of 35 died from heroin overdose; and

WHEREAS, Heroin has become the second most common drug after alcohol and the most common illegal substance for which individuals enter treatment in Illinois, compared to the fourth most common reason Illinoisans entered publicly-funded treatment in 1998; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the citizens of the State of Illinois, especially the parents of Illinois youth, to become aware of the dangers associated with the use of heroin and the escalating number of accidental deaths due to heroin overdoses; and be it further

RESOLVED, That we find that comprehensive drug education programs, including the Drug Abuse Resistance Education (DARE) program, serve as valuable tools in presenting the facts and dangers related to heroin use to Illinois youth; and be it further

RESOLVED, That we designate the date of November 4, 2011 as Heroin Abuse Awareness Day in the

State of Illinois in conjunction with National Drug Facts Week from October 31 - November 6, 2011.

WHEREAS, Richard Jaehne is the author of numerous publications, including "NATO School Vision 2000", which was presented to the Supreme Allied Commander, Allied Powers Europe, "Traumatic Stress, A Personal View From Combat", and numerous articles for professional journals and hundreds of speeches of note to international and U.S. crisis management and security forums; he is also the co-developer of the seminar entitled "Where the Battle Begins", which relates leadership in high-risk situations between the military and fire service; and

WHEREAS, In 2002, Richard Jaehne developed and led a series of 17 homeland security planning workshops statewide culminating in a 2-day Homeland Security Summit, attended by community leaders from across Illinois and the Illinois Homeland Security Coordinator; and

WHEREAS, Richard Jaehne received the Mutual Aid Box Alarm System (MABAS) President's Leadership Award in 2006 for sustained support in fire and homeland security preparedness and programs; and

WHEREAS, Richard Jaehne serves as a model of hard work, integrity, and dedication for the people of the State of Illinois; therefore, be it

WHEREAS, Many Illinoisans suffer from respiratory disease; in 2007, it was estimated that over 1.2 million people in Illinois (12.8% of adults) are burdened with asthma; and

WHEREAS, Air pollution causes major health problems for these and other Illinoisans; for the past 20 years, the State of Illinois has had one of the highest asthma mortality rates in the nation and has seen increasing prevalence, morbidity, and mortality rates; and

WHEREAS, The United States Environmental Protection Agency (U.S. EPA) is charged by the United States Congress to protect and improve the nation's air quality as required by the Clean Air Act; and

WHEREAS, Clean air protections are good for Illinois' economy and help save money, as the average length of an asthma hospital stay is 3.3 days with a total direct cost of \$15,155 per person; and

WHEREAS, On March 11, 2011, the U.S. EPA released the Second Prospective Study estimating the benefits and costs of the Clean Air Act Amendments of 1990; the study found that the direct benefits significantly exceed their direct costs, improving the economic welfare and quality of life for Americans; and

WHEREAS, That same report estimates that the economic benefits of reducing fine particle and ground level ozone pollution under the Clean Air Act Amendments of 1990 will reach approximately \$2 trillion in 2020; these savings are a result of disease prevention, prevention of lost-work days, and from the prevention of approximately 230,000 premature human deaths in 2020 alone; and

WHEREAS, The U.S. EPA has a proven track record of cost-effectively cleaning up a variety of air pollutants as required under the Clean Air Act; and

WHEREAS, The U.S. EPA is poised to set a number of standards under the Clean Air Act in the next three years that will cut dangerous pollution to protect our health and environment; and

WHEREAS, These standards will address the reduction of toxic mercury pollution and ozone levels, and the curbing of carbon pollution from power plants; therefore, be it

RESOLVED, That we urge the Governor to represent the State of Illinois as a supporter of the U.S. EPA's efforts to implement the Clean Air Act as appropriate; and be it further

RESOLVED, That suitable copies of this resolution be delivered to President Barack Obama, Governor Pat Quinn, Administrator of the U.S. Environmental Protection Agency Lisa P. Jackson, and the members of Illinois' congressional delegation.
