and texting while driving, can lead to successfully and significantly lowered crash risks for teen drivers; and

WHEREAS, Mt. Pulaski High School in Mt. Pulaski, Illinois, will hold a student assembly on May 23, 2011 to educate high school students about the dangers of distracted driving and encourage them to practice safe driving habits; and

WHEREAS, Mt. Pulaski High School will welcome State Farm Agent Deron Powell and Miss Illinois 2010, Whitney Thorpe-Klinsky, to the high school as part of the presentation on safe teen driving; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we designate the date of May 23, 2011 as "Mt. Pulaski High School Teens Drive Safe Day" in the State of Illinois as a reminder to all drivers, especially our youth, that they should avoid distractions while driving and arrive at their destinations alive and well; and be it further
