WHEREAS, Fundamental issues regarding access to, and the cost of, adequate health care appear to be inextricably intertwined with administrative and technical questions pertaining to procedural compliance with the Illinois Procurement Code and administrative rules; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we find that the circumstances surrounding these current procurements and their potential to cause adverse effects on the State and its citizens warrant a finding that it is in the best interests of the State to cancel the existing solicitations; and be it further

RESOLVED, That we urge the Governor and the Chief Procurement Officer to cancel those solicitations and to issue a new request for proposals in a timely manner in order to select an adequate network of administrators to provide access to health care for all State employees, retirees, and dependents; and be it further
