## HOUSE RESOLUTIONS

The following resolution was offered and placed in the Committee on Rules.

### HOUSE RESOLUTION 406

Offered by Representative Flowers:

WHEREAS, The Illinois House of Representatives adopted House Resolution 332 requesting the Commission on Government Forecasting and Accountability to study the cost of each healthcare mandate that is a part of the Illinois Insurance Code and in effect on the date that the resolution was adopted, as well as the cumulative effect of those mandates on the overall cost of health insurance in Illinois for businesses; and

WHEREAS, House Resolution 332 further directed that the findings of the Commission be reported to the General Assembly by February 6, 2012, to ensure that the members of the General Assembly are informed about the costs and overall impact these mandates have on the ability of small and medium-sized businesses to purchase health insurance; and

WHEREAS, In addition to the cost impact of health insurance mandates on business, there is also a need to analyze the purpose of the mandates that have been enacted in terms of the health outcomes that were intended by providing such coverage; and

WHEREAS, The cost impact of health insurance mandates in terms of their effect on the health and well-being of individuals and groups who may be covered should always be taken into consideration, especially if such coverage prevents further health problems or improves the health condition of the covered person; and

WHEREAS, Improvement of the health of individuals and groups covered by the insurance mandates can have a positive impact on the health and well-being of the employees of any business, which may impact the productivity of the workforce and the economic health of the business; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we request that the Commission on Government Forecasting and Accountability include, in the study that it conducts under House Resolution 332, additional findings and recommendations regarding the cost impact of health insurance mandates in terms of the intended purpose and health outcomes of each mandate so that the financial impact on business is not the sole consideration and the members of the General Assembly are more fully informed about the costs and overall impact of those mandates; and be it further

RESOLVED, That the Commission incorporate these additional findings in its report under House Resolution 332; and be it further

RESOLVED, That a copy of this resolution be delivered to the Executive Director of the Commission on Government Forecasting and Accountability.

### HOUSE RESOLUTION 411

Offered by Representative Pritchard:

WHEREAS, The Entertainment Software Rating Board (ESRB), established in 1994, is a self-regulatory organization that independently rates interactive entertainment software, including video and computer games; and

WHEREAS, The ESRB rating system provides age-based ratings and content descriptors for computer and video games, and through an advertising code requires the display of these ratings on all game

packaging and marketing materials; and

WHEREAS, The ESRB works to promote the rating system and educate consumers about the use of the rating system, including distributing ESRB educational material and airing and publishing public service announcements in local and national media, including a PSA with the Chicago Blackhawks in 2010; and

WHEREAS, Major retailers in the United States have embraced the ESRB rating system and have committed themselves to not sell Mature-rated video games to persons under 17 years of age; the Federal Trade Commission (FTC) recently reported that national retailers successfully enforce this policy 87% of the time; and

WHEREAS, The ESRB's successful self-regulatory program has earned the praise of the FTC, which found it to be the most comprehensive rating system for any entertainment medium in the country and recognized its importance for helping parents make informed choices about the games their children play; and

WHEREAS, Not all online interactive entertainment games have been rated by the ESRB and therefore parents must be vigilant about what online games their children are playing; and

WHEREAS, the Coalition of Entertainment Retail Trade Associations (CERTA) each year declares June to be Entertainment Ratings and Labeling Awareness Month, and, with the start of summer vacation for students, parents need to be vigilant about what their children are watching, playing, and listening to as well as the websites they are visiting; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge parents and caregivers to check the ESRB ratings when selecting computer and video games for children; and be it further

RESOLVED, That we strongly encourage interactive entertainment software creators to submit their video, computer, and online games to be rated by the ESRB; and be it further

RESOLVED, That we urge all interactive entertainment software creators, including video and computer game creators, to refrain from creating games based on real-life tragedies and violence against children.

#### HOUSE RESOLUTION 412

Offered by Representative Phelps:

WHEREAS, The State of Illinois is committed to maintaining stringent standards for chemical and nuclear safety, and for the protection of workers, residents, and the environment; and

WHEREAS, The Honeywell International, Inc. Metropolis Works specialty chemicals facility in Metropolis is the only uranium conversion facility in the United States, and the only domestic producer of uranium hexafluoride, a key component in nuclear fuel; and

WHEREAS, Environmental Protection Agency Enforcement and Compliance records for the Honeywell International, Inc. site in Metropolis reveal non-compliance with the Clean Water Act during 10 of the last 12 quarters, non-compliance with the Resource Conservation and Recovery Act during 12 of the last 12 quarters, and non-compliance with the Clean Air Act during 6 of the last 12 quarters; and

WHEREAS, Honeywell International, Inc. pleaded guilty in federal district court on March 11, 2011 to one felony count of knowingly storing hazardous and radioactive waste in Metropolis without a permit and in violation of the Resource Conservation and Recovery Act and was sentenced to a criminal fine of \$11.8 million and five years of probation; and

WHEREAS, The United States Environmental Protection Agency has stated that "Honeywell must account for its knowing violation of a federal law that protects the public from exposure to hazardous waste containing radioactive material," and that the company's illegal actions "put employees at risk of exposure to radioactive and hazardous materials"; and

WHEREAS, Illinois Attorney General Lisa Madigan reported on March 14, 2011 that Honeywell International, Inc. has agreed to pay a civil penalty of \$690,000 to resolve a separate lawsuit stemming from its illegal storage of thousands of drums of radioactive and hazardous waste near Route 45 in Metropolis; and

WHEREAS, Honeywell International, Inc. reported on 2010 Tier Two forms that its specialty chemicals facility in Metropolis housed a daily average of 66,591,684 pounds of substances classified by the company as immediate health hazards, and 65,859,160 pounds of substances classified by the company as chronic

health hazards in the event of exposure; and

WHEREAS, These substances include daily averages of 33,035,000 pounds of radioactive uranium ore and radioactive uranium chemical compounds, as well as 2,094,000 pounds of hydrogen fluoride, a chemical regulated as an Extremely Hazardous Substance under the Emergency Planning and Community Right-to-Know Act; and

WHEREAS, Honeywell International, Inc. has estimated that an accidental release of even a small portion of the hydrogen fluoride stored at the site could catastrophically impact up to 128,000 residents within a 25-mile radius of the Metropolis Works site; and

WHEREAS, On June 28, 2010, Honeywell International, Inc. locked out the experienced workforce that had been responsible for handling these hazardous chemicals, despite workers offering to remain on the job as contract negotiations continued, and in September of 2010 hired temporary replacement workers to resume operation of its uranium conversion facility; and

WHEREAS, The U.S. Nuclear Regulatory Commission mandated that these temporary replacement workers be evaluated prior to being allowed to operate the plant, and required that Honeywell International, Inc. "ensure no coaching occurs during the On-the-Job Evaluations (OJE)" and maintain "strict control" of "written examinations, related answer keys, examination banks, Job Performance Measures, and all other examination instruments"; and

WHEREAS, Honeywell International, Inc. was cited by the United States Nuclear Regulatory Commission (NRC) on November 10, 2010 for violating the rule that expressly forbade coaching when it, among other instances, "showed the candidate the locations of several components when the candidate was unable to locate them" and "helped the candidate follow the procedure when the candidate became confused"; and

WHEREAS, Honeywell International, Inc. was cited by the NRC for additional violations when it "failed to maintain strict control over examination materials," allowed candidates "to hear and listen to oral evaluation questions prior to their own examination," and further permitted "a number of operator candidates to observe another operator as he performed his OJE, thus compromising the task performance portion of the OJE"; and

WHEREAS, Honeywell International, Inc. has admitted to at least one release at the Metropolis site since its temporary replacement workers began operating the facility, specifically a release of hydrogen fluoride on December 22, 2010, which lasted approximately two hours and triggered emergency sirens and emergency mitigation systems; and

WHEREAS, The workers presently locked out by Honeywell International, Inc. possess numerous years of experience and training inside the Metropolis Works facility; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the importance of utilizing experienced and highly trained workers for the operation of chemical and nuclear facilities that use, store, and produce radioactive or hazardous substances; and be it further

RESOLVED, That we condemn the actions of Honeywell International, Inc. with regard to the lockout of experienced workers at the Metropolis Works specialty chemicals facility in Metropolis and calls on Honeywell to promptly end its lockout; and be it further

RESOLVED, That we condemn the actions of Honeywell International, Inc. with regard to repeated instances of non-compliance with the Resource Conservation and Recovery Act, the Clean Water Act, and the Clean Air Act; and be it further

RESOLVED, That we urge the U.S. Environmental Protection Agency, the Nuclear Regulatory Commission, and all relevant regulatory bodies to define clear jurisdiction over the Metropolis Works facility, and to conduct comprehensive and ongoing investigations, including full multi-media inspections, to ensure that the facility is operated safely and in compliance with federal regulations; and be it further

RESOLVED, That suitable copies of this resolution be delivered to United States President Barack Obama, members of the Illinois Congressional Delegation, U.S. Nuclear Regulatory Commission Chairman Gregory Jaczko, U.S. EPA Administrator Lisa Jackson, Honeywell International, Inc. CEO David Cote, and Honeywell Metropolis Works Plant Manager Larry Smith.

#### HOUSE RESOLUTION 417

Offered by Representative Rose:

WHEREAS, It is the policy of the State of Illinois to promote the electronic storage and transmission of State records and to support efforts to implement efficiencies in the creation, transmittal, and use of electronic files in order to reduce State government's unnecessary use of natural resources; and

WHEREAS, House Bill 1373, if enacted, will abolish the Electronic Records Advisory Board and, thus, eliminate an important voice in addressing specific State electronic records management issues, including: the identification of records created or managed through web-based environments, the preservation of electronic files of long-term value, the management of electronic files in a network environment, and the identification of record-keeping issues related to information system development; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Task Force on Electronic Information and Records Management is created (i) to review current policies, procedures, and guidance provided to State agencies by the State Records Commission as they apply to electronic files and information systems and (ii) to make recommendations to the State Records Commission concerning the identification and use of electronic files as State records; and be it further

RESOLVED, That the Task Force shall consist of the following 9 members:

- (1) the Secretary of State or his or her designee;
- (2) the Director of Central Management Services or his or her designee;
- (3) the Director of Revenue or his or her designee;
- (4) the Chief Information Officer of the University of Illinois or his or her designee;
- (5) the Chief Financial Officer of the University of Illinois or his or her designee;
- (6) the University Archivist of the University of Illinois or his or her designee;
- (7) the Executive Director of the Illinois Student Assistance Commission or his or her designee;
- (8) an individual, appointed by the Governor, to represent the interests of State agencies; and
- (9) an individual, appointed by the Governor, to represent the interests of businesses in the State; and be it further

RESOLVED, That members of the Task Force shall serve without compensation and shall not be reimbursed for travel expenses; and be it further

RESOLVED, That the Task Force shall meet no fewer than 3 times and at its first meeting, which shall take place no sooner than 60 days after the adoption of this resolution, select a chairperson from among its members; and be it further

RESOLVED, That the Task Force shall identify record-keeping issues related to information system development and also produce and deliver a report to the State Records Commission recommending policies, guidelines, and best practices for addressing the following:

- (1) the identification of electronic files as records;
- (2) the management of information identified as electronic records created or distributed through web-based environments;
- (3) the preservation of electronic files of long-term value; and
- (4) the management of electronic files in a network environment; and be it further

RESOLVED, That we urge the Secretary of State to post the Task Force's recommendations on the websites of the State Archives and the State Records Commission within 45 days after their receipt; and be it further

RESOLVED, That the Task Force shall have all necessary administrative assistance provided to it by the University of Illinois; and be it further

RESOLVED, That copies of this resolution be delivered to the Secretary of State, the Director of Central Management Services, the Director of Revenue, the Chief Information Officer of the University of Illinois, the Chief Financial Officer of the University of Illinois, the University Archivist of the University of Illinois, and the Executive Director of the Illinois Student Assistance Commission.

HOUSE JOINT RESOLUTION 37

Offered by Representative Bradley:

WHEREAS, Every county in Illinois is required to have an animal control agency or a County Board to carry out the Animal Control Act; and

WHEREAS, It is the duty of the Administrator of the Animal Control Act, through sterilization, humane education, rabies inoculation, stray control, impoundment, quarantine, and any other means deemed necessary, to control and prevent the spread of rabies and to exercise dog and cat overpopulation control; and

WHEREAS, The County Board is required to provide necessary personnel, training, equipment, supplies, and facilities and operate pounds or contract for their operation as necessary to effectuate the Animal Control Act; and

WHEREAS, Controlling dangerous dogs and centralized reporting of dangerous dogs and bite case data are important public health and safety issues; and

WHEREAS, Training and certification may help ensure a certain level of competency and preparation among animal control wardens; and

WHEREAS, 8 other states have instituted training programs for their animal control officers; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that the General Assembly shall create a committee to explore dangerous dogs, bite statistics and reporting, and animal control training; and be it further

RESOLVED, That the committee shall hold a minimum of 3 hearings throughout the State, including one in Southern Illinois, and shall report its findings to the General Assembly on or before October 1, 2011, and, after the committee reports its findings, it is dissolved; and be it further

RESOLVED, That the Department of Agriculture shall provided administrative and other support to the committee; and be it further

RESOLVED, That the committee shall be co-chaired by a Representative appointed by the Speaker of the House of Representatives and a Representative appointed by the Minority Leader of the House of Representatives and a Senator appointed by the President of the Senate and a Senator appointed by the Minority Leader of the Senate; and be it further

RESOLVED, That the committee shall consist of 20 members in addition to the co-chairpersons as follows: one pet owner appointed by the Governor; one veterinarian appointed by the Illinois State Veterinary Medical Association; one member appointed by the Illinois Farm Bureau; one employee of the Illinois Department of Agriculture appointed by the Director; one attorney appointed by the Illinois State Bar Association's Animal Law Section; one Illinois resident appointed by the Cat Fanciers Association; one person appointed by the Chicago Veterinary Medical Association; one humane society employee appointed by the Illinois Federation of Humane Societies; one animal control warden appointed by the Illinois Animal Control Association; one Illinois resident appointed by Best Friends Animal Society; one veterinarian appointed by Cook County Animal Control; one Assistant State's Attorney appointed by the Cook County State's Attorney's Office; one dog trainer appointed by PAWS Chicago; one Assistant State's Attorney appointed by the Madison County State's Attorney's Office; one member appointed by Safe Humane Chicago; one feral cat caretaker appointed by Alley Cat Allies; one animal behaviorist appointed by the University of Illinois College of Veterinary Medicine; one breeder appointed by the Illinois Federation of Dog Clubs and Owners; one attorney appointed by the Chicago Bar Animal Law Committee; and one veterinarian appointed by the Animal Protective League of Springfield; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Senate President and the Speaker of the House of Representatives.
