HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 757

Offered by Representative Ford:

WHEREAS, The Illinois House of Representatives adopted House Resolution 550 creating the Firearm Public Awareness Task Force to study concealed carry laws and public safety; and

WHEREAS, House Resolution 550 further directed that the findings of the task force be reported to the General Assembly by March 1, 2012; this due date for the report is no longer workable given the task force's significant responsibilities of gathering and analyzing information about concealed carry laws, the impact of concealed carry laws, and how public safety can be maintained if concealed carry became the law in Illinois; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the task force shall hold public hearings and shall issue a report of its findings and recommendations to the General Assembly on or before May 1, 2012; and that upon filing its report the task force is dissolved.

HOUSE RESOLUTION 758

Offered by Representative Phelps:

WHEREAS, More than a century ago, hunters, anglers, and trappers were among the first conservationists who realized America's natural resources were in peril and could not sustain unregulated harvest and habitat destruction; and

WHEREAS, Hunters, anglers, and trappers took it upon themselves to support laws that stopped excessive harvest of fish and wildlife, established game and fish agencies to protect fish, wildlife, and their habitat, and supported special fishing and hunting license fees to help fund the new agencies' efforts to provide for healthy natural resources for future generations; and

WHEREAS, Upon realizing that license fees alone were insufficient to restore and sustain healthy fish and wildlife populations, hunters, anglers, and trappers supported excise taxes on firearms, ammunition, hunting equipment, and fishing equipment to raise additional funds to support restoration and enhancement efforts of the State agencies; and

WHEREAS, These efforts became known as the Wildlife and Sport Fish Restoration Program that began 75 years ago with the passage of the Federal Aid in Wildlife Restoration Act in 1937, and again with the Federal Aid in Sport Fish Restoration Act in 1950, and further expanded with the Wallop-Breaux amendment to the Sport Fish Restoration Act in 1984; and

WHEREAS, The combined contribution of the Wildlife and Sport Fish Restoration Programs to State fish and wildlife agencies exceeds \$13 billion since 1939 (the first year money was distributed to the states), more than any other single conservation effort in American history; and

WHEREAS, This cooperative partnership between hunters, anglers, trappers, and State natural resource agencies has resulted in the most successful model of fish and wildlife management in the world, restoring populations from coast to coast, Alaska, and Hawaii; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize America's hunters, anglers, and trappers for their leading role in restoring healthy populations of fish, wildlife, and other natural resources, both game and non-game, to the abundance we see today; and be it further

RESOLVED, That a suitable copy of this resolution be provided to the Illinois Department of Natural Resources, all members of the Illinois Congressional delegation, and Illinois Governor Pat Quinn.

HOUSE JOINT RESOLUTION 62

Offered by Representative Cross:

WHEREAS, In an effort to address unsustainable growth in the Medicaid program and to improve the care provided to Medicaid enrollees, a bipartisan group of legislators worked with the Department of Healthcare and Family Services to craft comprehensive Medicaid reforms in early 2011; and

WHEREAS, Governor Quinn referred to these reforms as a "landmark achievement" when he signed them into law on January 25, 2011 after they had passed the Senate by a vote of 58-0-1 and the House of Representatives by a vote of 111-4-2; and

WHEREAS, Included in these landmark reforms were provisions to require Medicaid applicants to submit one month of income data and proof of Illinois residency when applying for Medicaid coverage; and

WHEREAS, The Department of Healthcare and Family Services has not implemented these key reforms due to communication from the Centers for Medicare and Medicaid Services indicating that the residency and income verification may violate Medicaid Maintenance of Effort (MOE) provisions contained in the

Patient Protection and Affordable Care Act; and

WHEREAS, The Department of Healthcare and Family Services has not requested a waiver to formally ask for the implementation of these reforms despite requests from members of the General Assembly to request such a waiver; and

WHEREAS, One of the reasons provided by the Department of Healthcare and Family Services for not submitting a waiver for the income and residency requirements contained in the Medicaid reforms is a lack of agency manpower to submit such waivers; and

WHEREAS, In an effort to work with the Department of Healthcare and Family Services to address staffing issues, Senate Bill 1762 was passed in November of 2011 and signed into law as Public Act 97-649 to provide flexibility outside of the Personnel Code to allow the Department to hire employees with experience in administration, information technology, and healthcare financing to facilitate implementation of Medicaid reforms; and

WHEREAS, Also included in the landmark Medicaid reforms was a provision to place a 2-year moratorium on the expansion of Medicaid eligibility, thus enacting a 2-year moratorium through January 25, 2013; and

WHEREAS, Despite this moratorium, the Department of Healthcare and Family Services officially submitted a waiver request to the federal government in January of 2012 to expand Medicaid eligibility in Cook County to individuals currently not eligible for Medicaid coverage; and

WHEREAS, The implementation of all of the landmark bipartisan Medicaid reforms remains a key to addressing the ever expanding backlog of unpaid Medicaid bills, which according to the Department of Healthcare and Family Services could reach \$21 billion by the end of FY 2017; and

WHEREAS, numerous other reforms also remain to be implemented, including coordination of care for high risks moms and babies, creation of a Medicaid transparency portal, payment recapture audits, use of durable medical cards, civil remedies for fraud, copayment requirements for unauthorized use of emergency rooms, enhanced third-party liability provisions, and the creation of a specialty drug program for high cost medications; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SEVENTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we recommend that the Department of Healthcare and Family Services formally file a Medicaid waiver to implement the income and residency requirements and all other provisions of Public Act 96-1501 that may require a waiver; and be it further

RESOLVED, That the Department of Healthcare and Family Services should timely submit to the Centers for Medicare and Medicaid Services any and all State Plan amendments necessary to implement all reform provisions included in Public Act 96-1501; and be it further

RESOLVED, That we urge the Department of Healthcare and Family Services to fully implement all previously enacted reforms to address the unsustainable growth in the Medicaid program and to improve the quality of care provided to program participants; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Governor, the Director of the Department of Healthcare and Family Services, and to the members of the Illinois Congressional delegation.
