It is reached epidemic proportions. Domestic violence knows no gender, no race, no socioeconomic status, no educational status. It affects all of us. It lurks behind closed doors, behind shame, behind 'It's none of our business. It's a personal matter.' I ask all of you to consider the people around you and know that someone out there is probably experiencing domestic violence right now. It's important to be aware. It's important to bring

Government to provide additional funds to Illinois in an effort to be proactive rather than reactive in the increased growth of Lyme disease and other tick-borne diseases in Illinois. I want to thank Members of the House for your previous support of Lyme legislation in 2018-2019, and again, ask for your support. After passing our legislation in 2018, IDPH and Illinois Natural History Survey began conducting tick drags across many Illinois counties, collecting ticks for detection and analysis. A tick drag is a person in full body covered clothing pulling a sticky cloth through a grassy area, like a yard or wooded area, to collect ticks. The ticks are later analyzed for Lyme or other tick-borne diseases. Current astounding results of these drags are on the IDPH Web site as a county by county interactive map. For example, a state average of the black-legged ticks collected are 39 percent positive for Lyme disease. If you live in northern counties, those rates are much higher at 50 percent of those ticks tested for Lyme. Jo Daviess County is 63 percent and Winnebago is an alarming 71 percent of those ticks tested and collected have Lyme disease. Since 2018, we've learned a lot. And through efforts of the Lyme Disease Task Force, INHS and IDPH, we can all acknowledge Lyme disease in Illinois ... is in Illinois and causing extreme pain and many other medical conditions. To bring awareness, the statewide Illinois Lyme Association is hosting a Peace, Love, Lyme Walk the month of May throughout all of Illinois. People can participate virtually or put together a local group to walk or run. More information is available at their Web site. I ask for a favorable vote on this Resolution."

Hepatitis C is particularly dangerous because the symptoms do not manifest upon contraction or, in some cases, in more advanced stages. Thank you."

As the Silver Search Program brings light to increasing incidents of people with Alzheimer's or dementia that get lost and the ways in which the public can help law enforcement return them home safely. This Resolution came out of robust conversation with my senior advisory committee that I run along with Senator Karina Villa. And I just want to give thanks to the folks that worked hard on this."

House Mussman: Resolution 39 recognizes that every student has the right to comprehensive sex education to help them protect themselves from sexual violence, sexually transmitted diseases, and unplanned pregnancies. I would like to thank Sonam Rikha and Samantha Chen of the youth group Comprehensive Sex Education Now for writing this Resolution and advocating for its passage. They want to shine a light on the fact that Illinois teens face a higher percentage of forced sexual intercourse, dating violence, and physical sexual violence than the national average. In 2017, Illinois ranked 10th in the U.S. for chlamydia and syphilis cases and is 17th for gonorrhea. Comprehensive sex education is proven to increase the use of contraceptives, reduce STDs, and reduce teen pregnancy rates. The S... CDC found a 12 percent reduction in sexual risk-taking among students who had comprehensive sex education, such as the kind indorsed by the National Sexuality Education Standards. I know we all support keeping our young people safe and healthy, and I would appreciate your support."
- Speaker Ammons: "Thank you, Representative Mussman. Recognizing Leader Batinick."
- Batinick: "Speaker, it is wonderful seeing you up there. Can we have a roll call on this vote, please? Thank you."

On this question, there are 64 'yays' and 44 'nays'. And this Resolution, having received a Constitutional Majority, is hereby adopted. Thank you, Representative Mussman. - Carroll: "Thank you very much, Madam Chair. And I'm not looking at the back of your head this time, I am looking at your face. So, you look great up there. Thank you. And ... thank you, of course, for having me follow up that Resolution with this one, but we'll try to ... this is a little more piecey. So, HR9 exists to raise awareness around brain aneurysms. A brain aneurysm is a bulging area in the artery in the brain, similar to a structure to a thin balloon. Roughly half a million people die each year caused by brain aneurysms, with half of those victims being under the age of 50 years old. Of survivors, 66 will suffer from permanent neurological deficit. Risk factors include cigarette use, hypertension, and a history of cerebral aneurysms in the family. In the United States, 1 in every 50 people has an unruptured brain aneurysm. Statistically, women are more likely to develop brain aneurysms than men at a three to two ratio. When looking at the statistics from a racial makeup, African Americans and Latinos are twice as likely to have brain aneurysm rupture than white patients. It is safe to conclude that women of

color are most at risk for brain aneurysms, though it can be fatal in all instances. With innovative screening techniques, individuals at risk of harboring brain aneurysms can be easily identified with imaging tests. When caught early, aneurysms are treatable and nowhere... nowhere near as fatal. For the above reasons, House Resolution 9 declares September 2021 as Brain aneurysm Awareness Month, and I ask for its adoption. Thank you."

Parkinson's disease is a progressive nervous system disorder that affects movement. Symptoms start gradually, sometimes starting with barely a noticeable tremor in just one hand. And additional symptoms may include slow movement, rigid muscles, impaired posture and balance, loss of automatic movement, speech changes, and writing changes. This is a disease that we will continue to bring awareness of in the State of Illinois. Thank you, Madam Chair."
- Speaker Ammons: "Thank you. If there's no further discussion, Representative Greenwood moves for the adoption of House Resolution 48. All those in favor say 'aye'; all those opposed say 'nay'. In the opinion of the Chair, the 'ayes' have it. And the Resolution is adopted. Representative Lilly for House Resolution 55. Representative Lilly, do you want me to just come back to you in a second? I'm happy to. Thank you.

Representative Welter for House Resolution 62. Representative Welter, you have a Floor Amendment. Would you like to explain the Floor Amendment so we can adopt it first?"

- Welter: "Yeah, the Floor Amendment just changes the scope of the audit at the suggestion of the Auditor General."
- Speaker Ammons: "Representative Walter... Welter... I'm sorry... moves adoption of Floor Amendment #2. All those in favor say 'aye'; all those opposed say 'nay'. In the opinion of the Chair, the 'ayes' have it. And the Amendment is adopted. Any further Amendments, Mr. Clerk?"

Clerk Bolin: "No further Amendments. No Motions are filed."

- Speaker Ammons: "Thank you. Representative Welter, House Resolution 62."
- "Thank you, Madam Speaker. And I will comment as well. Welter: Congratulations on your role up there today in the Chair. It is great to see you up there. House Resolution 62 directs the Auditor General to conduct a performance audit of the state's response of the management of the COVID-19 outbreak, specifically, at the LaSalle Veterans' Home. There is no opposition to this. I... I would stress to those in this Body, after the outbreak at the Quincy home, there was a similar request of the Auditor General. We're asking for a similar process to take place with LaSalle to understand the processes that were broken down, the failures of the state, and really what we can build on so that we never put our veterans in this situation again when simple protocols could've been put in place to mitigate the loss that occurred at the LaSalle Veterans' Home. That is why I suspect the Auditor General's

report will come back with our improvements and changes that may need to be made."

Speaker Ammons: "Thank you, Representative Welter. This Resolution requires an actual vote, Members. There's no further discussion, Representative Welter moves for the adoption of House Resolution 62. All in favor vote 'aye'; all opposed vote 'nay'. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Mr. Clerk, please take the record. On the question, there are 111 'ayes' and 0 'nays' voting in support of this Resolution. Having received a Constitutional Majority, the Resolution is hereby adopted. Representative Cassidy, for which reason do you seek recognition?"

Cassidy: "Point of personal privilege."

Speaker Ammons: "Please state your point, Ma'am."

Cassidy: "Thank you, Madam Speaker. And let me just add to the chorus of, you look mighty fine up there. It's nice to see you in that role. I rise today to share some news. Yesterday, when we took... when we came in and gaveled in, we heard about several of our colleagues who lost parents over the weekend. When I got back over to Stratton, I learned that our Page, Aaron Bailey, had also lost his mom over the weekend. Aaron has always been there for us. He takes such good care of us. I am taking up a collection, and many of you have already given, to help show our support and love for him. He was a caregiver to his mom. He was here yesterday. He knew that we were coming in and, in spite of his family's loss, he came here to do his job. And just please see me, I have a card.

And I just want to make sure that we give him our love and support."

- Speaker Ammons: "The Body will take a moment of silence for our colleague. Thank you, Members. Thank you, Representative Cassidy. Continuing with the business of Resolutions, I return to Representative Lilly for House Resolution 55."
- Lilly: "Thank you, Madam Chairman. I rise on today, Ladies and Gentlemen of the General Assembly, to introduce House Bill... excuse me... House Resolution 55. It declares August '21 as the Black Business Month in the State of Illinois. It resolves to eliminate redlining and to develop and implement laws and policies to provide equal opportunities for black entrepreneurs and African American-owned businesses. August is National Black Business Month. I love to introduce this Resolution to the State of Illinois. I ask for your 'aye' vote."
- Speaker Ammons: "Thank you, Representative Lilly. If there's no further discussion, Representative Lilly moves for the adoption of House Resolution 55. All those in favor say 'aye'; all those opposed say 'nay'. In the opinion of the Chair, the 'ayes' have it. And the Resolution is adopted. Continuing with Representative Lilly, House Resolution 56."
- Lilly: "Thank you, Madam Chairman. Again, House Resolution 56 declares May 20, 2021 as Stop the Bleed Day in the State of Illinois. It is so important that many of the trauma injury... injuries that are occurring to the citizens of Illinois, we must begin to create techniques and tools that allow us to stop the bleeding. On May 20, 2021, we're asking for it to be

Stop the Bleed Day in the State of Illinois. I ask for your 'aye' vote."

- Speaker Ammons: "Thank you, Representative Lilly. There's no further discussion, Representative Lilly moves for the adoption of House Resolution 56. All those in favor say 'aye'; all those opposed say 'nay'. And in the opinion of the Chair, the 'ayes' have it. And the Resolution is adopted. Moving to House Resolution 78, Representative Scherer."
- Scherer: "Thank you, Madam Speaker. And it's wonderful to have you up in the Chair. Congratulations for being there. Today I present House Resolution 78. It urges the vaccination plan for COVID to be made fully transparent and readily accessible to the public. I'm especially concerned about the rural areas of our communities. And this was actually originated in probably November or December. So, things are much better. We want to make sure that things continue to be provided for all communities, not just certain ones. Thank you."
- Speaker Ammons: "Thank you, Representative. If there's no further discussion... sorry. Representative Bourne, you seek recognition?"
- Bourne: "Thank you. An inquiry of the Chair. I see that there is an Amendment to this Resolution."

Speaker Ammons: "That Amendment was already adopted previously." Bourne: "Okay, thank you. Will the Sponsor yield?"

Speaker Ammons: "The Sponsor will yield."

Bourne: "Thank you. Representative, is your Resolution suggesting that the Pritzker Administration has not been distributing vaccines to every community in a fair way?"

- Scherer: "Oh, I'm sorry. I didn't catch that. Yes, I... this... like I said, this came back in November or December. And Representative Bourne, as you know, in our areas, there was some problems."
- Bourne: "Yes. And I'm seeing that the numbers are from January. Do we know that the numbers have improved? I just have questions of why we're adopting this Resolution now and what your concerns are with the Pritzker Administration's distribution of the vaccines."
- Scherer: "Yes, the numbers have improved, to your first question. And secondly, I just want to make sure that things continue on the right path. I feel it's very important that people get vaccinated. I might add that I've had both of my vaccinations and had no problems, even though I have lots of allergies. And originally, we thought that could be a big concern."
- Bourne: "Thank you. Representative, I certainly share in your concern of getting vaccine access to our rural communities. Just have questions on the outdated nature of this Resolution, but I will still plan to support it since I also have concerns with the Pritzker Administration's handling of the COVID pandemic."
- Scherer: "The reason that it's outdated is, as you know, Resolutions don't always move through the House at breakneck speed. So, it's been a... just a process to get it across the finish line. And then, there was a technical error that had to be corrected as well. Thank you."
- Speaker Ammons: "Representative Ford, do you wish to speak on this Resolution? Please proceed."
- Ford: "Thank you, Madam Speaker. Will the Sponsor yield?"

Speaker Ammons: "She indicates she will."

- Ford: "Thank you. Representative, thank you for bringing this Resolution to the General Assembly. In my opinion, it raises the awareness about how important it is for people to consider or take the vaccine. Do you think today's Resolution will add to the promotion and reduce some of the hesitancy on vaccines?"
- Scherer: "Thank you for mentioning that, Representative Ford. That is precisely why, when asked if I wanted to continue forward with it, I said, 'Yes, I'm very concerned that not as many people are getting the vaccine as we need for herd immunity.' Most recently, I saw that it was just 30 some percent, and we need to be at 70 some percent for herd immunity. I know, especially in the southern parts of the state, I saw some out of town guests this weekend, and they said no one in the south is wearing masks or getting vaccinated. So, that makes it even more important. I feel that it'd just be so readily available. We don't want people to have to go through any effort at all to try to get it. Thank you for the question."
- Ford: "Yes. Well, I thank you for using your platform to do such an important job at raising awareness. And I'd like to congratulate all those that have decided to take the vaccine to do their part, and also congratulate those that's considering. And hopefully, we can get as many people in the State of Illinois to consider or take the vaccine so that we can better improve the health and safety in the State of Illinois and end this pandemic in our great state. Thank you very much, Sue Scherer, for your Resolution."

So, to call it a disorder is truly incorrect. And for this Resolution, it is to start changing the narrative that post-traumatic stress is an injury, and with help and assistance in the mental health field, that it can heal and not to stigmatize it as a disorder. Thank you for your support of the Body."
