- Speaker Harris: "Representative, I think the rules are clear. This… your Motion would require unanimous consent. There is not unanimous consent. Representative Caulkins."
- Caulkins: "Yes, Sir. Thank you. Mr. Speaker, House Rule 51.5(c) is being arbitrarily enforced. That rule is being used to single out individual Members of this Body. And therefore, I ask you, under Rule 51.5(c), to remove from the House chamber all Members of the House of Representatives who answered the quorum call today, February 16, 2022. Under House Rule 51.5(a) (3), all Members must have submitted to and passed a temperature check prior to entry on the House Floor. No Member who is on the House Floor has taken and passed a temperature check prior to entering the House Floor. Under House Rule

51.5, the rule and its provision may not be suspended. As such, all Members are in violation of this rule."

- Speaker Harris: "Representative, understanding the concern you raised, to be sure that all House Rules are followed appropriately, Doorkeepers and House staff will come into the chamber and they will be taking the temperature of every person who is present in the chamber to be sure that everyone was temperature checked according to the House Rules. So, we will proceed down that path. Representative Caulkins."
- Caulkins: "Mr. Speaker, I believe... I believe (3), 'have submitted to and passed a temperature check prior to entry.' 51.5 Rule C... or 3. Excuse me, (a)(3). (a)(3), 'have submitted to and passed a temperature check prior to entry.' That rule... cannot be suspended or amended. And we either follow all of them, or we follow none of them."
- Speaker Harris: "Representative... Representative, we do not know who did or did not have a temperature check complying with that rule coming in to the chamber. Ladies and Gentlemen, I'm happy to report that, to be sure that the chamber is safe and that people are in compliance with House Rules, the temperatures have been checked of all Members and staff who are on the floor and we're ready to proceed with other business. - Batinick: "Thank you, Mr... thank you, Mr. Speaker. Quick point of person privilege. And what is the rule on when speaking? I can bring it down or no?"

Afterwards, the school board president actually resigned, citing threats. I know there's been school board members in other places that have resigned, and it's all because of this. It's not March of 2020. We've had no transparency on any of this. We've had no hearings on the Governor's mitigations. And it would be great if we could just work together and actually vote on some of the things that we were supposed to do so we don't have to deal with the TRO, so we don't have to deal with threats to school board members, so we don't have parents on both sides of this equation that really don't know what to grasp for for answers. I mean, this is a small microcosm of a case that we're allowing to happen throughout the state, and I'm hopeful... I'm hopeful that we can stay through the storm and maybe work on some of this stuff. Thank you."

He served as chairman of the Illinois Historic Sites Commission, the Springfield Historic Sites Commission, and the Sangamon County Historical Society. offered by Representative Greenwood, a Bill for an Act concerning State government. Senate Bill 4056, offered by Representative Mussman, a Bill for an Act concerning education. First Reading of these Senate Bills. There being no further business, the House Perfunctory Session will stand adjourned."
