Last year, she and other colleagues in her profession received almost no notice when their insurance reimbursement rate was threatened to be reduced by a significant amount by their contracted insurance provider. They were able to organize and push back on something that would've been devastating to their business and harmful to their patients, who have experienced interruption in access to their health care providers and therapeutic treatments. What they have proposed is legislation that requires 90 days prior notice before any rate reduction, no waivers of the right to receive notice, and no retroactive rate reductions. House Floor Amendment 1 was negotiated with the Insurance Council and brings them to neutral. I know of no other opposition, and I request an 'aye' vote."

Speaker Harris: "Representative Morgan, are you in opposition?"

Morgan: "Opposition."

Morgan: "Despite being a chief cosponsor in opposition... just for legislative intent, Representative, if you could just confirm. And would require private and governmental water distribution entities to alert their health care facility customers if there is a planned or unplanned disruption in their water supplies. Disruptions in water supplies often result in the releasing of large quantities of harmful bacteria into the water and disturbing the normal innocuous biofilm found on the inside of the pipes. Health care facilities are emphasized since they are... they serve the most vulnerable among us, the elderly and the infirmed. These facilities also have water management plans in place to address their disruptions and safeguard their patients. Most of them do. We worked with the Illinois Hospital Association, the Illinois Health Care Association, the American Water Works Association, so forth and so on, Illinois IEPA and IDPH. We addressed their issues in House Amendment 1. The IHA supports these changes, and I know of no opposition."

It would give stroke recognition and prevention strategies access to reliable sources of information. And the appropriation would be mutually agreed

The current... the current law is if the accused provided the intoxicating substance that rendered the victim unconscious, then... then that is in... that is a crime. The Amendment expands that to include if the person is being attacked took the substance herself or himself depending. This... the reason this is so important is that it removes one of the many vestiges in our law where, somehow, we make the victim of sexual assault, by their own action, somehow share in the guilt of that assault, which to me is absurd. limitations. The Bill replaces all references to child pornography in our statutes to child sexual abuse material. The Bill expands the use of support dogs beyond just for children. And then finally, the Bill classifies a child being coerced into filming a sexual act as a Class 4 felony. This in an initiative of the sexual assault and domestic violence prosecutors in Cook County. And it has the support of the Children's Advocacy Center, the Chicago Alliance Against Sexual Exploitation, and the Illinois Association of Chiefs of Police. We've worked closely with the Attorney General's Office on the Bill and intend to make some final changes in the Senate. Happy to entertain any questions."

It is a benign law on its surface, but what we've discovered in looking at this over the years is that it has an unintended consequence. Many taxing districts take the max allowed by PTELL so that in future years they can use that as a base to recalculate what their maximum levy could be. It's like what happens in the corporate world or the military,

where if you don't take it this year, you won't get to use it as your base for next year. So, this is a very complex law, but that's the gist of it. I'm trying to remove the incentive to always take the max to protect future increases. So, how do we do that? The proposal in... this is a universally liked proposal, is that if you do not take the max levy allowed by PTELL in any given period, in future years you can calculate the formula as if you did. That is the concept. The specifics are, this will occur... you can look back three years in order to determine the areas where, if you had taken the max, you can use that as a base to calculate the future. We have focused this on where more than 85 percent of the taxes are in the state, and that is on school districts, park districts, library districts, and community college districts to affect the most property taxes that affects individuals. We have done another thing. We thought about, okay, we're trying to solve an unintended consequence. Did we just cause more unintended consequences? Well, one unintended consequence we have in the Bill that we're going to avoid, we don't want to send substantial flexibility in terms of our tax dollars through school funding to school districts that are suffering bad fiscal health and have them turn around and not tax. So, if they are in the watch list or close to watch list in the school funding formula, then they don't get to take this flexibility because we expect their increase school funding from the state to go to education, not to affect their tax calculation. But the bulk of school districts do get this flexibility. The other thing we did is we want to avoid the unintended consequence of sticker shock. Because this has

been going on for years, in a given year a school all of a sudden increases the taxes on the taxpayer by a dramatic amount, so we put a limitation in here. In a year where you're recapturing the tax rate of previous years, you can only cause your tax levy to go up a max five percent. And then if you need to... another year to recapture the rest, you can take up to another five percent the following year, and then on. So, you always get to go back to the rate that you would've had. But the thing to recall about this is, this is about lowering taxes. The taxpayer that pays lower taxes because the local bodies choose to lower their taxes, that savings is always there. What this is about is changing the future rates. It does not recapture or claw back any of the taxes not previously paid. So, that's the proposal. I think it's a good start. I do think it's low-hanging fruit, and I hope that you support this."

Speaker Harris: "Representative Batinick."

Batinick: "Thank you, Mr. Speaker. Will the Sponsor yield?"

Speaker Harris: "Indicates he'll yield."

Batinick: "Representative, I... and this concept has floated around this building for a long time and it's... this is actually one of the more substantive Bills we're going to debate today. So, I want to make sure we're clear what we're doing. Basically, what happens at the local level is taxing bodies say, tax to the max because you can't get it back, right? Flowers: "Come in where, Representative? To the Department of Revenue?"

Harris: "This deals with health insurance."

Flowers: "Thank you very much, Mr. Speaker."

Slaughter: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. House Bill 4500 is an initiative of the Secretary of State's Office regarding its Department of Business Services. This is a very important department. Its critical duties include incorporating corporations and organizing limited liability companies and partnerships and being the filing office for annual and other reports that need to be filed to keep businesses in good standing in our state. House Bill 4500 amends the Business Organization Act to make consistent and to clarify certain provisions with the intent of streamlining and facilitating business transaction operations within the department. These changes are technical in nature. We did discuss in committee a provision regarding interrogatories. House Bill 4500 harmonizes the interrogatory language throughout our Business Organization Act and makes it consistent with existing language in the Business Corporation Act, the Not For Profit Act of 1986, and the LLC Act of 1994. The Floor Amendment reduces the amount of time a registered business agent can serve and operate after dissolution from five years to three years. Again, this is at the request of a couple committee Members on the other side of the aisle. I don't believe the Bill ever actually had opposition, but there was discussion. The Amendment, ultimately, came out unanimous. I ask for a 'yes' vote on House Bill 4500."

Reick: "Yeah, I... I would really like to. And, again, can you explain the need for a registered agent to be on the hook for... not on the hook, but the three-year look back for somebody who is a registered agent on a... on a..."

What you're now doing here is, you're saying that as long as you've signed up for once to be a registered agent, if the company decides they're not going to replace you, they can basically make you work for free to be the registered agent service of process. With 104 voting 'yes', 0 voting 'no', 0 voting 'present', these Bills, having received a Constitutional Majority, are hereby declared passed. Representative Caulkins for a point of personal privilege."

Caulkins: "Thank you, Mr. Speaker. Good afternoon, Members. The indictment of former Speaker Mike Madigan this week by federal prosecutors on 22 counts, including bribery and racketeering, is yet another stain on this Body and politics in Illinois. Almost every important Democrat holding public office in Illinois right now is there because Mike Madigan put them there, and that includes many of us here... or you here in the General Assembly and Governor JB Pritzker. Madigan raised the money for your campaigns through the schemes he is now under indictment for. Madigan did all the heavy lifting and made all the decisions. He ran the campaigns and Democrats fell in the line. That money allowed you to fund campaigns that lied about your opponent or their policies, or both. You know, I know that any Member that crossed him or didn't vote for him or his agenda was denied the funds to run your campaign or presented with a well-funded primary opponent. This indictment of Mike Madigan is an indictment of the entirety of the Democratic Party, a party he was allowed to control for over 30 years. I know the people of Illinois are watching this, and I hope they will remember who's been responsible for the corruption and abuse of power that has been uncovered by federal prosecutor. Not our Legislative Inspector General, not the Special Investigations Committee, and not our attorneys general. It's past time for real reform in Illinois politics. Thank you."

Avelar: "Point of personal privilege, Mr. Speaker."

Avelar: "Thank you. For today's Women's History Month celebration, we honor the work and legacy of Elizabeth Chambers Morgan. Elizabeth Chambers Morgan was one of the most influential activist and social reformers in the Chicago labor movement in the 19th and early 20th centuries. Born into a working-class family of 10 children, Chambers Morgan received little formal education. She began working 10 to 16 hour days at a mill when she was only 11 years old. She moved to Chicago

when she was 19. Chambers Morgan established the Illinois Women's Alliance and played a pivotal role in organizing the Ladies' Federal Labor Union. She was an integral figure in the fight for an eight-hour work day and for higher wages for women in factories. As a staunch advocate for labor issues, she also investigated and exposed the inhumane and unsafe working condition of Chicago's sweatshops. Elizabeth Chambers Morgan's passion and organizing skills improved the lives of working-class Chicagoans, particularly women and children. Thank you, Mr. Speaker."

Speaker Harris: "Thank you, Representative Avelar. Representative Davidsmeyer for point of personal privilege."

Davidsmeyer: "Thank you, Mr. Speaker. In light of the recent indictment of the former House Speaker, I think it's past time that we get serious about real ethics reforms. Got a list of five things that will lead to more faith from the constituents and the citizens of the State of Illinois. First, we need to address conflicts of interest. You may notice that I'll often stand up and state, due to a possible conflict of interest, I will be voting 'present'. I know there are a number of people on this floor that may need to do that as well. Many people vote on issues that may benefit themselves or their spouse. And judicial maps could be also carved out for an individual's family. Two, we have to establish parity between what's expected from the State Employees Ethics Act and the General Assembly Ethics Act. We shouldn't have one standard for state employees and one standard for this Body. Three, we need to expand, expand the jurisdiction of the Legislative Inspector General to investigate outside of our

official duties to ensure that there is not a legal conflict of interest between your personal life, your personal private business, and what you're doing here on this floor. Number four, we need to make sure that the Legislative Inspector General and the Legislative Ethics Committee have the authority and oversight over the same types of issues. Five, the Legislative Ethics Commission is an equal bipartisan commission. Four Republicans and four Democrats. That Body should have to have a supermajority to block an investigation. Not a simple majority of one party or the other, but a supermajority, ensuring that one party isn't protecting their own people. Mr. Speaker, it is past time that we do real ethics reform in this Body. Thank you."

Speaker Harris: "Representative Williams."

Williams, A.: "Thank you, Mr. Speaker. In March 2020, the name Dr. Ngozi Ezike became a household name and many of us got to see her work in the first very difficult months of the pandemic. I just wanted to thank her for her months and years of service in a time of unprecedented challenge for the State of Illinois and wish her the best as she moves on to a new position as President and CEO of the Sinai Chicago, Chicago's largest private safety net hospital. I may have gotten that title a little wrong, but just wanted to extend my sincerest congratulations and gratitude to Dr. Ngozi Ezike for her service to the State of Illinois. Thank you."
