However, as we move to a different phase of the pandemic, we want to make sure that children in particular are not kept in remote court hearings simply for the sake of expediency or costs savings. We know that in-person court hearings provide them greater access to counsel and a better and more well-rounded judicial outcome. So, we encourage the passage of this Resolution simply to say, as safety permits, we hope that these hearing return to in-person. Thank you."
- Speaker Hoffman: "Is there anyone seeking recognition? Seeing none, Representative Guzzardi moves for the adoption of House Resolution 616. All those in favor signify by saying 'aye'; all opposed 'nay'. In the opinion of the Chair, the 'ayes' have it. And the Resolution is adopted. Moving to page 8 of the Calendar, appears House Resolution 665, Representative Davis."
- Davis: "Thank you very much, Mr. Speaker, Members of the House.

 I move to adopt House Resolution 665, which reaffirms the

It expresses continued support for meaningful participation in international organizations that impact the health, safety, and well-being of the people of Taiwan and supports Taiwan's aspiration to make more contributions in international societies. And let me also remind Members that last year, May 19 of 2021, we established а first-ever Illinois Statehouse Friendship Caucus, which is the first of its kind in the nation and it was a bipartisan effort. And I'm proud to say that my cochair in that effort was Representative Tim Butler. And we commemorated the establishment of that caucus with the House Resolution #3, dated June 1 of 2021. I ask for its adoption. Thank you."

Speaker Hoffman: "Seeing no one seeking recognition, Representative Davis moves for the adoption of House Resolution 665. All those in favor signify by saying 'aye'; all opposed 'nay'. In the opinion of the Chair, the 'ayes' have it. And the Amendment (sic-Resolution) is adopted. Moving back to page 4 of the Calendar, appears House Joint Resolution 55, Representative Buckner. Please proceed."

Buckner: "Thank you, Mr. Speaker. House Joint Resolution 55 urges the Illinois Attorney General to create a conviction integrity unit. The background behind this is that we know

many state's attorneys around the state have decided to stand up their own conviction integrity units to look at instances of convictions that were wrongfully... wrongfully occurred. And so, this just creates the situation... this just asks for a situation where the Attorney General can streamline these units so that the entire state can be under one process. Speaker Hoffman: "Seeing no one seeking recognition, Representative Buckner moves for the House... the adoption of House Joint Resolution 55. All those in favor signify by saying 'aye'; all opposed 'nay'. In the opinion of the Chair, the 'ayes' have it. And the Amendment (sic-Resolution) is adopted. Demmer: "Thank you, Mr. Speaker. The U.S. Department of Interior did a study on this and confirmed that was the case. And the only way to resolve this issue is for Congress to take action. We can't do anything about it here other than express our support for Congress resolving the situation. I ask for your support."

House Resolution 67 (sic-675) calls upon House Members to support the Illinois Comprehensive Cancer Control Plan, updated for 2022-2027, a Comprehensive Cancer Control Plan and partnership with the Executive Committee and working with the organizations like the American Cancer Society, Anderson Hospital, Cook County Health, University of Illinois, Lurie's, and other great, great cancer care providers. Want to seek out a plan to ensure that we're doing the best with the resources and tools we have to increase awareness and access to cancer education, screening, treatment, long-term survivorship, decreased death, elimination of disparities in cancer outcomes are great. The Department of Public Health will be working with the Illinois Cancer Partnership and outlining of various recommendations. Again, fighting the good fight. We know that cancer is tough. Cancer is still around, but we know that we will continue to fight cancer and we will win the battle. I, myself, am a cancer survivor. We have other cancer survivors, like Representative Ford and others, our family members have battled, some have lost. But the fight continues, we will beat cancer. And this is the part of the tool in which we're using governmentally to ensure that we win, not fight, but win, the battle against cancer and make Illinois a healthy place in this country and this world, quite frankly. So, I thank God that our great partners, Lurie's, the University of

Illinois, great educational institution, University of Chicago, throughout the State of Illinois are leading the battle in the fight against cancer. We're going to not only say Illinois residents, but the great medical institutions of Illinois are going to save residents across this country. We are a leader. This is a great opportunity. So, I request your support. And again, let the fight continue. We will beat cancer. Again, thank you all."

- Speaker Hoffman: "Leader Evans moves for the adoption of House Resolution 675. All those in favor signify by saying 'aye'; all opposed 'nay'. In the opinion of the Chair, the 'ayes' have it. And the Resolution is adopted. Representative Scherer on House Resolution 677. Please proceed. Out of the record. Representative Harper on House Resolution 684. Representative Harper."
- Harper: "Thank you, Mr. Speaker. House Resolution 684 declares the month of June as Caribbean-American Heritage Month in the State of Illinois. I encourage an 'aye' vote."
- Speaker Hoffman: "Seeing no one seeking recognition, Representative Harper moves for the adoption of House Resolution 684. All those in favor signify by saying 'aye'; all opposed 'no'. In the opinion of the Chair, the 'ayes' have it. The Amendment (sic-Resolution) is adopted. Leader Batinick, for what reason do you seek recognition?"

Batinick: "Thank you, Mr. Speaker. Point of personal privilege." Speaker Hoffman: "Please state your point."

Batinick: "You know, there's an opportunity for us to come together as a Body, and it's pretty rare we're able to unite fully against a common cause. Anybody who drove down here in

their car realizes that gas prices are hurting everybody. It's disproportionally hurting middle-income and lower-income people. Last time I checked, lower-income people aren't the ones with Teslas. I introduced a Bill, I know there's a similar one introduced in the Senate, House Bill 5723. What it would do is, we charge a sales tax percentage on gasoline, and as the price goes up on gas, the state actually is incurring a windfall that is unexpected. This simply caps the sales tax we get on gas at the level that it was January 1. And this could mean 10 to 20 cents a gallon for consumers. Like I said, this is disproportionately hurting the poor. And I would urge anybody to jump on as a cosponsor to House Bill 5723. We have to do something. We have to do something now. People back home are hurting. Thank you."

Speaker Hoffman: "Representative Ugaste, for what reason do you rise?"

Ugaste: "Point of personal privilege."

Speaker Hoffman: "Please state your point."

Ugaste: "Thank you. Hope everyone had a good weekend. It was St. Patrick's Day. We were all able to get out, go to parades and parties. There's a few items though that I want to call to the chamber's attention. And it came to my mind today because of a nursing home Bill that one of my colleagues is sponsoring in the House here, Senate Bill 1405. It's a great nursing home Bill. And I was wondering why we really needed this Bill because I was told the department had put rules into place that would make certain what happened at the beginning of COVID, which was two years ago, never happened again. And that is families wouldn't be kept apart from their loved ones

in nursing homes. And then I thought for a moment, well, wait. Even if we have rules or even if we have a statute in place, we have yet another problem still. And that problem is the continuing emergency declaration of our Governor in which he can invalidate statutes, look over rules, and impose his will upon the people of the State of Illinois. March 13, 2020, which was just two days ago in two years, was the start of this pandemic. Schools were closed. And the order at the time was schools would be closed through March 30. On March 15, all bars and restaurants were closed through March 30. It's now 2 full years later, 27 emergency declarations. Where's the emergency, folks? Where is the emergency? We are going about our lives. We are going about our businesses again, as we should. The actual emergency that one person needed to control, where the Legislature didn't meet to do their work, ended a long time ago. Normally, 'cause I've spoken about this before, I would sit back and say we should be ashamed of ourselves. But I'm not going to this time because I have stepped up to try and change this, my caucus, the people on my side of the aisle have. There's only one group refusing to change the current situation, which somehow allows emergency to go on for two years. And that's the Supermajority, the Democrats, the party in power. You're dictating it. I've had a rule, it's been hung up... a Bill. It's been hung up in Rules and then Executive Committee for a couple years now. The Governor should be ashamed of himself for continuing to make emergency declarations. I hate to say it, but all of those who haven't joined on this Bill should be ashamed of yourself. We took an oath of office, folks. You

all know it. We took an oath to support the U.S. and the Illinois Constitution. The U.S. Constitution has a guarantee clause, says the United States should guarantee a republican form of government. That means one in which people govern through elections. One person's been governing on this very issue for the past two years. Better yet, Article II, Section 1 of the Illinois Constitution, our own Constitution, says, 'The legislative, executive, and judicial branches are separate. No branch shall exercise the powers belonging to the other.' What are we doing? Why are we letting this go on? Why won't you join me? What is it going to take? Shouldn't we be concerned about protecting our form of ... our system of government as we go into an election? Shouldn't we be concerned that we have a Legislature that should be able to speak on all issues? There's time to change this. I know there's time. Although committees have had their deadlines and Third Readings had their deadlines, I know how things work. I've watched it far too long. This can get out and get done if you want. I'm asking you to join us. I'm asking you to put an end to this. No one person should be able to declare an emergency for two years."

Speaker Hoffman: "Representative Moeller."

Moeller: "Thank you, Mr. Speaker. Point of personal privilege."

Speaker Hoffman: "Please state your point."

Moeller: "I have the honor of presenting today's women's history moment for the House chamber. In honor of today's history moment, I want to recognize that today, March 15, is Equal Pay Day. A day that symbolizes how far into the year a woman must work on average to earn as much as a man earned the

previous year. Today is an important... it's important to reflect on how far we've come in lessening the pay gap but also to talk about how much more work we still need to do. Back in 2019, with a Bill that I sponsored here in the House and that Governor Pritzker signed, our state took a great step forward for equal pay, making it illegal for an employer to require an applicant's pay history as part of the hiring process or in determining a wage offer. And just today, President Biden's administration announced a similar measure that would prevent federal agencies from using prior wage information in the hiring process. Here in Illinois, we are ahead of the curve, setting the standard for other states and the Federal Government, but more needs to be done. Women have been fighting an uphill battle for equality in the workplace since our nation's inception. And this has been an even greater struggle for black, Latina, indigenous, and trans disparities even with the pay greater women, opportunities even fewer. And this pay gap persists across industries and occupations, even in occupations where women make up the majority of the workforce. As we look to the future, let us consider how we will once and for all achieve full equality. The pandemic has laid bare the inequities on our system, with women suffering 60 percent of pandemicrelated job losses due to disproportionate representation and hard-hit industries and the loss of child care and the need to leave the workforce to stay home and take care of their families. As we repair our economy, let's strengthen our resolve in removing the systemic causes of pay inequity. Let's ensure that our daughters and granddaughters won't experience

the same obstacles and barriers that we and prior generations have endured. To do this, we must enact policies and show greater support for affordable child care for all, universal preschool, and paid family leave. Support's provided in most industrialized countries today. These policies help working families stay in the workforce and raise a family. And let's go further in providing pay transparency that gives workers greater ability to negotiate for themselves and identify unfair or illegal pay practices. On this Equal Pay Day, let's commit to ending the need for an Equal Pay Day observance because we will have finally achieved pay equity for all. Thank you."

Speaker Hoffman: "Leader Andrade in the Chair."

Speaker Andrade: "Leader Bourne, what do you wish to be recognized for?"

Bourne: "Thank you, Mr. Speaker. A point of personal privilege, please."

Speaker Andrade: "Please proceed."

Bourne: "Thank you. I also rise today in honor of Women's History Month. Three years ago, I rose on this floor to talk about Women's History Month, and I highlighted the first spacewalk that was all women. And today I rise to recognize another leader in space, a woman from Illinois, Janice Voss. She attended elementary school in Rockford and in 1975 got her engineering degree from Purdue. Voss earned her doctorate in aeronautics and astronautics from Massachusetts Institute of Technology in 1987. Voss then became an astronaut in 1991 and flew her first mission in 1993. But her ties to NASA went back much earlier to the 70s where she worked on computer

simulations in NASA's Engineering and Development Directorate. She was a crew trainer in the late 70s and helped develop the Mars Observer in the early 90s. She was assigned as a mission specialist and she orbited the earth 779 times between 1993 and 2000. This makes her the leading woman to have five flights into space. She retired from space flight and remained active with NASA, serving as the Science Director for the Kepler Space Observatory which... while searching for other solar systems for planets similar to earth. Her work with Kepler was especially noteworthy as it coincided with a period of time at NASA where space flights were grounded after the crash of the Shuttle Columbia in 2003. She kept the process of exploration and discovery going during a time of terrible tragedy at NASA. This is a quote about her. 'Her boundless enthusiasm for getting as much research done was contagious and especially welcome in the challenging time after Columbia. Her experiences from flying science missions as an astronaut were invaluable and optimizing our on-board research.' Janice passed in 2012, and in all she flew five shuttle missions, making her the record holder for an American woman in space. NASA has calculated that she flew 18.8 million miles in space, which is more than half the distance from here to Mars at Mars' closest point. It's a long way from her starting point in here in Illinois and what a great, great example for all of the young women looking to go into science careers today."

Speaker Andrade: "Representative Costa Howard, for what reason do you rise?"

Costa Howard: "Point of personal privilege."

Speaker Andrade: "Please proceed."

Costa Howard: "Mr. Speaker, today I rise to honor the Glenbard West boys basketball team. This remarkable group of young men won state over the weekend, the first ever in our school's history. They went 37-1 and that 1 was a buzzer beater to a school out in California. These young men have exemplified what team work really looks like. While there are many superstars on that team who are going off to play college, they played together like a team. And in honor of those young men, I'd like to... that are Caden Pierce, Kent Buchholz, Logan Brown, Andrew Dauksas, Luuk Dusek, Michael Glover, Declan Scheck, Louie Amabile, Paxton Warden, Jack Cardwell, Benji Zander, Geo Esmalla, Bobby Durkin, Braden Huff, Jack Oberhofer, Luke Gadomski, Graham Pierce, Ryan Renfro, Joe Enright, and Owen Reifel. And they're coached by Rod Molek, Jason Opoka, and Coach P. Again, this group of young men had a remarkable season. They are being touted as the best team of all time here in the State of Illinois. But to the people of the 48th District, we're just proud to have a state championship from Glenbard West. Thank you."

Speaker Andrade: "Representative Hamilton, for what reason do you wish to rise?"

Hamilton: "I, too, would... thank you, Leader... or Speaker. I, too, would like to... personal privilege."

Speaker Andrade: "Please proceed."

Hamilton: "Congratulations to Glenbard West. I know a few of those players, so it's good to see them in Champaign and... played against one of the parent's moms in volleyball. She played at Northwestern and I played at U of I, so it's great to see

them. But I, too, would like to congratulate Sacred Heart-Griffin boys basketball team for bringing home the Class 3A State Championship trophy. First time ever in school history to, one, for the boys' basketball team to make it to the state final, but also to win the state championship trophy. They... we will be bringing the team here to the House. And we will present the award to them individually, to each athlete and their coaches. Such an honor and an honor to be here to present it."
