Randolph: "Mr. Speaker and Members of the House, House Bill 3783 amends 'The State Free Public Library Act' to enable research library to amend their articles of incorporation. Presently the act makes no appropriation for the amendment or change of basic rules of operation. The acts which permit research libraries to corporate throughout the state was first enacted in 1891. This bill will revitalize our case law which has not permitted research libraries to grow, expand and to meet the new challenges of the 20th Century. This bill was put in at the request of the Newbury Library located in Chicago and it is an example of the outstanding intellectual and scholarlistic opportunities which research libraries have afforded the scholars of Illinois. They asked that the act be amended, the number of trustees be changed from seven to twenty-five and I urge that you

The Newbury Library was incorporated as a free public library on April 13, 1892. Under the provisions of the act dated Júne 17, 1891, the act before reads and revised last year allowed libraries incorporated under it to have from seven to fifteen trustees. Since the amendment to the act was to have the number has been changed from seven to twenty-five, but the above amendment that I just mentioned does was made at the request of the John Freer Library and so far as we know, the only other free library incorporated under the act which is now able to increase its number of trustees up to twenty-five. However, this does not apply to the Newbury Library, because their certificate of cor-



poration states that there shall be thirteen. Under ordinary circumstances, they would be able to amend their certificate of incorporation, except that the act itself has no provision for such an amendment."

- Edward E. Bluthardt: "Well, is the real purpose then to enlarge the number of trustees on the board of directors?"
- Paul J. Randolph: "That is the real purpose of it. That is, yes, sir."
- Edward E. Bluthardt: "Is this the library across the street from Bughouse Square in Chicago?"
- Paul J. Randolph: "Ah, yes, it is located directly across from Washington Park known as Bughouse Square in the City of Chicago."
- Edward E. Bluthardt: "All right, thank you."
- Hon. W. Robert Blair: "Is there any further discussion? The question is shall the House pass House Bill 3783? All those in favor shall vote 'Yeas' and the opposed 'No'. Have all voted who wished? The Clerk will take the record. On this question, there are 154 'Yeas' and 2 'Nays' and this bill having received the constitutional majority is hereby declared passed. House Bill 3788."
- Fredric B. Selcke: "House Bill 3788. A bill for an act to amend 'The Municipal Code'. Third reading of the bill."
- Hon. W. Robert Blair: "The gentleman from Cook, Mr. Randolph."
- Paul J. Randolph: "Mr. Speaker, Members of the House, House Bill 3788 and its companion bill, 3789, may I hear the two together, Mr. Speaker?"



Hon. W. Robert Blair: "Does the gentleman have leave? Read the 3789."

Fredric B. Selcke: "House Bill 3789. A bill for an act to amend Section 3 of 'The Hotel Operations' Occupation Tax Act'. Third reading of the bill."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Randolph." Paul J. Randolph: "Mr. Speaker and Members of the House. House Bill 3788 and 3789 amend 'The Chicago Hotel' and 'Operators Occupational Tax Act' and the State Hotel Occupa tional Tax Act'to place in the statute a practice that has been carried on since the inception of the two acts. the act was originally drafted, the tax is on a hotel or motel operator and is subject to be paid by him, but as a matter of practice, this tax was passed on to a person staying in the motel or Motel. These two bills simply place in the statute the permission for the hotel or motel operators to then pass this tax to the hotel users. legislature last year passed House Bill 2176 and 2177 and which gave the same permission to local retailers in the Retailers' Occupational Tax Service Act. As you remember, for the same, for the 1% municipal occupational tax the retailer passed this on the consumer, even though he had no specific permission in the act. Last year we gave the retailer this permission and I urge you to vote favorably on these two bills."

Hon. W. Robert Blair: "The gentleman from Kane, Mr. Hill."

John Jerome Hill: "I wonder if the sponsor would yield to a



question?"

- Hon. W. Robert Blair: "All right, he indicates that he will, but let's see if we can't get a little order in here. We are on third reading, gentlemen. Just wait a minute until it quiets down. All right, do you want to proceed now, Mr. Randolph, oh, Mr. Hill."
- John Jerome Hill: "Isn't this illegal to pass it on to the individual that is staying at a motel or hotel right now according to the statute, isn't it illegal? And this would make it legal to pass it on to. . ."
- Paul J. Randolph: "This this will ah clarify the act. This amendment does not change the act, but clearly clarifies in the amendment and allows the tax to be passed on. A friend of mine. . . "
- John Jerome Hill: "Ah, Mr. Speaker, I'd like to speak on the bill."
- Paul J. Randolph: "Thank you."
- Hon. W. Robert Blair: "All right, proceed."
- John Jerome Hill: "Ah, Mr. Speaker and Ladies and Gentlemen of the House, this piece of legislation will allow the hotels and motels to charge direct to the customer in regard to these various taxes. As the law now states, it is illegal to pass this on to the customer and this will make it legal to do it. I would appreciate very much if you would vote in opposition to this piece of legislation."
- Hon. W. Robert Blair: "The gentleman from DuPage, Mr. Hudson. George Ray Hudson: "Would the sponsor yield for a question?



Paul, is it my understanding that this is creating, is this the creation of a new and additional tax? My understanding is that this does not create a new tax, the tax has already been imposed, but it is not necessary under the existing statutes to show this on the to show this on the bill, therefore the consumer would be denied the advantage of showing this as a deduction of some kind. Is this part of what you're saying?"

Paul J. Randolph: "Ah, the hotel and motel operators are now passing the tax on. This only clarifies and makes this legal, saying that as we permission we gave the retail merchants last year."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Muragos."

Samuel C. Maragos: "I'd like to ask the sponsor if he'll

yield for a question?"

Paul J. Randolph: "Yeah."

Hon.W. Robert Blair: "Yes, he indicates he will."

Samuel C. Maragos: "Paul, is it not true that in effect all retail and all retailers occupation tax and all used taxes were always passed on by the taxpayers and primarily the retailer and motel or hotel operator even before the new constitution was in effect but they used to use it as a service charge because there was a prohibition on the old constitution, is that not right?"

Paul J. Randolph: "It's right."

Samuel C. Maragos: "Is it not true, therefore, that under the new constitution of 1970, there is no prohibition to consider



it a sales tax directly to the consumer or the ultimate user under the words of the old constitution."

Paul J. Randolph: "Right."

Samuel C. Maragos: "And therefore the user now because it's really clarification under the new constitution, in fact it might be called in fact a constitutional implementation bill, isn't that correct?"

Paul J. Randolph: "That's right."

Samuel C. Maragos: "And the Department of Revenue just wants to clerify usage and not opposing the new tax, it is just making a use, which is hotel or motel operators has been able to do up to now by passing it on as a service charge, he now can do it in the form of a tax and designate it as such and it is not changing any of the circumstances and therefore I ask that we support this piece of legislation."

Paul J. Randolph: "That is absolutely correct. Thank you."
Hon. W. Robert Blair: "Any further discussion? The gentle-

man from Madison, Mr. Walters."

Robert J. Walters: "Will the gentleman yield to question, please?"

Hon. W. Robert Blair: "He indicates that he will."

Robert J. Walters: "Representative Randolph in the synopsis in our digest it says that this permits Chicago hotel operators, does this include hotel operators throughout the State of Illinois?"

Paul J. Randolph: "Ah, yes, it does."

Robert J. Walters: "Thank you."



Hon. W. Robert Blair: "Is there any further discussion? The gentleman from Bureau, Mr. Barry."

Tobias Barry: "Will the sponsor yield to a question?"

Hon. W. Robert Blair: "Yes."

Tobias Barry: "Paul, in a nutshell, last year we passed law that suggested that this tax should not be passed on to the consumer and this year the administration prefers to change their mind on the subject, does that put it in a nutshell?"

Paul J. Randolph: "It might."

Tobias Barry: "Thank you very much."

Paul J. Randolph: "This measure has the approval of the Department of Revenue."

Tobias Barry: "Thank you very much."

Paul J. Randolph: "Okay."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Juckett."

Robert S. Juckett: "Mr. Speaker, will the sponsor yield to a
question?"

Hon. W. Robert Bjair: "Yes."

Robert S. Juckett: "Ah, Paul, is this the current tax which is added on to, like similar to the one that is added on to our motel bills here?"

Paul J. Randolph: "Yes, it is."

Robert S. Juckett: "Okay. If it is the same tax, then why
do they need the authority? Is it now illegal for them to
pass that on and to add that on to our hotel bills?"

Paul J. Randolph: "This was the original intent, but they



would not ever have the actual authority and this gives them
the authority now to pass it on, which they have been doing
all along. And this measure of these two bills have the
full support of the Department of Revenue."

Robert S. Juckett: "What legalized what they have been doing?"
paul J. Randolph: "Yes."

Hon. W. Robert Blair: "Any further discussion? The question is shall, does the gentleman care to close?"

Paul J. Randolph: "I solicit your favorable vote."

Hon. W. Robert Blair: "All right, the question is shall these two bills pass? All those in favor will vote 'Yeas' and the opposed 'No' and the Clerk will take two roll calls.

The gentleman from Cook, Mr. William Walsh."

William D. Walsh: "Mr. Speaker and Members of the House, I don't think any of the discussion on this bill has really hit on what it really does. This tax that is referred to here is not the state hotel - motel tax which is presently at 5%. This is the city of Chicago tax which we enacted or permitted the city to levy a few years ago which at the time was said to go for tourism and indeed, that is where it does go. Now, no one benefits more from tourism than the hotels and motels and so it was thought that they should absorb the tax rather than have it in effect fall on the hotels and motels. Now, what these bills propose to do is take that off of the hotels and motels and permit them to pass it on to the hotel users and in effect have a 10% tax in Chicago, when we have a 5% tax in the rest of the State.



I think these are bad bills and they should be defeated." Hon. W. Robert Blair: "The gentleman from Cook, Mr. Hyde." Henry J. Hyde: "Mr. Speaker, Ladies and Gentlemen of the House. I take a slightly different view and explaining my vote and my distinguished colleague, Bill Walsh. The tax exists the tax is not absorbed by the hotel-motel operators it is passed onto the consumer, the user in the form of an increase in hotel bill, so what it amounts to is that the hidden tax. I'm all for the public knowing that they're being taxed and the amount of the tax is. I think the public ought to know all of these hidden taxes so they can get some idea of who is imposing these taxes and what they amount to and so this really is like a truth in lending bill, it's a truth in renting a hotel bill to let you know that you're being caught for a tax and the amount of the tax, and so rather than concealing it, it reveals it and I think it's they're both excellent bills."

Hon. W. Robert Blair: "Have all voted who wished? The gentleman from Cook, Mr. Randolph."

Paul J. Randolph: "Ah, Mr. Speaker, Members of the House, all these bills do House Bill 3788 and 3789, amend the Motel Tax Act and what they do will serve essentially the same purpose for hotel operators as they did for the retail merchants last year. These bills codify the long standing practices and procedures concerning hotel taxes and clarifies the right and duties of hotel operators and their tax in connection with the state and municipal taxes. This will



assist in a smooth and a consistent administration of hotel taxes and will benefit the state as well as the hotel and motel operators and their guests and I would appreciate a favorable vote on the two majors."

Hon. W. Robert Blair: "The. . . "

- Paul J. Randolph: "The bills last year sponsored by the Retail Merchants Association and the Department of Revenue they sponsored these so they would have no objection to the same things being done now with taxes in regard to state and local hotel operators occupational tax. I please ask for your support."
- Hon. W. Robert Blair: "The Clerk will take the record. The gentleman from Cook, Mr. Randolph."
- Paul J. Randolph: "Ah, Mr. Speaker, I ask that the two bills, 3788 and 3789 be postponed. 88 and 89."
- Hon. W. Robert Blair: "All right, does the gentleman have leave to place them on postponed? Postponed consideration.

  All right, they will be postponed. The gentleman from Lawrence, Mr. Cunningham."
- Roscoe D. Cunningham: "Mr. Speaker and Members of the House.

  We're honored today to have some of the Petrolia School

  Students from Lawrence County in the balcony on the east

  side, would you please stand up. The Principal is Martha

  C. Brookhart, my sister."
- Hon. W. Robert Blair: "The gentleman from . . . 3645."
- Fredric B. Selcke: "House Bill 3645. A bill for an act to amend Sections 3 and 7 of 'The Illinois Industrial Develop-



ment Authority Act'. Third reading of the bill."

Hon. W. Robert Blair: "The gentleman from Franklin, Mr. Hart.

Richard O. Hart: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. This bill was projected by the Governor. It would amend 'The Illinois Industrial Development Act' to expand the landing authority to include lawns for recreational purposes. This is a very important piece of legislation to my district and to the counties in southern Illinois in the area of economic depression. And I would appreciate the support of the House. The bill was in Executive Committee, passed out with a vote of 12 to 6, I believe, and I would appreciate your support."

Hon. W. Robert Blair: "Further discussion? The question is shall House Bill 3645 pass? All those in favor will vote 'Yeas' and the opposed 'No'. Have all voted who wished? The Clerk will take the record. On this question, there are Dan Pierce, 'Yeas', Pate Philip, 'No', Hirschfeld, 'Yeas', Walters, 'Yeas', Bartulis, 'Yeas', Phil Collins, 'Yeas', Glass, 'Yeas', Scariano, 'Yeas', Day 'Yeas', Dyer, 'Yeas', Bluthardt, 'Yeas', Fleck, 'Yeas'. On this question, there are 110 'Yeas', 6 'Nays', 2 'Present' and this bill having received a constitutional majority is hereby declared passed. Introduction and First Reading of House Bills."

Fredric B. Selcke: "House Bill 4641, Jones, et.al. Appropriates \$21,250.00 to the Capitol City Railroad Relocation Authority. First reading of the bill. House Bill 4642, Barry,



et.al. Appropriates \$682,672.00 to the Legislative Council First reading of the bill. House Bill 4643, Barry, et.al. Appropriates \$25,000.00 to the Legislative Council for science research unit and consulting panel. First reading of the bill."

Hon. W. Robert Blair: "Further committee reports."

Fredric B. Selcke: "Mr. Henss, from the Committee on Higher Education to which House Bills 4323 and 4451 were referred, reported the same back with amendments thereto, with the recommendation that the amendments be adopted and that the bills, as amended, do pass. Mr. Henss, from the Committee on Higher Education, to which House Bills 1719, 4447, 4448 and 4496 were referred, reported the same back with the recommendation that the bills do pass. Mr. Henss, from the Committee on Higher Education, to which House Bill 2428 was referred, reported the same back with amendments thereto, with the recommendation that the amendments be adopted and that the bill, as amended, do not pass. No further committee reports."

Hon. W. Robert Blair: "Resolutions."

Fredric B. Selcke: "House Resolution 600, Hirschfeld. House Resolution 601, Lechowicz, et.al. House Resolution 602, Berman. House Resolution 603, Palmer, et.al. House Resolution 604, Palmer."

Hon. W. Robert Blair: "Agreed Resolutions."

Fredric B. Selcke: "House Resolution, House Joint Resolution 69, Harold Washington. House Joint Resolution, excuse me,



Senate Joint Resolution 69, Harold Washington and House Joint Resolution 129, Clabaugh, et.al."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Hyde." Henry J. Hyde: "Ah, Mr. Speaker, the Agreed Resolutions are House Resolutions 600, commends and congratulates the Nets. a women's basketball team from Urbana, Illinois, upon winning their second year in a row, the University of Illinois Women's Intramural Basketball championship. House Resolution 603 congratulates the Sisters of St. Mary upon their 100th anniversary. House Resolution 602 urges President Nixon to solemnly appeal to the Soviet leader to end the discrimination against the people of the Jewish faith when he visits the Soviet Union. House Resolution 601 commends the Polish National Alliance and its President Aloysius Mazewski, on the 181st anniversary of the adoption of the Polish constitution. Fredric B. Selcke: "House Bill 4645, McPartlin. Amends 'The Township Zoning Act'. First reading of the bill. House Bill 4646, McPartlin. Amends an act concerning public utilities. First reading of the bill."

Hon. W. Robert Blair: "All right, the House will be adjourned until 11:00 A.M. tomorrow."
