A roll call for attendance was taken and indicated that all were present with the exception of the following: Representative John B. Brandt - illness; Representative James Y. Carter - illness; Representative J. Horace Gardner - death; Representative Thomas R. Houde - illness; Representative Henry J. Klosak - illness; Representative Michael H. McDermott - illness; Representative James Pate Philip - illness; Representative Edward J. Shaw - death. Hon. W. Robert Blair: "The Doorkeeper will see that those persons who are not entitled to the floor are removed therefrom. The House will be in order. The invocation this afternoon will be by Dr. Johnson."

Dr. John Johnson: "We pray. Lord God, we know that sometimes it is difficult for us to pray. This is perhaps one of those times. And yet, we know that you hear us even when we haltingly approach you. You know, O Lord, much more than dd we both the extent and degree to which we stand in need of your guidance and counsel and your strength right now. As great issues confront the Members of this House, give them, above all, clarity of thought and purity of conviction which will enable them to discuss, to debate, and then reflect the will of the people in the decisions which they ultimately make. Grant that we may always be able to live with our own decisions. Grant that we may ever recognize the rights of others to hold to their decisions. And grant that we may always be ready to place the final disposition of all items before your tribunal. Be present with them now and ever strengthen them to acknowledge their accountability to you, the Searcher of all hearts and the Judge of all men. Give all of us now your Spirit to seek peace and to live peaceably with each other, in this House, and in this Session. We ask this in the Name of Our Savior. Amen."

Hon. W. Robert Blair: "Roll Call for attendance. The gentleman from Cook, Mr. Shea."

Gerald W. Shea: "Mr. Speaker, I question a quorum of this

House. I would ask for an oral Roll Call and I would ask that the person get up and identify himself that he is here." Hon. W. Robert Blair: "Alright.. There are ah.. 164 Members here. That is a quorum and your request for an oral Roll Call is denied. Messages from the Senate."

Fredric B. Selcke: "Ah.. Messages from the Senate by Mr. Wright, Secretary. Mr. - I am directed to inform the House of Representatives that the Senate has passed Bills of the following titles, in the passage of which I am instructed to ask the concurrence of the House: Senate Bill 1335, 1442, 1443, 1489, 1492, 1499. Passed by the Senate, May 23, 1972. Kenneth Wright, Secretary. Mr. Wright, Secretary. Fredric B. Selcke: "Mr. Hunsicker, from the Committee on Agriculture, to which House Bill 1071, 2185, 2186, 2302, 2694, 2695, 2696, 2697, 2833, 2845, 3575, 3576, 3610, 3617, 3668,

3669, and 3670 were referred, reported the same back with the recommendation that the Bills be ordered to lie on the table, pursuant to Rule 32(c) and 32(d). Mr. Hunsicker, from the Committee on Agriculture, to which House Bill 4661 was referred, reported the same back with the recommendation that the Bill do pass and that it be re-referred to Appropriations. Mr. Conolly, from Public Utilities, to which Senate Bill 1279 was referred, reported the same back with the recommendation that the Bill do pass and be placed on the Consent Calendar. Mr. Conolly, from the Committee on Public Utilities, to which Senate Bill 1557 was referred, reported the same back with the recommendation that the Bill do pass. No further Committee Reports."

Hon. W. Robert Blair: "The gentleman from Cook, Mr. Hyde."
Henry J. Hyde: "Mr. Speaker, ah.. I move, pursuant to Rule 81, that ah.. the floor be cleared of all unauthorized personnel."
Hon. W. Robert Blair: "Right.. And, in order that we can make sure of who is authorized and who isn't, the Clerk of the Floor will be cleared of all persons, other than Members. And, those persons, who are entitled under Rule 81 to be on the floor, will be readmitted, only upon identification. And ah.., Mr. Doorkeeper, ah.. will you see that ah.. those persons... that everybody is off this floor except the Members and that nobody comes back in, even though they are entitled, until they have identification? And ah.., I want that door and these two and I want the hallways cleared of all persons other than those that I mentioned. And, I want



those doors on both sides of the ah.. Chamber ah.. ah.. watched for that purpose. Alright.. The floor, now having been ah.. cleared of all persons other than Members, the Doorkeepers are instructed to only allow those Members.. or those persons back on the floor who are permitted to be on the floor, under Rule 81, but only upon identification. And ah.., I suggest that they... in order not to be challenged later on ah.., perhaps, pin a little ah.. ah.. identification on their ah.. ah.. attire. Alright.. The gentleman from Cook, Mr. Shea, for what purpose do you rise?"

Roll Call. Now, I know that all votes will be taken by the electronic Roll Call. But, that's votes. Now, I asked for a quorum... to see if a quorum of this House was present. Certainly, the Speaker made the first step in that direction by using his power, under Rule 81, to clear the House. But, as I look around, I see a number of empty seats. And, I just wanted to make sure that we had a sufficient number of Members on this floor to conduct the business of this House." Hon. W. Robert Blair: "Alright.. Under what Rule are you preceding?"

Gerald W. Shea: "Mr. Speaker, ah.. I think it's a Rule in the sixties. I don't...."

Hon. W. Robert Blair: "Well, you name the Rule. I'm not going.. I'm not prepared to rule unless you name a particular Rule under which you're ah.. requesting the Chair to direct its attention. While we're waiting on that, further Committee

Hon. W. Robert Blair: "Introduction and First Reading." Fredric B. Selcke: "Ah.. House Bill 4676, Regner, a Bill to make an appropriation for the ordinary and contingent ex-

penses of the Joint Legislative Commission of Economic Advisors. First Reading of the Bill."

Hon. W. Robert Blair: "The ah.. gentleman from ah.. Cook,

Mr. Shea. Have you found the Rule now that ah..."

Gerald W. Shea: "Yes, but..."

Hon. W. Robert Blair: "Alright.."

Gerald W. Shea: "We got a little bit farther than I wanted to real quick...."

Hon. W. Robert Blair: "Well...."

Gerald W. Shea: "I would make a request that all Bills in this House be read in full on all stages of the proceedings. I realize full well that the Constitution no longer requires it, but I understand full well that the Rules of this House do require it. Now, with regards to my question on a quorum call, Rule 73 says, 'when a call of the House or a vote shows that there is not...."

Hon. W. Robert Blair: "What Rule?...."

Gerald W. Shea: "Rule 73, Mr. Speaker. It says, 'when a call of the House' and I am requesting a call of the House to see

if there is a quorum present. Or, 72, Mr. Speaker." Hon. W. Robert Blair: "Alright.. The gentleman has asked for a call of the House ah.. pursuant to Rule 72. So, ah.. we will take that by a record Roll Call. All Members present will so indicate by voting ah.. on the Roll Call 'aye'. There are a hundred and one persons voting and that's a quorum. For what purpose does the gentleman from Cook, Mr. Shea, rise?"



Gerald W. Shea: "Under Rule 63, I request a verification." Hon. W. Robert Blair: "Alright.. Now, I'm going to allow the first verification. Although, under that Rule, which is ah.. ah.. the Chair's Ruling that ah.. that only pertains to Roll Call votes, not to calls of the House. But, we will verify it this.. this ah.. particular quorum call of the House. Ah.. the Members will be in their seats. That means every Member. Alright.. Hon. W. Robert Blair: "Alright.. The questions of the ah..

of those voting ah.. ah.. present. The gentleman from Cook, Mr. Shea."

Gerald W. Shea: "Representative Burditt?"

Hon. W. Robert Blair: "How is he shown on the Roll Call?"
Fredric B. Selcke: "The gentleman is recorded as voting 'present'... 'aye'."

Gerald W. Shea: "Is he in his seat, Mr. Speaker? Oh! There he comes. Representative Conolly?"

Hon. W. Robert Blair: "How.. How's the gentleman shown?"
Fredric B. Selcke: "The ah.. gentleman is shown as voting
'vea'."

Hon. W. Robert Blair: "Alright.. He is not present. So, take..." Gerald W. Shea: "Representative Nowlan?"

Hon. W. Robert Blair: "Take.. Take him off the attendance Roll Call."

Hon. W. Robert Blair: "How's the gentleman from Stark, Mr. Nowlan, shown?"

Fredric B. Selcke: "The gentleman ah.. is recorded as voting 'yea'."

Hon. W. Robert Blair: "He's not in his seat. So, take him off ah.. the quorum call."

Gerald W. Shea: "Representative Philip?" Hon. W. Robert Blair: "How's he shown?" Fredric B. Selcke: "The gentleman is recorded as 'not voting'." Gerald W. Shea: "I have no further guestions."



Hon. W. Robert Blair: "Conolly is there in the aisle. So, put him back on the attendance call. Alright.. on this question, there are a hundred ah.. present and that is a quorum. The ah.. gentleman ah.. ah.. from ah.. Cook, Mr. Carroll, for what purpose do you rise?"

Howard W. Carroll: "Mr. Speaker, before there is an official announcement of that, I would like to know how I was recorded on the Roll."

Hon. W. Robert Blair: "It's already been verified. And, once the matter has been verified ah..., and the questions were asked by the person who requested, ah.. and it's announced, then that's it. So, if you care to find out, you may come up here. I... For the record, which is being transcribed, Representative Carroll from Cook County is on the floor. Now, if you want to come up and see if you're on the Roll Call, you may do so. Alright.. Ah.. The ah.. gentlemen from ah.. ah.. Cook, Mr. Lechowicz, for what purpose do you rise?"
Thaddeus S. Lechowicz: "Mr. Speaker, before the Roll Call was verified, I was ah.. trying to ah.. seek your recognition

to be recorded as 'present'."

Hon. W. Robert Blair: "Well, that matter has gone by. But, I will state, through the record, that you are indeed present. The gentleman from ah.. Cook, Mr. Douglas."

Bruce L. Douglas: "I also tried to attract your attention, Mr. Speaker. I'd like to be recorded as 'present'."

Hon. W. Robert Blair: "We're not going to ah.... The.. The Roll Call is already ah.. ah.. been ah.. verified. And ah..

and.. and the results have been ah.. announced. For what purpose does the gentleman from Cook, Mr. B. B. Wolfe, rise?" Bernard B. Wolfe: "Ah.. Mr. Speaker, a point of parliamentary inquiry, if I may. Was the ah... Was this verification the verification of the attendance Roll that was taken at the opening of the Session or was it merely the verification of a Quorum Call which was made subsequent to the attendance record?"

Hon. W. Robert Blair: "No and yes. The gentleman from Cook, Mr. Scariano."

- Anthony Scariano: "Ah.. may the record show that I'm on the floor, Mr. Speaker."
- Hon. W. Robert Blair: "House Bills Second Reading. The ah.. There has not been an indication to the Chair that any Members, who have Bills on Second Reading, desire for those ah.. to be ah.. called. And, so ah.. I would suggest ah.. for a few minutes here why we'll wait that there's an indication of any Member that has a Bill on Second Reading and desires it to be called ah.. for Second Reading, the Chair will ah.. consider doing that. The gentleman from ah.. Cook, Mr. D. J. O'Brien, for what purpose do you rise?"

Daniel J. O'Brien: "Mr. Speaker, on a point of personal privilege ah.. my Mother told me that there would be days like this. So, I would like to take this opportunity to introduce to this House, in the Gallery right behind me, my Father and my Mother and my Brother, Patrick. Well, not.. not days just like this, but almost."

Hon. W. Robert Blair: "Alright.. 4437."

Fredric B. Selcke: "House Bill 4437, a Bill for an Act to amend the 'Revenue Act'. Second Reading of the Bill. No Committee Amendments."

Hon. W. Robert Blair: "Any Amendments from the floor? The gentleman from ah.. Cook, Mr. Shea, for what purpose do you rise?"

Gerald W. Shea: "Mr. Speaker, I've requested of the Chair that all Bills be read in full."

Hon. W. Robert Blair: "State your Rule."

Gerald W. Shea: "Rule 37."

Hon. W. Robert Blair: "Rule 37 provides 'that every Bill shall be read at large on three different days'. The question of construction is what does at large mean. In order to make that provision coincide with the provision of the State Constitution, ah.. which provides 'that a Bill shall be read by Title on three different days in each House. It's the Chair's Ruling that at large simply means that it shall be read before the House and that the ah.. Constitutional ah.. mandate that it shall be read by Title will be followed. So, the readings by the Clerk satisfies the Rule as the Chair interprets the Rule."

Gerald W. Shea: "Mr. Speak... Mr. Speaker, I respectfully dissent from the Chair's Ruling and ask that my comments by journalized because, I think, we're putting this Bill in jeopardy."

Hon. W. Robert Blair: "Third Reading. For what purpose does

Hon. W. Robert Blair: "Well, I.. I asked the Clerk for further...
if there were any Amendments and ah.. and ah.. I.. I didn't
ah.. Well, there is a ah.. piece of paper here which says,
'Amendment to House Bill 4437' with no indication of anyone
being a Sponsor on it. And, also it says, 'Amendment No.
blank'. Well, I understand why the Clerk when I asked for
Amendments, said that there ah.. that there was no indication that there were any before him."

Raymond W. Ewell: "Well, ... "

- Hon. W. Robert Blair: "The Chair has no further requests for any ah.. Bills to be read on Second Reading. House Bills Third Reading. We'll go back to Second Reading. There is one Bill. 4.. Back to Second.. 4408."
- Fredric B. Selcke: "House Bill 4408, a Bill for an Act to provide for the timely deposit of fees collected pursuant to law by any elected or appointed official of local government. Second Reading of the Bill. Second Reading of the Bill.

One Committee Amendment. Amend House Bill 4408 on page 1,..." Hon. W. Robert Blair: "The gentleman from McLean, Mr. Hall." Harber H. Hall: "Ah.. Mr. Speaker and Ladies and Gentlemen of the House, House Bill 4408 ah.. relates itself to the ah.. depositing of fees ah.. by County and ah.. Municipal ah.. ah.. Treasurers ah.. on a regular basis in accordance with the Constitution. Ah.. this ah.. Amendment changes the wording so that the ah.. deposits have to be made ah.. at least



monthly and can be made at any other time. I move for the adoption of the Amendment."

Hon. W. Robert Blair: "Discussion? All those in favor of the adoption of the Amendment say 'aye',... We have ah.. five ah.. Alright.. Ah.. Mr. Mike Madigan, from Cook, Mr. O'Hallaren, Mr. Yourell from Cook, Mr. ah.. Bradley from McLean, Mr. Berman from Cook. Alright.. On the adoption of Amendment No. 1, to House Bill 4408, all those in favor will vote 'aye' and the opposed 'no'. Have all voted who wished? The Clerk will take.... Ah.. take the record. On this question, there are ah.. 77 'Ayes' and no 'Nays' and ah.. for what purpose does the gentleman from Cook, Mr. O'Hallaren, rise?"

Bernard J. O'Hallaren: "Ah.. Mr. Speaker, I wasn't able to get on the ah.. my. my switch. I'd like to be recorded as voting 'aye'. And, also I would like to poll the absentees." Hon. W. Robert Blair: "Well, any Member can... What Rule are

you ah.. asking for polling the absentees under?" Bernard J. O'Hallaren: "Well, if you'll just wait a second,

I'll get my little book."

Hon. W. Robert Blair: "The gentleman from ah... Well, while he's ah.. looking at the point, I'll recognize the gentleman from McLean, Mr. Hall."

Harber H. Hall: "Ah.. Mr. Speaker, in view of the fact that there were no dissenting votes ah.. against this Amendment, it would ah.. seem that the request is a dilatory move and I ah.. respectfully ah.. request the Chair to go on to continuing

business."

Hon. W. Robert Blair: "Well, Rule 63 does provide that, 'any Member may demand a verification of the Roll Call vote. And, this ah.. was a Roll Call vote. The gentleman from ah.. ah.. But, there has not been a ah.. a request for a verification. There has been a request to poll the absentees. And ah.., I have asked the gentleman from ah.. Cook, Mr. O'Hallaren to cite the Rule that he's referring to on polling

the absentees. The gentleman from Cook, Mr. O'Hallaren." Bernard J. O'Hallaren: "Well, Mr. Speaker, with all due respect ah.., as long as I've been in this House, I've never heard that there is a written Rule in our Rule Book relative to polling the absentees. And, I notice that the Speaker has ah.. allowed this on previous occasions and I would like to know under what Rule he allowed it."

Hon. W. Robert Blair: "Courtesy of the Chair."

Bernard J. O'Hallaren: "And then, may I have the same courtesy, please?"

Hon. W. Robert Blair: "The gentleman from McLean, Mr. Hall." Harber H. Hall: "Well, Mr. Speaker, ah.. ah.. I recognize the privilege of the Chair ah.. at times ah.. when it indicated.. indicates that it might have some meaning. I ah.. reiterate that there were no dissenting votes.on behalf of ah.. against this Amendment. And, it would seem that ah.. ah.. that the request need not be approved in view of the fact that it's dilatory."

Hon. W. Robert Blair: "Well, I ah.. I agree. This is a ques-

tion that's decided by a simple majority vote. And ah.., there were 77 'Ayes' and no 'Nays' and.. and it would appear that the gentleman's ah.. objection on the question that this being a dilatory question inasmuch as the gentleman could not find a Rule for that provision, the Chair will so hold. The gentleman from ah.. Cook, Mr. Shea."

Gerald W. Shea: "Mr. Speaker, how am I recorded on the ah.. vote?"

Hon. W. Robert Blair: "How is ah.. the gentleman from.Cook recorded?"

Fredric B. Selcke: "The ah.. gentleman is recorded as 'not voting'."

Gerald W. Shea: "May I be recorded as 'present', please?" Hon. W. Robert Blair: "Record the gentleman has 'present'.

Any ah.. further Amendments?"

Fredric B. Selcke: "Amendment No. 2, Hall, amend House Bill 4408 on page 1, by deleting lines 18 and 19 and inserting in lieu thereof the following:..."

Hon. W. Robert Blair: "The gentleman from ah.. McLean, Mr. Hall."

Harber H. Hall: "Ah.. Mr. Speaker and Ladies and Gentlemen of the House, Amendment No 2, in respect to this same Bill, ah.. clarifies the language in the last sentence ah.. in respect to certain fees that are not properly ah.. in control of the Municipality involved. Ah.. these fees are actually in a state of limbo or escrow. And ah.., we are trying to define these fees. And, I move for the adoption of Amendment



No. 2, to 4408."

Hon. W. Robert Blair: "Is there discussion? The question from Bureau, Mr. Barry."

Tobias Barry: "Will the Sponsor yield to a question?" Hon. W. Robert Blair: "He indicates he will."

Tobias Barry: "Harber, I don't find anything about fees in

the last line, as you ah.. attempted to explain it. Would you ah.. explain it again to me, please?"

Harber H. Hall: "Ah.. I.. I'll be happy to ... "

Tobias Barry: "Ah.. I'm looking at the Bill and I see nothing about fees in the last line. Do you mean Section II, the last paragraph?"

Harber H. Hall: "Well, the last.. the last sentence ah..

Excuse me, I meant the last sentence when I said the last

line. The last sentence ah..."

Tobias Barry: "The last sentence says, 'such Officials, however, may maintain overpayments, tax redemptions, trust funds and special funds as provided for by Law or Ordinance'. It has nothing to do with fees."

Harber H. Hall: "Ah.. yes. This clarifies which monies ah.. Ah.. the fee money must be deposited. But, there are certain other monies ah.. that come into the hands of certain treasurers, County and.. and City ah.. ah.. Treasurers that they ah.. ah.. are not properly accountable to the Municipality for whom they serve. These fees, we are not requiring to be deposited in accordance with this proposed Bill." Tobias Barry: "Well then, where would they be deposited?"

Harber H. Hall: "That would be ah.. a matter of ah.. ah.. the policy of that particular Treasurer. If he's asked to ah.. hold ah.. in his custody property or monies belonging to others, ah.. he would have the authority to determine where that would be held. And, I presume that would be upon negotiation with those who properly ah.. ah.. would be reflected as owners of that money."

Tobias Barry: "Well, let me ask this question. Your ah.. Amendment No. 2 says, 'that the public official may maintain overpayments'. Now, I don't think that this is a good Amendment because there's no limitation on what that overpayment may be. We may be dealing in pennies. We may be dealing in hundreds of thousands of dollars. Ah.. dc you think that it's a good Amendment in spite of the fact that ah.. could be the case?"

Harber H. Hall: "Well, obviously, an overpayment ah.. is not money properly belonging to the Municipality involved and should not ah.. ah.. The control of that should not be dictated by State Legislation. We are ah.. trying to ah.. protect the money properly belonging to the Municipality ah.. involved. And ah.., heretofore, before this Bill, ah.. if it passes, ah.. there's been nothing statutorily ah.. proclaiming what's to be done with ah.. money held by Treasurers of Municipalities ah.. that belong to the Municipality. That is to say, that a County Circuit Clerk or a County Treasurer could ah.. ah.. keep the money in his desk drawer or he could take it home or keep it in a shoe box. Ah.. this specifies



that it will be deposited on a regular basis. Ah.. monies that don't belong to the Municipality, ah.. we ah.. ah.. again, reiterate with this Amendment 2 that ah.. that would ah.. be ah.. in his control. Of course, it's pointed out that he is a bonded official and, if he would abscond with anybody's money, ah.. he would be subject to other statutes. Tobias Barry: "But, Harber, correct me if I'm wrong. But. ah.. that last sentence seems to indicate the exception to the Rule that is ah.. recited in Section II by the first full ten line sentences or thereabouts in that the last sentence that you are attempting to correct by this Amendment suggests that the Official may maintain monies other than in an account, if I understand the Amendment correctly. And, if I.. I do, I might add that I think it's a bad Amendment."

Harber H. Hall: "Well, this.. this pertains to ah.. regular depositing ah.. as per... prescribed place. Monies that belong to the Municipalities such as taxes and fees. Other monies that we can't enumerate or specify that ah.. ah.. are asked to be held in escrow in someone's office, ah.. have... ah.. ah.. are beyond the control, we suspect, of the General Assembly and ah.. through the statutes. Ah.. we are protecting only certain monies that ah.. we ah.. control through statutory provisions to collect the money in the first place." Hon. W. Robert Blair: "Is there further ah.. discussion? The gentleman from Cook, Mr. Berman."

Arthur L. Berman: "Mr. Speaker, I respectfully request a Roll

Hon. W. Robert Blair: "Ah.. Alright.. Mr. Berman.. Mr. O'Hallaren.. Mr. Matijevich and Mr. McGah and ah.. Mr. Carroll and ah.. Mr. McLendon. The question is on the ah.. adoption of the Amendment. All those in favor will vote 'aye', and the opposed 'no'. For what purpose does the gentleman from ah.. Cook, Mr. Shea, rise?"

If you'll read it, Harber, you'll find that the ah.. language that you mean to insert ends with a period which means then that you are knocking out the last two lines of the Bill in fact or, at least, there's a period prior to the last two lines of the Bill and there is no new sentence starting. And so, therefore, I think this.. this Amendment should be withdrawn and redrafted."

Hon. W. Robert Blair: "The gentleman from ah.. McClain, Mr. Hall."

Harber H. Hall: "Ah.. Representative Barry, you are entirely correct. I noticed that myself. I encircled it and sent it down to Mr. Bobbitt pointing that out and I intend to correct this in the Senate. Unless the Clerk can make a correction at this... at this ah.. stage by ah.. crossing out the period, I would respect... respectfully suggest that ah.. we pass this and send it over to the Senate where it will be corrected. Can it be changed in Enrolling and Engrossing by ah.. a mark by the Clerk?"

Hon. W. Robert Blair: "Yes, that's a matter that can be handled in Enrolling and Engrossing here in the House. Barry.. 'no'."
Harber H. Hall: "Thank you, Mr. Barry, for suggesting that."
Hon. W. Robert Blair: "The gentleman from Cook, Mr. O'Hallaren."
Bernard J. O'Hallaren: "Ah.. Mr. Speaker, ah.. Ladies and Gentlemen of the House, at the appropriate time, I would ask ah.. for a verification. But, I think, from what we've been doing in the past few weeks is ah.. polling the absentees

Hon. W. Robert Blair: "The ah., gentleman from Champaign, Mr. Hirschfeld."

John C. Hirschfeld: "Well, Mr. Speaker and Ladies and Gentlemen of the House, I ah.. would not want to take away any of the distinguished Representative's rights. But, it seems to me that this is plainly dilatory. And, under Robert's Rules of Order, which is all we have to turn to in a situation like this, it sets forth quite clearly what should happen with dila... with dilatory motions. And, it states that a motion is dilatory if it seeks to obstruct or thwart the will of the Assembly as clearly indicated by the existing parliamentary situation. And, it goes on in greater length and, of course, it gives the Chair the right, naturally to always be courteous and fair. But, it is to be at the same time firm in protecting the Assembly from imposition. And. I must say, in all sincerity, that, I think, it is an imposition on the rest of the Members of this House, to persist in these dilatory motions. And, I would sincerely appreciate that if the Chair would rule that it is dilatory and proceed with the business of the General Assembly. If you've an opportunity of reading the newspapers lately, you would notice that many of the youngsters that come down here and visit the House have been extremely upset by what they think is dilatory motions on our part anyway. When they are so obviously dilatory, I think they should be eliminated."



- Hon. W. Robert Blair: "Alright.. On the ah.. gentleman's question from ah.. ah.. Champaign, ah.. Mr. Hirschfeld, of course, Rule 63 provides that any Member may demand a verification of a Roll Call vote. Hon. W. Robert Blair: "How's he recorded?"

Bernard J. O'Hallaren: "That's all, Mr. Speaker. Thank you." Hon. W. Robert Blair: "On this question, there are 48 'Ayes',

13 'Nays', 21 'Present' and ah.. 22 'Present' and the ah.. Amendment is adopted. Are there further Amendments?" Fredric B. Selcke: "Amendment No. 3, Ewell, amend House Bill

4408 on page 1, by striking the Enacting Clause."

Hon. W. Robert Blair: "The gentleman from ah.. Cook, Mr. ah.. Ewell."

Raymond W. Ewell: "Mr. Speaker and Members of the House, I, above all people, do not believe in dilatory tactics. I think what we must do here is look at the heart of the matter. Now, Legislator's interests must be a little longer than the rivers and dams in his District and his scope must be a little wider than the creeks and sloughs. And, therefore, I have look at this particular Bill and have determined that it would be good for the people of the entire State if we struck the Enacting Clause. I'd like to say that what this Bill does, in effect, it gives a backhanded indictment of the Mayors, Treasurers, Public Officials of this State with and without cause. I can understand the harsh criticism that might come from some Districts. But, I can not believe



in an indictment that would be as broad as this because this indictment would extend, not only to the large City of Chicago and not only to the Northern Cities like Rockford, but it would reach down to the smaller Cities like Cairo and the tip of our State. And, it would indict the Treasurer. It would say that your present method is not good enough. That some how or another, you have been purloining the money that belongs to the people or to the State. This is a serious charge, Mr. Speaker, and it should not be leveled in a shotgun blast. It should be leveled at each individual District. If there's some reason for us to believe that the Treasurer of Bensonville is not doing the right thing, should we not leave this to the people of Bensonville to decide? Why should we, as Members of this Legislature, invoke our wisdom and seek to take away the Home Rule Powers of such Communities as Aurora and Lincoln. Mr. Speaker, I think we're doing a grave and serious injustice when we allow this Bill to stand. Because, as it is written, it would cast that inference that somehow some people in a Village like Antioch might not be doing the right thing. Mr. Speaker, I think that this is a serious charge. It's something that the Legislature should take into the utmost consideration before we decide to tinker in the internal affairs of all of the Public Officials of the State of The ramifications of this Bill are numerous. What Illinois. we're going to do by enacting this Legislation is make City Councils all over the State pass new Laws, change their

27.



accounting systems, change, perhaps, the banking systems that they have. And, we are, in general, going to cause chaos and disruption beyond our intention. Mr. Speaker, if we would give this Bill adequate consideration, we would determine what havoc we're about to play upon the people of the State. And I, from a large City, find that it is necessary to enlarge my scope and vision and not narrow it down to only my own selfish interest in the Twenty-Ninth District. And, I must try to somehow arise as a Statesman and consider the entire State and consider the affect of this Legislation which we are about to perpetrate upon the people. I suggest . that there has been... that I have received no letters from Alton, Rock Island, Olney, nor any letters from my District stating that this type of Legislation is necessary. I find that this type of Legislation, to the contrary, is a direct assault upon the integrity of elected officials, officials who have been elected by the people of their District. And, who should have the right to speak for the District but the Officials. Now, the County Treasurers, the City Treasurers, they have their own methods of accounting. They have been doing it this way for a number of years. I have seen no ground swell or cry from any section of this State that there is any pilferage or larceny from any of these Districts. And, I think, what we do here is a devious thing with wicked and evil implications. Mr. Speaker, if we examine this Bill, we will soon become aware that it is, in fact, a sinister evil and malodorous indictment of people from all sections

of the State. I've heard nothing from the Sponsor to determine who requested this Bill. I've heard nothing from any Member who said that they received any communication on this type of Legislation. And, if we are to seriously view that which we are doing, we would realize that our forefathers, when they adopted the Constitution of the State of Illinois, were aware of these things, but they did not tinker with the internal mechanisms of the local officials. They did not dare to approach the Home Rule Sections. And, the Constitution, and our fathers even amended the Constitution, and again, we fail to tamper with time-honored and respected principles of self-government and self-determination. And again, Mr. Speaker, we amended the Constitution and we had a Constitutional Convention within the past few years. Agaih. these wise men from all over the State considered this subject. Men from all sections, from every County came together and thrashed out the problems. And, I'm talking about the Counties of Cook, the County of Champaign and others, Lake County also. Mr. Speaker, when these men came together from all parts of our State, again, they did not interfere in the internal workings of the Local Units of Government, the time-honored sections, those that we have all felt necessary to look to for guidance and for trust. Mr. Speaker, I suggest to you that, when the people got together and reviewed the Constitution, again, they found no need to tamper with the internal affairs of Local Government. To the contrary, they extended onto Local Governmental Units the power

of self-determination, a time-honored and accept principle which the voters endorsed, not halfheartedly, if you please, but wholeheartedly. And, as the people pile vote upon vote of thanks to the delegates of the Constitutional Convention for this fine Constitution, howhere, howhere, did they make any mention of such an evil and malodorous Bill. Mr. Chair... Mr. Speaker, I suggest that we're going into the dark waters of finance where there is no bottom and where we can see neither to the right and neither to the left. I suggest that there is only one way that the people of the State of Illinois ought to be financed and that is the proper way. And, that is by... is determined by those Local Units of Government. This Bill will take away power from the people. And, therefore, it is bad. It will tend to concentrat power in the evil hands... Mr. Speaker..."

Hon. W. Robert Blair: "The gentleman from Cook, ah.. Mr. Hyde." Henry J. Hyde: "Well, Mr. Speaker, ah.. I so enjoy the ah.. ah.. the ah.. illumination that I'm hearing from the gentleman from Cook that I'd like to yield my ten minutes to the distinguished gentleman from Cook so that we can proceed with this instructive dialogue."

Hon. W. Robert Blair: "That cert... That certainly... That certainly is in order and we'll certainly give your ten minutes to him. Proceed, Mr. Ewell."

Raymond W. Ewell: "Mr. Speaker, it is from the... I must first acknowledge with a grateful heart...."

Hon. W. Robert Blair: "Ah.. Alright.. One.. One moment, please.



What... What... What... You... Just a minute.. The gentleman from Logan, Mr. Madigan, for what purpose do you rise?" Edward R. Madigan: "Ah.. Mr. Speaker, a point of information for Mr. Ewell that might help him in...in his making up his mind in what he wants to say about this Bill next. This Bill was before the Legislature in 1971 and was passed on June 23rd and you voted for it."

Hon. W. Robert Blair: "Alright.. Proceed now, Mr. Ewell."
Raymond W. Ewell: "Mr. Speaker, in light of that fact, I must
change my stance."

Hon. W. Robert Blair: "Well, you've got another ten minutes on your own for that. Yeah.."

Raymond W. Ewell: "And, like the distinguished Majority Leader,

I am prepared to admit and confess the errors of my way. Having taken a second look at this Bill, I have determined that, indeed, must have some good features. And, as a result, I think it's necessary to analyze the Bill. And, if someone would provide me with a copy, 4408, I will be glad to stand corrected in my sinful erroneous ways. Perhaps, I was a little rash and I have not heard from all the Counties. Having heard from Lake County and other Counties Downstate, the vote appears to be changing. And perhaps, it would be wise of us to give this Bill a little consideration. Perhaps, when we're talking about the money of the people of the State of Illinois, perhaps, we ought to treat it a little more carefully and with a little more consideration. Perhaps, there's some wisdom to taking this money out of non-interest

bearing accounts, politically favored banks and place it so it might gain the proper amount of interest and credit to the people of the State. And, in fact, this Bill might, indeed, be the first step toward a new, responsible fiscal policy that will endeavor to benefit all of the people of the State of Illinois. Because, if we collect these monies faithfully, carefully record them, tally them, place them in interest-bearing accounts, we might, indeed, help solve the serious fiscal policies that confront us. And, Mr. Speaker, we are all aware of the serious fiscal policies that face the State of Illinois. A penny saved is a penny gained. And, I think, that this principle must follow us from our \$900,000,000 renovation to the appropriation to the school children. I think that this principle for fiscal responsibility is a sound one. One that has been espoused by our forefathers. And, I, Mr. Speaker, am certainly for fiscal responsibility. I do not ... "

Hon. W. Robert Blair: "What... What... No.. Wait until he's finished."

Raymond W. Ewell: "I do not believe that we can continue on our ways of wild and reckless deposits. We must deposit carefully and with serious consideration..."

Hon. W. Robert Blair: "One.. One moment.. One moment, please. The gentleman from Logan, Mr. Madigan."

Edward R. Madigan: "Ah.. Mr. Speaker, Representative Hall has called my attention to an error that I made and I want to apologize to the gentleman from Cook, Representative Ewell.



That Bill was 2618 last year and it passed by a vote of 155 to 3 but Representative Ewell was not recorded as voting either way on the Bill."

Hon. W. Robert Blair: "Now.. Now, back to the gentleman from ah.. Cook, Mr. Ewell."

Raymond W. Ewell: "Mr. Speaker, again, I am glad to stand rectified. Never let it be said that the Representative from the Twenty-Ninth District will ever stand on any incorrect statement. Having taken my stand, Mr. Speaker, I shall not retreat. I think that this Bill now is in a nebulous area. I think that we ought to strike the Enacting Clause in order that we can start over and give it fresh consideration. I think that, as one distinguished Legislators has said, perhaps, we ought to meditate upon the subject. Perhaps, we ought to send to the mountains of India and seek guidance. Or, better yet, we should send the Bill back to Committee. Mr. Speaker, in all probability, this is probably a good Bill, if it were written correctly. But, I have come across some serious doubts, as have been pointed out by the Representative on our side of the aisle, who told about the defects in the Bill and the imperfections. And, I, for one, do not believe that we can hand out all of our responsibilities and delegate them to that unspeakable body on the other side of the aisle. I do not think that it is our function nor are we privy with any agreement between the people and the Senate, that the Senate should conduct all of the business, that the Senate should rewrite all of our

Legislation, correct all of our errors and to change the purport and the intent of the Bill. Mr. Speaker, we are in trouble indeed and we are in troubled times. And, I suggest that a new approach to this Bill by the proper consideration, perhaps, by a Committee of the Whole, the entire House. And if we placed all of the collective brains that we might have in our possession, we might again draft a Bill worthy of consideration, a Bill worthy of having our names stamped upon it. Mr. Speaker, I think that if you would convene a Committee of the Whole and give this Bill the proper consideration, the people of the State of Illinois would forever be indebted. And, whether we talk about the Counties of Jackson or Boone or Rock Island, Winnebago, Lake, Johnson, Peoria...."

- Hon. W. Robert Blair: "Wait... Wait a minute.. The gentleman.. The gentleman from Johnson, Mr. McCormick."
- C. L. McCormick: "Mr. Speaker, you'd better warn that gentleman not to take certain places in vain. Down in my Country, you know, Johnson County is famed for two fine things, shoe boxes and coon dogs."

Hon. W. Robert Blair: "Proceed."

Raymond W. Ewell: "Mr. Speaker, I noticed that...."

Hon. W. Robert Blair: "The gentleman from Rock Island, Mr.

Pappas, for what purpose do you rise?"

Peter Pappas: "Well, Mr. Speaker and Ladies and Gentlemen of the House, ah.. with the Speaker's eloquence, ah.. some of his arguments have gone completely over my head. And, I

would like to relinquish my ten minutes to the Speaker so that possibly in the next ten minutes, he could give me what his position is on this Bill."

Hon. W. Robert Blair: "Alright.. We will certainly grant the gentleman your ten minutes. Proceed."

Raymond W. Ewell: "It is with... It is with deep gratitude and humility that I accept this generous offer. In speaking for the people of the State of Illinois, I should like to go intp the technical Sections of this Bill for the elucidation and illumination of the Representative from Rock Island, whom we all love, admire and respect. The first Section sets out Legislative purpose. It tells what the Legislature intended to do when it enacted this piece of Legislation. Moreover, it serves as a guide to the Legislators as they read and wade through the voluminous material of this Bill. Voluminous not voluptuous.. It tells about the purpose of the Act and what we are intending to do, something like the situation when you want to be clear about something. You have to tell people, first of all, where you're going, you have to tell them when you arrive and you must tell them where you have This Bill talks about deposits and deposits are monies, been. collateral, consideration or anything of value that might be received by any of the divers public officials from City Treasurers...."

Hon. W. Robert Blair: "Ah.. One moment, please. For.. For what purpose does the gentleman from ah.. Winnebago, Mr. Simms, rise?"



W. Timothy Simms: "On a point of personal privilege, Mr. Speaker. Ah..today with us in the ah.. House Gallery is a group of ah.. school children from the Sixth Grade Class of Highland School, whose District is with Representative North, Giorgi and Myself. And, we're proud to have them down here today, if they would stand up, please. Highland School... Sixth Grade from Rockford."

And, I do not think there's a one of us under the sound of my voice or in this State who would like to be without money. These deposits and/or fees and fees is that consideration which is deposited to certain Agencies on behalf of certain individuals

We can talk about the Township Unit where the Township Collector is the person in charge and the person who would collect the fees. And, we can break it down into the Cities where the person is normally called the City Collector. And he, in turn, collects the fees and collects the fees that he might take on behalf of the people who are depositing them there for the particular State. Now, we have certain Counties and I'm sure...."

Rep. Arthur A. Telcser: "Representative Hall, for what purpose do you rise, Sir?"

And, I have just had a little information from a voter in Watseka and they told me that they're glad that, at least, one person in this General Assembly is going to look beyond the rivers and dams of his own District. They think that it is very admirable that we consider all of the people of the State. And, they think it's wonderful that we should give thanks to the many public officials who have collected monies for years and years and years. And, in many cases, they have accounted for these monies. The other cases are still pending. But, what we realize here is that we're tampering with the fundamental units of Government with this Bill. And, I think, therefore, it is worthy of the most sustained consideration. When I was a Member of the County... County Government Committee, I learned many things from the distinquished Leader and I learned many things about Township Government. But, one of the first things I learned, is don't ever tinker with Township Government because that is the fundamental unit of the people. I have respected this principle in the time that I have been here. And, I would urge my Colleagues, one and all, and from both sides of the aisle, to adhere to this sacred principle of Township Govern-

ment, don't tread on me. And, I think, that one of the most indispensable units is the County Collector and I have great respect for the County Collectors.
