But perhaps if you'd allow me to be a bit unconventional today I'd like for you to sit back and to relax and to picture with me a girl; she can be any girl. This girl is special because she is involved. I'm speaking to you today not as a Junior Miss but as one who has grown to know and to love the program which we're involved in. Now picture if picture with me, if you will, a girl; and I'm sure you all know one, two....maybe several like her. She's different because she is young and she is eager and she is concerned. Picture a girl who's been in choir in school, the church choir, the school band, the orchestra, the school plays. Perhaps she's involved in student government. Maybe she's on the athletic team in the winter time, the track team in the summer. She is in the National Honor Society. is a National Merit Semifinalist and she is an Illinois State Scholar. That may...may sound impossible but what she is is everything you could want in your own daughter. What I have described is a Junior Miss. Junior Miss is something that we believe in strongly because we're searching for the hope and the promise in girls of tomorrow. I guess the best way to describe Junior Miss to all of you



who may not understand it, is through a saying by Ralph
Waldo Emerson which goes something like this, 'Though

Winchester: "Yes, that is correct."

Winchester: "Last winter's program started in August. This year's winter program starts in February."

Satterthwaite: "But, what I'm asking is, will this money go
back to pay for temporary personnel who were hired for

future program?"

Winchester: "There were no persons hired for the previous program. This is for the new program."

Satterthwaite: "If we were able to execute one year's program without additional personnel, why is it necessary for the coming year to hire additional personnel?"

Winchester: "The answer is because it was practically impossible
to run last year's program without administrative assistance

and that's why we are asking forfor this type of assistance now."

Satterthwaite: "Well it seems to me it would be backwards to ask for it for a second year. We've already set the mechanism in order. The community action agencies have been through this once. The problems should have been



spending administrative money now for a program that's already been in operation....and should be functioning."

Winchester: "Representative, apparently no one, last year, was allowed to take any money out of the funds that were

appropriated to them for administration. This is the first year that administrative funds are being deducted."

Satterthwaite: "This then would be administrative funds that would be distributed to the community action agencies for administrative purposes, or in the Office of Manpower?"

Winchester: "It is for the Governor's Office of Manpower and
Human Development. The local agencies will be getting
their own money."

Satterthwaite: "This is not 'pass through' money to the community action agencies?"

Winchester: "No. They get their own money."

Satterthwaite: "Thank you."

Speaker Redmond: "Anything further? Representative Anderson.

Anderson: "Mr. Speaker, ...the Sponsor yield for a question?"

Speaker Redmond: "He indicates he will."

Anderson: "Representative, this last program that we've just been through, with the Crisis Intervention, where each person that was at 125 percent of poverty, was granted a \$250 grant to help with their fuel bills, that was supposed to end August 31 and on August 23 it was extended until September 23. Then, with the federal guidelines, that money was supposed to have been distributed in one month, or the program should have been finished by October 23.

As late as last week there was some grants that still weren't paid. Now will this additional money help to keep the payments in line with the federal guidelines? Because what I fear is any money that wasn't used by April 1 of

this \$200 that was given to the persons, in the name of the fuel companies, will revert back. And I think some of that money is going to revert back. Now will this



money speedup those payments so that the well-deserving people will get full use of this money?"

Winchester: "In answer to your question, Representative

Anderson, yes, it will. Apparently no states were given

Speaker Redmond: "Representative Matijevich."

Matijevich: "Yes, Mr. Speaker and Ladies and Gentlemen of the House, I'd like to remind the Ladies and Gentlemen of the House that when this Bill did leave the House of Representatives before, I had said that I wanted the agency to cooperate with the Democratic Staff of the Appropriations Committee. I know that we can't stop this legislation in one day's time. But I'd like to again give this warning to the Members of the House of Representatives. You know we talked about scandals in the nursing home industry and health care and all kinds of scandals. I believe that probably the greatest scandal that we'll ever have will be in the CETA program. I want to tell the Members of the House of Representatives that I think that the State of Illinois and especially having a Governor who tells the people all over the State of Illinois that he's one who believes in accountability, that we ought to stand firmly...that any program ought to have accountability. The CETA program and the operation of the Governor's Office and CETA's funds has been one that is so complex and so confusing I don't think anybody ... anybody can make heads or tails out of it. It is a classic case of where one can pass the buck. We have been held in limbo because of the matter of the difficulty of the East St. Louis CETA program. The difficulty of the Federal Government saying whether the prime sponsorship should be in St. Clair County or whether the State of Illinois should take over that sponsorship. There has been no decision. There has been indecision. I can't lay all of the blame on the Governor's Office and Director Murray. But I can say, from where I stand as Chairman of the Appropriations Committee that heard this legislation that we had better....and I think I'm talking not just to conservatives who always talk about accountability, I'm



talking about everybody, because we're talking about the employment of people who need jobs. We had better look at accountability. If I had more time I would want this legislation to stay right here so that we could fight and we could tell the Federal Government 'wait a minute, it's not your dollars it's our dollars.' It's everybody's dollars. We don't think it's free money. We want to make sure it's used properly. We want to make sure that it's not used for political purposes which we know it has been. Not byjust by Republicans, but by Democrats too. That's not the purpose of CETA funds. Now this Amendment is being put together in anticipation of the state being asked to take over these funds. There is no assurance that the state is going to be asked to take over these funds, Mr. Speaker. As a matter of fact, this Amendment will almost guarantee that the City of East St. Louis will lose the prime sponsorship and the state will be asked to take it over. I think that the City of East St. Louis ought to be allowed to remain as the prime sponsor of these programs and, therefore, I am going to oppose this Amendment, Mr. Speaker."

Speaker Redmond: "Representative Winchester."

Winchester: "In response, Mr. Speaker, to the Representative's statement. This is a federal decision and a federal decision only. If this money is not made available to the Governor's Office of Manpower and Human Development and it's a continuation then if, by some chance, the Department of Labor decides that East St. Louis is going to lose the prime sponsorship then there will be no public service programs in East St. Louis. Then what are they going to do

Mudd: "Did you do anything at all with the debt service formula on school construction at all? Did you add any monies at all, to it?"

Winchester: "I have been advised that we have not....But there is authority to use this money."

Mudd: "All right then, my understanding is that there is
money in the debt service account to take care of everything that we got going until the next Appropriation
Session."

Winchester: "That is correct."

Mudd: "Thank you."

Speaker Lechowicz: "The Gentleman from Macon, Mr. Dunn."

Dunn: "Thank you, Mr. Speaker. Will the Sponsor yield for a question?"

Speaker Lechowicz: "He indicates he will."

Dunn: "Were these funds in the administration's budget proposal from last spring?"

Winchester: "No. No, Representative."

Dunn: "And are they then in addition to what was proposed by

the...by the Governor at that time?"

Winchester: "That is correct but the Bureau of the Budget has approved them."

Dunn: "And for what specific projects are these funds designated?"
Winchester: "Well, do you want me to read all of them, or are

you just interested in your district, Representative Dunn?"

Dunn: "Well, my district would be an item of concern to me."

Winchester: "Why don't I read them? For Lake County, Waukegan, \$387,385; for Lake County, Fox Lake, \$501,523; for

Whiteside County, in River Bend, \$765,099; for DeKalb,

Genoa, \$1,344,358; Woodford, in Germantown Hills \$69, \$770,439;

Dunn: "What is the...."

Winchester: "Now, I like this, John, let me go on....\$858,264;

This is getting good, John. Perry County and St. Clair

County, DuQuoin, \$1,418,035; Dupo, \$67,000; Dupo 196,

\$58,000; Marissa, \$969,418; Cook County in Raster,

\$2,108,000; Cook County in Gompers, \$1,163,000; Cook,

Nansen, \$1,912,000; Cook, in McCormick, \$1,686,188; Cook

County, Byford, \$880,000; ...That's it."

Dunn: "What is the revenue source for these funds?"

Winchester: "Construction bonds."

Dunn: "And where does the debaty-service come from to retire those bonds?"

Winchester: "GRF."

Dunn: "General Revenue?"

Winchester: "General Revenue Funds."

Dunn: "Mr. Speaker, if I could just address myself to the Amendment...briefly."

Speaker Lechowicz: "Please proceed."

Dunn: "I would just like to impress upon the Membership what
we are doing here if this Amendment is approved, we are
authorizing General Revenue monies to be expended for the
purposes of school construction and I would ask each of
you to just think about your situation back home and ask
yourself whether the people back home would rather have
the money for new schools or whether they would like to
see this much General Revenue money plugged into the
School Aid Formula so they could keep open the schools
that they already have. Think about the districts back in
your legislative district...school districts which are
bankrupt at this time, who could use a grand total of
\$15,000,000. Think what \$15,000,000 would do to your



chances for reelection if you could go back home and say that was plugged into the School Aid Formula, think how many school board members, how many school superintendents how many parents, how many teachers and how many children would be proud of you to come home and tell them that.

Think about that when you vote about this money for construction of new buildings, not payment of money into the

Speaker Lechowicz: "Have all voted who wish? The Lady from Adams, Mrs. Kent, to explain her vote."

Kent: "Now that we have the votes I'll keep quiet. Thank you."

Speaker Lechowicz: "The Gentleman from Cook, Mr. Madison, to explain his vote."

Madison: "Mr. Speaker, I thought we were on questions. I didn't know that the board had been opened."

Speaker Lechowicz: "Well, it is open, Sir."

Madison: "Can I ask the Sponsor a question?"

Senate Bill 16....er....I'm sorry, Amendment #16 and
Amendment #8 heard together, since they are basically
the same thing."

Speaker Lechowicz: "It's kinda late in the Session right now, Sir."

the radios. This is the funds to provide a radio program
in those cars. It's 100 percent reimbursable from the

Governor's Traffic Safety Program, Mr. Speaker."

Speaker Lechowicz: "Do you want to explain that Amendment again?"

Winchester: "All right."

Representative Winchester."

Mr. Madison."

Speaker Lechowicz: "Is there any discussion? No, we heard you.

Is there any further discussion? The Gentleman from

Cook, Mr. Vitek. Your light's on, John. The Gentleman from Peoria, Mr. Mudd."



Mudd: "Mr. Chairman. If the Sponsor would yield for a question?"

Speaker Lechwociz: "He indicates he will."

Mudd: "Are these vehicles replacement vehicles, Representative

Winchester: "They are all brand new, Representative. Patrol cars."

Winchester: "Thank you, Mr. Speaker. Senate Amendment #15

adds \$1,866,000 in CDB Funds for the Public Affairs Center

at Sangamon State University. This was originally

\$3,000,000...I understand. It was negotiated down; work
ed out through a compromise down to \$1,866,000."

Speaker Lechowicz: "Any discussion? The Gentleman from McHenry, Mr. Skinner."

Skinner: "Mr. Speaker, would the...would the Sponsor yield?"

Speaker Lechowicz: "He indicates he will."

Skinner: "I would like to know if the Capital Development Board has rebid the project...for a third time?"

Winchester: "I have been informed that that is not true. The answer is 'no'."

Skinner: "Then I rise to speak against this Amendment and I rise to speak about as vehemently as I can. There's a firm in Antioch that was the second lowest bidder on the plumbing contract, approximately half a million dollar contract, in the first round of the bidding. CDB decided that the contracts had come in too high. Everyone had bid too high. So they put it out for bidding a second time. And the second time the only thing that happened was that the low bidder upped his bid by about \$70,000 and all of the higher bidders, next coming along, lowered their bid. Now, because of the rebidding, we're going to pay, I think it was \$150,000; at least \$150,000 more than we would have paid if they'd accepted the first bids. And the Capital Development Board, apparently to this date, refuses to put it out for bid for a third time. Now there is something kinky in this. I don't know what it is, but it doesn't smell right."

Speaker Lechowicz: "Any further discussion? The question is, shall Amendment #15 be adopted? All in favor vote 'aye', all opposed vote 'nay'. The Gentleman from Sangamon, Mr. Kane, to explain his vote."



Kane: "Mr. Speaker, Ladies and Gentlemen of the House, I
think that the previous speaker...made a...at least
left a wrong impression with a lot of Members on this...
in this House, concerning the bidding on the project to
complete the Public Affairs Center at Sangamon State
University. The bids, as they went out the first time,
and if you're familiar with the bidding procedure....is
that the mechanical contracts are put out separately so
that there are about a total of eight or nine total bids.
What happens is that the Capital Development Board..."

Speaker Lechowicz: "Excuse me, Doug. Would all unauthorized personnel remove themselves from the floor? Please proceed."

Kane: "The Capital Development Board has to look at all of the bids and rebid all of them or ...or take them all. On the second bidding, when the bids came back in, the bid that the Capital Development Board was particularly interested in was the general....the bid for the general contract. That bid was considerably lower than...than the original bid for the general contract...somewhere in the...in the vicinity of over a million dollars. There were...on the mechanical bids, some of them were up, most of them were down. And I don't question the fact that the plumbing contract perhaps may have, on the second bid, come in at 60 or 70 thousand dollars more. But as a total package, the bid on the Public Affairs Center, for all of the bids, with the general contract and with all of the mechanicals, the total bid was somewhere in the neighborhood of \$1,600,000 less than the original contracts as they came in This Amendment, when it passed the House in the Thanksgiving Session, we passed it here for 3.3 million dollars. The Senate reduced that amount to \$1,800,000, to cover the existing contracts. If this Amendment does not pass, if it is not adopted, the current contracts that are out and the current bids that are in will have to be scratched and will have to go out for a third bid. What that will

Speaker Lechowicz: "Would the Gentlemen kindly bring his remarks to a close?"

Winchester: "Could you hold just a second, Representative

Barnes, until I can get you an answer? You are correct,

Representative Barnes, it is fifteen....fifteen for

downstate and five for Chicago."

Barnes: "So you are ending up with a three to one ration for downstate schools, from the General Revenue Fund. Is that what what you think? \$15,000,000 for downstate and \$5,000,000 for the City of Chicago?"

Winchester: "Representative Barnes..."

Barnes: "....Where the number of students...where the number of students is outweighed heavily in the other direction?

Is that what I'm hearing from you?"

Winchester: "Representative Barnes, I have been informed that

it has always been this ratio of three to one and it is

how it passed out of this House to the Senate."



Barnes: "Well, that's not the question that is being propounded here. It seemed to me that you said that, in your explanation, that these was some needed funds for some extremely needed projects around the state. Not based on a formula or in acceptance of a passed procedure that has always been upheld in this Body. As I understand this is a situation that exists now that did not exist during the Appropriation hearing just a few months ago. Is that the case? "

Winchester: "Mr. Speaker, could I yield to Mrs. Kent?"

Speaker Lechowicz: "The Lady from Adams, Mrs. Kent. Mary Lou

Kent, please proceed."

Kent: "Thank you, Mr. Chairman. Mr. Barnes, this money.....

you know how schools are on lists for approval after....

well, some of them haven't passed their bond issues yet,

but there are some on those lists that have passed their

bond issues, they have their money ready to go and that's

what these sums are based on. Some of them that are

ahead of them as far as priority is concerned, have not

passed a referendum, do not have that money available.

So some of these then can slide up and use the money and

not lose all of their referendum money in inflation. That

Barnes: "Well, Representative, I think I understand that, but in the City of Chicago you don't have that problem, because a referendum is not a prerequisite for spending for these additional funds. We simply don't do that up there. It's nonreferenda. So what I'm saying here..."

Cunningham: "Mr. Speaker, your graciousness has no equal in this world. Maybe it's because we're the largest state that exports
farm products in the United States. Maybe it's because
we're the third largest producing state for farm products.
That makes us the top in the na...in the world. If we
can't recognize the people that produce these ...products



and guarantee that we're going to have a good production, and a sound agricultural base for years to come, then we're not protecting one of the natural resources or one of our products in this state that we're one of the leading states in producing, then I don't know who should be involved. I don't think we're getting involved to that extent. We want the Federal Government to know that we support our farmers in Illinois and that we want them to get the type of parity and the type of consideration that is equitable....equitable; and that is whatever is fair. And I think that's what any Legislator in this House wants is whatever is fair for the farmers in Illinois."

Speaker Lechowicz: "Representative Rigney."

Rigney: "Will the Sponsor yield?"

Speaker Lechowicz: "He indicates he will."

Rigney: "Representative Mulcahey, did you make the statement,

'We now are living with 63 percent of parity.' under the present administration?"

Mulcahey: "That's correct, Representative Rigney."

Rigney: "What was it under the days of good old Earl Butts, the....when the farmer enjoyed prosperity and we were

selling our products overseas. Could you give me that

figure?"

Mulcahey: "No. I have no idea."

Rigney: "Well, just specifically, what does this Resolution do other than say that we are concerned about the

situation? I haven't seen any constructive suggestions to Congress about what they are ...you know...supposed to

be doing about the present farm situation."

Mulcahey: "Well, Mr. Rigney, first of all, in 1943, when parity
was reaching 100 percent...when parity was reaching 100
percent, the consumer buying power rose 110 percent. It
increased employment, it decreased inflation, and farm
industry was buying more and more raw material, more



machinery et cetera. The farming affects the entire economy, we all know this. And now since 1973, and note that date, since 1973, thirteen and a half billion dollars has been lost in agricultural income. Now the result of this simply is that 94.6 billion dollars has been lost...of the national income, with an 18.9 billion dollars being lost in revenues to the government. So that's just what happened since 1973. And what we're doing here is simply calling upon the President's Council of Economic Advisors to take notice. It is a serious situation, which I'm sure you know, that is described in this Resolution, and to put forth all their efforts to bring about equitable parity."

Rigney: "Well it seems to me that the only thing you're saying is that apparently the President's Council of Economic Advisors isn't aware of the present plight of America's farmers and perhaps that is true. If I may just make some brief comments, Mr. Speaker. It's a sort of Resolution that obviously you couldn't oppose because it's really not doing anything. It's not saying to Congress what should be their course of action to address this very serious situation, where the farmers are limping along with 63 percent of parity. I would hope that there might be a Resolution that would call for some constructive action.
