Speaker Redmond: "The Gentleman has moved the adoption of the Agreed Resolutions. Those in favor indicate by saying 'aye'; 'aye'; opposed, 'no'. The 'ayes' have it. The Resolutions are adopted. Have another announcement. All the new Members are to pick up your mail in the postoffice in the basement of the



New State Office Building. If you have any mail that's where it'll be. Representative DiPrima, you still seek recognition?" DiPrima: "Yes, Sir. Can I please have your attention, please? Mr. Speaker, Ladies and Gentlemen of the House, with all the bad news we've been getting about the weather I'd like to make an announcement that Bud Washburn, as you know, has retired as a Member of the House and he was unemployed and he was interested in obtaining the job as Director of Veterans Affairs. And I guess he wasn't getting too much approval from the new Governor and I went downstairs yesterday afternoon and I grabbed the Governor and I talked to him and I told him that he was my choice to become the new Director of Veterans Affairs. And he said he would have to contact the Veterans Organizations. I said, 'Well, you tell them that I am endorsing Bud Washburn'. And with that he met Bud Washburn last night, he said, "DiPrima spoke to me, that was good enough for me'. And Bud Washburn will be your new Director of Veteran Affairs. Bud Washburn or told me to make that announcement."

Speaker Redmond: "Have you told the Governor yet, Representative..."
DiPrima: "That's the first time I ever went to any Governor since

I've been here. And I scored."

Speaker Redmond: "Resolutions."

Clerk O'Brien: "House Joint Resolution #3. Resolved by the House of Representatives of the 80th General Assembly of the State of Illinois; the Senate concurring herein, that when the two Houses adjourn on Thursday, January 13, 1977, they stand adjourned until Monday, January 17, 1977 at 12 o'clock, noon."

Speaker Redmond: "Representative Madigan."

Madigan: "Mr. Speaker, the Adjournment Resolution provides for adjournment today until Monday which will be a Perfunctory Session.

And, Mr. Speaker, we wish to announce a schedule beyond Monday."

Speaker Redmond: "Well, it will be perfunct here, day by day, until

we know what the Senate....we haven't resolved it, I would think,

about ten days..."

Madigan: "Will we notify the Members...."



Speaker Redmond: "We'll notify the Members, yeah."

Madigan: "Of the next Regular Session?"

Speaker Redmond: "That's correct. We've done that before, it will be perfunct on Monday and as soon as wa...the Senate is organized and we know when we'll be coming back why we'll advise you."

Madigan: "I move the adoption of the Adjournment Resolution."

Speaker Redmond: "Is there any discussion? The Centleman has moved the adoption of the Adjournment Resolution. Those in favor say 'aye'; 'aye'; opposed, 'no'. The 'ayes' have it and the Resolution is adopted. Representative Madigan."

Madigan: "Mr. Speaker, I move to amend the Adjournment Resolution to read, '2 p.m. Monday rather than 12 noon Monday'. Perfunctory

Session. I move to amend the Adjournment Resolution which provides for a Perfunctory Session on Monday. To amend that Resolution from 12 noon to 2 p.m."

Speaker Redmond: "That's at the request of Senator Shapiro of the

Senate who is fearful of the weather conditions. So the question's on the Gentleman's motion for the Amendment. All in

favor say 'aye'; 'aye'; opposed 'no'. Representative Madigan."

Madigan: "To repeat, Mr. Speaker and Members of the Body, the Membership will be notified by mail of when we will go back into Regular Session. Thank you."

Speaker Redmond: "The 'ayes' have it and the Gentleman's motion is adopted. Further Resolutions?"

Clerk O'Brien: "House Resolution 13, Meyer, et al."

Speaker Redmond: "Committee on Assignments. First Reading and Introductions."

Clerk O'Brien: "House Bill 120, Griesheimer. A Bill for an Act to amend the Illinois Vehicle Code. First Reading of the Bill.

House Bill 121, Deavers, Daniel. A Bill for an Act to amend the Revenue Act. First Reading of the Bill."

Speaker Redmond: "Announcements. Representative Katz."

Katz: "Mr. Speaker and Ladies and Gentlemen of the House, now that the 80th General Assembly has begun we're very anxious to get the



rules completed and I did want to announce that the views of each Member of this House will be solicited by the Rules Committee. There will be a hearing that will be subsequently announced for Springfield, another hearing in Chicago. You can take your pick but we would welcome the suggestions and proposed changes in House Rules from each Member of this House. And the Speaker would encourage you to participate in that. We make the announcement today so you'll have plenty of time to think about it and to get started on your suggestions. You will also be getting a letter from your

Speaker Redmond: "Representative Katz."

Katz: "In addition to that if, in studying this problem you would like to check with the Parliamentarian he is very available.

David Epstein, will be available to answer any questions you might have regarding House Rules and any staff member that we have will be available. The Speaker is very anxious that the new Members feel part of the 80th General Assembly, participate and the assistance of David Epstein and other staff members is available to each Member of this House."

Speaker Redmond: "If you have any other Bills that you want introduced they can be introduced during the Perfunctory Session. So if you'll leave them with the Clerk why, not that I'm encouraging a proliferation of the Bills to be introduced, but if you do have them why you can leave them with the Clerk and they will be taken care of during the Perfunctory Session. Introduction, First Reading."

Clerk O'Brien: "House Bill 122, Cunningham. A Bill for an Act to amend sections of the School Code. First Reading of the Bill."

Speaker Redmond: "Anybody have any announcements, anything else that you want to come before this Body? No further announcements.

Don't forget to turn in your requests for Committee Assignments to your respective leaders. And we're ready now to adjourn pursuant to the Adjournment Resolution 'til Monday at 2 o'clock which, in the House, will be Perfunctory Session until the



Senate is organized, we'll have to have Perfunctory Sessions daily and you will be advised when we will go into Regular Session. And my hope and guess is it will be approximately ten days from now. What's that? Ten days or two weeks. And if there are any hearings in the Rules Committee you'll be notified by Chairman of the Rules Committee. Chances are there'll be one in Springfield and one in Chicago. Representative Ryan. Representative Telcser."

Telcser: "Mr. Speaker, Members of the House, a number of our new

Members have been asking me about what a Perfunctory Session

is. I want to point out to them that they need not be in

attendance when we're in a Perfunctory Session."

Speaker Redmond: "That is correct and there is one other distinction in that since you don't get per diem."

Telcser: "If you're not in attendance, no show, no dough."

Speaker Redmond: "Or even if you show. Anything further? I've been advised by the Secretary of State's representative that the license plates, the mailing, they will be mailed first class to you in your home and they will start mailing them Monday. Anything else? Oh, yes, I've been reminded, please leave your key in the voting switch and the keys in the drawers. And that's specifically...you don't have to do that after we get going but leave the key in the voting switch and the keys in the drawers. About ready to adjourn if anything else....?

Pursuant to the Adjournment Resolution the House now stands adjourned 'til Monday, 'til 2 o'clock for a Perfunctory Session and you'll be notified of the next Regular Session. House is now adjourned.
