Clerk O'Brien: "Amendment #1, Pierce, amends House Bill 247 on page two, line 13, by deleting \$15,000 and inserting in lieu thereof \$10,000."

Speaker Redmond: "Representative Pierce."

Pierce: "Mr. Speaker, House Bill 247 is unprecedented in that it increases the maximum for the small estate affidavit where assets can be transferred by the decedent on a mere affidavit from \$5,000 to \$15,000 which tripleswhich triples the limitation on small estates. What Amendment #1 does is provide for a \$10,000 maximum. In other words, we doubled the limit. Now, Mr. Speaker, when you started to practice law, I imagine the small estate affidavit was a thousand or two thousand dollars. I know when my father started it was five hundred dollars."

Speaker Redmond: "Five hundred dollars."



Pierce: "Five hundred dollars? I didn't realize you went back that far. Five hundred dollars, and we've increased it steadily over the years and I agree with the Bar Association and Representative Ewing, that \$5,000 is probably inadequate maximum today and I would double that to \$10,000. What the Committee Amendment does, excuse me, mean, what the Bill does is triple that to \$15,000. So, I therefore ask that we adopt Amendment #1 to the Bill which reduces from \$15,000 to \$10,000 the maximum size of an estate that may be transferred on a small estate affidavit. Even with this Amendment we're still doubling from \$5,000 to \$10,000....the small estate affidavit."

Speaker Redmond: "Representative Houlihan, do you seek to interrupt? For what purpose do you arise?"

Houlihan: "We don't have the Amendment and I'm wondering if this Committee Amendment has been distributed?"

Speaker Redmond: "Has the Amendment been distributed?" Pierce: "It's not a Committee Amendment....I understand the Republicans have it on the other side but some Democrats

don't have it on our side....including myself." Speaker Redmond: "Conspiracy."

Pierce: "The Sponsor told me he had it, Representative Ewing.

Ah....It was presented to the Clerk yesterday."

Speaker Redmond: "Well, I understand thatMr. Page, has it been distributed on the Democratic side?..."

Pierce: "Well, we can pull it out of the record and we can..."

Speaker Redmond: "Take it out of the record until the Republicans

give us some of the Amendments."

Pierce: "....We can think ábout it....."

Speaker Redmond: "Until the Republicans give us some of the Amendments. Well it's only distributed on one side. That is half of an Amendment.... House Bills, Third Reading. House Bill, Third Reading....I understand Representative Flinn wasWas he excused? Speaker Redmond: "Third Reading with the understanding it

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "Amendment #1, Pierce, amends House Bill 247

on page two, line 13 and so forth."

Speaker Redmond: "Representative Pierce."



Pierce: "Mr. Speaker, I explained this Amendment very articulately, completely, and with vigor, a few minutes ago. But to repeat, the basic Bill, House Bill 247, which is the Joint Bar Association Bill, not the joint Bill but the Bar Association Bill, nothing to do with marijuana. What it does is ..increases..."

Speaker Redmond: "Representative Madison, for what purpose do you rise?"

Madison: "Mr. Speaker, you took this Bill out of the record a few moments ago because the Amendments had not been distributed. To my knowledge that condition has not changed."

Pierce: "It's been distributed here."

Madison: "Well, I have not received a copy."

Speaker Redmond: "Pages, be sure that the Democratic side have a copy of all the Amendments. Representative Madison does not have a copy."

Madison: "I got one now."

Pierce: "The Amendment is simple. The Bill triples the small estate affidavit limitations from \$5,000 to \$15,000 and an estate can be transferred on a mere affidavit. Now, when the Speaker started to practice law back there about 1935, or whenever it was, the limitation was \$500 and it was supposed to be only for the smallest estate. Only very minor amounts. Since then we upped it to \$1000, to \$2,000 to \$3,000 to \$5,000. I agree with the Bar Association and with the Sponsor that with inflation the \$5,000 is probably too low a limitation and what the Amendment does is ...says we'll double that to \$10,000. The basic Bill triples it to \$15,000. I want to point out that life insurance is not included because you don't need to open an estate to transfer life insurance to go to a widow or any named beneficiary. Also, a joint tenancy home, that, you don't need to open an estate. We're talking about property that is not in joint tenancy. Property that does not consist of life insurance. Property



that does not by itself, go to anyone but must go; either by a will or the laws of intestacy. To me \$15,000 gets to be, right now, too large an amount to transfer on a mere affidavit. That \$15,000 is in addition to life insurance. It's in addition to the joint tenancy home and therefore Amendment #1, which lost by one vote in Committee, would limit the maximum small estate affidavit to \$10,000 rather than \$15,000 which is the case with House Bill 247. It would still double that limit and I move the adoption of Amendment #1 to House Bill 247."

Speaker Redmond: "Representative Ewing."

Ewing: "Yes, Mr. Speaker, Members of the House, I would oppose this Amendment. We've been through the very same debate in the Committee and the Committee determined that \$15,000 was not an exorbitant amount today. Now, this is a permissive Bill. It's a consumer Bill. It saves the small people from paying attorney fees and having probate if their estate is under \$15,000. Now, you can go ahead and have probate if it's necessary and if you want to, under the statute. This doesn't prohibit it. Fifteen thousand in today's economy is about three hundred when you started practicing, Mr. Speaker. You can have six thousand dollars in your car and I would ask that we vote down this Amendment."

Speaker Redmond: "Representative Schlickman."

Schlickman: "Well, Mr. Speaker and Members of the House, I arise to support this Amendment, which would have the effect of doubling the amount by which an estate will be exempt from formal administration or probate. It just seems to me, Mr. Speaker and Members of the House, as a matter of principle, whenever you triple something or double it....or go by two hundred percent, it should be viewed with caution. I might also add, Mr. Speaker and Members of the House, that there will be considered by this Legislature, subsequently, another Bill which will go



far beyond this Bill, providing for unsupervised administration but with the necessary safeguard. I therefore, Mr. Speaker and Members of the House, suggest that we retain the moderate size of small estates but on account of inflation, increase it to \$10,000 as this Amendment would do and on the other hand anticipate a far better approach which both the Bar Associations of this State will be sponsoring. It seems to me if we defeat this Amendment, we allow the Bill to go to Third, with a two hundred percent increase....a tripling...we will not be acting, in the best interest of our constituents, and possibly will be preventing a farther reaching approach subsequently to be considered and which will have necessary safeguards. For these reasons, Mr. Speaker and Members of the House, I join with the Gentleman from Lake in soliciting your support of this Amendment by voting 'aye' on its adoption."

Speaker Redmond: "Representative Daniels."

Daniels: "Yes, Mr. Speaker, Ladies and Gentlemen of the House, I rise to oppose this Amendment and I think that it will be well-advised to inform the Members of the House that what we're speaking of in this occasion is not necessarily just a two hundred percent increase but a substantial saving in legal fees to those people that probate small Now, all of us have had the cries of senior citizens and people that have asked for relief in probate. This is one of the areas that we can give them relief in saving cost of probating an estate by going through the small estates affidavit route as called for in this Bill, in estates under \$15,000. Now, I would remind you, that this is the kind of Bill that our people are crying for and we have an opportunity to vote for such Legislation right now by opposing this Amendment. Furthermore, I think that we will be well-advised to keep in mind that both the Illinois State Bar Association and the Chicago



Bar Association strongly support the Legislation in the form that it appears before you now, so I recommend that you oppose this Amendment."

Speaker Redmond: "Representative Geo-Karis."

Geo-Karis: "Mr. Speaker,...."

Speaker Redmond: "Please give the Lady order."

Geo-Karis: "Thank you. With all the noise here I've lost the gist of the Amendment." Can I refer my question to the Sponsor of the Amendment?"

Speaker Redmond: "Representative Pierce."

Geo-Karis: "Representative, does your Amendment decrease the decedent's estate to \$10,000 from \$15,000?"

Pierce: "Yes, it decreases the amount in the Bill from 15 to 10. It doubles the present law, however, from 5 to 10."

Geo-Karis: "I'd like to speak on the Amendment, Mr. Speaker...

....Mr. Speaker and Ladies and Gentlemen of the House, I regret that I must oppose this Amendment because the Sponsor of the Bill said, with the inflation situation today, 15 thousand is what 5 thousand was maybe five or ten years ago. I think the 15 thousand figure is even low but still it's better than nothing and I would like to oppose the Amendment and let the original Bill stand with the 15 thousand."

Speaker Redmond: "Representative Epton."

Epton: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House, obviously I have a conflict of interest in this matter, notwithstanding, I will vote my conscience."

Speaker Redmond: "Representative Leinenweber."

Leinenweber: "Thank you Mr. Speaker, I'd like to rise in.....

also in support of the Amendment. A lot of people, I

think, are probably unaware of what the small estate

tax permits to be done. It permits a person who has

money....or an institution that holds money of a decedent,

to pay it over to a person who claimsunder a sworn

statement prepared, perhaps, by that person alone, to pay



money over to that individual, not subject to any super-15. vision or any bond whatsoever. Merely on what a person is willing to put in a sworn affidavit. Probably there is more perjury that goes on, perhaps unwittingly, with the small estate tax than any otherparticular institution in the State of Illinois. I certainly agree that some raise is justified. Certainly \$10,000 is a reasonable amount.....most automobiles, which are of course...are used upon the death of the decedent, would be within the automobile. That is probably the number one use for the small estate affidavit, however, I don't think that we should get into sums of money like \$15,000 because you're going to have transfers of stocks, bonds and cash merely on the sworn statement of an individual, not subject to any supervision or any bonding at all. I think \$10,000 is sufficient raise."

Speaker Redmond: "Representative Pierce to close."

Pierce: "Just to close, Mr. Speaker, I just want to point out again that when we're talking about a limitation in this Bill of \$15,000, that's not really the total limitation, because the home, which is usually in joint tenancy, would be an additional limitation, all life insurance paid to a name....a named beneficiary would be in addition to the \$15,000, any joint bank accounts and savings account, would be in addition. What we're saying here is, you could still transfer, under my Amendment, my small estate affidavit, a \$100,000 home in joint tenancy, a \$50,000savings account, a \$10,000 checking account in joint tenancy, plus I would allow \$10,000 in property that was not in joint tenancy, to be transferred in affidavit. I think that's enough. I think anything bigger than that, at least for the next two years, we'll see how inflation goes,it's enough to double that maximum limitation from five to ten thousand and I ask for support on Amendment #1."

Speaker Redmond: "Further?The question is on the adoption



of the Amendment. Those in favor vote 'aye', opposed vote 'no'. Have all voted who wish? Have all voted who wish? The Clerk will take the record. On this question there are 38 'aye', and 83 'no', and the Gentleman's motion failed. Any further Amendments?"

Clerk O'Brien: "No further Amendments."

Clerk O'Brien: "House Bill 120, a Bill for an Act to amend

Sections of the Illinois Vehicle Code. Third Reading of
the Bill."

Griesheimer: "Thank you, Mr. Speaker. House Bill 120 is a Bill that merely clarifies a situation in the State of Illinois, under the Vehicle Code, which has created many problems and a number of deaths in the last few years. Under this Bill we will try to resolve the circumstance that arises when stop and go lights or traffic control signals are not working at an intersection. The problem being that there is no law on the book at the present time that requires a motorist to do absolutely anything when he approaches an intersection where the stop and go lights are electrically not working whatsoever. As a consequence, in Lake County alone, there has been two deaths, where both motorists have gone driving at high speeds, into the intersection, presuming they had the right of way, and have smacked into another car. What this Bill will do is cause any intersection where there are stop and go lights, and they are not working whatsoever, to be considered a four way stop and each vehicle approaching that intersection, upon seeing the stop and go lights and the fact that it is not working, must come to a complete stop and treat it just exactly as he would a stop sign, and



then proceed safely. The Bill was completely reviewed by the Department of Transportation and also the Chicago Motor Club, they made suggestions, we amended the suggestions in there. It is my understanding that both, the Department of Transportation and the Chicago Motor Club are now endorsing the Bill as it stands and I believe it will add a great deal of safety to the general driving and Rules of the Road of the State of Illinois. I would

this is a good Resolution, it came up once before and there were some objections from the other side of the aisle. As far as the Leaderships are concerned over there they did not have so many concerns but there were in-

dividual Legislators that thought perhaps I might of had

a conflict on this. But, I assured him and there are no

problems in that area. The.... I would like to....in support of this Resolution, Mr. Speaker, read an excerpt from one of the leading downstate newspapers...this is an editorial





of the Champaign-Urbana Currier of January 10, 1977. They state that the Illinois Transportation Study Commission, an arm of the General Assembly has expressed interest in investigating CTA accidents, if the Legislature approves the Resolution directing it to do so. We urge the General Assembly to approve the Resolution. After earlier CTA accidents the Commission in January of '75, made a report and several recommendations on how future accidents may be prevented. It noted that many previous accidents were attributed to human error as was the recent accident. Recommendations concentrated on ways to reduce the chance of human errors such as physical examinations, tests for drugs, review of hiring and firing practices, and better training and higher pay for trained operators. A new investigation should review how many of those recommendations have been carried out and whether more steps are needed. Mr. Speaker and Ladies and Gentlemen of the House, this is a good Resolution. I would ask for its adoption."

Speaker Redmond: "Representative Wolf."

Wolf: "Mr. Speaker, I would ask leave to table House Bill 73

I am the..."

Speaker Redmond: "You are not recognized for that purpose...

at this time. Representative Totten."

Totten: "Well, thank you, Mr. Speaker. Ladies and Gentlemen of the House, I rise in opposition to House Resolution 48, for...in several different areas. First of all, the Resolution as written indicates that the Transporation Study Commission will study all the accidents since January of 1974. Now, I have before me a copy of the last study that the Illinois Transportation Study Commission did and that study, if this Resolution is passed, will duplicate four of the six accident investigations that the Transportation Study Commission did in this study that was put on our desks in January of 1975. Secondly, in an article that appeared in the Chicago Tribune in the



last couple of weeks, they indicated that the Federal Government and the CTA would both be investigating the most recent accidents on the CTA.....and for that study, the CTA is proceeding with a \$375,000 appropriation, \$300,000 of which will be paid for by the Federal Government. Now, I think it is quite premature, at this time, for an investigative agency of state government to pursue an investigation which is duplicative of investigations they have already made into CTA accidents and to expend any state moneys on a study which very well could be done by a Federal Grant which has been given to the CTA. Now for the life of me I can't see why the Transportation Study Committée would avoid the premature argument...that I have made and want to proceed with its study unless it is looking for work to do and to expend some of the moneys that have been appropriated to the Transportation Study Commission. For the Members' information, let me submit that since the fiscal year 1972, the budget appropriations for the Transporation Study Commission have gone from \$50,000 to the present fiscal year appropriation of \$329,000. That is a manyfold increase. It is estimated, with current expenditures, there will be a considerable lapse in the Transporation Study Committee's appropriation for this year....and it is apparent, by this Resolution, which will undoubtedly duplicate many state and federal activities into investigating the CTA accidents. That this Resolution is an attempt to eat up what will be a lax expenditure in the Transportation Study Commission's budget this year and is strictly a make-work project for that Commission. I would submit to the Members that this Resolution is both premature and efficient waste of State money....and that at this time this Resolution should not be passed."

Speaker Redmond: "Representative Neff."

Neff: "Thank you, Mr. Speaker. Mr. Speaker, I would have to



take some....issues with Representative Totten as far as money being spent. I dont' think it was the intentions of the Transportation Study Commission to spend any money at this time. We thought that it would be good to be prepared and I agree with him that there is other investigating going on and we realize that and personally, right now, I don't think we have to do any investigating but I still think the Resolution is all right in case something comes up or some of the Legislators come up and they want more.....something done that we haven't got the answer to....be prepared to do it. As far as any money being spent on this I don't think it was the intention of the Chairman or any member of the Study Commission to actually spend any money and I personally do not believe at this time there will be any money spent. I think we will have enough investigating done and I think the people are going to have the answers to the accident of the RTA, without any money spent but I also think that there's nothing wrong with this Resolution ... to go ahead and pass it so that the Transportation Study Commission can be prepared if we find it's necessary and the Legislators find it necessary that more investigating be done."

Speaker Redmond: "Representative James Houlihan."

Houlihan: "Will the Gentleman yield for a question?"

Speaker Redmond: "Please give the Gentleman order."

Houlihan: "Representative Garmisa, would this study...or this project be conducted by the former Speaker, Bob Blair,

who is on staff of the Commission?"

Carmisa: "The study will be conducted by the Members of the Commission and our in-House staff."

Houlihan: "What,if you might enlighten some of the Members, is the current status.....I think there was some controversy over a former Member, that is Speaker Blair, being on staff there and there was some suggestion that the Commission befunded with....as I understood it....the

I was asking questions about his staff and specifically about whether or not former Speaker Blair was a member of the staff and whether he was on contract at this time and I think the question has been raised by Representative Lechowicz as to whether that was germane to this Resolution. What I was trying to determine was whether in fact, the bodythe Commission itself, could make an adequate investigation by determining its resources."

Speaker Redmond: "The Parliamentarian advises me the general subject of the question is germane but he has questions about whether or not it can be specific and particular ... name individual people...."

Garmisa: "I thought I already answered the question, Mr. Speaker."

Speaker Redmond: "Representative Houlihan, are you satisfied



with the response?"

Houlihan: "Well, if Representative Garmisa could just give me the salary figures I would be ...satisfied...yeah..."

Speaker Redmond: "Parliamentarian...indicates that that's beyond the scope of what he thinks would be germane. Anything further? Representative Madison."

Madison: "Thank you, Mr. Speaker. Would the Sponsor yield for a question?....I wish you would keep the Parliamentarian close because mine may not be germane either. Representative Garmisa, I would like to know what role, if any, former Speaker Blair will have in relation to this investigation?"

Garmisa: "None as farsas I know."

Madison: "None as far as you know. Then that means that it is possible that he will have some involvement in this investigation?"

Garmisa: "I would say that anything is possible, but I would assure you, Representative Madison that Speaker Blair is not going to have anything to do in this particular investigation."

Peters: "Mr. Speaker, I might suggest that if in fact Bob Blair did have something to do with the investigation, it would be the best thing that could happen."

Speaker Redmond: "Representative Skinner."

Skinner: "Yes, I'm sorry, I filed a fiscal note on this and I

don't know whether it's relevant or not. Perhaps you would
like to rule on whether it is relevant?"

Speaker Redmond: "Resolution....the fiscal note requirement does not apply to a Resolution."

Skinner: "Oh...well, then perhaps the Sponsor could repeat the

man of this Commission, in his dual role as chairman of the House Transportation Committee, to ...if they would form a subcommittee to investigate AMTRAK and since then, of course, I know nothing has happened because I haven't been contacted about it. I would suggest that if the Commission is like other Commissions and has scarce resources, that there are other things more important to be spent, that we spend money on, than investigating something that the Federal Government is fully competent to investigate and has already investigated. Speaker Redmond: "Representative McBroom tabled House Joint Resolution 8."

Lechowicz: "Thank you."

Speaker Redmond: "Constitutional Amendment. Representative Miller."

Miller: "Thank you, Mr. Speaker, I move that pursuant to Rule 18 (k), that the Rules be suspended to allow House Bill

226 to be heard in the Executive Committee tomorrow."

Speaker Redmond: "Representative Madigan."

Madigan: "Would the Sponsor bring that matter over here before he proceeds?"

Speaker Redmond: "Would you discuss it with Representative

Madigan? We'll take this out of the record temporarily.

Representative Deuster."

Deuster: "If it's possible, Mr. Speaker, House Bill 76 has been passed over because Representative Steczo's Amendment was not distributed. Whereas, the General Assembly is called upon to increase compensation for public university faculty; and Whereas, there has been expressed concern regarding the personnel policies at the various public universities of this State; therefore, be it Resolved by the House of Representatives of the Eightieth General Assembly of the State of Illinois, that the Auditor General be directed to conduct a management audit of faculty personnel policies at the public universities of the State and, as a part of such audit, (1) to determine whether uniform, specific written faculty personnel policies exist at each university, within each university system and for the State higher education _ system as a whole, and whether such policies include provisions for course load requirements, release time for research or other purposes, and salary schedules; and (2) to determine, for such policies as are found to exist, through the use of accepted data collection and analysis techniques, whether the policies are being properly and uniformly adhered to; and (3) to determine whether a management system exists to monitor and enforce compliance with existing faculty personnel policies; and (4) to compare faculty salary schedules with schedules in use for similar positions in private institutions; and, be it further Resolved, that the Auditor General make his findings and recommendations available to the General Assembly, the Governor, the Legislative Audit Commission and the Illinois Board of Higher Education."

Speaker Redmond: "Representative Skinner, do you seek



recognition?"

Skinner: "I wonder if the Sponsor would yield to a question?

I must say I am embarrassed...."

Speaker Redmond: "He indicates he will."

Skinner: "...Who is the Sponsor?"

Speaker Redmond: "Representative Waddell... He is on your team."

Skinner: "... I didn't hear. One of the things in evaluating public employment and whether they are getting payed enough and getting enough other benefits, ...that have been suggested by some, is that you compare the turnover rate in public universities, who are public employment, with the turnover rate in comparable private institutions. I wonder if the Auditor General might be empowered by this Resolution to also make that type of a comparison?" Waddell: "Yes, that's entirely possible. Plus the fact that one of the things that is of utmost concern,...that deluge of letters that you had received, for example, on the salary increases that you had voted for last time, are then reported back by the university because they do not manage the money the way you and the Appropriations Committee set it up here. As a result of that, even though you had voted for seven...seven and a half percent increase, in the schedule across the board, last time. When it did not appear, now you became the whipping boy as a Member of the General Assembly because they took it upon themselves for the prerogative of establishing what was important and what was not. You, as a Member of the General Assembly, caught heck because you didn't provide thatthat increase, wherein effect, you really did last time. This sets a procedure that the Auditor General can go in and recommend, to the General Assembly, and to the Governor, and other interested parties, a procedure that is understandable by all, that we do not have today, and yours can be included."

Skinner: "Well, that certainly would be an exception, if we're



dealing with higher education, that anyone can understand what's happening...."

Waddell: "Agreed."

Skinner: "I would suggest one slight correction, however, the raises did not come with my vote."

Speaker Redmond: "Is there any further discussion? Representative Matijevich... Matijevich."

Matijevich: "Mr. Speaker and Ladies and Gentlemen of the House, I listened carefully to Representative Waddell's explanation and I don't think I have any opposition to it but I do have some opposition to the procedure. I don't think it's good procedure to have the Leadership agree to an.....to a substantive Resolution and then immediately come up on the floor. I can see where in the future, what will happen is, Members will just go to the Leadership and say 'let's agree to this Amendment', and we go around the Committee.
