At this time, after a long, hard tedious day by many of the employees of the House, the Reference Bureau, the Legislative staff and we certainly, and the Members of the House appreciate it, I now move that we stand adjourned. And the Minority Leader agrees and he is very thankful all the work done by all the people downstairs that...really, we can't thank them enough. Now I move we adjourn."

Speaker Redmond: "Question's on the Gentleman's motion. Those in favor say 'aye'; 'aye'; opposed, 'no'. The 'ayes' have it. House now stands adjourned."
