personal privilege which I . . . very seldom do . . ."

Speaker Redmond: "Proceed . . . point . . . but if it has nothing to do with 773 . . ."

Matijevich: ". . . Nothing to do with . . ."

Speaker Redmond: "... Third Reading. Third Reading. Now, Representative Matijevich."

Matijevich: ". . . Mr. Speaker, and Ladies and Gentlemen of the House,

today in my district is a news release asking that anyone interested in seeking to fill the Senate position vacated, when Senator Bill Morris resigns to serve as Mayor in Waukegan, declare their interest before an Advisory Committee, which meets this Friday. Since there has been widespread speculation that I might fill that vacancy, I feel that I must relate my decision. So anyone considering application for appointment can plan accordingly. Never before have I ever, ever considered filling a vacan... filling a Senate seat or running for that position and for various reasons. Although I have always respected both Houses of this Legislature, I believe this House of Representatives, to which I have learned to love, really suits my style. It is much more democratic, small 'd', as far as T'r concerned, than the Senate. As many of you . . . as many of you know, I like to loosen my tie. When it gets hot, I like to take off my coat and work. And in the Senate those are 'no-nos'. I've always tried to salt the seriousness of the occasion here in the House by some humor. And I think that the Senate just isn't the place for that; and, in fact, I'm afraid the world isn't getting to be a place for that anymore. In order to accept Senator Bill Morris' vacancy, I would probably be morally committed to join that loosely organized group called the 'Crazy Eight'. And I guess I qualify because in many respects I'm crazier than any of them. And I know I'm tougher than any of them, and even tougher than some of the regulars, like John Knuppel. But like Will Rogers, I don't belong to any organized party. I'm a Democrat. And I feel that I ought to always have the latitude to fight with anybody, whether it's the regulars or the .



'Crazy Eight'. And believe me I've fought some tough ones with the regulars and even won some. So I guess I shouldn't ever even have considered running for the Senate; but let me tell you beyond my beliefs, I did consider it. I have considered it. And I'll tell you why I even considered it, because I've had some disappointments over here. Some of you may not know them. You know, we've had a lot of fight about the expanded Leadership in the House and the Senate. And everybody's blaming George Ryan over there and Art Telcse for the fact that their . . . it's only been in their minds. And all of us know that when you expand the Leadership, surely a Minority Leader can't do it on his own. But I want to tell you what happened to me the day before we voted for the Speaker, because everybody knows my candor around here. I've always told it like it is. One of the Leaders called me when I got to the hotel checked in the hotel, and there was a note there. It said, 'Very, very urgent'. In fact, I've kept that note for a souvenir. And this Leader said to me, 'John, we've had a meeting. We're going to expand the Leadership. And you're it. And the Speaker wants you to nominate him for Speaker'. And I told the Leader, I said, 'You know I was going to nominate him anyway'. But I appreciate that; and I hope I earned that, even though I had mixed emotions about that because I've always felt we've got too damn many Leaders around here. So everybody knows what happened in the end. And then I tried to organize the Appropriations Committee. And I had some disappointments there, too. But knowing if I ran it the way I wanted to run it, it would be a good Committee. I could go on with some disappointments that even went on two years before that. So because of those, I did consider running for the Senate. And then I thought to myself that some temporary disappointments should not be the reason why I should make a final decision. It should be what my inner feelings feel are better for me, and my party and for the people that I represent. And after all of my problems that I've had, and I've had had some differences with some people on the floor; but I've yet to have a personal difference that went beyond that time where we had our difference. And we finally resolved it. And I can say that all the



things that I've said about Speaker Redmond when I nominated him were true. And he is a great friend of mine; and that these disappointments were only temporary. Oh, I fought like hell with the Leader that told me later that it didn't work out. But I thought this revelation might be . . . might be illuminating to some who are just blaming George Ryan and Art Telcser for all the difficulties. So I'd like to say that, in closing, you know, some of us weren't here when we started today; and the minister gave a prayer . . . a prayer. And he always starts out with his sayings; and I usually jot them down because I appreciate most of them. And he started out with Walt Whitman today; and he said, 'Surely whoever speaks to me in the right voice, him or her, I will follow'. Well, you know, we get so hectic around here that we get to talking to ourselves. And our . . . the voice that I'm following is the words that I've said to myself. And I've said that I'm going to fight just as hard, I'm going to stay over here in the House. The District in the 31st is going to be a democratic district. I've looked over the names of people that they are considering, and there may be more. And I'm on the Legislative Committee to make that pick. And, by the way, my colleague, chairman, who's the second of the three, said, 'John, if you want to go, let me know and you can go'. But I made the decision that I gave to my good friend, Zeke Giorgi, when he had that same chance; I said, 'Zeke, stay right here where you'll have some fun, do some work and enjoy your life (it's short)!. And by the way, he was that Leader that gave me that important message that day. Thank you, Mr. Speaker. I'll be here awhile."



Speaker Redmond: "Representative Conti, for what purpose do you arise?"

Conti: "Point of personal privilege, Mr. Speaker, Ladies and Gentlemen of the House. I'm going to take this opportunity to overstep my boundaries and represent a group of youngsters that are graduating from the St. Huber's Eighth Grade Graduating Class who is represented by the ably Mrs. Macdonald, Don Totten, Eugenia Chapman.

Dorothy 'Romonolo' happens to be in that school and that's the St....Huber's Eighth Grade Graduating Class from Hoffman Estates; is here with Father Brennan, Mrs. 'Virgils', Mrs. 'Herbda', Mrs. Caruso, Mrs. 'Ponatonto' and Mary Beth 'McGloom'. They're up... up in that area up there."

Speaker Redmond: "Representative Cunningham."

Cunningham: "Mr. Speaker....the thing on? Mr. Speaker and Ladies and Gentlemen of the House, in response to the statement by Representative Matijevich, and it's a point of personal privilege. I am authorized on behalf of the Members, Republican Members, of Appropriations I to publicly announce that we'll put up with King John in the Committee if he mends his ways and shows the same tireless dedication to work that he has in the past provided the House is equally responsive to his needs and keeps him here in the House. But I, for one, personally resented the comment about the sartorial perfection of the people across the rotunda. The man that he would have filled his shoes to the overflowing as you all recognized and saw came over to this House barefoot on many, many occasions - and if any of us had done that we would have been ousted on our ear - so King John, I want to say this to you. Don't pull an Art Berman on us. You know, he came before and told us how dedicated he was to this House, never, never would he leave us, but now he's gone. We need a few people with your brains over here. Don't leave even though you sit on the wrong side of the aisle."

Speaker Redmond: "I think that I should make a confession that inasmuch as we had to change the clocks because of daylight saving time, I commissioned Representative Cunningham to take care of our clock here in the chamber. 778."

Clerk O'Brien: "House Bill 778. A Bill for an Act to revise the law



in relation to recorders. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Speaker Redmond: "Representative Ryan."

Ryan: "Well, Mr. Speaker, I didn't understand everything the Gentleman from Peoria said but he hasn't talked to me about the suspension."

Speaker Redmond: "I would suggest we hold your motion, you talk to

Representative Ryan. Representative Taylor, for what purpose do
you arise?"

Taylor: "Mr. Speaker, I rise for the purpose of a motion and that is to suspend the Six-and-a-half Day Posting Rule for Bills that we are scheduled to hear on Saturday, in the Committee on Cities and Villages. I have discussed it with the Leadership on both sides of the aisle. That's some fourteen Bills. House Bills 405, 475, 532, 596, 1016, 1049, 1050, 2297, 1468, 1469, 1588, 1725, 1864, 1926, 1933, 1962, 2414 and 2136. I have discussed it with the Leadership on both sides of the aisle and I move to suspend the appropriate Rules in order to have these Bills heard on Wednesday in House Committee...."
