and towel fees, and graduation fees. That's a matter of local option."

Anderson: "Yes, but isn't that unconstitutional because it's supposed to be a free education?"

Lucco: "No. It has never been proven to be unconstitutional, Sir." Anderson: "Aren't we condoning something then that is, you know, not constitutional by doing this?"

Lucco: "No. Until it's proven unconstitutional, I wouldn't say that we have."

Speaker Redmond: "Representative Brady."

Brady: "Yes, Mr. Speaker and fellow Members, I rise in support of this Bill. What this Bill is doing is addressing itself to other items beyond textbooks such as fees which are charged in many areas of our educational process across the board. We have moved into an area where we not only charge in some areas for textbooks, but we have fees which in the case of indigent people, would be very exorbitant and would put the poor children at a great disadvantage. I think that this is necessary to make a statement and mandate this from this Assembly, and I urge your favorable support of this Bill."

- Speaker Redmond: "Representative Martin. Representative Martin. I can't see Representative Martin. Somebody's standing between the Representative and the podium. Please sit down."
- L. Martin: "Mr. Speaker, we are now again beginning to mandate programs without supplying local districts the monies to pay for these programs. This is something this General Assembly has talked in Committee about. It has said, in general, it does not approve of it. And yet, here we go again. This will mean local school districts thoroughly strapped will have to pay for a state mandate and the state will not kick in a share. I would ask the Sponsor if he knows of any child in the State of Illinois that has not been involved in a program, an indigent child because of any fees. Remember your local districts. When you mandate a program, you cannot mandate programs and not give them financial relief to pay for these programs. I urge a 'no' vote on this issue."

Speaker Redmond: "Representative Hart."

Clerk O'Brien: "House Bill 929. A Bill for an Act creating the Commission on the Organization of the General Assembly and defining its duties. Third Reading of the Bill." Speaker Redmond: "Representative Katz."

Katz: "Well, House Bill 929 recreates and extends the Commission on the Organization of the General Assembly. You will recall that this Commission has made many recommendations adopted for improving the lot of Illinois Legislators and the way in which legislative business is conducted. More recently, it published the book on opportunities in state government, making available to Legislators and to other persons available positions. There is no appropriation involved. The Commission has not spent any public funds for a number of years. I would urge the adoption and passage of House Bill 929."

Speaker Redmond: "Representative Kane." Kane: "Would the Sponsor yield for a question? Is this the Commission that recommended deadlines for the General Assembly that's causing all the problems we're having right now?"

Katz: "Well, it is the Commission that recommended deadlines, but the problems you're talking about result from human nature, not from the acts of the Commission."

Speaker Redmond: "Any further discussion? Representative Schlickman." Schlickman: "Would the Sponsor yield? In terms of powers and duties, how does the content of this Bill, House Bill 929, compare with

the previous enabling legislation?"

- Katz: "The duties are the same as those that were in the last legislation. In the original legislation that was adopted in the, by the 74th General Assembly, the duties were much broader. After that, it became a question simply of implementing and monitoring the adoption of various recommendations and they have been very limited since then. There has been no appropriation of any state funds to the Commission since the initial year in the 74th General Assembly. Since then, the Commission has operated at a low-key level. The only funds that it has used has been funds that were originally given by private foundation in the 74th General Assembly to the Commission. No public funds have been expended since that time."
- Schlickman: "What is the total amount of appro... or excuse me, total amount of expenditures of this Commission during the past year? And what was the total amount of receipts?"
- Katz: "Well, there were no receipts other than interest of a small amount that accumulated on about fifty-five hundred dollars in funds that the Commission had from money that was given to it by foundations in 1974. I do not have the exact figures on the expenditures within the last year. It is still somewhat active in terms of expenditures because the money that was used to pay for the paper and for some other expenses incidental to the publication, <u>Opportunities in State Government</u>, have been paid from the Commissions accumulated fund. That has been a very popular book, booklet and indeed is in its second edition. I will be very glad to give you the exact amount of the expenditures. I would estimate them, however, at around twenty-five hundred dollars in all." Schlickman: "Does that figure include the cost of the publication to which you've referred?"

Schlickman: "It's been my understanding with respect to C.O.G.A. that it's objection was to analyze the operations of the General Assembly and make recommendations with respect to the operations. Is that correct?"

Katz: "Originally, it made about ninety-seven recommendations as I recall, Representative Schlickman. Since that time, however, it is not engaged in just going out and making recommendations of what it sees. The provision in the statute says that it will make recommendations or conduct studies only as matters are assigned to it by the General Assembly or be its Leadership. The activities this past year involved the publication of the opportunities book and simply monitoring the changes made. But there were no new assignments to it and I have... the Members of the Commission have tried to avoid being an overall Commission that rides off in all directions at once. It acts only when the General Assembly directsit to in terms of new projects. And since it was not given any during the past year, its activities have been involved in the publication of the booklet, Opportunities in State Government, and also in terms of monitoring the recommendations originally made by the Commission."

Schlickman: "Well, don't you think that the Commission on the Organization of the General Assembly is going far afield when it starts promoting employment in state government?"

Katz: "Well, it is not..."
Schlickman: "In the Executive Branch, not the Legislative Branch."
Speaker Redmond: "Representative Kane, for what purpose do you rise?"
Kane: "Point of order. This is becoming a dialogue."
Speaker Redmond: "I think you're right and we don't like dialogues."
Schlickman: "May I speak to the question, Mr. Speaker?"
Speaker-Redmond: "What'd you say?"
Schlickman: "May I speak to the Bill?"
Speaker Redmond: "Yes, yes, yes. Please do."



Schlickman: "Well, Mr. Speaker and Members of the House, it's about 5:40 and shortly we're going to have a sunset in Illinois. It seems to me that with respect to this Commission which has been in existence since 1965, there ought to also be a sunset. Now, Mr. Speaker and Members of the House, we have a Rules Committee. We have a large staff assisting the operation of this House as well as a large staff in the Senate assisting it. I think, Mr. Speaker, Members of the House, we've had enough with respect to analyzing the General Assembly and it's operation. I think, Mr. Speaker and Members of the House, based on the admission of the Sponsor of this Bill that this Commission hasn't been asked to do anything and it has to by its own initiative, develop programs to justify its existence such as the publication of a book describing to people opportunities for employment in state government simply doesn't want its continues existence. And for these reasons, Mr. Speaker and Members of the House, I urge a 'no' vote on House Bill 929."

Skinner: "Mr. Speaker, would the Sponsor yield to a question?" Speaker Redmond: "He will."

Speaker Redmond: "Representative Skinner."

Skinner: "Mr. Sponsor, about the time that I was trying to get some printing done by the Legislative Council and was denied that privilege, I heard the rumor that the book about which we are holding this discussion was printed without the authorization of your Commission. Is that correct?"

Katz: "No, it is not correct. As a matter of fact if the Gentlemen will direct themselves, both the two previous speakers, to the Bill, they will see that, in fact, the Commission was directed by the General Assembly in subparagraph 3 to make available to the public information regarding opportunties for participation in state government. That was the directive of this General Assembly. This Commission has not spent any public funds. It is doing precisely what the statute directs it to do and I understand the Gentlemen to object to the fact that we are not spending any public funds, that we are doing only what the statute directs us to do. I do not believe that that is a very valid basis of objection and I would urge the Members of the General Assembly to recreate what

has been a useful Commission that has spent no public funds and has quietly tried to do its bit to improve legislative operations and too, in accordance with subparagraph 3 of section 2, made available to the public information regarding opportunities for participation in state government."

Skinner: "At what meeting date was this printing authorized? Where may I find in the minutes that it was authorized?"

Katz: "I do not have any copies of any minutes, Mr. Skinner. I'd be very happy to discuss the subject with you. A majority, an overwhelming majority of the Members of this Commission favored doing what the state directed it to do. This Commission has not tried to prevent you in any way from having anything that you had printed in the council. You shouldn't blame this Commission for any problem you may have had with the council. This Commission was not responsible for your not getting something printed. We did the very best that we could and I would be very happy to have the Members vote whatever they want with regard to the Commission. It is not an empire-building operation as witness the fact that it has not had an appropriation of funds since 1965."

Skinner: "Was the printing of this pamphlet approved in the minutes of the meeting prior... was it approved as a... and appears as approved in the minutes prior to the time that the job order was placed with the Legislaive Service...Legislative Council Service Unit?"

Katz: "I am really not sure, Mr... first of all, Mr. Skinner, as to when an order was placed with the Legislative Service Unit. I would want to point out to you that if you will look at the publication, you will see that it is a joint publication of the Commission and of the Illinois Legislative Council. The Council was a copublisher of this book and gathered together the material. I am really not able to understand your concern about all this with all of the state money that is being spent everywhere. This is the one project that involves no expenditure of state funds. And hence, I find it strange that you are so concerned about this little Commission that has not had any expenditure, any appropriation of state funds in twelve years."

Skinner: "Mr. Speaker, if I might address the question. I would like to apologize to the Membership, at least any of them that think that any questions that I have asked required more than a 'yes', 'no' answer as with three of the questions and one just required a date. I did not think this would take five minutes of time. - Katz: "The House Executive Committee, Representative Houlihan, heard this Bill and the House Executive Committee recommended that the Bill do pass. As I have explained to you and to others here, there is not involved any expenditure of state funds with regard to this Commission. You will really have to speak to the House Executive Committee, I guess, as to why they unanimously, as I recall it, recommended this Bill out do pass. They were the ones who recommended it do pass and all I'm really trying to do is to get the House to follow the recommendation of its Executive Committee that this Bill be reported as passed by the General Assembly." Speaker Redmond: "Representative McAuliffe. McAuliffe, you seeking recognition?"

McAuliffe: "Mr. Speaker and Ladies and Gentlemen of the House, I find

Code. Third Reading of the Bill."

Speaker Redmond: "Representative McGrew."

McGrew: "Thank you very much, Mr. Speaker and Ladies and Gentlemen of the House. House Bill 930 amends the School Code as it relates to the election of school boards. As you may know, now every member that files a petition to run for the school board gets all of the gross mailings from the State Board of Elections telling them what they must do, how much they must file for their campaign disclosure and so on and so forth. Nearly all of the districts around the state do not have campaigns that expend a thousand dollars. I don't know why they were included in the first place, but in lieu of taking them completely out of the form, what I did is say that if they spent over a thousand dollars, they still have to comply. But instead of receiving such information from the

> State Board of Elections, they would receive a letter, a certified letter as amended for Representative Walsh, a certified letter saying that if they plan to expend over a thousand dollars, they must file. I move for its adoption."

Speaker Redmond: "Is there any discussion? The question is, shall this Bill pass? All those in favor vote 'aye', opposed vote 'no'. Have all voted who wished? Have all voted who wished? Clerk will take the record. On this question, 147 'aye' and 1 'no'. And the Bill having received the Constitutional Majority is hereby declared passed. 931."

Clerk O'Brien: "House Bill 931. A Bill for an Act to amend the Fair Employment Practice Act. Third Reading of the Bill." Speaker Redmond: "Representative J. Davis."

J. Davis: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. House Bill 931 as amended seeks to exempt certain client relationships of rehabilitation facilities from the Fair Employment Practices Act. The accepted categories under House Bill 931 would be those persons in rehabilitation facilities, both public and private, that are in the following categories: a) An evaluee-a person that's in a diagnostic program for as much as up to twenty-- six weeks. b) A trainee-a person who was a result of the evaluation process and to implement the diagnostic findings can be trained for up to one year in that same facility. c) a work activity client or one who is in a day care therapeutic setting for whom work inconsequencial and who receives no direct renumeration for therapeutic work performed. These exemptions would relieve a significant financial and administrative burden from those rehab. units who are servicing these clients. The bulk of these facilities are funded through private solicitations, public grants and operating revenue of employees who do not fall into the above categories and hence, would not be accepted from the Fair Employment Practices Act. This Bill is supported by the Department of Mental Health, by the Division of Vocational Rehabilitation, by the Association of Rehabilitation Institutes. I am unaware of any opposition to the Bill and it passed through Labor and Commerce with a unanimous do pass vote. So I would urge



your favorable vote on House Bill 931."

Speaker Redmond: "Any discussion? The question is... Representative Lechowicz."

Lechowicz: "Will the Sponsor yield to a question, Mr. Speaker?" J. Davis: "Yes, indeed."

Lechowicz: "Could you tell me how many people are included in that category as far as inmates and clients?"

J. Davis: "Well, we're not really talking about inmates here, Representative Lechowicz. I don't have the exact number because..." Lechowicz: "...employ inmates to provide services."

J. Davis: "I beg your pardon? I'm sorry, I didn't understand." Lechowicz: "What I have, there are cases where rehabilitation facilities

employ inmates to provide services. Therefore, there are situations where an inmate is also a client of the rehabilitation facility. This Bill would exclude such inmates from the Fair Employment Practices Act. I'm just asking how many people fall into this dual category?"

J. Davis: "Well, it's a fluid number, Representative Lechowicz, simply because if you'll note the categories, they can only remain in the first two for a limited period of time. So that consequently if they are trainable or developable into the employee category and can seek gainful employment either outside of the sheltered workshop or within the sheltered workshop, they move into the employee classification. Therefore, become covered under the Fair Employment Practices Act. The only exclusion would be the work activity client who would be in a therapeutic day care situation who would have no consequencial work. It's simply a therapy situation. At any given time, it depends on the population of the rehabilitation facility or the sheltered workshop. Now, the Association of the Rehabilitation Institutes around the State of Illinois, particularly in sheltered workshops number probably in the neighborhood and I've got to guess here, Representative, in the neighborhood of fifty to sixty with an average population of... in diagnostic or in these categories with maybe twenty or twentyfive fluidly running through at that point in time. So perhaps some one thousand to twelve hundred at any given point in time,

but they are constantly moving out of that situation and into the work area where they would be covered or they would be not qualified at all. And they would be put into a work activity situation where their work would be inconsequencial. Does that answer your question, Sir?"

Lechowicz: "Well, you're talking about fifty to a hundred people?"
J. Davis: "No, Sir. I said it could be as high as a thousand to twelve
hundred people in all three categories at any given time depending
on the referrals from the Department of Mental Health and the Division of Vocational Rehabilitation."

Lechowicz: "All right, thank you."

Speaker Redmond: "Any further discussion? Representative Satterthwaite." Satterthwaite: "Will the Sponsor yield?"

J. Davis: "Yes, indeed."

Satterthwaite: "Representative, is this intended to take these particular categories of people outside of the Fair Employment Practices Act for the amount of reimbursements for the work which they are doing?"

J. Davis: "No, that is not the intention. Evaluation clients and the trainee clients are not paid at this point in time, nor are the work activity clients, do not receive renumeration except while they're in training, there may be renumeration. It will accept those. We're only talking about the 'fringe benefit' package that applies to these categories."

Satterthwaite: "So that you are saying that even if your Bill passes the amount of money that someone in a sheltered workshop situation is now receiving would not be influenced by this Bill?"

J. Davis: "It certainly would notbe influenced. In fact, that is not the intent of the Bill at all. The intent of the Bill is to relieve the financial and administrative burden of the fringe benefits for those clients who are really in a temporary nature. If they are placed permanently outside the sheltered workshop, obviously... where they are placed outside, obviously they fall into the civil employment situations where they would be covered. If they remain within the sheltered workshop with a job function and remove from these categories, they will be paid and they will



fall under the Fair Employment Practices Act. We're only exempting diagnostic, training and work activity clients. You must understand the three categories."

Satterthwaite: "But your trainee category could last for as long as

a twelve-month period."

J. Davis: "That is indeed true. It could possibly last that long, yes." Satterthwaite: "And in many cases, particularly with the developmentally

handicapped person, it would last that long."

J. Davis: "It is possible, yes."

Satterthwaite: "Now, during that twelve-month period of traineeship,

what happens to the money that they would otherwise qualify for

in this job that they're doing?"

J. Davis: "Salaries are not affected by this Bill."

Satterthwaite: "Thank you."

Speaker Redmond: "Anything further? Representative Davis, to close." J. Davis: "I simply urge a 'yes' vote on House Bill 931."

Speaker Redmond: "Representative Barnes, are you seeking recognition?

Pardon me. Barnes. Gene Barnes."

E. Barnes: "Thank you very much, Mr. Speaker. Would the Sponsor yield_ to a guestion?"

Speaker Redmond: "He will."

E. Barnes: "Representative, I'u not quite clear on the exemptions that you will be giving to the employees under the Act. Could you run that by me just one more time?"

J. Davis: "In terms of what?"

- E. Barnes: "In terms of who would be exempt and the purpose for the exemptions."
- J. Davis: "Well, the purpose for the exemptions, once again, is financial and administrative. The categories exempted and one would have to... if you have a sheltered workshop in your district, I suggest, Representative Barnes, that you vist them or contact them sometime. You'll find that most sheltered workshops in conjunction with D.M.H. and particularly D.V.R., have continual and ongoing diagnostic programs in which they have referrals for evaluation purposes to induce a work program for or a possible work program for gainful employment outside the sheltered workshops. It



is purely a diagnostic tool and that is the category of the evaluee. When that evaluation is done at that point, they can become either placed outside the workshop or go into a training classification for placement outside the workshop or within the workshop. If neither of those two plans are viable to the diagnostic process, they become what the sheltered workshops or day care centers, therapeutic day care centers would classify as a work activity client. In other words, the developmental disability is so severe that the work performed will be inconsequential. It is a day care therapy situation. Those are the only three categories we're talking about. When a client is moved into finally sheltered workshop employment on a permanent basis or placed outside the sheltered workshop in civilian employment, then of course, they fall under the Fair Employment Practices Act."

- E. Barnes: "So this, in effect, would exempt them solely for the period they are in training which, I believe you said could be up to a year but normally not more than a twelve-month period."
- J. Davis: "It will never be more than a twelve-month period and indeed is oftentimes and I say this without benefit of specifics, but oftentimes much less."

Clerk Hall: "Resolved, by the House of Representatives of the 80th General Assembly of the State of Illinois, the Senate concurring herein, that there shall be submitted to the electors of this state, at the general election next occurring at least six months after the adoption of this Resolution, a proposition to amend Sections 8, 10, and 12 of and to add Sections 12.1 and 12.2 to Article VI of the Constitution, the amended and added Sections to read as follows: "Article VI, the Judiciary. Section 8. Associate Judges.



Each Circuit Court shall have such number of Associate Judges as provided by law. Except where elected in accordance with Section 12.1, Associate Judges shall be nominated by Judicial Nominating Commissions in each Judicial Circuit and selected by the Governor in the manner provided in subsection (d) of Section 12 of this Article. In the First Judicial District, unless otherwise provided by law, at least one-fourth of the Associate Judges shall be appointed from, and reside, outside Chicago. The Supreme Court shall provide by rule for matters to be assigned to Associate Judges. Section 10, Terms of Office. The terms of office of Supreme, Appellate and Circuit Judges shall be six years; and of Associate Judges, four years. Section 12, Selection and Retention. (a) Supreme, Appellate, Circuit and Associate Circuit Judges shall be selected in the manner provided in subsection (c) of this Section from nominees submitted by Judicial Nominating Commissions; except as provided in Section 12.1. (b) The office of a Judge shall be vacant upon his death, resignation, retirement, removal, or upon the conclusion of his term without retention in office. Whenever an additional Judge is authorized by law, the office shall be filled in the manner provided for filling a vacancy in that office. (c) There shall be a Judicial Nominating Commission in each judicial district which shall nominate persons to fill vacancies on the Supreme Court and the Appellate Court for that district. There shall be two Judicial Nominating Commissions in the Cook County Circuit which shall have identical functions and concurrent, equal jurisdiction and which shall nominate persons to fill vacancies in the offices of Circuit Judge and Associate Judge in the Circuit as such vacancies shall be allocated to the two commissions by Supreme Court Rules. In each of the other Judicial Circuits which has elected to provide for the selection of Judges under this Section by a referendum under Section 12.1 of this Article. There shall be one Judicial Nominating Commission to fill vacancies in the offices of Circuit Judge and Associate Judge. (d) If a vacancy occurs in the office of Supreme, Appellate, Circuit or Associate Judge, the administrative director shall notify the chairman of the appropriate Judicial Nominating Commission, who shall immediately convene the Commission.

The Commission shall, within thirty days after the vacancy occurs, select at least three nominees for each vacancy and submit their names to the administrative director. Within seven days after he has received the names of the nominees, the administrative director shall publicly draw by lot the name of one of the nominees and submit it to the Governor. The Governor is allowed one veto for each vacancy to be filled. If the Governor does not veto the first nominee to be submitted to him within twenty-nine days after the name of that nominee has been submitted to him, the vacancy shall be filled by that nominee. If the Governor exercises his veto within the twenty-nine day period, the administrative director shall publicly draw by lot the name of one of the remaining nominees. Such second drawing constitutes the selection of the nominee whose name is drawn, and the Governor has no further veto. The same nominee may be submitted by the Commission to the administrative director for no more than three successive vacancies. The name of any nominee vetoed by the Governor shall not be resubmitted during the term of that Governor. (e) Not less than six months prior to the general election next preceding the expiration of his term of office, any Judge previously selected or elected may file in the office of the Secretary of State a declaration of candidacy to succeed himself, and the Secretary of State, not more than ninety days nor less than sixty-three days before the election, shall certify the Judge's candidacy to the proper election officials. The District Judicial Nominating Commission shall survey the record of each Judge who has filed a declaration of candidacy to succeed himself and shall make a determination as to whether or not he has met the then prevailing accepted judicial standards. If the District Judicial Nominating Commission determines that the Judge has not met such standards, it shall file a statement of such determination with the Secretary of State before the certification of the Judge's candidacy, and this determination shall be printed on the election ballot alongside the Judge's name. At the election the name of each Judge who has filed a declaration shall be submitted to the electors, separately and without party designation, on the sole question whether he shall be retained in office

for another term. The retention elections shall be conducted at general elections in the appropriate judicial districts and circuits. The affirmative votes of three-fifths of the electors voting on the question shall elect him to the office for a full term commencing the first Monday in December following the election. Any Judge who does not file a declaration within the time herein specified, or, having filed, fails of retention, shall vacate his office on the first Monday in December following the general election, whether or not his successor shall yet have qualified. (f) If an incumbent does not file a declaration of candidacy within the time specified above, the selection and appointment of his successor, if any, shall proceed immediately in the manner provided in subsection (d) of this Section so that the successor may take office as soon as the vacancy occurs. (g) Any law reducing the number of Judges of the Appellate Court in any discrict or the number of Circuit or Associate Judges in any circuit shall be without prejudice to the right of Judges in office at the time of its enactment to seek retention in office. A reduction shall become effective when a vacancy occurs in the affected unit. Section 12.1. Selection and Retention in other Circuit Courts. (a) The Judges and Associate Judges of Circuit Courts outside Cook County shall be elected, and vacancies in such offices may be filled by appointment for interim periods, in such manner as may be prescribed by law; provided, that subsections (e), (f) and (g) of Section 12 of this Article shall apply to such Judges and Associate Judges as shall be elected pursuant to the provisions of this Section. However, the electors of any Circuit outside Cook County may by referendum adopt the provisions of Section 12 of this Article to govern the selection and tenure of Judges and Associate Judges of that Circuit. The electors of any Circuit outside Cook County shall vote on the proposition at the general election held not less than three months following the filing of petitions with the Secretary of State, signed by not fewer than 5 per cent of the total number of electors who voted at the next preceding general election in the Circuit, asking that the proposition be submitted to referendum. If a majority of votes cast on the proposition

shall be in the affirmative, the provisions of Sections 12 and 12.2 of this Article shall thereafter govern the selection and tenure of Circuit Judges and Associate Judges of the Circuit Court of that Circuit. Section 12.2. Judicial Nominating Commissions. (a) The Judicial Nominating Commission for each District or Circuit shall consist of six lawyers, no more than three of whom shall be members of the same political party, five laymen, no more than three of whom shall be members of the same political party, and one Judge who is then sitting on the Circuit of Appellate Court. The Judge shall be the Chairman of the Commission and shall vote only in the case of a tie. (b) The six lawyer members of each District and Circuit Commission shall be selected in the following manner: The county chairman of chairmen of each established political party for the county or counties comprising the judicial district or circuit shall select one lawyer of that party in that Judicial District or Circuit to serve as a member of the Commission for that District or Circuit. The Governor shall appoint the remaining number of lawyers to make up a total of six lawyers in each District and Circuit. Such layers shall be selected from the certified election result list of Bar Association secret ballot conducted elections for that District or Circuit. The Governor may select as his first appointment any lawyer on the appropriate certified election result list. Each of the successive additional appointments of the Governor shall be the remaining lawyer then standing highest on the certified election result list who is not of the same political party as the lawyer last appointed before him. As to every Judicial District or Circuit, the Supreme Court shall designate a major Bar Association to conduct the election of lawyers. (c) The five laymen members of each Judicial District and Circuit shall be selected in the following manner: The county chairman or chairmen of each established political party for the county or counties comprising the judicial district or circuit shall select one layman who is a registered voter of that party and who resides in that District or Circuit, to serve as a member of a Commission for the District or Circuit. The Governor shall select and appoint two laymen members who are registered voters

of different political parties and who reside in that District or Circuit. In the event of the existence of more than two established political parties, the Governor's selection of laymen is to that extent diminished, and, if diminished to one layman, then that appointee may be of any political party. As to every Judicial District and Circuit, the Supreme Court shall designate a major Bar Association to select a layman for each District and Circuit in the following manner: The president of the designated Bar Association shall submit the name of a registered voter of each established political party in each Circuit and in each District to the Illinois Court Administrator, who shall publicly draw by lot, from those names submitted for each Circuit and for each District, one name as a layman committee member for that District or Circuit. (d) The judicial member of each Commission shall be selected as follows: All of the Judges then sitting in the Circuit Court of that Circuit, or in the Appellate Court in that District, shall vote by secret ballot and elect one of their number to serve as chairman of the Commission for that Circuit or District. (e) Initially the Governor shall divide the layman appointees and the lawyer appointees into two groups and shall designate one group to serve for three years and one to serve for six years. As near as may be, the groups shall be equal and the number of members of one political party shall not exceed halt the number of the group. Thereafter the terms of all members shall be for six years. (f) A vacancy in the office of chairman or member of the Commission shall be filled for the unexpired term in the same manner and for the same qualification as those originally chosen. (g) No person who holds any office under or is an employee of the United States or this state ar any municipal corporation or political subdivision of this State or who holds any official position in a political party is eligible to serve on a Judicial Nominating Commission. No incumbent president of a major Bar Association is eligible to serve on a Judicial Nominating Commission during his term of office. Compensation for service in the state militia or the armed forces of the United States for such periods of time as may be determined by rules of the Supreme Court shall not be

considered a disqualification. No member of a Judicial Nominating Commission may be nominated to judicial office for a period of three years from the last day of his service on the Commission. A member, having served a full term of six years on a Commission, may not be elected to serve on a Commission for the next three years. (h) Members of Judicial Nominating Commissions shall not receive any compensation for their service but shall be entitled to reimbursement for necessary expenses. Such Commissions may conduct such investigations, and employ such staff members as may be necessary to perform their duties. The decision of the Commission must be by concurrence by a majority of its members. Proceedings of the Commission shall be confidential. (Clerk does not read Section (h).) (i) All lawyers residing in Illinois may vote in their respective districts and circuits as to lawyer nominees to Commission membership through the designated Bar Association whether or not they are dues paying members of that Bar Association. Lawyers may vote only in the district and circuit in which their principal office is located. Where the presidents of the respective Bar Associations are not notified to the contrary by a lawyer as to his residence at the time of any Bar-conducted election, then the Supreme Court Cler's records as to residence at the time of admission to the Bar will serve as the last known address for purposes of any balloting by the Bar Association. Schedule. If approved by the electors, these Amendments shall take effect the next day following proclamation of the result of the vote. The adoption of these Amendments shall not operate to reduce the existing term of office of any incumbent Judge. First Reading of the Constitutional Amendment. No further business, the House stands adjourned."
