Clerk O'Brien: "House Bill 1211. A Bill for an Act making....supplemental appropriation to the State Board of Education."

Speaker Redmond: "Is there any motion with respect to the Amendment?"

Clerk O'Brien: "Second Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Redmond: "No motion with respect to it, I take it."

Clerk O'Brien: "No motion filed."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "Amendment #2 failed in Committee. Floor Amendment #3...."

Speaker Redmond: "Who is the Sponsor of....Floor Amendment?"

Clerk O'Brien: "Anderson. Amends House Bill 1211 on page 1 by deleting lines 1 and 2...."

Speaker Redmond: "Representative Anderson. Representative Hanahan,

are you familiar with this Amendment?"

Hanahan: "Yes, this is identical to the Committee Amendment that was offered. It is posed by the Office of Education and the Chief - Sponsor and I'd move to table Amendment #3."

Speaker Redmond: "Question's on the Gentle....Representative Ryan."

Ryan: "Well, Mr. Speaker, Representative Anderson is not on the floor.

I don't know where he is, he was here just a minute ago, I wish

that you'd....at least let him argue on the motion to table and give him a second to get on the floor before you try and table his Amendment."

Hanahan: "Well, well..."

Speaker Redmond: "Representative Hanahan."

Hanahan: "Mr. Speaker, the Session is...is on, I believe you called a

Session to order. We are on Second Reading. I...I....the Amendment
that he has offered is a bad Amendment, most Republicans voted against
it in Committee...."

Ryan: "Mr. Speaker..."

Hanahan: "I could...I could just suggest that the Gentleman should be

Ryan: "Mr. Speaker."

Speaker Redmond: "Representative Ryan."

Ryan: "Well, you know...."

Hanahan: "I'll move it back to Second Reading tomorrow if you wanted...

Ryan: "We'll move the Bill today if you give me, you know, a couple of seconds, we'll have Anderson on the floor. Okay, here he comes now,

here he comes."

Speaker Redmond: "Here comes Representative Anderson to solve the problem. Representative Lechowicz."

Lechowicz: "Mr. Speaker, could we have a little order in the chamber and ask that all unauthorized personnel remove themselves from the floor?"

Speaker Redmond: "Your point is well taken. The House will come to order, unauthorized personnel leave the floor. Representative Anderson."

Anderson: "Yeah. What this Amendment does is release a request for \$11,360,800 for fiscal '77 supplemental from the General Revenue and Common School Fund. It also makes a Common School Fund transfer of 65,200 from the Regional Superintendent's Salary Line Item to the Orphanage and State-Owned Housing Line Item. No increase in the Common School Fund. The request for \$3,497,545 of federal

funds remains unchanged. There is really no need for matching funds. for this \$3,000,000 from federal funds. Now, \$8,000,000 of this supplemental appropriation is already in the Governor's Budget Bill for this year. This is lapsed funds and he had counted on it for this \$75,000,000 grant to the Common School Fund over and above... this is new money over and above last year's appropriation. The Education Transportation Fund is now funded at 78% for the Common

School. If we pass this particular Amendment Special Ed Transportation will be funded at a 100%. It's now funded at 92% for this fiscal year. Personnel is funded at 89% to School Aid Formula

at 94%. If we pass this Bill it will be funded at a 100%. So

I think that Special Ed is going to have to tighten its belt just

for the Common School. For Special Ed Personnel it's now funded



as well as the Common Schools have, so I move for the adoption of this Amendment."

Speaker Redmond: "Any discussion? Representative Hanahan." Hanahan: "Well, Mr. Speaker, Members of the House, we have a state law guaranteeing our school district reimbursement that we guaranteed last year and year before and year before that, and as long as we have tried to live up to our commitments to Special Ed and to Special Ed Transportation. Now, because the Governor has vetoed, or amendatorily vetoed, some of these appropriations that I stood on the floor of this House, and even John Porter, Representative Porter commended me for the...the ability to bring to focus the exact amount of monies that we had committed by law to school districts around this state, that we, the General Assembly, the 79th General Assembly, committed to our....our citizens that if you expended that money in your school district and you provided the Special Education and the Special Education Transportation that we would reimburse you. And, Mr. Speaker, Members of the House, this. Amendment completely makes fatter, it makes complete hypocrisy out of law if this Amendment is now adopted...because this Amendment completely contradicts what the law of Illinois calls for, and that's the reimbursement at the levels that the law calls for on Special Ed and Special Ed Transportation. I just suggest to those Members of the General Assembly who campaigned last November saying that education was a number one priority and education was a number

Speaker Redmond: "Any discussion? Representative Friedrich. Friedrich."

Friedrich: "I don't want to speak on this Bill, I had a...wanted to
table something."

Speaker Redmond: "Representative Gene Hoffman."

Hoffman, G: "Mr. Speaker, Ladies and Gentlemen of the House, we heard a lot of rhetoric about the state living up to its responsibility.

Well, let me share with the Members of this Body that this money, the supplemental appropriation money, is included in the General Distribution money that is planned for in the Governor's Budget.



It's very simple. It is very simple. Now, this particular money is...is funded, is set into a particular category of students. The eight million dollars to be used in the next fiscal year is to go to all students, special students and otherwise. All students. Now, we are not only underfunding Special Education but as you and I well know, we are not fully funding the regular State Aid Formula. Now, the question is very simple, do you want to take this money and distribute it to all the students in all the school districts in the State of Illinois or do you not? Do you want, in fact to take and hold this into one specific category and only of that class of people share? Remember, that we're underfunding both programs. Don't be fooled. Support this Amendment."

Speaker Redmond: "Representative Schneider."

Schneider: "Thank you, Mr. Speaker, Members of the House, I would argue likewise that we support the Amendment only because we said for so many....so many days now, and in fact so many years, that we are facing a real problem in funding of education. If every Spring we're going to come back and try to unravel the kinds of budgeting we've tried to do to keep us consistent with the revenues and still hold pretty good to our responsbilities as educators in terms of distributing dollars, I think we're going to be wasting our time. It's a mistake to support a proposal without this Amendment. I think this Amendment gives us the federal money that does not require a match. It relieves us from the pressures of trying to always to add supplemental appropriations to programs that we cannot possibly fund. I would ask, therefore, for the adoption of the Anderson Amendment."

Speaker Redmond: "Representative Ryan."

Ryan: "Well, thank you, Mr. Speaker and Ladies and Gentlemen of the House, this Amendment is going to save 11.3 million dollars worth of General Revenue money that is not in the Governor's Budget. And I would certainly hope the Gentleman from McHenry, if this is successful, if he's successful in putting this Bill out without the Amendment, is going to be prepared to vote and introduce the Tax Increase Bill.

We, as Republicans, don't want this right now. We can't afford it.



And I would certainly urge the support of Anderson's Amendment to save about eleven million dollars in the General Revenue Fund."

Speaker Redmond: "Representative Skinner."

District is speaking for Chicago more than he is speaking for his
District. We're talking about 11.4 million dollars here in the
supplemental request and everyone who is not from Chicago should know
that Chicago's going to get 4.7 million dollars of it. And I would
respectfully submit that that's a little more than Chicago's share.
Henderson and Warren County, just as another example of a previous
