Speaker Redmond: "Roll Call for attendance. Committee Reports."

Clerk O'Brien: "Representative Matijeich, Chairman of the Committee on Appropriations I to which the following Bills were referred; action taken June 7, 1977. Reported the same back with the following recommendation: do pass Senate Bill 484, Senate Bill 494, Senate Bill 432; do pass as amended Senate Bill 328, Senate Bill 337."

Speaker Redmond: "Representative Matijeich."

Matijeich: "Mr. Speaker, Members of the House, we just had a report from the Appropriations I Committee and I want to tell the Membership that on a day when the House was not in Session that we had out of twenty-six Members, we had twenty-three Members there and I just want to publicly thank the Members of the Appropriations Committee and Roscoe Cunningham, the Minority Spokesman. They worked hard. We got almost, about six hours work when the House wasn't in Session that we wouldn't have gotten in and I appreciate

Matijeich: "Speaker, on behalf of the Members, I want to thank you. The Speaker brought us all some ice cream and we appreciate that. And Roscoe Cunningham brought us all some watermelons."

Speaker Redmond: "Representative Tipsword."

Tipsword: "Mr. Speaker, before I forget it, we had some late assignments of Bills to Insurance. Would it be possible to make a motion for posting of those at this time or would you rather..."

Speaker Redmond: "No, you might just as well. I don't know whether the memo with respect to the workload has yet reached your desk, but it's kind of terrifying so I welcome your motion."

Tipsword: "Mr. Speaker and Members of the House, I would move that the appropriate rule of the House for the posting of Bills for six and a half days might be suspended so that the Insurance Committee might post Senate Bills 241, 516, 517, 524, and 652 which were just today assigned to us so that they might be heard at our regular meeting on Friday."

Speaker Redmond: "Representative Giorgi."

Giorgi: "Mr. Speaker, House Resolution 298 by Skinner notes the work of the House Motor Vehicles Committee. 299 by Waddell honors Mr. Earle Stafford on his 50th wedding anniversary. 301 by Lechowicz talks about Mr. Maurice Scott, called Mr. Tax and his retirement. House Resolution 302 by Matejek talks about a polka disc jockey contest. 300 by Younge notes the passing of Reverend William P. Alexander of East Saint Louis. And House Resolution 303 by Waddell honors the Harvard Milk Day Farm Festival. And I move for the adoption of the Agreed Resolutions."

Speaker Redmond: "Is there any discussion? The question's on the Gentleman's motion. Those in favor say 'aye', opposed 'no'. The 'ayes' have it. The motion carries. The Agreed Resolutions are adopted. Senator Phil Rock has just joined us. Representative Skinner."

Skinner: "I some discussion on the Resolution, Sir. I think the House Members now that the Resolutions have passed should know that they have just named the Motor Vehicles Committee as the Consumer Protection Committee of the Year."

Speaker Redmond: "Representative Matijevich."

Matijevich: "Mr. Speaker, Ladies and Gentlemen of the House, I'd like to have leave of the House to suspend the posting notice on House Bill 2412. Henry Klosak asked me to post for this week last week and we hadn't had the Bill assigned to the Committee yet. And it has now been assigned and we'd like to have it heard. I have had approval from both sides of the aisle. It's House Bill 2412, leave to suspend the notice so that it can be heard this afternoon in Appropriations Committee I."

Speaker Redmond: "Does the Gentleman have leave? Hearing no objection, leave is granted. We'll use the Attendance Roll Call. Has he got the Bill? Approval of the Journal."

Clerk O'Brien: "House Journal for the 54th Legislation Day, Tuesday,



May 10, 1977, 10 o'clock p.m. The House met pursuant to adjournment. The Speaker in the Chair. Prayer by Father William Krueger, Chaplain. By direction of the Speaker, the Roll Call was taken."

Speaker Redmond: "Representative Giorgi."

Giorgi: "Mr. Speaker, I move that we dispense with the reading of the Journal. Journal #54 of May 10, 55 of May 11, 56 of May 12, 57 of May 13, and 58 of May 16 be approved as read. I move for the adoption of the Resolutions."

Speaker Redmond: "You've heard the Gentleman's motion. Is there discussion? Hearing none, the question's on the motion. Those in favor say 'aye', opposed 'no'. The 'ayes' have it. The motion carries. Representative Von Boeckman, for what purpose do you arise?"

Von Boeckman: "Mr. Speaker and Ladies and Gentlemen of the House, I'd like to have leave to hear Senate Bill 1301 at twelve noon tomorrow in the Motor Vehicles Committee."

Speaker Redmond: "Does the Gentleman have leave? Representative Ryan, have you... Representative Von Boeckman, have you discussed this with Representative Ryan? Representative Cunningham, for what purpose do you rise?"

Cunningham: "Mr. Speaker, I had a point of inquiry. I understood some nice words were said by... about me by my great and good friend, Honest John Matijevich, and I was un... I was detained and didn't hear them and it was an imposition for him to repeat so that I might enjoy them and so there that such words were spoken."

Speaker Redmond: "We have requested that copies of the tape be made and sent out to Lawrence County and that they be transcribed and sent to every newspaper in the State of Illinois."

Cunningham: "How good of you, Speaker, and also of Honest John Matijevich. Thank you."

Speaker Redmond: "Representative Von Boeckman, have you discussed that with Representative Ryan? Representative Ryan."

Ryan: "Yes, Mr. Speaker, what is it I can do for you?"

Von Boeckman: "No, I didn't discuss it."

Speaker Redmond: "I wonder maybe if you would across the airways here. Well, I think... What was it you wanted to do with respect to

Von Boeckman: "We want to hear it in Committee tomorrow."

Ryan: "Why?"

Von Boeckman: "We were asked to."

Ryan: "What is the Bill?"

Von Boeckman: "I don't even know who's handling the Bill."

Ryan: "What is the Bill?"

Speaker Redmond: "Maybe you'd better discuss it with Representative Ryan. Senate Bills, First Reading."

Clerk O'Brien: "Senate Bill 596. A Bill for an Act to amend the Revenue Act. First Reading of the Bill."

Speaker Redmond: "House Bills, Second Reading. House Bills, Second Reading appears House Bill 715. Representative Younge."

Clerk O'Brien: "House Bill 715. A Bill for an Act to make an appropriation to the Depressed Areas, Land Use and Community Development Commission. Second Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Redmond: "Any motion or Floor Amendment?"

Clerk O'Brien: "No motions or Floor Amendment."

Speaker Redmond: "Third Reading. 1023."

Clerk O'Brien: "House Bill 1023. A Bill for an Act to make an appropriation to the Capital Development Board for the Development of Progress Plaza Industrial Park. Second Reading of the Bill. Amendment #1 and 2 were adopted in Committee."

Speaker Redmond: "Any motions or Floor Amendments?"

Clerk O'Brien: "No motions or Floor Amendments."

Speaker Redmond: "Third Reading. 1593."

Clerk O'Brien: "House Bill 1593. A Bill for an Act to provide for the ordinary and contingent expenses of the Department of Conservation. Second Reading of the Bill. This Bill has been read a second time previously and Amendments #1, 3, 4, 5 and 9 were adopted."

Speaker Redmond: "Is there any motions or Floor Amendments?"

Clerk O'Brien: "Amendment #10, Deavers. Amends House Bill 1593 as amended by deleting Section 6 and so forth."

Speaker Redmond: "Representative Deavers."



Deavers: "Mr. Speaker, Amendment #10 increases the appropriation and reallocation..."

Speaker Redmond: "The Gentleman standing between Representative Deavers and the Chair, please sit down. Representative Campbell, I can't see."

Deavers: "And when you can't see me, you're in trouble."

Speaker Redmond: "Well, that's a pretty big guy that was in front of you. He was a pitcher. Not very good, but he was a pitcher."

Deavers: "Okay, Amendment #10 is an increase of two hundred and fifty thousand dollars and it reappropriates some of the money within the process of two hundred and fifty thousand whereby we're going to end up with ten additional correction or conservation police officers. They have nothing to do with the State Police. They're not going to arrest anybody or anything and I think this Amendment's been agreed to on both sides now and I move for the adoption."

Speaker Redmond: "Is there any discussion? The question's on the Gentleman's motion for the adoption of Amendment #10. Those in favor say 'aye', opposed 'no'. The 'ayes' have it. The Amendment's adopted. Any further Amendments?"

Clerk O'Brien: "Floor Amendment #11, Winchester-Deavers. Amends House Bill 1593 as amended on page 4, line 31 and 32 and so forth."

Speaker Redmond: "Representative Winchester. Representative Deavers."

Deavers: "Amendment #11 appropriates an additional fifty thousand of game and fish funds for electronic data processing in Administrative Services to provide for program, design and testing in an automated deer permit processing system. And again this... the Bureau of the Budget has approved it and the Governor's office and I move for it's adoption."

Speaker Redmond: "Any discussion? The question's on the Gentleman's motion. Those in favor say 'aye', opposed 'no'. The 'ayes' have it. The motion is adopted. Motion carries and the Amendment's adopted. Anything further?"

Clerk O'Brien: "Floor Amendment #12, Deavers-Winchester. Amends House Bill 1593 as amended by deleting Section 7 and so forth."

Speaker Redmond: "Representative Deavers."



Deavers: "Amendment #12 increases the Department of Conservation '78 operations budget by three hundred thousand in the game and fish fund, the Division of Fisheries and this gives us an additional head count of 13. Again, it's an agreed Amendment with the Department and the Governor's office and I move for its adoption."

Speaker Redmond: "The question's on the Gentleman's motion. Those in favor say 'aye', opposed 'no'. The 'ayes' have it. The motion carries, Amendment 12 is adopted. Any further Amendments?"

Clerk O'Brien: "Floor Amendment #13, Winchester-Deavers. Amends House Bill 1593 on page 12, Section 15 and so forth."

Speaker Redmond: "Representative Winchester."

Winchester: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. Amendment #13 is requested by the Department of Conservation. It has been approved by the Bureau of the Budget. The Amendment appropriates ten million dollars of Federal funds to the Department of Conservation to participate in the Youth-Adult Conservation Program. No state money is involved, it's strictly a Federal grant. This Amendment authorizes D.O.C. to spend the money. It's 100% Federal money and I move for the adoption of Amendment #13."

Speaker Redmond: "The Gentleman's moved the adoption of Amendment #13. Those in favor say 'aye', opposed 'no'. The 'ayes' have it. The motion carries, the Amendment's adopted. Any further Amendments?"

Clerk O'Brien: "Amendment #14, Deavers-Winchester. Amends House Bill 1593 as amended on page 1 by inserting between line 19 and 20 the following and so forth."

Speaker Redmond: "Representative Winchester or Deavers as the case may be."

Deavers: "Amendment #14 provides for the funding of the equal employment opportunity program and Endangered Species Board by reducing various line items within the Department of Conservation's operation budget. There's no change in monies whatsoever. We're spending the same kind of monies, but we have to fund these equal employment opportunity and endangered species and I move for its adoption."

Speaker Redmond: "Any discussion? The question's on the Gentleman's..."



Representative Leverenz."

Leverenz: "Thank you, Mr. Speaker. With all the noise on the floor and perhaps the lack of volume on the microphone, I was unable to hear the explanation of that and I think it's the first one that had any reductions in any line items. And perhaps we could have some order and we could hear the explanation again."

Deavers: "Ted, do you have some specific question or would you just like to hear the whole thing?"

Speaker Redmond: "Representative.... The question's on the Gentleman's motion for the adoption of Amendment... Representative Leverenz."

Leverenz: "Thank you, Mr. Speaker. Again, Representative Deavers, I don't have any specific question. I was just totally unable to hear the explanation. There were some deletions and I only ask that you receive the proper amount of order so that explanation can be heard."

Speaker Redmond: "Representative Deavers."

Deavers: "Ted, in the Amendment what happened under the Equal Opportunity Employment Program, we didn't fund it and they needed thirty-one thousand dollars. And what they did was reduce other parts of the budget to pick up that thirty-one thousand so there indeed is no change in the amount of money that was appropriated. Move for the adoption."

Speaker Redmond: "Question's on the Gentleman's motion for the adoption. Those in favor say 'aye', opposed 'no'. The 'ayes' have it. The motion carries, the Amendment's adopted. Any further Amendments?"

Clerk O'Brien: "Floor Amendment #15, Schisler. Amends House Bill 1593 as amended by inserting after the last line in Section 10 the following and so forth."

Speaker Redmond: "Representative Schisler."

Schisler: "Mr. Speaker and Ladies and Gentlemen of the House, this Amendment is for electrical hookups and connections at two sites-- Spring Lake and Anderson Lake over in Fulton County. And I move for the adoption of the Amendment."

Speaker Redmond: "Representative Deavers."

Deavers: "Yes, Representative Schisler visited with me about this and we'll accept the Amendment."



Speaker Redmond: "The question's on the Gentleman's motion for adoption of Amendment 15. Representative Wolf."

Wolf: "Would the Gentleman yield for a... Sponsor?"

Speaker Redmond: "He will. Representative Schisler."

Wolf: "Representative Schisler..."

Speaker Redmond: "The Gentlemen standing between Representative Schisler and the Chair, please sit down. Representative Birchler, Representative Kempiners, Representative Willer."

Wolf: "Representative Schisler, just questioning the electrical work for Spring Lake. When I was there last fall, they closed up part of the campground up there. Is that to renew that or what is this going to be used for?"

Schisler: "The electrical wiring in both of those campsites had been strung in trees and so forth and it was to the point where it was dangerous and so they wanted to cut that off until we get new equipment."

Speaker Redmond: "Anything further? The question's on the Gentleman's motion for the adoption of Amendment #15. Those in favor say 'aye', opposed 'no'. The 'ayes' have it. The motion carries, the Amendment's adopted. Any further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. At this time, I'll turn the podium over to Representative Robinson."

Robinson: "Thank you, Mr. Speaker. It's my privilege at this point to introduce one of the constituents from the 50th District, represented by myself, Representative Jones and Representative Kane, Miss Illinois Teenager, Deanna Marr, who will be competing in the National Teenage Queen Contest down in Atlanta, Georgia. I would like to also point out that there were three finalists from throughout the state out of the 108 who competed and all three of the finalists were from Sangamon County. I'd like to introduce Miss Deanna Marr."

Miss Marr: "Thank you. Good afternoon, Honorable Representatives, visitors and friends. I would like to take this opportunity to thank you for your valuable time to let me visit the House. I am very proud to be the representative of Illinois teenagers and



be from the greatest state. As Miss Illinois National Teenager, I intend to uphold our national motto - Don't wait till you're grown to be great, be a great teenager. Thank you."

Robinson: "At this time, I'd like to present Deanna with the Resolution congratulating her that was passed here and also like to point out that Bill Marovitz has already been down and got her address."

Speaker Redmond: "The observation has been made that it's too bad that the beauty that is so prevalent in the females in the 50th District doesn't also prevail the Representatives from the 50th District. 1637."

Clerk O'Brien: "House Bill 1637. A Bill for an Act to make an appropriation to the Commission on the Pioneer Memorial Plaza. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "None."

Speaker Redmond: "Third Reading. 2077."

Clerk O'Brien: "House Bill 2077. A Bill for an Act to make an appropriation to the Capital Development Board of the development of the Progress Plaza and Industrial Park. Second Reading of the Bill. Amendment #1 and 2 were adopted in Committee."

Speaker Redmond: "Any Amendments from the floor or any motions?"

Clerk O'Brien: "No motions or Floor Amendments."

Speaker Redmond: "Third Reading. 2385."

Clerk O'Brien: "House Bill 2385. A Bill for an Act to make an appropriation to the Illinois Law Revision Commission. Second Reading of the Bill. Amendments #1 and 2 were adopted in Committee."

Speaker Redmond: "Any motions or Floor Amendments?"

Clerk O'Brien: "No motions or Floor Amendments."

Speaker Redmond: "Third Reading. 2386."

Clerk O'Brien: "House Bill 2386. A Bill for an Act to amend Sections of an Act to provide for the ordinary and contingent expense of the Department of Finance. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "None."



Speaker Redmond: "Third Reading. 2387."

Clerk O'Brien: "House Bill 2387. A Bill for an Act to make an appropriation to the Illinois Transportation Study Commission. Second Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Redmond: "Any motions or Floor Amendments?"

Clerk O'Brien: "No motions or Floor Amendments."

Speaker Redmond: "Third Reading. 2388."

Clerk O'Brien: "House Bill 2388. A Bill for an Act to make a supplemental appropriation to the Department of Transportation for railroad relocation demonstration projects. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "None."

Speaker Redmond: "Third Reading. 2394."

Clerk O'Brien: "House Bill 2394. A Bill for an Act to make an appropriation to the Illinois Recreation Council. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "None."

Speaker Redmond: "Third Reading. 2404."

Clerk O'Brien: "House Bill 2404. A Bill for an Act to make an appropriation to the Administrative Office of Illinois Courts. Second Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Redmond: "Any motion or Floor Amendment?"

Clerk O'Brien: "No motions or Floor Amendments."

Speaker Redmond: "Third Reading. Representative Kelly. Representative Kelly."

Kelly: "Yes, Mr. Speaker, I would like to ask for leave of the House to have House Joint Resolution 39 heard by the House Executive Committee tomorrow. I talked to the Vice-Chairman, Representative Mudd, about this and certainly received his approval and I would like leave of the House."

Speaker Redmond: "The Gentleman have leave? Representative Schlickman."

Schlickman: "Would the Sponsor yield?"

Speaker Redmond: "He will."

Schlickman: "What is the content or substance of this Resolution?"



Kelly: "This is a Resolution that is a Respect Life Week Resolution which has been through this Body several times over the last few years and it designates a week in October to be a Respect Life Week for all forms of human life."

Schlickman: "Thank you."

Speaker Redmond: "Representative James Houlihan."

J. Houlihan: "Representative Kelly, this is obviously a controversial issue. I know that it may have some impact on the consideration of the Equal Rights Amendment and I suggest you hold this until Representative Greiman's here on the floor."

Kelly: "He is on the floor but I certainly don't see any reason to hold it back. And I would, therefore... I don't know, are you objecting? No, I'll tell you the reason why..."

Speaker Redmond: "Representative Mudd, for what purpose are you anguishing?"

Mudd: "Yes, Mr. Speaker, I don't think the contents of the Resolution should be discussed here on the floor, but we have no objection of hearing this Resolution tomorrow in Committee. And I think that if there are any people who oppose it or are proponents for the Resolution that that would be the time to address it. And I think that the time involved in the... hearing this Resolution and setting different dates that it addresses itself to is important that we do hear it tomorrow and I would ask everyone in the House to go along with Representative Kelly's request so that we could hear it tomorrow in Executive Committee."

Speaker Redmond: "Representative Mann."

Mann: "Well, Mr. Speaker and Members of the House, I wonder if the Gentleman would yield for a question. Representative Kelly, I don't want to in any way impede the progress of your Bill because like every other Member, you're entitled to a hearing. And I certainly would fight for that right for you to have a hearing. The question then becomes, is it a Bill of such magnitude to enough people here in the state to justify perhaps going through the ordinary postings since it would in no way jeopardize the Bill because it's a House Joint Resolution. And should I object, I want it to be made perfectly clear here that this is not on



the issue per se because I haven't seen the Bill. And I do not know ahead of time what I'm going to do with the Bill, but I just wanted to make that input."

Kelly: "Representative, I certainly agree with you and always have every time I've had this similar Resolution every year. I've never asked for an avoidance or an expediency on any one of these, on this particular Resolution. But this Resolution pertains to the Respect Life Week which is, I would say, probably something that, well I don't know if you'd support it, but I certainly think you appreciate all human life and I think most of the Members in this House have this feeling. But there is a convention of the National Illinois Right to Life... I'm sorry. The National Right-to-Life Organization is holding their convention in Chicago, Illinois this year, later this month and the Members of the Committee had asked that we could pass this through so that copies could be made for this purpose. And that's why I'm asking you to expedite the Resolution. Otherwise, I wouldn't make that request."

Mann: "Mr. Speaker, may I address this briefly?"

Speaker Redmond: "Proceed."

Mann: "I couldn't agree more with the Sponsor. He's responsible and we've served together on Commissions and worked together on many matters and regardless of my position here, I want him to understand and I want the Membership to understand that at this point, I only have a vague knowledge of the Bill based upon the answers given by the Sponsor. So that if I were to object to this posting overnight, it would only be on the basis that we are affecting large numbers of people who are polarized on this issue. And I think in that sense we ought to move deliberately, especially because House Joint Resolutions have until almost we close down the shop to get going. And while I think it's great for the convention to be going and I can see why you'd want it, I nevertheless think that in the long run everybody's interest would be protected by a little deliberation here. So I object."

Speaker Redmond: "Objections have been raised. Representative Kelly."

Kelly: "Could I at this time make a formal motion to... to ask for..."



consideration of this suspension of the rules to have this Bill and I would..."

Speaker Redmond: "According to our rules, that motion should be in writing and it should be on the Calendar for one day. And the requirements of that may be suspended only by unanimous consent, so failure to have received the unanimous consent would require a motion in writing and have it on the Calendar. Representative Kent."

Kent: "Yes, Mr. Speaker, could I ask a question? Is this to post the Joint Resolution in Executive on Thursday?"

Speaker Redmond: "Representative Kelly, explain to Representative Kent what..."

Kelly: "Yes, I would like to have a motion to post and to have it heard by the Executive Committee tomorrow and I would like to know if I could get leave to have an oral motion in that affect."

Kent: "I believe that the first procedure would be to have the rule that limits it to fifty Bills be excused first because we have already fifty Bills posted."

Kelly: "Yeah, why don't we just forget the motion and certainly we'll go after it. Thank you."

Speaker Redmond: "Okay, Representative Garmisa. Representative Garmisa."

Garmisa: "Mr. Speaker and Ladies and Gentlemen of the House, I'd like to have leave of the House to hear Senate Bill 643 and 922 in Transportation Committee this Friday at eleven o'clock without the usual posting."

Speaker Redmond: "Does the Gentleman have leave? Representative Schlickman."

Schlickman: "Could have an explanation of the Bills?"

Garmisa: "We just got the Bills in Committee. They were assigned to Transportation. I'm not acquainted with them, Gene."

Schlickman: "I object."

Garmisa: "I do know that they were..."

Speaker Redmond: "Objection has been raised. Representative Schlickman."

Schlickman: "I might add that probably these Bills haven't even been printed."

Speaker Redmond: "I've been led to... The Clerk tells me that all of



our Bills have been printed."

Schlickman: "Not Senate Bills."

Speaker Redmond: "Yes, they have, Sir. Your apology will be accepted. When you were home sleeping, the Clerk was working. Any other announcement or requests? Expatriate, Senator Merlo, has returned to the scene of the crime. He's known as Condominium Merlo. Senate Bills, Second Reading. 24, Representative Ebbesen, do you want to call that one? Senate Bill 24."

Speaker Redmond: "Any motion with respect to that Amendment?"

Clerk O'Brien: "No motion filed."

Speaker Redmond: "Read the Amendment, Floor Amendment."

Clerk O'Brien: "Floor Amendment #2, Schlickman. Amends Senate Bill 170 as amended by inserting 20-5 and so forth."

Speaker Redmond: "Who was the Sponsor?"

Clerk O'Brien: "Representative Schlickman."

Speaker Redmond: "Representative Schlickman."

Schlickman: "Well, I'm the Sponsor of the Amendment. Representative Hart is the Sponsor of the Bill. He's not here. This is an Amendment, though that has been discussed with him and he has no objection to it."

Speaker Redmond: "Representative Giorgi."

Giorgi: "Never mind, Speaker."

Speaker Redmond: "The question's on the Gentleman's motion for the adoption of the Amendment. Those in favor say 'aye', opposed 'no'. The 'ayes' have it. The motion carried, Amendment's adopted. Any further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Redmond: "316. Have you discussed your Amendment with Representative Capparelli? We'd better take this... take this one out of the record. 377."

Clerk O'Brien: "Senate Bill 377. A Bill for an Act to amend Sections of an Act relating to alcoholic liquors. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "None."

Speaker Redmond: "Third Reading. 3...420."

Clerk O'Brien: "Senate Bill 420. A Bill for an Act to amend the School Code. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "None."

Speaker Redmond: "Third Reading. 421."

Clerk O'Brien: "Senate Bill 421. A Bill for an Act to amend the Illinois Insurance Code. Second Reading of the Bill. Amendment #1 was adopted in Committee."

Speaker Redmond: "Any motions or Floor Amendment?"

Clerk O'Brien: "No motions or floor Amendments."

Speaker Redmond: "Third Reading. 473."



Clerk O'Brien: "House Bill 473. A Bill for an Act to amend the Insurance Code. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "None."

Speaker Redmond: "Third Reading. 482."

Clerk O'Brien: "Senate Bill 482. A Bill for an Act to provide for a Metropolitan Exposition and Auditorium Authority in Waukegan. Second Reading of the Bill. Amendment #1 was tabled in Committee. Amendment #2 was adopted in Committee."

Speaker Redmond: "Any motion or Floor Amendment?"

Clerk O'Brien: "No motions or Floor Amendments."

Speaker Redmond: "Third Reading. 492."

Clerk O'Brien: "Senate Bill 492. A Bill for an Act to amend Sections of the Viet Nam Veterans Compensation Act. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "None."

Speaker Redmond: "Third Reading. 493."

Clerk O'Brien: "Senate Bill 493. A Bill for an Act to amend Sections of the Revenue Act. Second Reading of the Bill. Amendment #1 and 2 were adopted in Committee."

Speaker Redmond: "Any motion or floor Amendment?"

Clerk O'Brien: "Motions filed to table Amendment #1 and 2 by Representative Bradley."

Speaker Redmond: "He's not here. Representative Bradley."

Bradley: "Well, Mr. Speaker, I'd like to table the... Amendments #1 and #2 as the motion suggests at this time to Senate Bill 493."

Speaker Redmond: "Are you the Sponsor of those... you the House Sponsor of that Bill?"

Bradley: "I'm the House Sponsor of the Senate Bill and I was the Sponsor of those two Bills. We have some other Bills... or some other Amendments filed to clean up the Bill."

Speaker Redmond: "Okay, question's on the Gentleman's motion to table Amendment #1 and 2. Any discussion? Hearing none, the question's on the motion. Those in favor say 'aye'. Representative Leverenz."



Leverenz: "Thank you, Mr. Speaker. Is the House Sponsor of the Bill also the House Sponsor of the Amendments?"

Speaker Redmond: "He is."

Leverenz: "Could he perhaps give a brief explanation then of what Amendments are going to replace 1 and 2?"

Speaker Redmond: "Representative Bradley."

Bradley: "The first Amendment was an Amendment that was suggested by Members of the Committee to the House Bill, 1325 very similar to 493, and that Amendment took the home out of the formula, out of the method in determining the assessed valuation of the farmland and the home would be assessed at thirty-three and a third percent of the value as was suggested as I said by some Members of the Committee. I think it made it a better Bill. We're going to do that with further Amendments. The language was not in exactly the same shape that... and there was some problems with some of the assessors and we're going to, I think, resolve those problems with Amendments I have on the floor of the House. The second Amendment that I tabled was the hold harmless Amendment and again we had some things brought to our attention that we're going to put the hold harmless back in in better shape, I think, with the... either Amendment 3 or 4. I think there was a couple of Amendments filed, a couple of Amendments filed in front of the ones that I had put in to take care of those two problems. And then we have a third Amendment, but we're going to put those two Amendments back in in other Amendments as requested by other Members of the House. It'll make it a better piece of legislation."

Leverenz: "Thank you."

Speaker Redmond: "Representative Waddell."

Waddell: "Would the speaker yield?"

Speaker Redmond: "He will."

Waddell: "Bradley, under your Bill, is... and under the amended version, have you changed in any way the present existing termination of both acreage and/or the lot provision that is made with a small acreage?"

Bradley: "I couldn't hear the last part."

Waddell: "The lot provision that has been made in the... in the law as



it is right today. In other words, if they had one lot within the homestead that they wanted for a son or a daughter or something like that, that particular portion as far as assessing is concerned, has that been changed?"

Bradley: "Well, it will be when we put the other Amendments on. They will be assessed, any home will be assessed at thirty-three and a third percent of the value just as it is on urban homes. And when we get it in the shape we want it to be in, that's where we will be, I hope. I mean, that's what the Amendments 3, 4, 5 will do."

Waddell: "Does it also take into consideration that the definition of a farm, let's say for example where you have a broiler industry which is definitely a farm-related industry, but you don't have large acreage, you could do it on less than five acres. Does that address that situation?"

Bradley: "It does it in the Bill as provided right now, anything less than... at a five-acre tract would not be considered farm... farming ground and consequently would not be, the assessments would not be computed under this legislation."

Waddell: "How then would it be computed if you had a broiler operation?"

Bradley: "They would compute it at thirty-three and a third percent of the value just as it would be today. But it does not come underneath the description of farmland as provided in this Bill."

Speaker Redmond: "Representative Mary Lou Kent."

Kent: "Thank you, Mr. Speaker. Mr. Bradley, may I ask a question?"

Speaker Redmond: "Representative Bradley."

Kent: "Mr. Bradley, the... over here. There are two Amendments as I understand it. One is to assess the house separately. What is the other one?"

Bradley: "No... a hold harmless provision which directly affects Adams County. The other Amendment... now, we're tabling these two Amendments, we're going to come back with them later in a better form. But it would provide that if the '77 tax is payable in '78 using this formula, they could not be less than your '77, '76 taxes, payable in '77, so there would be no loss of tax dollars to local governmental taxing bodies."



Kent: "Now, there is no... is this what they are requesting on delaying it a year? Will this help that situation?"

Bradley: "Will it help what situation?"

Kent: "The County Assessors have been writing asking that it be delayed a year."

Bradley: "No, we're not delaying it a year."

Kent: "Now, it's my understanding you're tabling these Amendments and then you're going to bring back new ones."

Bradley: "Yes, we're going to bring back some Amendments that... some of the Assessors have indicated they've had problems with the... taking the home out and then what do they do. Well, we're going to provide that they take the home out, assess it at thirty-three and a third percent, put it back in the farm package and they are assessed at that particular rate, whatever it might be. The formula and the house package would be assessed and the Assessors have asked us to do that. And then the other one is the hold harmless provision."

Kent: "Thank you."

Speaker Redmond: "Any further discussion? Representative Neff."

Neff: "Thank you, Mr. Speaker. Gerald, this takes effect as of 1977?"

Bradley: "Pardon me, I didn't hear the question."

Neff: "This would take effect in 1977?"

Bradley: "1977 taxes, payable 1978."

Neff: "Yes, I've had letters and maybe you have, too, from several supervisors of assessments saying that it's going to be almost impossible to get this work out. They're in favor of the Bill, the ones that I have heard, but they would like to have it postponed till 1978 in order to get some of the things worked out."

Bradley: "Well, the only thing that I think is going to happen. If we delay it till 1978, payable '79, you're going to have exactly the same people coming back and saying, we need to delay it because the taxes would increase on farmland next year on the assessment and they would have exactly the same problem if we delay it a year that they're going to have if we don't delay it a year. And the... we think that with the Amendments we're going to put on that it is possible for the supervisor or for the boards and



supervisor of assessments to assess the land and get the tax bills out on time. Over fifty counties will have no problem at all in doing this. The other fifty counties that simply have not kept up the paperwork necessary in county by county in some fifty counties, they do not even take advantage of the two and a half cent tax that's available to them to provide the necessary paperwork to assess property correctly and provide files. Other... some other fifty counties have done this, have no problem at all with this legislation. What we're really... we're into the Bill here, but what we're really asking them to do is we're going to give them a figure and the Department of Local of Government Affairs, say at four hundred dollars an acre to assess land instead of four hundred and twenty or three hundred and eighty. We're only giving them one change and that is the top dollar for the best grade of land in the county and go ahead and assess it from there. I don't see where there's that big a problem if we're just changing the top dollar."

Neff: "Thank you. I think maybe this does explain, I think I can explain it to some of these what you're doing and I just don't believe they're going to have the problem that they feel they're going to have. Thank you."

Speaker Redmond: "Representative Schneider."

Schneider: "Well, thank you, Mr. Speaker, Members of the House. I would like to have the Members pay closer attention than what is presently apparent because these Amendments as they presently stand create certain kinds of hardships that the Sponsor does not speak to. Number one, will the Sponsor yield to a question? Jerry? Jerry, it's my understanding that you intend to incorporate 1 and 2 into another Amendment. Is that Amendment available?"

Bradley: "Yes, Sir. We're going to have three additional Amendments, but 1 and 2 are... and I don't know the correct number, Mr. Schneider, but they're there."

Schneider: "May I ask the Clerk? Jack, Jack, has there been an Amendment circulated that incorporate 1 and 2, is that your understanding?"



Clerk O'Brien: "Amendments 5, 6 and 7 have been filed."

Bradley: "You have filed two Amendments, so that would be, I assume, 3 and 4 and my three will be 5, 6 and 7, yes."

Schneider: "Yeah, are... they are distributed, Mr. Clerk? Are 5, 6 and 7 distributed?"

Clerk O'Brien: "Not yet. They're being printed right now."

Schneider: "Well, can we... Jerry, why don't we wait and take it out of the record? I think it's difficult to speak to the issue without the assurance in writing in Amendment form that Amendments #1 and 2 will be incorporated in 5, 6 and 7. So if it's... I think to facilitate logical discussion, we ought to hold the Bill and then discuss the Amendments as they are before us. And I would ask that, that the Bill be taken out of the record."

Bradley: "Well, the only thing I was trying to do was table the two Bills and you'd rather hold them and... I don't know if they've been distributed. Let's find out if..."

Schneider: "They have not."

Bradley: "All right, take it out of the record."

Schneider: "Thank you very much."

Speaker Redmond: "Out of the record. 600 out of the record. 694."

Clerk O'Brien: "Senate Bill 694. A Bill for an Act to amend the Illinois Vehicle Code. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Amendments from the floor?"

Clerk O'Brien: "None."

Speaker Redmond: "Third Reading. 1225."

Clerk O'Brien: "Senate Bill 1225. A Bill for an Act to amend the Illinois Securities Law. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "None."

Speaker Redmond: "Third Reading. Representative Hart, do you seek recognition? Representative Hart."

Hart: "Thank you, Mr. Speaker. I'd like to have the attention of the Democratic Members of the House. First, I'd like to introduce our Comptroller, Michael Bakalis, who's here on the floor."



Mike, would you raise your right hand? And I would secondly like to say that the Democrats are going to have a Conference immediately in Room 118, I presume. Jack, right? Room 114? Room 114. Dr. Bakalis will be at the Conference and we would appreciate it if we could have a good attendance from the Democratic Members. So we'll... we will have a Democratic Conference. We will not return to the House floor after the Conference and we will have our Committee meetings at two o'clock or as soon as the Conference is over."

Speaker Redmond: "Representative Capparelli, are you seeking recognition?"

Capparelli: "Mr. Speaker, I'd like to suspend the appropriate rule so that the Executive Committee might hear more than fifty Bills next week. These will all be Senate Bills."

Speaker Redmond: "Does he have leave? Hearing no objection, leave is granted. The Attendance Roll Call will be used. Representative Madigan."

Madigan: "Mr. Speaker, are we ready to adjourn?"

Speaker Redmond: "We are. Wait a minute."

Madigan: "Do we have any further announcements?"

Speaker Redmond: "Mr. Clerk, what's your problem?"

Clerk O'Brien: "Just one minute perfunctory to read a couple Senate Bills, First Reading."

Speaker Redmond: "Representative Madigan."

Madigan: "Are there any further announcements, Mr. Speaker?"

Speaker Redmond: "Any further announcements? We're about ready to adjourn. Any suspension of the rules for posting or anything else? Representative Madigan, did we have any excused absences on the Democratic side?"

Madigan: "If the record would show, Representative Kornowicz is excused because of illness. And Mr. Speaker, I would suggest that the Committees scheduled for two o'clock this afternoon meet at 2:30 and the Committees scheduled for four o'clock meet at 4:30. And if I could have the attention of the Membership, Mr. Speaker..."

Speaker Redmond: "Will you please give the Gentleman order? Give the Gentleman order."



Madigan: "In order to accommodate the Democratic Conference, the two o'clock Committees shall meet at 2:30 and the four o'clock Committees shall meet at 4:30. And what time did we intend to come in tomorrow, Mr. Speaker?"

Speaker Redmond: "Eleven o'clock."

Madigan: "I move that we adjourn until eleven o'clock tomorrow morning."

Speaker Redmond: "After the one-minute perfunctory? The question's on the Gentleman's motion for the adjournment. Those in favor say 'aye', opposed 'no'. The 'ayes' have it. Now stands till eleven o'clock tomorrow morning."

Clerk O'Brien: "Senate Bills, First Reading. Senate Bill 1025. A Bill for an Act to amend Sections of an Act relating to inspection of hospital records. First Reading of the Bill. Senate Bill 1027.
