following proposition to amend the Constitution of the



United States of America: Joint Resolution. Resolved by the House of Representative and Senate of the United States of America in Congress assembled (two-thirds of each House concurring therein), That the following article is proposed as an Amendment to the Constitution of the United States, which shall be valid to all intents and purposes as a part of the Constitution when ratified by legislatures of three-fourths of the several states within seven years from the date of its submission by the Congress: Article: Section 1, equality of rights under law shall not be denied or abridged by the United States or any state on account of sex. Section 2, the Congress shall have the power to enforce by appropriate legislation the provisions of this article. Section 3, this Amendment shall take effect two years after the date of ratification therefore, be resolved by the House of Representatives of the 80th General Assembly of the State of Illinois, the Senate concurring herein, that such proposed Amendment to the Constitution of the United States of America be and the same is hereby ratified and be it further resolved, that a certified copy of this Resolution be forwarded too the Secretary of State of Illinois to the Administrator of General Services of the United States, to the President pro tem of the Senate and the Speaker of the House of Representatives of the Congress of the United States and to each Senator and Representative from Illinois in the Congress of the United States. First Reading of the Constitutional Amendment."
