Flinn: "No, it's not out of order. I'd be glad to give it to you, far as I'm concerned, unless the Speaker calls me out of order. What the Governor's Amendatory Veto done was strike out the raise in minimums of salaries which you yourself objected to in House Bill 2256. It makes the Bill entirely permissive for county boards to raise salaries or not raise them and there's no counties ... no counties will be forced to raise the salaries because the minimum is cut back to where it was."

Schlickman: "Is this that Bill you yourself indicated you didn't care for; the one that establishes or increases minimum salaries?"

Flinn: "That's right. And now...and at that time I offered to you and

others that ...that might have been in the hearing of my voice at the time, that I was going to introduce legislation to do away with the maximum and minimums next year and get the Legislature out of the business of setting the salary limits or minimums."

Schlickman: "Well, Mr. Speaker, if I may address myself to the motion?" Speaker Matijevich: "One moment. Let's all give him attention. We are

now on the order of business...so we're not playing around anymore. The Gentleman, Elmer Conti, tells me if we waste any more time the Republicans will garner two more votes, so we better do this in a hurry. The Gentleman from Cook, Representative Schlickman."

Schlickman: "Mr. Speaker and Members of the House, I rise to oppose this motion on two counts. Number one, the Gentleman has not demonstrated that an emergency exists and has not demonstrated as to why we should give immediate consideration by suspending the rule. Number two, Mr.

Speaker and Members of the House, going to the merit of this Bill; the objection that had been made to the Bill previously and the one that the Governor has sustained, is that by this Bill we are simply mandating higher salaries for local governmental officials. I think the Gentleman is right that we should wait until next year and attack this in a rational fashion by eliminating minimums..particularly.. so that we don't impose upon local government's added costs, that we don't presume for them as to what salaries should be. So for those reasons I oppose this motion for immediate consideration of the Governor's veto."

Speaker Matijevich: "The Gentleman from Knox, Representative McMaster." McMaster: "Thank you, Mr. Speaker. If Representative Schlickman will listen. Representative Schlickman, I hope you're listening. I think you're overlooking the thrust of the Governor's Amendment -Number one. The only mandated thing about the Bill would have been the increase in minimums which the Governor struck out and which Representative Flinn is going along with this Amendment. In other words, we are not mandating any increases, Gene. Secondly, you questioned whether it was or was not of an emergency nature. It is for this reason; county boards are involved in making and adopting their budget for the oncoming fiscal year of theirs which starts December 1. If we do not take action it hangs them up waiting to see what we are going to do about these salaries. Therefore, it is in fact of an emergency nature to all county boards with the exception of Cook County within the State of Illinois. I do urge that we adopt this motion to discharge the rules and vote on this piece of legislation, this Amendatory Veto, today."

Speaker Matijevich: "The Gentleman from St. Clair, Representative Flinn, to close on the motion...to suspend the rule, Representative Flinn." Flinn: "Mr. Speaker, we've been talking on the Bill itself and think that's probably proper because we need to know what the Bill does. But what Representative McMaster says is true, it does not mandate anythins to the county board, it simply raises the maximum permitted for the county boards to vote for salary increases that puts the minimum back where it was...which was what Mr. Schlickman had objected to to start

with. He said he was for the Bill except for that purpose. Now, ...and Representative McMaster also is correct in talking about the necessity of it passing now. The question becomes moot if we don't act today and get it over in the Senate because the new county officers will be taking office before long and it will be four years before the county boards will be permitted to take any action. It..it does not and I repeat, it does not offer any mandate at all to the county boards. It is completely permissive and I would ask that my motion be passed."

Speaker Matijevich: "The Gentleman from St. Clair, Representative Flinn, has moved to suspend Rule 44.1 for the purpose of taking up the Governor's veto of House Bill 2256. All those in favor of voting for the motion vote 'aye', those opposed vote 'nay'. Takes 89 votes on the suspension. Have all voted....Have all voted who wish? On this motion...Take the record. On this motion there are 136 voting 'aye', 6 voting 'no', none 'present', and the motion carries and the rule is suspended. DiPrima 'aye'. On the Calendar we are now under Amendatory Vetoes, there appears House Bill 2256 and a motion to accept the Governor's specific recommendation for change by adoption of the Amendment to the motion. On that motion, the Gentleman from St. Clair, Representative Flinn."

Flinn: "Thank you, Mr. Speaker. Mr. Speaker and Ladies and Gentlemen of the House, this Bill is pretty well been explained already. I do move to accept the specific recommendation of the Governor as far as House Bill 2256 is concerned and if there are any questions I'll try to answer them."

Speaker Matijevich: "Is there any discussion? There being no discussion, there has been a motion to accept the Governor's specific recommendation. And the question is, shall the House accept the Governor's specific recommendation for change with respect to House Bill 2256 by adoption of the Amendment? All in favor will vote 'aye', all opposed will vote 'nay'. This requires 107 votes. 107 votes. Because of the effective date it takes 107. Have all voted? Have all voted who wish? The Clerk will take the record. On this issue there are 149 voting 'aye', 3 voting 'no', one voting 'present', and



this motion having received a constitutional three-fifths majority prevails and the House accepts the Governor's specific recommendations for change regarding House Bill 2256 by adoption of the Amendment.
