Borchers: "Mr. Speaker, fellow Members of the House. I
see I remember, I hope that's proper salutation and
all that, is it, Mr. Speaker? I haven't forgotten
the proper procedure?"

Speaker Redmond: "What was that, Sir? I didn't..."

Borchers: "I said, Mr. Speaker and fellow Members of the

House. Am I using...after several years am I

remembering the proper procedure?"

Speaker Redmond: "Whatever you do is correct, Weber."

Borchers: "Well thank you very much, Mr. Speaker. Coming from you that's a compliment. Mr. Speaker, I wish...

I move to discharge the Committee on Assignment and advance to Speaker's Table and suspend Rule 41(a) for immediate consideration of Resolution...House

Resolution #11."

Speaker Redmond: "Would you explain the Resolution, Representative Borchers?"

Borchers: "Yes. This Resolution, as you probably all are aware, at this time the tractor cavalcade from Illinois and the rest of the country is in West Virginia. And Representative Donovan and myself are Co Sponsors of this Resolution at the request of the American Agricultural Movement of Illinois.

Now it's strictly...we're only speaking in behalf of the American Agricultural Movement of our own state and none other. The reasons we feel...we support



this movement is because they are our Illinois Farmers, they're from our state. I don't know whether...a lot of policy of one sort or another is involved or not and I don't care. Frankly, all of my family are Farm Bureau members. I do not...and past leadership of the Farm Bureau in our area. I'm a past member myself of the Farm Bureau but the point to me is not because of policy, because I'm not sure there's any policy differences. I haven't heard anything from the Farm Bureau one way or the other or any other agricultural groups. I just know I feel it's our duty as a Legislator and a Legislature to defend and support the actions of our own farmers in going to Washington to try to get better policy... better prices for the grain that they raise. And we all know, in the farming areas, what a serious time we've had. Now, Mr. Speaker, do you want me to read this whole Resolution or not? Should I read it or not? Mr. Speaker, isn't there a copy on the desk...everyone...so far...this Resolution?"

Speaker Redmond: "The copies have been distributed, yes."

Borchers: "Am I to read it or not, Mr. Speaker? Mr. Speaker,

am I to read it or not?"

Speaker Redmond: "Representative Hanahan, for what purpose do you rise?"

Hanahan: "Mr. Speaker, I can't hear the Gentleman. He's talking too fast and there's too much noise there."

Speaker Redmond: "Okay, would you repeat your explanation,

Representative Borchers?"

Borchers: "I merely asked if I'm supposed to read the

Resolution, although you all have it on your desks

or are supposed to have it."

Speaker Redmond: "How long is it?"

Borchers: "One page and a small section of another."

Speaker Redmond: "Go ahead and read it."



Borchers: "May I ask if Mr. Donovan will read it because
I'm likely to lose my voice I see."

Speaker Redmond: "Okay."

Borchers: "Representative Donovan, would you read it?"

Speaker Redmond: "Representative Donovan, do you desire

to read the Resolution? Well Representative Borchers is a former Member and he's been returned to this chamber and he desires to have it read, so. Representative Kosinski, for what purpose do you rise?"

Kosinski: "Mr. Speaker, may I respectfully recommend that
you suggest to Representative Borchers that inasmuch
as we have this on our desk and have read it very
carefully and in toto that he merely put this to
a matter of vote."

Speaker Redmond: "I guess it is a little bit unusual. Maybe the first thing that you ought to do is...is the motion to suspend the rule. And you... Representative Borchers puts that motion and the question is on his motion to suspend the rule and it requires 107 votes. Representative Madigan."

"Mr. Speaker, I rise in opposition to the Madigan: Gentleman's motion. We are at the very beginning of this Legislative Session. We considered several of these motions yesterday to move to immediate consideration and the will of the Body was that at this early stage of the Session we ought to give credence to our Committee system. That matters at this point of the Session ought to be referred to Committee, considered by the Committees and then the considered judgement of the Committee be taken into account by the full body before we act upon any matters to be considered at this time. I, for one, do not see the emergency nature of the Gentleman's motion. Certainly this matter could be referred to Committee, considered by Committee next week and



reported out to othe floor for consideration next week and therefore, I rise in opposition to the Gentleman's motion."

Speaker Redmond: "Is there anything further? Representative Borchers."

Borchers: "The only thing I can say...I understand the position of

Representative Madigan on this but it just happens that in a sense we are in an emergency situation. This cavalcade of some 5,000 tractors are now approaching Washington. They're already in West Virginia and next week they will be there. This Resolution calls for sending a copy...giving a copy and they're carrying the copies with them to deliver if this House will give them a little support to our 24 Congressmen, our 2 Senators, the Speaker of the House of Representatives, the President Pro Tem of the Senate and the President of the United States. And they would like to use these an an entry to get into the necessary places of authority to try to help improve the lot of the farmers of Illinois and of course indirectly of the rest of the nation. But we should be concerned with our own people first. So I would like, if Representative Madigan would, I would ask him to withdraw his objection. Of course, if he won't he won't and that's it. But I do hate the loss of this time."

Speaker Redmond: "Any further discussion? Representative Darrow?"

Darrow: "Will the Sponsor yield?"

Speaker Redmond: "He will."

Darrow: "Representative Borchers, is the State Farm Bureau in favor of this Resolution or have they taken a stand?"

Borchers: "There is absolutely no stand that I know of by the Farm

Bureau against this Resolution. I never heard of any."

Darrow: "So if we vote against this Resolution it won't go into our rating?"

Borchers: "Pardon? I didn't hear that."

Darrow: "If we vote against your Resolution the Farm Bureau will not take that into consideration in rating us?"

Borchers: "I don't ... I don't know what the Farm Bureau will do,



whether they'll petition the Members of my own family and
we're not members of this group...of the...of the Resolution.
But I would say that considering what my own family thinks
they'll be...they're not for or against it. Rather they're for it
but they're not against it. I've heard nothing from the
Farm Bureau."

Darrow: "Thank you."

Ropp:

Speaker Redmond: "Representative Ropp."

"Mr. Speaker, Members of the House, I'd like to speak in regard to this Resolution in that down through the years agriculture has gone on its own rather well. However, in recent times we have faced many problems with increased inflation. Whenever the Federal Government has gotten into the problems of agriculture we find we end up in greater trouble than we many times were before we started. I had hoped that this Resolution would have stated something to the degree that if farmers and the Federal Government would become more involved in aggressively seeking international trade, particularly with mainland China now, where there are a billion people of new mouths to feed, that this would do certainly a great deal in assisting what the American Agriculture Movement is trying to ascertain. And in the Resolution, particularly on the back where it says, 'Illinois farmers feel strongly on this and the issue that thay are all planning a tractor march to Washington'. I think that's a little presumptious that a great many farmers are supporting the tractor move when in effect they are supporting the intent and not necessarily the tractor move and so I think that we...given this to Committee Assignment we could work on it and by Wednesday I'm sure they'll still be in Washington for a more effective vote to really be meaningful to them."

Speaker Redmond: "Representative Donovan."

Donovan: "Yes, Mr. Speaker. Mr. Speaker..."

Speaker Redmond: "Representative Donovan, proceed."

Donovan: "I ask that Representative Madigan withdraw his objection,



inasmuch that this is an emergency...as far as time is concerned only. We have to...this march is going on and will probably culminate within the next week or ten days and if this is going to have any effect I think it should probably be acted on as soon as possible, preferably today. So I ask Representative Madigan to withdraw his objection and just vote it up or down."

Speaker Redmond: "Representative Madigan is seeking recognition."

Madigan: "Mr. Speaker, Representative Donovan has explained the
emergency nature of the Resolution to me and we have determined
that this particular Committee will not meet, at least next
week and possibly the following week. And in light of all
that I withdraw my opposition to the motion."

Speaker Redmond: "Representative Leinenweber."

Leinenweber: "I wonder if I could ask the Sponsor of the Resolution a question?"

Speaker Redmond: . "You may. Proceed."

Leinenweber: "Representative Borchers, if we adopt this and the

Secretary of Agriculture does what the Resolution requests him

to do, what would the fiscal impact on the United States

Government be?"

Borchers: "What's...I didn't get that last question?"

Leinenweber: "What would be the fiscal impact on the United States

Government if, in response to this Resolution, the Secretary

of Agriculture does what we're asking him to do?"

Borchers: "I wouldn't be able to answer that question because the...

of the largess of our country and I have had no time to

make any examination into the fiscal...possible fiscal

responsibilities and events that might concur from it. I

wouldn't know."

Leinenweber: "Well, Mr. Speaker, briefly on whether we ought to bypass

Committee, we've all, one time or another, taken a position that

the Federal Government is spending too much money. In fact, this

House did adopt a Resolution calling on the Federal Government

to balance its budget. I think it would be rather presumptious



for us to pass a Resolution without having studied the fiscal impact on the United States Government. I think this is one question that certainly ought to be addressed in Committee and that's the purpose of a Committee hearing. I'm sorry Representative Madigan withdrew his objection. I would certainly object to a speedy adoption of this Resolution because we might have egg on our face, on one hand telling the Federal Government to eliminate a deficit and the second hand telling them to spend more money."

Speaker Redmond: "Are you ready for the motion? Representative Borchers, to close."

Borchers: "I would like to point out that what the fiscal policy is... what will effect the fiscal policy is not really of an importance here. The Federal Government is going to do as they darn please, as they always do and which we all know they do. The point is, we have Illinois' farmers going out of their way to try to do something to better the lot of the farmers and the price of farm products. Now China, without any question, is a great opening market that we will have presented and our farmers will take advantage of. I can see no reason why parody, for example, won't help in the maintaining of the cost and the profit to our farmers for the sale of grain to China. I see ... I see that it may well help. I cannot see how in any degree this Resolution will harm or hurt the Federal Government. All it will do is help attract attention to the farmer plight of not only the people... the farmers of Illinois but of the United States of America and gain them some publicity of their needs and possibly help them to make a greater sale of grain into China."

Speaker Redmond: "The question is on the Gentleman's motion... Representative Ackerman. Representative Borchers has already closed.

Wait until we call and then we'll call on you to explain your vote. The question is on the Gentleman's motion so suspend Rule 41(a) to permit immediate consideration of House Resolution 11. Those in favor vote' 'aye', opposed vote 'no'. Representative



Ackerman, to explain his vote. Representative Totten, you're distracting Representative Ackerman. Representative Ackerman, to explain his vote."

Ackerman: "Well, I sympathize with the American Agricultural Movement and their goal to improve the lot of the American farmer, I do not believe the majority of our Illinois farmers agree with the way they propose to accomplish this. Farmers historically have been as independent from government regulations as possible and I don't belive they are ready to accept the controls which would go along with the 90% parody guarantee which they are asking for. While commending them for bringing the problems of the farmer to the attention of the American public I must oppose this Resolution. I would hope they would turn their efforts toward supporting better markets and better exports free from the threat of embargoes. Thank you."

Speaker Redmond: "Have all voted who wish? Representative Steele."
Steele: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House.

I would urge more green lights in support of this timely Resolution. If we wait another week or two, frankly the very purpose of this Resolution is not going to be needed. Now, we in Illinois are the number one agricultural state in the nation. And these farmers are making a noble effort to be seen and to be heard and to have a cause that they think is very important be heard at Washington. And as the number one agricultural state I think that we should show our support for the cause of the farmer. If you've seen them as I have traveling day after day and week after week in the cold, the subzero weather that we've been seeing, if you've seen them camping out and going through some of the hardships that are involved, I think that they feel very strongly that they have a cause that needs to be heard. As the number one agricultural state I think it's timely and I think it's appropriate that we, as Illinois, show that support and give them the votes that they need to pass this Resolution. I urge more green lights there. We do need 107 to make this effective today and I urge your support."



Speaker Redmond: "Representative Borchers, to explain his vote."

Borchers: "I ask for this last opportunity to have those lights changed to green because I feel deeply that we have an obligation to support our farmers. It isn't a matter necessarily whether you agree or disagree with all the policies involved of this group or that group or the other or what you feel.

These people are our own people, our own farmers. They're feeding us and I think from a matter of loyalty we should give them what encouragement we can to help their cause when they go to Washington. It's a matter of our duty to do these things and that's why I feel that you change any red vote to a green vote. Thank you."

Speaker Redmond: "Have all voted who wish? Have all voted who wish?

Representative Robbins. Representative Mahar, will you please sit down?"

Movement. I strongly back the Farm Bureau and everything...and most of the things that they agree with. I think that we should support everyone's right to have a fair price for their commodities. I do not believe that the Government should do it. I think, and I am very proud to see that the vote has reached above the number needed to pass the Resolution because the farmers are the backbone of Illinois and they need the support of all of the people of Illinois. Thank you."

Speaker Redmond: "Have all voted who wish? The Clerk will take the record. On this question there's 112 'aye' and 24 'no' and the motion carries. On the Resolution... Representative Borchers, on the adoption of the Resolution. You prevailed on your motion for immediate consideration."

Borchers: "I didn't hear."

Speaker Redmond: "I say, the motion for immediate consideration prevailed, now the question is on the adoption of the Resolution."

Borchers: "I move the adoption of the Resolution."

Speaker Redmond: "Is there any discussion? On this question...we'll take a voice Roll Call. Those in favor say 'aye', opposed 'no'.



In the opinion of the Chair the 'ayes' have it, the motion carries and the Resolution is adopted. Representative Katz."

Katz:

"Mr. Speaker, I hope that the Members of the House will listen very carefully to what I am about to say. We will be adopting House Rules soon, we hope very early so that we will be able to get the handbook printed. Thursday of next week, at nine a.m. starting here on the House floor, the House Rules Committee will be meeting for the purpose of hearing any suggestion that any Member has for any change in any rule of the House. any Member feels that there is some way that the rules ought to be improved, Thursday of next week, starting at nine a.m. is the time for them to be here on the House floor. They will each be receiving a letter from the Speaker. However, we wanted to make this announcement so that the Members can start preparing for any statement that they would like to make next week. The Clerk has distributed to each Member of the House a copy of the present temporary rules that govern us. So if you want to prepare a statement for next week, this is to remind you to take home with you from your office here the House rules, if you would like to have them. The statement that the Member needs to make next week does not have to be technical in nature. It does not have to be lengthy. But next Thursday morning is likely to be the only time that Members will have an opportunity before the Rules Committee to present their pet projects for changes in the House rules. And so we of the Rules Committee and speaking for the Speaker, urge and solicit any observation, comments, suggestions, for changes in the House rules next Thursday morning here on the House floor will be the place where those can be given. Now so there is no misunderstanding, that is not a meeting of the House, it is a meeting of the House Rules Committee. So the Members can be here next Thursday, any Member that wants to present a statement will have an opportunity to be heard. We encourage all of you with suggestions to bring them here next Thursday morning on the House floor."
