Schlickman: "We have in Article XII, I think of Section 10 of the Constitution the Intergovernmental Corporation Section, ample authority for units of local government to work with one another such as you suggest here. Why the need for this Bill?"

Skinner: "Because of village attorney says that there is some hangoup. That either the township road commissioners' lawyer doesn't think that...that Section of the Constitution is fully implemented or else the Department of Transportation doesn't think it is fully implemented. I agree with you, that was my initial reaction and the legal beagles in your fraternity have...someone has convinced the village fathers that they can't get it done without this stupid

Schlickman: "Well let me ask one further question. If you were going to authorize a highway commissioner of a road district to provide the service wouldn't you also then

have to authorize a municipality to secure the service?"

Skinner: "I hope not. Fervently, I hope not."

Schlickman: "Well for your sake and Bull Valley, I would hope so too."

Speaker Redmond: "Any further discussion? The question is, shall this Bill pass? Those in favor vote 'aye', opposed vote 'no'. Have all voted who wish? Have all voted who wish? The Clerk will take the record. On this question there's a 138 'aye' and no 'nay' and the Bill having



received a Constitution Majority is hereby declared passed. 252, Representative Conti."

Clerk O'Brien: "House Bill 252...."

Speaker Redmond: "Representative Polk on the floor? Polk. 309, take that one out of the record. 309, Representative

Clerk O'Brien: "House Bill 309,....309 Chalk. A Bill for an

Act to amend Sections of the Illinois Highway Code. Third

Reading of the Bill."

Speaker Redmond: "Representative Williams."

Williams: "Thank you, Mr. Speaker and Members of the House. This is much the same I suppose as Representative Skinner's Bill. What the intent of this is in areas where a township and a municipality would have a common street statutory. ... let's see, authority of the highway commissioner to expend. the funds in coporation with the municipality to do a complete....the highway improvement program. And that would include the resurfacing a curb and gutter and sidewalks. This Bill has the complete endorsement, in fact, it was really sponsored at the request of the township officals of ... with Illinois and I have a letter here saying that they will support it and it really would have been put on the Consent Calendar but there was the Amendment to insure that it would include a complete improvement program. I would ask... I support an 'aye' on this Bill."

Speaker Redmond: "Any discussion? Representative Winchester."
Winchester: "Thank you, Mr. Speaker. As the Sponsor of the
legislation said, it did come out of the Transportation
Committee on a 16 'yea' vote, one 'nay' vote. There was
a problem with the Bill but he did accept an Amendment
that was offered by the Department of Transportation....
as amended now. The Bill is a good Bill and I would
ask for support of House Bill 309."

Speaker Redmond: "Is there any further discussion? The question



is, shall this Bill pass? Those in favor vote 'aye', opposed vote 'no'. Have all voted who wish? Have all voted who wish? The Clerk will take the record. On this question there's 144 'aye' and 1 'no' and the Bill having received the Constitution Majority is hereby declared passed. 342, Representative Yourell."

Clerk O'Brien: "House Bill 342..."

Speaker Redmond: "Representative Yourell, out of the record.

Do you seek recognition, Representative Yourell on another matter?"

Yourell: "Yes, Mr. Speaker. Thank you, Mr. Speaker, Ladies and Gentlemen of the House, I would like to take a moment of the House's time to introduce to you two outstanding young people from the State of Illinois who have won the Junior Citizen award for 1978 and 1979, representing ten thousand participating students. This Junior Citizens program has been sponsored by Palas Bank and Trust and the originator of the program is Miss Sandie Dorgan. And I would like to introduce to you, in the press gallery on the Democratic side, Miss Junior Citizen of 1978 and 1979, Mary Lesnefsky. Mary would you stand up. And Mr. Junior Citizen, Gus Tie. Gus would you stand up. Thank you very much."

Speaker Redmond: "On the Order of Motions appears a motion with respect to House Resolution 89. Representative Winchester is recognized. House Resolution 89, Representative Winchester."

Winchester: "Thank you, Mr. Speaker. I move to suspend the appropriate rule for immediately consideration of House Resolution 89. Alright. House Resolution 89 would intrust the Department of Agriculture to take care of a problem that we are having in two or three legislative districts in the southern part of the state. About seven months ago there was a grain elevator bankruptcy in Gallatin County and there was a 6.5 million dollar loss. This was



the largest loss of any bankruptcy in the State of Illinois involving grain elevators. There is two hundred and eighty-six claimants and there is only one hundred thousand dollars to be divided up among two hundred and eighty-six That one hundred thousand dollars is a bond claimants. that was being....that was required to be posted in order to get licenses by that grain elevator. Now the Department of Agriculture is saying to these two hundred and eightysix claimants that they have to come to Springfield for a hearing. And there are at least ten attorneys that are involved and maybe more. Alright, now they are going to be charging fifty dollars an hour and it's a four-hour drive up here and a four-hour drive back at fifty dollars an hour and then many of them are going to be required to stay overnight in Springfield, many of these folks are older folks in their seventies and we want the hearing in southern Illinois to make a long story short. Now agriculture is taking a hard nose position against this saying that, it would cost ... the cost would be prohibitive. We're talking about three hearing officers and one...one clerk, one secretary and the files. It could be done in the court house in Gallatin County and I might add that if these people receive any money back from their loss, it's going to be pennies on the dollar. And they are going to turn around and pay this in the expenses of the attorneys. And, by the way, the attorneys are the ones who are calling me and asking if we can't do something. So by adopting this Resolution we're in essence telling the Department of Agriculture to go to southern Illinois and conduct the hearings there. I would appreciate the adoption."

Speaker Redmond: "Representative Skinner."

Skinner: "Mr. Speaker, I stand in support of this Resolution.

It is so obviously the right thing to do that the government bureaucrat should go to the people who are in need of the services that we shouldn't have to pass a Resolution.



But I know that we have to because the Department of Agriculture forced DeKalb, Boone, McHenry and Kane County farmers to come all the way to Springfield in the grain bankruptcy to get their pittance of the hundred thousand dollar bond. I don't know whether this is going to do any good or not because beating on the Executive Branch is like....talking into a hurricane usually, but it might help."

Speaker Redmond: "Representative Rea."

"Is it on? Now it's on. Thank you, Mr. Speaker and Members of the House, we have attempted to solve this problem without bringing it before the General Assembly. We have talked to the Director of Agriculture and have also asked the Governor to intervene on our behalf to bring the hearings to southern Illinois where it affects many people that would, as Representative Winchester indicated, have to travel four hours one-way...traveling over two hunred miles and only receiving pennies on a dollar of investment that they have lost through the grain elevator bankruptcy. I certainly would like to encourage everybody to vote for this Resolution and our attempt to get the hearings held in the area and the total cost would be much less than it would by conducting it here in Springfield and would certainly save the people of that area, not only inconvenience but considerable money. I would ask that you all vote 'aye'."

Speaker Redmond: "Anything further? The question....Representative

Conti: "Mr. Speaker and Ladies and Gentlemen of the House, I move the previous question."

Speaker Redmond: "The Gentleman has moved the previous question.

The question is on the Gentleman's motion for immediate suspension of the rules of immediate consideration of House Resolution 89. Is there any objection to....?

Hearing no objection....hearing no objection we will use



the Attendance Roll Call on the suspension of the rules.

Now on the motion...on the adoption of the Resolution, yeah.

Representative Winchester."

Winchester: "I would now move that we adopt the Resolution, Mr. Speaker."

Speaker Redmond: "The question is on the Gentleman's motion for the adoption of House Resolution 89. Those in favor vote 'aye', opposed vote 'no'. Have all voted who wish?

Representative Ewing for what purpose do you arise?"

Ewing: "Mr. Speaker, to explain my vote. This is a blatant anti-

lawyer Bill and I would suggest we all vote green."

Speaker Redmond: "Have all voted who wish? The Clerk will take the record. On this question there's 141 'aye' and no 'nays', the Bill....the Resolution having....the motion having received the Constitution Majority is hereby declared adopted. Death Resolution. Death Resolution, yeah. You have one I guess. Representative Friedrich.

Clerk O'Brien: "House Resolution 91, Ralph Dunn. Respect to
the memory of Dr. Jack F. Isakoff, former research director
for the Illinois....Isakoff, former research director of
the Illinois Legislative Council."

Speaker Redmond: "Representative Friedrich."

Friedrich: "Mr. Speaker, a number of the Members of this Body have had the privilege of knowing and working with Jack Isakoff over a long period of time. He was at one time... he has been a teacher of government at SIU, he took some time off and came up here and was on the....advisor for the Executive Article Committee which John Leon and Harlan Rigney and I served. He was also head of the Legislative Council here for years and to me he was one of the most dedicated people that ever served in state government. He was a great asset both to the state and to the Constitutional Convention and I'm sure that you all share with me



his loss."

Speaker Redmond: "Representative Dunn. Representative Ralph
Dunn."

Dunn: "Thank you, Mr. Speaker. I too was a friend of Jack
Isakoff, he and myself, Representative Rigney and Representative Birchler and Senator Buzbee are the Legislators
from my district. We are going to miss Jack Isakoff, he
was a friend of all of us, a fine, gentle, man and he's had
a long suffering spell and certainly we're all going to
miss him. I would like to ask that the names of all the
Members of the House be added to the Death Resolution and
I would like to move its passage."

Speaker Redmond: "The question is on the Gentleman's motion for the adoption of House Resolution 91. Those in favor say 'aye', opposed 'no'. The 'ayes' have it and the motion carried, Resolution is adopted. Representative J.J. Wolf."

Wolf, J.J.: "Well, Mr. Speaker and Members of the House, I certainly concur with the Resolution for Mr. Isakoff, who I knew as well as many others. But I would like to at this time, Mr. Speaker, make this point. In the future I don't think it's proper that somebody gets up and asks that the names of all Members be added, it puts some of those who might not want to be added to a particular Resolution in a very embarrassing position. And I would hope, Mr.

Speaker, that that would not be a practice of this House."

Speaker Redmond: "Thank you. Announcements, don't be mislead we have some business that we have to pass. Have to pass House Bill 136, the fact that we're going to the order of announcements doesn't mean that we're winding down, there is an Amendment that 186 that hasn't yet been presented. Announcements, Representative Williams.

Williams: "Yes, thank you, Mr. Speaker, Members of the House.

I would move to suspend, I think Rule 18 which is the

posting notice for six Bills to be heard in the Cities

and Villages....Tuesday at 2:00. Actually the notice that



we had today says that we are running behind and if we don't have a meeting next week, that means that we're really going to be jammed up you know, on the 20th. So if we could suspend the posting notice, the six and a half day notice, so that House Bill 17, 40, 7, 5, 27, 555, 556 and 674 be posting for a hearing of the Cities and Villages at 2 P.M. on March 13, in room 304. This has been checked with the Minority Leader and with Minority Spokesman and with the Majority Leader."

Speaker Redmond: "The Gentleman has moved to suspend the Posting Rules. Is there any objection? Hearing no objection, we will use the Attendance Roll Call. You don't have the number of the Bills? You have the numbers. Any other announcements? Agreed Resolutions."

Clerk O'Brien: "House Resolution 85, Madigan-Beatty-Kucharski. 86, Kelly. 87, Kelly. 88, Kelly. 92, Gaines. 93,

Slape. 94, Van Duyne. 95, Van Duyne. 96, Van Duyne.

98, Kelly."

Speaker Redmond: "Representative Giorgi."

Giorgi: "I didn't get a copy of Kucharski Resolution. I think
95 and 96 are alike are they not? 95 and 96?"

Clerk O'Brien: "Yeah, they're the same Resolution."

Giorgi: "Madigan's 85 honors Dr. Redmond for 50 years of scouting.

86 by Kelly, notes the silver wedding anniversary. 87

by Kelly, a 50th anniversary. 88 by Kelly, talks about
the Temple B'nai Yehuda of Homewood. 92....35th anniversary,
you want to read it. 92 by Gaines, talks about John
Hope Franklin celebration. 93 by Slape, talks about the

President-elect of the Association of schools and Van Duyne honors Bob Whitley for his victory in class wrestling championship and 95 honors Mark Ruettiger and I move for the adoption of the Agreed Resolution except for Kucharski."

Speaker Redmond: Is there any questions? The question is on the Gentleman's motion for the adoption of the Agreed Resolutions.

Those in favor say 'aye', opposed 'no'. The 'ayes' have



it and the motion carried and the Agreed Resolutions are adopted. Further Resolutions."

Clerk O'Brien: "House Resolution 90, Greiman-Telcser. 97,
Friedrich. House Joint Resolution 16, Meyer-McClainRyan-Flinn. House Joint Resolution 17, Meyer. House
Joint Resolution 19, Bradley."

Speaker Redmond: "Committee on Assignments."

Clerk O'Brien: "House Joint Resolution 11 and House Resolution 81, Ebbesen."

Speaker Redmond: "Speaker's Table. Representative Ryan." Ryan: "Well, thank you, Mr. Speaker and Ladies and Gentlemen of the House. I would like if I may, to take a few brief moments to acknowledge the outstanding legislative service that has been given to the people of Illinois by one our Republican colleagues who is today serving his last day as an official Member of this Body. At midnight tonight he becomes the chief liaison for the Governor's Office and I would like to say a few words about him if I may. I think that we are fortunate that this dedicated Member has not chosen to leave the field of public service entirely. That he's moving instead to a position that will enhance his ability to shape the legislative process and to work toward realizing the standards of good government to which he and all of us are dedicated and even you, Mr. Speaker, are dedicated too. I said something nice about you, Bill."

Speaker Redmond: "Please repeat."

Ryan: "Well I would like to extend to our colleague best wishes and good luck, our colleague, Jim Edgar, and a lot of success in his new position. He's going into a tough job, he's going to have to come back and work with most of us, hopefully all of us and I look forward to that and to you, Mr. Edgar, I would like to extend my best wishes and congratuations. I guess maybe sympathy, but Jim is going to be gone after midnight tonight and going to leave a big vacancy over here on this side of the aisle.



I just wanted to bring that out to the Members that didn't know it."

Speaker Redmond: "I've just been advised by the Parliamentarian that he and Jim Edgar were interns together. I would like to have some little observation, I know that I'm not supposed to do it from up here but Ryan and Walsh are always so generous in letting me run all over the landscape. The Republican side can ill afford to lose men like Jim Edgar...but seriously, Jim Edgar was probably one of the reasons that I took the strong stand that I did with the legislative pay raise because I felt that it would be a terrible thing if men like him were unable to serve in the General Assembly. I felt it at that time and I feel it now, we're going to miss you, you and I had a little beginning here that you've forgotten but I haven't. But good luck to you. Thank you very much for all you have done. Representative Campbell."

Campbell: "Well, Mr. Speaker and Ladies and Gentlemen of the House. As a friend and as my running mate in the 53rd District this is certainly going to be a great loss to the 53rd District and I think a great loss to this Body as well. But I certainly sure along with the rest of you, I wish Jim the best of luck and God speed in his new job ahead. Thank you."

Speaker Redmond: "House Bill, Second Reading. House Bill 186.

Representative Edgar, do you want.....Representative

Edgar."

Edgar: "Thank you very much, Mr. Speaker. I do well remember what you were referring too. I...you know, the last few days I've been thinking about what would I say. I'm surprised, you know....you know someday you're leave the House, sometime you leave earlier than you want to leave. It's a little shorter than I had planned though longer than many of my constituents really wanted me to stay here. I'm going to miss this Body, I've enjoyed it very



much the last ten years working in the legislative process. I do look forward to working with the legislature in the future, I hope the people will realize that our offices are located on the second and half floor that's hopefully more than a symbolic place to put the legislative liaison office. I think that means that we will try to meet you more than halfway. I wish I had a tape of George's comments because it's probably going to be the last thing nice that he says about me for a while ... and the Speaker. That I've enjoyed it here and I look forward to working with you in the coming months to try to do what is best for the state and to provide the kind of government that people have elected both branches to provide. Again, thank you very much for all your help and courtesy and we'll be around to talk to you in the future. Thank you very much."

Speaker Redmond: "Representative Stuffle."

Stuffle: "Yes, Mr. Speaker and Members. Jim Edgar and I have

served one term together and more or less grew up in the same pattern together and served in the same offices, worked with the legislature and I want this Pody to know that as a Democrat from that district, the only one, they only give us one out of the four Legislators. Jim and I and Chuck Campbell have been able to work together in the 53rd District in this last term and even before we were Members and I want to wish him well as does Chuck and every Member of the General Assembly because he will do an excellent job continuing his work for the Governor of Illinois. I wish him well and hope that he will see fit to come and see us on the Democratic side of the aisle and ask for our support as well as the Republican side."

Speaker Redmond: "Representative Kane."

Kane: "Representative Edgar, having served in both slots at one time or another having been on two and a half and on two,

I just want to say, it's better here than there."



Speaker Redmond: "House Bills, Third Reading. House Bill,

Third Reading appears House Bill 186. Representative

Chapman is recognized."

Chapman: "Mr. Speaker and Members of the House, I ask leave
to return House Bill 186 to the Order of Second Reading
for the purpose of further Amendments."

Speaker Madigan: "The Lady requests leave to take this Bill back to the Order of Second Reading for purpose of an Amendment. Is there leave? Leave being granted the Bill shall be placed on the Order of Second Reading."

Clerk O'Brien: "Floor Amendment #3, Kempiners. Amends House

Bill 186 as amended on page 1, and first line by changing Section 6 and 7...."

Speaker Madigan: "Mr. Kempiners."

Rempiners: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. This is the supplemental appropriation for the Department of Children and Family Services and the reason that these Amendments are being offered is that I believe a compromise has been worked out between the Sponsor and the Department and the Leaders on this side of the aisle. Amendment #3 which I offer, provides for a transfer of nine hundred and thirty-five thousand dollars among various line items from certain operation line items into certain personal services and contractual services line items within the department to respond to the concern that Representative Chapman had regarding the use of the supplemental appropriation funds for vacant slots not dealing with child abuse as well as the contract with the employees of the department. This money will be used to respond to those needs and I would move for its adoption."

Speaker Redmond: "Is there any further discussion? Mrs.
Chapman."

Chapman: "Mr. Speaker and Members of the House, I had asked the department and I'd asked the administration to respond



to my concern that the 5.1 million dollars requested would be used for child abuse. My concern was based on the fact that the department had told us that the cost of the collective bargaining agreement would be 1.3 million dollars. And that they would not be able to provide the number of positions that this Legislature had indicated they would fund. I'm happy to say that the administration has responded and Amendment 3 offered by Mr. Kempiners provides just under a million dollars in transfers in order to provide sufficient dollars to fund the collective bargaining agreement in order to respond to the need that....it appeared to me this department would have to request a deficiency appropriation. I welcome this openness and candor on the part of the administration and hope that you will all vote 'yes' on Amendment #3."

Speaker Madigan: "Is there any further discussion? There being no further discussion, the question is, shall Amendment #3 be adopted. All those in favor signify by saying 'aye', all those opposed by saying 'no'. The 'ayes' have it the Amendment is adopted. Are there further Amendments?"

Clark O'Brien. "Floor Amendment #4, Chapman. Amends House
Bill 186....."

Speaker Madigan: "Mrs. Chapman."

Chapman: "Mr. Speaker, under Amendment #4, no longer is there a requirement that funds be earmarked for child abuse.

In my view there is no longer a need to require this.

It has been pointed out that the Legislature sometimes can move very rapidly on certain issues, but on others it takes a long time. It's clear to me that this matter of responding effectively to child abuse claims...is a matter of high priority for state government. And the Legislature clearly agrees with this assessment. The Bill, I believe, is in shape now where it can pass speedily in the House and the Senate and should be able to land on the Governor's desk for his signature next week. I ho



that....as soon as we adopt Amendment #4 we will be able to move to Third Reading and send this Bill to the Senate today. I ask for your approval."

Speaker Madigan: "Is there any further discussion? Mr. Kempiners."

Kempiners: "Thank you, Mr. Speaker. Amendment #4 does what we

on this side of the aisle have been attempting to do for

four months and I would urge your support for Amendment

#4."

Speaker Madigan: "Is there any further discussion? There being no further discussion, the question is, shall Amendment #4 be adopted. All those in favor signify by saying 'aye', all those opposedsay 'no'. In the opinion of the Chair the 'ayes' have it. The Amendment is adopted.

Clerk O'Brien: "No further Amendments."

Are there further Amendments?"

Speaker Madigan: "Third Reading. Mr. Clerk, who is the Sponsor of the Bill?"

Clerk O'Brien: "Read the Bill a third time."

Speaker Madigan: "Read the Bill the third time. Who is the Sponsor?"

Clerk O'Brien: "Representative Chapmar. House Bill 186, a
Bill for an Act to amend Sections of an Act to provide
for the ordinary and contingent expense of the Commission
on Delinquency Prevention in the Department of Children

Speaker Madigan: "Mrs. Chapman, do you wish to suspend Rule

and Family Services. Third Reading of the Bill."

35 (c) to hear this Bill immediately?"

Chapman: "I do so move, Mr. Speaker."

Chapman."

Speaker Madigan: "The Lady moves to suspend the provisions of Rule 35 (c) to hear this Bill immediately. Is there any objection? Is there leave? Leave is granted. Mrs.

Chapman: "Mr. Speaker, House Bill 186 appropriates 5.1 million dollars to the Department of Children and Family Services.

The intent of the department is to use these dollars to



employ three hundred new child abuse caseworkers and to provide considerable dollars in contractual funds for private agencies in providing support of services to deal with child abuse. It also includes just under a million dollars in transfers to personnel services. I'm happy in closing to welcome on the floor the new director of the Department of Children and Family Services, Director Greg Coler, who is standing next to Mr. Kempiners. And to urge you all to vote 'yes' for this Bill, which shows the high priority this Body gives to children and their needs and particularly to child abuse programs and services."

Speaker Madigan: "The Lady moves that this Bill pass. Is there any further discussion? Mr. Kempiners."

Kempiners: "I would also ask your support for this legislation.

Speaker Madigan: "The question is, shall this Bill pass? All those in favor signify by voting 'aye', all those opposed by voting 'no'. Have all voted who wish? Have all voted who wish? Have all voted who wish? The Clerk shall take the record. On this question there are 155 'ayes', no 'nays', no voting 'present' and this Bill having received a Constitutional Majority is hereby declared passed.
