

Doorkeeper: "Attention, Members of the House of Representatives, the House will convene in five minutes. All persons not entitled to the House floor, please retire to the gallery."

Speaker Redmond: "House will come to order. Members, please be in their seats. Be led in prayer by Reverend Krueger, the House Chaplain."

Reverend Krueger: "In the Name of the Father, the Son and the Holy Ghost, Amen. O Lord, bless this House to Thy service this day. Amen. Andre Gide wrote: 'Man cannot discover new oceans unless he has courage to lose sight of the shore'. Let us pray. Almighty Father, to Whom we give our heartfelt thanks for the many and great blessings which have been given to us of Thy loving kindness; we pray Thee this day that we ever may make only such use of them that is well pleasing to Thee. Provide us, O Lord, with the courage and leadership as we labor in this House of Representatives for the State of Illinois; to be fearless in forging new and better ways of meeting the needs of the people whom we are dedicated and elected to serve. Let no cause be too distant for us to foresee; too obscure for us to discern; or too vast for us to comprehend. That, thusly armed, we may be ever effectual in all our given and called-for responsibilities; through Jesus Christ our Lord."

Speaker Redmond: "Roll Call for attendance. Committee reports."

Clerk O'Brien: "Representatives... Representative Capparelli, Chairman of the Committee on Executive, to which the following Bills were referred; action taken March 8, 1979, reporting the same back with the following recommendation: do pass House Bill 21 and 327, do pass as amended House Bill 383, be adopted House Joint Resolution 9, tabled in Committee House Bill 497. Representative Kane and Mugalian, Co-chairman from the



Committee on State Government Organization to which the following Executive Order was referred; action taken March 8, 1979 and reported the same back with the following recommendation: do not disapprove Governor's Executive Order #1. Representative Kane and Mulgalian, Co-chairman of the Committee on State Government Organization to which the following Bill was referred; action taken March 8, 1979, reported the same back with the following recommendation: do pass as amended House Bill 455."

Speaker Redmond: "Representative Madigan, are there any Democrats whose absence should be excused? Representative Walsh, please pay attention. Representative Madigan."

Madigan: "Mr. Speaker, I don't know of any Democrats who have requested an excused absence. But I instructed all of them to call Representative Walsh's office so maybe you had better consult with him."

Speaker Redmond: "Representative Walsh, do you have any Democrats whose absence should be excused?"

Walsh: "There's a lot of them that would like to be..."

Speaker Redmond: "Representative Madigan."

Madigan: "Mr. Speaker, would Mr. Walsh tell us if he has a different set of criteria for Democrats from outside the City of Chicago as opposed to those who live in the City of Chicago?"

Speaker Redmond: "Representative Walsh."

Walsh: "I have the same criteria for Democrats in the City of Chicago, outside of the City of Chicago and Republicans everywhere."

Speaker Redmond: "My spies tell me that there are Democrats in your family, is that right? The (doddles) and some of the others."

Walsh: "Ex-Democrats."

Speaker Redmond: "The Walsh family were Democrats until they



collected the insurance and moved to the suburb. Is that right?"

Walsh: "They became enlightened, Mr. Speaker, as other Irish have."

Speaker Redmond: "Cousin Jane is a Democrat. How about the one that was the president of Notre Dame, what was he?"

Walsh: "He was a good Republican, Mr. Speaker."

Speaker Redmond: "Introduction, First Reading."

Clerk O'Brien: "House Bill 844, Campbell. A Bill for an Act to amend Sections of the Illinois Pension Code. First Reading of the Bill. House Bill 845, Huff. A Bill for an Act making an appropriation to the Chicago Community School Study Commission. First Reading of the Bill. House Bill 846, Schraeder. A Bill for an Act relating to changes in the salary of judges, Members of the General Assembly and elected and appointed Members of the Executive Branch. First Reading of the Bill. House Bill 847, C.M. Stiehl. A Bill for an Act to amend Sections of the Southwest Regional Port District Act. First Reading of the Bill. House Bill 848, Schneider. A Bill for an Act to amend Sections of an Act to require protective coverings or fencing on or about dangerous excavations. First Reading of the Bill. House Bill 848, Birchler. A Bill for an Act to amend Sections of an Act concerning public utilities. First Reading of the Bill. House Bill 849, Lechowicz. A Bill for an Act to amend Sections in the title of an Act requiring that certain types of Bills introduced in the General Assembly have provided a note indicating the fiscal effect thereof on state finances. First Reading of the Bill. House Bill 850, Lechowicz. A Bill for an Act relating to state mandating of local government expenditures, services standards, employment conditions and retirement benefits. First Reading of the Bill."

Speaker Redmond: "Representative Ryan, are there any



Republicans whose absence should be excused?"

Ryan: "Yes, Mr. Speaker, I have two. Representatives Peters and Representative Capuzi and both due to illness. I believe they're both in the hospital. I'd also like to make an announcement, unless you want me to hold it."

Speaker Redmond: "Proceed."

Ryan: "I have a couple...first is that one of our colleagues, Representative Tim Simms, is the proud new father of a baby girl named Andrea Elizabeth. His wife had a pretty tough time and I guess...it was alright. I told him I'd tell him what causes that if he'd talk to me. Mr. Speaker and Ladies and Gentlemen of the House, as I told you last Thursday, Representative Edgar resigned from the Illinois House to accept a position, more or less responsibility involved I'm not sure, with the Thompson administration. Mr. Speaker, could we have a little attention here so I could make this announcement? I just need a..."

Speaker Redmond: "Please give the Gentleman order."

Ryan: "I'd like to take a brief moment of everybody's time here to introduce the man that's going to fill that vacancy and our newest colleague. Harry Woodyard yesterday was sworn in to represent the 53rd district in the 81st General Assembly. Although Harry is a newcomer to this floor, he is definitely no newcomer to public service. He currently farms over 1200 acres in Edgar County and in the past he has served for 18 years as a Republican Precinct Committeeman. He's served as Republican County Chairman from 1964 to 1970 and has served on the County Board again from 1972 to 1976. He presently serves on the Danville Junior College Board and the Paris Community Hospital. Throughout his career in public service, Harry has distinguished himself as a dedicated and exceptionally able public official. He comes to Springfield as a man that has been representing his area in the county level



for many years. Now he'll join his fellow district lawmakers, Representatives Chuck Campbell, Larry Stuffle and Senator Max Coffey in representing those residents on a statewide level. I hope that you will join me in formally welcoming to the Illinois House, our newest colleague, Harry 'Babe' Woodyard, right here. And I would defer to Representative Campbell at this time. Campbell."

Speaker Redmond: "Representative Campbell."

Campbell: "Mr. Speaker and Ladies and Gentlemen of the House, I, too, want to welcome Babe Woodyard. Most of you will learn to know him as 'Babe', which everyone does. He's been one of my county chairman for a number of years and you will find him very cooperative, very capable and a very energetic individual. And I am sure all of you will learn to love this guy after he's been around this House for a long time as I do. Thank you very much."

Speaker Redmond: "Representative Stuffle."

Stuffle: "Yes, Mr. Speaker, just briefly, I can agree completely with what Representatives Ryan and Campbell said. I've worked with Harry Woodyard, 'Babe' Woodyard, as I know him in the district. He doesn't work on a partisan basis. He's worked for people there, he's worked with me as a Democrat and I'm sure he'll work well here on the House floor and work well for our constituents in the 53rd district."

Speaker Redmond: "Representative Woodyard."

Woodyard: "Thank you very much. I'm very proud to be a Member of this Assembly."

Speaker Redmond: "You keep you speeches at that length and you'll be a great favorite. Representative Collins, do you have any predictions about what's liable to happen in the next week? Representative Bradley."



Representative Collins."

Collins: "Yes, Mr. Speaker, I conferred with Representative Leinenweber and we predict that the finals will be Notre Dame against DePaul."

Speaker Redmond: "There's one flaw in that. Senate Bills, First Reading."

Clerk O'Brien: "Senate Bill 90, Representative Rigney. A Bill for an Act making an appropriation to the Illinois Department of Conservation. First Reading of the Bill."

Speaker Redmond: "House Bills, Third Reading. House Bills, Third Reading, appears House Bill 176. Representative Deuster is recognized."

Clerk O'Brien: "House Bill, 176. A Bill for an Act to amend Sections of the Probate Act. Third Reading of the Bill."

Speaker Redmond: "Representative Deuster."

Deuster: "Mr. Speaker, I would ask leave to take House Bill 176...I would ask leave to take House Bill 176 back to the Order of Second Reading for the purpose of one Amendment which has been filed and distributed as Amendment #2. The only...the Amendment puts an effective date in the Act. So at this time I would ask leave to take House Bill 176 back to Second Reading?"

Speaker Redmond: "Does the Gentleman have leave? Hearing no objection, House Bill 176 is to be returned to the Order of Second Reading. Is there an Amendment, Mr. Clerk?"

Clerk O'Brien: "Amendment #2, Deuster, amends House Bill 176 on page 3 by adding after line 29 the following: 'Section 2, this Act shall take effect January 1, 1980.'"

Speaker Redmond: "Representative Getty, for what purpose do you rise?"

Getty: "Well, Mr. Speaker, I'd ask the Chair if that wouldn't be the effective date under the law as it is now anyway? Under the Uniform Effective Date Act?"

Speaker Redmond: "Representative Deuster is recognized...on



the Amendment, Representative Deuster. Well, let him move the adoption and then the Parliamentarian will give us the...well, Representative Getty."

Getty: "Mr. Speaker, it would just seem that if that would be the effect of the law without saying that that the Amendment..."

Speaker Redmond: "I wish the Democratic side would look over to the Republican counterparts and see how well ordered they are and how well behaved and they're sitting in their seats and maybe the Democrats would do the same thing. I can't hear a thing here. Please, come to order."

Getty: "It would appear that possibly that is not what Representative Deuster wants to do by the Amendment because all this Amendment would do would make the Act effective on the date that it would effective under the Uniform Effective Date Act anyway and I would suggest he might have some other intent."

Deuster: "Mr. Speaker, I think it would be best to take this out of the record. Representative Getty has a raised a question that I'd like to resolve before we go further. Thank you."

Speaker Redmond: "Take it out of the record then. Yeah, we'll hold it on Second Reading. House Bills, Second Reading. House Bill 13, has a fiscal note been filed on that, Mr. Clerk?"

Clerk O'Brien: "A fiscal note is furnished."

Speaker Redmond: "Is furnished?"

Clerk O'Brien: "Yes, Sir."

Speaker Redmond: "Are there any Amendments from the floor?"

Clerk O'Brien: "House Bill 13. A Bill for an Act to provide for submission to the electors of this state a certain question of public policy. Second Reading of the Bill. No Committee Amendments. Floor Amendment #1, McPike, amends House Bill 13 from page 1..."



Speaker Redmond: "Representative Greiman."

Greiman: "Mr. Speaker, I filed a request for a fiscal note in this matter."

Speaker Redmond: "The Clerk tells me that the fiscal note has been furnished."

Greiman: "I've seen the fiscal note and it is not according to statute here, Mr. Speaker. If I can just catch my breath. It provides that...the Fiscal Note Act provides that an agency, commission, board or etc. shall make the fiscal note. All we have here is Mr. Kelly signing a piece of paper that says that the state board says it's 50 thousand dollars...not within the statute. I would sight 42.32 of chapter 63."

Speaker Redmond: "This Bill will be taken out of the record with the request of the Sponsor. House Bill 36, Representative Terzich. You ready on that? 36, Mr. Clerk."

Clerk O'Brien: "House Bill 36. A Bill for an Act to amend various Acts to revise obsolete procedural references. Second Reading of the Bill. No Committee Amendments."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "This Bill was read a second time previously. Floor Amendment #1, Getty, amends House Bill 36 on page 4 by deleting 6 and inserting in lieu thereof the following: 'a temporary restraining order or'."

Speaker Redmond: "Representative Getty."

Getty: "Mr. Speaker and Members of the House, Amendment #1 is purely technical. Just to make the words flow properly. There was an unnecessary additional word 'temporary', in that. We've clarified it by the Amendment. I'd move for the adoption."

Speaker Redmond: "Is there any discussion? The question's on the Gentleman's motion for the adoption of Amendment #1. Those in favor say 'aye', aye, opposed 'no'. The 'ayes' have it, the motion carried, Amendment 1 is adopted."



Any further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 91."

Clerk O'Brien: "House Bill 91, Second Reading. A Bill for an Act to amend Sections of an Act in relation to the issuing of fee bills. Second Reading of the Bill. No Committee Amendment."

Speaker Redmond: "Any Amendments from the floor?"

Clerk O'Brien: "Floor Amendment #1, Getty, amends House Bill 91 on page 1, line 10, by inserting the word 'written' before the word 'request'."

Speaker Redmond: "Representative Getty."

Getty: "The purpose here is just to make clear that it's intended that the request be in writing."

Speaker Redmond: "Any discussion? The question's on the Gentleman's motion for the adoption of the Amendment. Those in favor say 'aye', aye, opposed 'no'. The 'ayes' have it, the motion carried, the Amendment is adopted. Any further Amendments?"

Clerk O'Brien: "No further Amendments."

Speaker Redmond: "Third Reading. 286. Monroe Flinn, are you ready with those?"

Clerk O'Brien: "House Bill..."

Speaker Redmond: "Out of the record...and 287 out of the record. Representative Ryan."

Ryan: "Mr. Speaker, it's been brought to my attention that these Amendments that we've just acted on aren't on the Members desks. Do you know if they've been passed out or...."

Speaker Redmond: "Have they been passed out? Evidently have not, we'd better hold...is that true for both Bills? We'll have to put them back on the Order of Second Reading then. 36 and 91, the Order of Second Reading because the Bills...the Amendments were not on the Members desks. Well put them back on Second. Announcements."



Representative Katz."

Katz: "Mr. Speaker and Ladies and Gentlemen of the House, I wanted to urge the Members of the House who have...who have Bills that they are planning to put in to get to the Reference Bureau this week and get the Bills on order. Under the rules under which we're operating, we have a deadline for Bills that...I believe it's April 6th, now Members who get their requests on file this week, even if the Reference Bureau doesn't have those Bills back by April 6th they're going to be able to put them in. It's the Reference Bureau's inability to do it. But after this week the Rules Committee of the House, if they stick to the position they've so far taken, it will be the Member's responsibility to make sure that their Bills are back from the Reference Bureau and if they request to the Reference Bureau the preparation of Bills after this week, it's going to be their own tough luck if the Reference Bureau doesn't get those Bills back. So I do want to encourage the Members of the House to get down to the Reference Bureau this week and get your orders for Bills that you're going to want put in this week, then if the Reference Bureau is swamped and is not able to get your Bills back by the time the deadline comes, it will not be your fault and the Rules Committee, I know, is going to urge that the Members be allowed to put in their Bills whenever they get back. But this is likely to be the decisive week for ordering Bills from the Reference Bureau and I hope the Members who want to get Bills in for sure will be down to the Reference Bureau this week and get their orders in. Thank you, Mr. Speaker."

Speaker Redmond: "Representative Kane."

Kane: "Would the last Speaker yield to a question?"

Speaker Redmond: "What was your inquiry?"

Kane: "Would the last Speaker yield to a question?"



Speaker Redmond: "Will you yield, Representative Katz? I guess he will."

Katz: "If the Gentleman has a question, absolutely."

Kane: "Yeah, are you talking about the deadlines in the temporary rules or are you talking...what about the permanant rules and the deadlines that are in those? Are we going to talk about permanant rules this Session or not?"

Katz: "Oh, yes, I'm sure that we are, Representative. I was talking about those rules that are currently in effect. The temporary rules that are the rules that will be governing the House until they are changed. I was not..."

Speaker Redmond: "Please come to order."

Katz: "I was not assuming what was going to happen because I don't really know what's going to happen, Representative Kane, but I know that under the present rules in effect there is a deadline of April 6th. I know that even if the temporary rules are adopted...if the rules that are sitting now on Members desks are voted on before then they have approximately the same day. I was just urging the Members so they will not be disappointed later. We have a lot of new Members to try to get their orders for Bills in to the Reference Bureau, preferably some time this week to make sure that whether we have the temporary rules in effect or some other rules that they are not disappointed in being able to introduce their Bills."

Kane: "Well, I think I recall you saying earlier that we were going to act on the permanent rules as quickly as possible and I'm wondering if you're moving back on that committment?"

Katz: "No, when the Chairman of the Rules Committee calls the rules they will called and debated by the Members, Mr. Kane, I think you know that, Sir."

Speaker Redmond: "Representative Pullen."

Pullen: "Will the Chairman of the Rules Committee yield,



please, Mr. Katz?"

Speaker Redmond: "Representative Katz, would you yield?"

Katz: "I would be happy to yield to Miss Pullen any time, Mr. Speaker."

Pullen: "Thank you. I have a copy of the temporary Rules in front of me and I believe those are the Rules under which we're operating and I find only a deadline of April 2nd for introduction of Bills, not April 6th. And I find no deadline for making a request to the Reference Bureau. It seems to me, Sir, that the deadlines you're talking about are those that are in the permanent Rules that have been proposed which we have not acted on. And if you're talking about the Rules under which we're operating, I certainly don't see where you get April 6th and March 15th. Those were in the Rules that we hammered out in Committee and no one on this House floor has had any opportunity to take action on those rules."

Katz: "Yes, Miss Pullen, if you are asking me a question... I didn't really...had not checked with the House Rules, I wasn't sure whether it was April 6th or April 2nd. All I was saying, however, is that as far as the Rules that you are now looking at, there is nothing in that Rule Book that says that if a Member...it says that the Rules...that the Bill must be introduced by April 2nd. If the Member requests a Bill a week before then and it is not in the Member's hand by April 2nd, the Member has not complied with those Rules and would not be able to put that Bill in unless the Rules are waived. And so I was really just trying to let the younger Members of the House particularly know that there is not a provision to that effect and that they ought to get their request in early so that they have their Bills back in time to be able to comply with that April 2nd deadline that you made reference to."

Pullen: "Well you indicated that if a request were made by



now and the Bill were not ready by the deadline that you expected it would be the position of the House to permit such a Bill to be introduced because it was requested at this time. Are you indicating that the position of the Rules Committee, which is not officially the position of this House, will become the position of this House without a vote or are we going to be voting on the rules before April 2nd, we hope?"

Katz: "I don't know the answer to the last question. All I can say is that...that it would be my recommendation that any Bill that had been ordered by March 15th ought to be able to be put in by a Member even if it is later than April 2. But I do not presume to say what the House will do, but certainly the Rules Committee would favor letting a Member who has requested from the Reference Bureau a Bill by March 15th and due to no fault of his own is not back by April 2nd, a majority of the Rules Committee would urge that the deadline of April 2nd be waived for that Member. And so I thought that the Members who order their Bills early in this week would be in a preferred position and I was simply encouraging them to put their Bill orders in place down in the Reference Bureau if they could this week."

Pullen: "I guess that since we do not have permanent Rules or any prospect of prominent rules that we should be advising people to be sure to get their rules drafted so they'll have them ready by April 2nd because that's what's in the rules. Thank you very much."

Speaker Redmond: "Representative Schneider."

Schneider: "Thank you. Once again the Elementary and Secondary Education would like to make an announcement, that is we have one Bill scheduled which is a duplicate of a Bill we passed out last week. The Sponsor has agreed not to hear it. That is the only Bill posted, therefore, Elementary and Secondary Education will not meet today,



Tuesday, but will meet at its regularly scheduled meeting next Tuesday if the Sponsors will call their Bills for posting. Thank you."

Speaker Redmond: "Chairman of the Judiciary II. Judiciary II, Representative Katz."

Katz: "Yes, Mr. Speaker, Judiciary II will be meeting in room 118 immediately upon adjournment."

Speaker Redmond: "Representative Jones. Representative Jones."

Jones: "Yes, thank you, Mr. Speaker. The Insurance Committee will meet D-1 at 4 p.m. instead of 122 at 4 p.m. in the Stratton Office Building, D-1, the Insurance Committee will meet in D-1. It's a change from room 122 D."

Speaker Redmond: "Representative Williams, Vice-Chairman of Cities and Villages."

Williams: "Yes, thank you, Mr. Speaker. Cities and Villages will meet immediately after adjournment in room 304, that's the Capital Development Board room in the office building."

Speaker Redmond: "Any other announcements? Representative Matijevich."

Matijevich: "Mr. Speaker and Ladies and Gentlemen of the House, although Appropriations I Committee is not meeting today, the Democratic Members are asked to go room 114 at 2 p.m. with a short briefing with the staff. Thank you."

Speaker Redmond: "Representative Conti."

Conti: "Mr. Speaker and Ladies and Gentlemen of the House, I...just to get back to the announcement that the Chairman of the Rules Committee made, Mr. Katz, it's seems to me he's trying to help the new Members by trying to have an explanation of what kind of rules we're operating under. I remember cutting my vacation short, getting down here at 9 o'clock in the morning and working as late as 10, 11 o'clock at night to prepare some kind of rules. Now if he really wants to be of service to



the new Members, let's stay here this Thursday, Friday, Saturday and Sunday, let's stay this whole week and let's work 12 hours, 14 hours a day and let's get some rules adopted so we can help these new Members."

Speaker Redmond: "Representative Friedrich."

Friedrich: "Well, I would suggest to you, Mr. Speaker, as Chairman of the Rules Committee, if you do not call this thing I am going to file a motion to have the resolution called. I think it's time we adopt the rules. But to support Representative Katz's suggestion that you get down to the Reference Bureau, it's very important you do. Apparently the minds of this Body is real fertile year and we've got an unusual number of requests for Bills and thanks to the Majority party who refused to go along with our request for additional staff in the Legislative Reference Bureau, we're short. So if you go down there and don't find enough people to get it done, you can talk to the people who last year insisted we cut that appropriation."

Speaker Redmond: "Representative James Taylor, are you seeking recognition? Please, give the Gentleman order. We have some guests...we have some guests of the Chamber. Representative Conti. We're having guests in the balcony to be introduced."

Taylor: "Thank you, Mr. Speaker and I want to thank the Members of the House. I'm on the first assignment that the Speaker had given me since I've served in this new role, it's a difficult one for me today. Because we have some visitors here from Nigeria. They are the Nigerian Legislative Administrators, two clerks and two editors. Courts in the Nigerian Legislature are un-elected chief administrative offices of the new legislative House. All are senior civil servants. Editors are responsible for collecting, editing, printing and disseminating the proceeding of the Legislative Assembly.



Editors report to the Clerk. There're visiting our country and our state today. Some of the Members of this legislative government...branch of government had dinner with them last night and I apologize for not being able to be in attendance myself. But they are in the gallery here just on the Republican side. Bear with me on the names and I will only call their last name because I have problems with all of the names. The chief Clerk is Mr. Olajide, Mr. Olajide, a Nigerian. The other Clerk is Mr. Onajide, Mr. Onajide. And the Editor, Mr. Oluyemi, Oluyemi, Oluyemi. The other Editor is Mr. Fawunmi, Fawunmi. And their escort in our country is Ms. Loezere, Loezere. Let me thank you for stopping in and I hope you enjoy your stay. Thank you, Mr. Speaker."

Speaker Redmond: "Representative Madigan."

Madigan: "Mr. Speaker, are there any further announcements?"

Speaker Redmond: "Representative Laurino."

Laurino: "Mr. Speaker and Ladies and Gentlemen of the House, the Subcommittee meeting of the election contest between Swanstrom and Brinkmeier will be held in M-2 immediately after adjournment approximately 2 o'clock."

Speaker Redmond: "Representative Collins."

Collins: "Well, thank you, Mr. Speaker, with the difficulty I've had to getting recognized lately I'm beginning to feel like Representative Totten did last year. However, I would like to ask you, Mr. Speaker, as much as we enjoyed the filibuster by Representative Katz, there are some unanswered questions as to the rules. Now I don't think that the deadlines that he spoke of today are of any importance to us if get about the business of this House. Representative Conti and Representative Friedrich have continually asked you when we're going to call the rules. Now, Mr. Speaker, I don't have to remind you that you are the one that implored all of us



to call the rules in your first Session as Speaker and actually pleaded for votes. You were going to be the first Speaker who went through a Session without rules according to your own statement. I wouldn't want you to be that, Mr. Speaker. I think that we have wasted enough time on the rules and...more appropriately I think we wasted more time delaying the rules and I wonder why you have chosen this course of action, Mr. Speaker? I think that we have time this week, we should address ourselves to the rules, there's nobody asking us for early adjournment, why don't we get to the business of the House, Mr. Speaker? You've been putting us off and putting us off. I really...I think it's overdue...long

overdue for us to consider the rules. The Rules Committee, at your insistence, Mr. Speaker, met early and met long hours and I think you owe it to every Member of this House now to call these rules and let the House debate them and consider them and vote the various rules up or down. You're doing the Membership a disservice, Mr. Speaker, I think you owe it to us to call the rules no later than tomorrow."

Speaker Redmond: "You're earning your keep, Mr. Collins, as a leader."

Collins: "Maybe I should suggest..."

Speaker Redmond: "Representative Matijeich."

Matijeich: "Mr. Speaker and Ladies and Gentlemen of the House, as long as there's so many people that want us to do the business of the people of the State of Illinois I'll tell you a good way to do it. And as long as the last Gentleman who spoke is a new leader on the other side of the aisle, he can help to do it. A week ago tomorrow we heard the Governor's budget message and we've heard a lot of criticism about the budget process and the appropriations process last year and I think the criticism was right. And if you want to do something



about the budget and the appropriation process being a little bit better, when that budget message was delivered last Wednesday, on that very day the budget Bill should have been introduced. Now if you want to do something for the people of the State of Illinois, get those Bills in the Reference Bureau. They can be drafted as we found out last Session in one night. Get those Bills introduced tomorrow and we'll get the business of the people of the State of Illinois rolling right away."

Speaker Redmond: "Representative Madigan. 10 minutes."

Madigan: "Is it my turn?"

Speaker Redmond: "Yeah, 10 minutes."

Madigan: "Mr. Speaker, allowing for 10 minutes of Perfunctory Session, I now move that we adjourn until 11 A.M. tomorrow morning."
