Speaker Flinn: "Representative Breslin. Representative Breslin that's your amendment. The lady wishes to withdraw the amendment. Are there any further amendments?"

Breslin: "Oh, oh, oh."

Speaker Flinn: "Third Reading. House Bills Third Reading.

Clerk O'Brien: "House Bill 95. A Bill for an Act to repeal the requirement the County Superintendent of Schools maintain a list of text materials used in any school subject in his jurisdiction. Third Reading of the Bill.

Representative Deuster."

Deuster: "Mr. Speaker, Ladies and Gentlemen of the House.

House Bill 95 as it was amended yesterday, accomplishes



two purposes. First of all, it repeals an obsolete requirement of the Illinois School Code that the Regional Superintendent of Schools maintain a list of all of the text material and educational material used in the schools. I introduces the original Bill at the request of my own Regional Superintendent of Schools, Bill Thompson of Lake County and I have in my hand a letter from the Superintendent, Regional Superintendent of Schools of Cook County, Richard Martwick, indicating that he too believes that that portion of the law is obsolete and should be repealed. Secondly, the Bill as it was amended yesterday, as you will remember from the debate on Second Reading, contifies and guarentees the right of the public, any member of the public who's interested, to inspect text and instructional material used in the public schools. Amendment one to House Bill 95 provides that any member of the public may inspect all text and instructional material used in the public schools. That is a safeguard, of course, to guarantee that the people and the taxpayers have a right to know to look at the text materials if they're interested and that's what the Bill does. I'd be happy to answer any questions. I think it is a simple Bill and a good Bill and deserves your support."

Speaker Flinn: "Any further discussion? If not, the question is shall House Bill number 95 pass? Those in favor vote aye, those oppose vote no. Have all voted who that wish? Have all voted that wish to vote? The Clerk will take the record. On this question there are 117 ayes, 14 voting no, and 14 present. The Bill having received the Constitutional Majority is hereby declared passed. House Bill 148, Representative Deuster. Read the Bill first."

Clerk Hall: "House Bill 148. A Bill for an Act to amend sections of the Illinois Marriage and Dissolution of



Marriage Act. Third Reading of the Bill."

Speaker Flinn: "Representative Deuster."

Deuster: "Mr. Speaker, Ladies and Gentlemen of the House.

House Bill 148 came out of the Committee unanimously. It's a very simple Bill. I believe it was on the Consent Calendar. All that it does is add one word to the Illinois Marriage and Dissolution of Marriage Act, to make sure that where there is a divorce or dissolution of marriage, the county clerk does not have an obligation or duty to send the certificate all over the United States to the different states. The law now says that they should that this should be sent to... pardon me, the law now provides that this would be sent to the department which means the Department of...forgot the Department. And it simply inserts the word in front of the department 'Illinois' so that we know that there duty is just to send the record to the Illinois Department of Public of Health, I'm sorry. All it does is add the word 'Illinois'. The county clerk, circuit... clerk of the Circuit Court in Lake County asked that this Bill be introduced and the clerks support it. Very simple, and I would urge your support for the Bill."

Speaker Flinn: "Is there any further discussion? If not, the question is shall House Bill 148 pass? Those voting...Those in favor vote aye, those oppose vote no. Have all voted who wish? Have all voted who wish? The Clerk will take the record. On this question there are 149 ayes, O nays, O voting present and the Bill having received the Constitutional Majority is hereby declared passed. For what purpose does the entleman from Cook, Representative Capperelli arise?"

Capperelli: "Yeah. I would ask leave of the appropriate
rules at the House Executive Committee to meet in
the Speakers Office while we stay in session. We
got caught in a twist on one Bill which we have to clear



so it will be heard next week."

Speaker Flinn: "The Gentleman has asked leave to suspend the appropriate rules so that the, his Committee can hold a short session in the Speakers Office while we're still in session. Is there leave? Hearing no objection the leave is granted."

Capperelli: "Will you all report to the Speakers Office?

Thank you."

Speaker Flinn: "House Bill 14. 14. Representative Daniels Bill. Read the Bill."

Clerk Hall: "House Bill 14. A Bill for an Act to amend sections of the Illinois Municipal Code. Third Reading of the Bill."

Speaker Flinn: "Representative Daniels."

Daniels: "Mr. Speaker, Ladies and Gentlemen of the House.

House Bill 14 requires that the corporate name of a municipal water commission be an appropriate name indicative of the area involved. It also requires that the corporate authorities of each municipality belonging to a water commission approved by Resolution the decision of the water commissioners to accept new members by a majority of those members. Representative Walsh had an Amendment to the Bill which was a relatively simple. Amendment applying to his area alone and I would move for adoption and passage of this Bill."

Speaker Flinn: "Is there any discussion? If not, the question is shall House Bill 14 pass? Those in favor vote aye, those oppose vote no. Have all voted who wish? Have all voted who wish? The Clerk will take the record. On this question there are 140 voting aye, 0 voting nay, and I voting present and the Bill having received the Constitutional Majority hereby declared passed. Add Farley to those among yes. Representative Farley, in order to vote yes, you must sign a slip down in front I forgot about the rule change. House Bill 311."

Clerk Hall: "House Bill 311."



Speaker Flinn: "Out of the record. The request of Sponsor.
House Bill 329."

Clerk Hall: "House Bill 329. A Bill for an Act to amend sections of the Senior Citizens and Disabled Persons

Property Tax Relief Act. Third Reading of the Bill."

Speaker Flinn: "Representative Kornowicz. Take it out

of the record. House Bill 413. Out of the record.

House Bill 420, out of the record. House Bill 675.

Read the Bill."

Clerk Hall: "House Bill 675. A Bill for an Act to regulate the practice of public accounting and to repeal certain Acts therein. Third Reading of the Bill."

Speaker Flinn: "Representative Brady."

Brady: "Yes, Mr. Speaker and fellow Members. We started to discuss this Bill before. It's a continuing education Bill for certified public accountants only. The Certified Public Accountant Society has asked for this Bill to be mandated by the Department of Registration and Education. I urge your favorable support."

Speaker Flinn: "Any further discussion? Representative Walsh."

Walsh: "Well Mr. Speaker and Ladies and Gentlemen of the
House. In spite of the excellent sponsorship of this
Bill, I rise to oppose it because in my view it is
probably one of the worst Bills that we will have before
us in this session of the legislature. It indicates
a new philosophy that I'm afraid might be taking hold
that we ought to look into very carefully for the
benefit of our constituents. And that is the question
of continuing education for professions and trades
for licensed people. We have some 85 or 90 licensed
trades of professions in this state. This is the
first effort to provide for continuing education. I
suppose that if this is successful, that we'll have
many others. Now what continuing education means, Mr.



Speaker and Ladies and Gentlemen of the House, is that

the association to which these people who are licensed belong, provides for rules and regulations by which their membership remains licensed and they use the state as the enforcing arm. Now that's purely and simply, Mr. Speaker, an effort to control the number who are practicing that profession. In this case public accounting. Now when the numbers are controlled that means they're reduced, athat means there are fewer of these people available to offer these services to your constituents. I noticed that this Bill passed the Veterans Affairs Regulation and Reg. and Reg., whatever that is, Committee 12 to zip. Now, it was placed on the Consent Calendar. Someone wisely, not I, removed it from the Consent Calendar and it should have been removed from the Consent Calendar. I submit to you that at that meeting and I was not there but I might as well had been. I'll tell you what happened. There was a witness from the Department of Registration and Regulation, there was a witness from the Association that is interested in this, and there were no other witnesses. And you know why there weren't any other witnesses, because the only people agaist this are, should be the people. And the Committee laid down and said, 'Well since there's nobody against this, it must be good, let's pass it out'. Well I submit to you that it isn't any good and if you are doing your job as Representatives of the people, then you ought to dismiss this out of hand. I must say that the Committee in this instance, is almost guilty of misfeasance. They're not the only Committee, unfortunately, that is guilty of this, but the Committee ought to, and all Committees ought ot take into consideration what is right for the people. What this thing does is limit the number of people that will be in public accounting and therefore, drive the prices up for the services that your constituents need. I think you ought to be able to see that,



it's as clear as the nose on your face, and I urge you to vote no on this Bill."

Speaker Flinn: "The chair, the chair recognizes the Gentleman from McHenry, Representative Skinner."

Skinner: "Yes, Mr. Speaker and Members of the General Assem bly. I don't rise to attack the Committee that voted this Bill out of it, but I would point out that there are 6533 public accountants, certified public accountants and there are about 20,000 lawyers in the state. there are few enough CPA's in the state that we should be trying to limit there number and that is essentially what this Bill attempts to do. It's saying that any CPA that doesn't want to spend whatever time the Department of Registration Education decides is required for "continuing education" won't be allowed to practice. Now licensing has traditionally been a way to limit competition. Cetified Public Accountants are probably one of the most exclusive licensed professions in the State of Illinois. It's harder to become a CPA in this state than it is to become a lawyer. The test is tougher. More people fail it than fail the Bar. I don't think that we need to impose more restrictions on CPA's than already exists. I don't think it's going to make a CPA a better CPA to be forced to go back to school. It just seems to me that we are attempting in Illinois and have been for about the last 50 years, to turn back the clock several centuries. We're attempting to recreate in Illinois the medieval guild system. Pretty soon, everyone is going to have to belong to a guild or licensed profession. And I would expect to see soon a licensing procedure for politicians. I believe that Jack Mabley has suggested such a proposal and my seat mate Representative Mahar has couter suggested that we should also have a licensing procedure for reporters. Now eventually, you get to some profession for which it makes no sense whatsoever to have a license.



Perhaps it will be garbage collectors that will be next. One just doesn't know. And it seems to me that we ought to kill this trend as Representative Walsh so pointedly said in the beginning. And I would hope that we would defeat this Bill as well as virtually every other licensing proposal that comes before this General Assembly. We need to encourage competition not stifle it."

Speaker Flinn: "The gentleman from Cook, Representatave Conti is recognized."

Conti: "Mr. Speaker and Ladies and Gentleman of the House.

. I couldn't agree more with my former colleague, Representative Walsh. This Bill I have an awful lot of concern over because I know there are several Bills along with this Bill for continued education. Now I've got 40 employees as a real estate braker and I, not as mandated by the state do send 10 to 12 of them to school every year. And I've noticed that these private schools where they used to give \$65 courses, are now charging as high as \$350. It cost us over \$35,000 for continued education for my salesmen, but if the state starts mandating this now I could see where these private schools are going to have a field day with their fees. This is just one of many Bills that will be coming out for continued education and mandating various professionals, professional institutions to continue this education and I think that this would setting a dangerous president and I want to call out the attention spoken mostly to most of the attorneys in the House. That anybody that's been an attorney for more than 10 years, I defy them to take the Bar examination tomorrow morning and see if they can pass it."

Speaker Flinn: "The gentleman from Cook, Representative Mugalian is recognized."

Mugalian: "Will the Sponsor yield to a few questions?"

Speaker Flinn: "He indicates he will."



Brady: "Mr. Speaker."

Speaker Flinn: "Yes."

Brady: "I don't want to take up the time of the House.

Obviously we discussed this before and the Members
just didn't feel this way. Something must have been
miscommunicated. Why don't we take it out of the record and

see if we can straighten it out. Thank you, Mr. Speaker. Speaker Flinn: "I think the Gentleman has a right to take it out of the record we are not on Roll Call so we'll take it out of the record, request of the Sponsor.

Representative Leinenweber, what do you, purpose do you rise?"

Leinenweber: "Well I'm not sure exactly what the purpose other than to make a comment on what Representative Skinner said relevant to the Bar exam being allegedly easier than a CPA exam because more CPA's flunk their test than lawyers flunk the Bar test. Lawyers are smarter."

Speaker Flinn: "House Bill 529."

Clerk Hall: "House Bill 529. A Bill for an Act to make an appropriation to the Department of Transportation.

Third Reading of the Bill."

Speaker Flinn: "Representative Schisler back there? I don't see him. Take it out of the record, he's not back there.

House Bill 162."

Clerk Hall: "House Bill 162. A Bill for an Act to amend sections of the Illinois Vehicle Code. Third Reading of the Bill."

Speaker Flinn: "Representative McAuliffe, you want your Bill here 162? Take it out of the record. House Bill 192."

Clerk Hall: "House Bill 192. A Bill for an Act to amend sections of the Nursing Home Sheltered Care Homes and

Home for the Aged Act. Third Reading of the Bill."

Speaker Flinn: "I don't see Representative Marovitz on the floor either. Take that out of the record. House Bill 203. Representative McMaster, you want the floor

There unique differences exist in urban education such as the verse learning, learning styles, multirethnic

background of the student population. And this necessitates the existence of such a commission. The commission

tates the existence of such a commission. The commission was originally a established in 1972 and worked closely with the Office of Education and I solicite your affirm-

ative vote. Thank you."

Speaker Redmond: "Representative Leinenweber."

Leinenweber: "I have great respect for the sponsor of this

Bill but unfortunately, this Bill was heard in Executive

Committee and on the same day that we considered a great

number of sunset Bills, which indicated that the feeling of the Members of the General Assembly is that these Commissions are to have some limited life existence so that they wouldn't go on forever and ever when one of

these is created. The sponsor of this Bill put what

I thought was a rather incredible Amendment on this Bill



and that was to remove the deadline for this particular Commission to go out of existence. So if we pass this Bill, not only are you extending the life of a commission which has already been extended two or three times, but you're going to give it perpetual existence. This thing will be with us for the next generation. Perhaps even longer. I think it's time, either have the Sponsor take this back and put a deadline so it a sunset provision on this Bill so it will at least be consistent with the other actions we're taking or maybe it should be killed outright. I'm not familiar with the work of this commission. I don't know what it's been doing for the last several years. I don't know what impact it's had. It hasn't made much on me obviously. But I don't think that we ought to pass this Bill in this particular form at this time when we're been so concerned about sunset. We're going to create this thing and give it perpetual existence

Speaker Redmond: "Representative Bullock."

Búllock: "Mr. Speaker and Ladies and Gentlemen of the House.

which is a bad policy and therefore I urge a no vote."

I'd like to say that I'm a relatively new Member of this commission and I certainly would like to be given an opportunity to join with Representative McCourt and others to undertake a federal hearing and

Bradley: "Well with that in mind then, Mr. Speaker, I will go ahead with House Bill 460. And what House Bill 460 it addresses itself to a problem that many retailers in the State of Illinois have with the Department of Revenue. The Department on, of Revenue notifies the retailer when he owes a tax liability to the state rather immediately. However, on the other side of the coin on occasions where a retailer would go from a \$10,000 a month plus tax liability to a \$5,000 plus, there are occasions where the Department of Revenue does not notify the retailer that he does have a credit to his account and actually then, bills the retailer at a higher amount or sometimes for as much money as that retailer may have a credit with the state. It put some retailers to a tremendous disadvantage in so far as the amount of money that must be deposited with the state. So what we're simply asking here is that the state notify within 30 days of a credit that is coming to the retailer the same as they are doing when there is a debet so that the retailer will not have to, in some occasions, go to the bank, borrow money to pay those taxes. It also has an amendment that Representative...Marylou (Kent) has put on that maybe she would like to address herself to that amendment, but I, that's what the Bill originally does and I would ask for the support of the House."

Speaker Redmond: "Representative Kent."

Kent: "Thank you Mr. Speaker and Members of the House. The amendment that has been placed on 460 will deaccellerate the sales tax payment, therefore; giving him 30 days to make their report and this too, will enable them to be on a cash flow basis where they don't have to borrow money to have that money in ahead of time. I urge your support on this Bill."

Speaker Redmond: "Representative Friedland."

Friedland: "Thank you Mr. Speaker and Ladies and Gentlemen of



the House. The sponsor of this measure if 100% correct.

It's an excellent measure to help the over-burdened business man, large and small. I urge your favorable consideration of this issue."

Speaker Redmond: "Any further? Representative Johnson.

Representative Bradley, do you want to close?"

Bradley: "Mr. Speaker, just in closing in response to Representative Kents remark. She's absolutely correct and if you look at the bank check balance that we have now in the State of Illinois as we receive those statistics from the auditor, we're in much better shape financially than we were when we had those speed up attacks.

House Bill 580 is sponsored by the Motor Vehicle Laws Commission to correct an error that we made in 1975 in passing House Bill 1252 which increased the fees for all recreational vehicles and unfortunately the recreation trailers were also included in this increase. What we were trying to do was to raise the prime abusers of the bin fee on the pick-up trucks and vans which the RV place, not the RT place. As we know, all our T plates are towed by a licensed vehicle which is already paid as



flat rate for the privilege of using our roads and therefore, they are paying another tax besides this.

Now I want to make sure also that everybody understands the difference between an RV plate and an RT plate.

An RV plate is a motorized self-contained unit. Most of the RV plates are nothing more than vans or pick-up trucks with camper shells inserted the bed of the truck.

We attempted to rectify this last year with House Bills 31, 32. It passed the House by 132 to 8 votes however, we all know what the fate of our Bills was when it went over to the Senate Rules Committee and it was never heard in the Senate. This legislation has been approved by the Secretary of State, the State Police, the Department of Transportation and the Motor Vehicle Laws Commission. I would solicite a favorable support

VanDuyne: "County Superintendent of Highways is mandated for a six year contract. And I consider this to be an unneccesary restriction on the authority and the function of the County Board and this Bill, since the, makes it just a little bit more simple in that it gives the County Board a discretion liability to belong and it allows them to negotiate with the asperit for the job for the terms of a minimum of two years to provide the continuity of the office up to a maximun of six years in result.

The County Boards have to hire and pay these people and more important ant put up with them for the term of their contract so

I think it follows that they should play a permenant part in determining the length of their contract. It

came out of the County and Twonships Committee 11 to 1.

I ask for an aye vote. Thank you."

Speaker Redmond: "Representative McMaster."

McMaster: "Mr. Speaker, Ladies and Gentleman of the House.

For your information I urged the no vote on that Committee. Let me explain something to you. Superintend ent of Highways at the County level is an educated man a professional man, to ask him to move from one end of the state perhaps to the other end, in order to be employeed by a specific county as a County Highway Sup. and to be in the position of moving for two years, for two a year period I think is very unfair to that kind of an individual. I certainly feel that we have had no problems currently with a six year term for a County Highway Superintendent and I don't really know why we want to change it. I do know that one of the lobbyists for county people appeared interest at the Committee hearing and registered in support of the Bill, but he also made the remark that it was certainly not one of their more important Bills that they were working

on this year. I certainly feel that to be fair and to maintain a good County Highway program, that you should go ahead and hire your County Highway Superintendents for a period of six years and I think it's very unfortunate, I don't like to oppose Leroy on a Bill, but unfortunately, this is one that I do not beleive in and I would appreciate a no vote."

Speaker Redmond: "Representative Kane."

Kane: "Would the Sponsor yield to a question?"

Speaker Redmond: "He will."

Kane: "Under the present law in which County Highway Superintendents are given six year terms, what are the provisions .

for removing that Highway Superintendent in less than
a six year term?"

Van Duyne: "Doug, if yourasking me the question. I presume, and I really don't know, but I presume that it's no different than any other contract signed by two people agreeing in that he's got to do something wrong. There's got to be some kind of a cause before his contract could be revoked and I think even more specifically, that would be written in the terms of his contract."

Kane: "Mr. Speaker, Ladies and Gentlemen of the House. I rise in opposition to this Bill. I think that given the kind of condition that our county highways are in, that we need to be able to get the best qualified individuals to serve in that position as possible. Two years is too short a time to make a dent on county highways. It doesn't allow a new county engineer the time to put together an overall plan for the improvement of the highways in the county. I think that six years is a good period of time. It has worked well in the past. There are provisions in the statute for the removal of a County Superintendent of Highways if he does not his job well. And I would urge the defeat of this Bill."

Speaker Redmond: "Representative Robbins."



Robbins: "Mr. Speaker and Members of the House. I urge the passage of this Bill to allow the County Board the flexibility that you do in other contracts. The fact that a man can initiate a contract for two years or he can initiate a contract for six years and the County Board can go along with whatever contract they want to do. I think it's time we returned a little bit of the freedom back to the people, say 'You've got to do this of you've got, or you can't do nothing'. Let's give a man an opportunity to work for two years and it may be lesser salary and go in and increase his salary after he's shown a new term of a new County Board of his capability instead of freezing him at six years on a lower salary. This law does not keep the County Board from issuing a six year contract. You can have a six year contract under this law just as you have now. If the man has a good program and wants to keep it going, but give the County Board and the man that is working as a Highway Superintendent the right to do what they think is right. Thank you."

Speaker Redmond: "Representative Skinner."

Skinner: "I have a question of the Sponsor. I would like

to know why this Bill is necessary? Why isn't working

now?"

Van Duyne: "Cal, I don't know why it's necessary either, but

Speaker Redmond: "Representative Van Duyne."

I just think, I can ask you, answer the quetion by asking you one. Why is it necessary, or why is it mandated by the State of Illinois that any one individual, and the only one in the whole state that I know of that is ordered to give, by the state to the County Board to give a man a six year contract. Even our own administrator of the Department of Transportation for the whole state is not mandated to give a six year contract. I do not have a six year contract, neither do you. No one else in the state that I know of is mandate, I don't even



know how to say it, is mandated to have a six year contract. It's the usipation of the County Boards authority. It give the County Superintendent of Highways a ax or club to hang over the head of the County Board. They become Tackadaisical. They become unresponsive and in some case unresponsible. And I'm going to tell you something else, there is no way that you can fire a man with a six year contract unless you practically catch him at the airport with money hanging out of all pockets that belongs to the county. And you know that and I know that. I have no special vendetta against anybody accept from the philosophical point of veiw, That I just pointed out to you. And I want to also point out to you that my County Superintendent of Highways has just signed, last month, a six year contract So this is no vendetta against him. I think that it is absolutely unreasonable for the state to mandate to a County Board which is charge with the responsibility of paying these people, hiring them, and overseeing them, and they're the people that are suppose to be responsible to the people in that county to make sure that those roads are maintained and cared for properly and I think it's an unneccesary restriction on their obligation to the people. And as I say, it's no big deal, but some of the people seem to be a making the big deal. The only people that I know of that are against this Bill is 102 people, the County Superintendents of Highways. If you think that there are not, is not supporting this Bill, ask your County Board members."

Skinner: "Mr. Speaker, I haven't had contact with any of the County Superintendents of Highways in the state, and I likewise have had no, I've had no problem with any of the County Superintendent of Highways in any of the five counties I represent. They all seem to be highly professional people. And I just don't see a reason for

the Bill. I don't think the case has been made by answering the question, 'Why is this Bill needed' with the counter question, 'Well, why isn't it needed'. It's up to the person proposing the change to make the case for the change and I don't think that case has been made."

Speaker Redmond: "Representative Ewing."

And I think it's a logical, reasonable approach and I just simply ask you for an aye vote."

So they came out with an actuarial assumption."

It's just a commission to kind of oversee and make recommendations to the Governor that he might not get otherwise. That's the purpose of it Representative Flinn."

Flinn: "Thank you."

Speaker Redmond: "Question is shall this... Representative
Barnes."

Barnes: "Thank you very much. Would the Sponsor yield to a question?"

Speaker Redmond: "He'll yield."

Barnes: "Representative, I wasn't quite clear of the real, necessity for this Advisory Board. You said that this was a companion Bill to a Bill that has currently been acted upon in this session. Is that correct?"

McBroom: "Yes, the subsidy Bill has passed, Representative

Barnes. It's a three Bill package. The appropriation

Bill is still on the Calendar. The subsidy Bill has

passed."

Barnes: "Well, as I understand, the Bill that's before us right now, this is a subsidy Bill. This is not a Bill for appropriation request, is it?"

McBroom: "There's no appropriation whatsoever in this Bill,
Representative Barnes. Yes, this could be addressed
assa subsidy Bill too. But the main Bill has already
passed the House."

Barnes: "What was the main Bill?"

McBroom: "706."

Barnes: "What did it do. I'm trying to get to a point here.

It seemed to me, you're saying that this a substantive Bill. Was 706 an appropriation request? Or was it

a money Bill or what was it? So we can understand fully



what you're saying here."

McBroom: "The original Bill amended the Agricultural Fair

Act and increased grants to 4-H and...

Barnes: "Was that the Bill, Representative, that, that had as part of the law that it was writing in a ongoing cost of living increase for the rates and these people that we are voting on now will be the ones that will monitor and insure that Bills rates are increased each year proportionally?"

McBroom: "Yes...

Barnes: "... That is the Bill."

McBroom: "Yes."

Barnes: "I just want to advise the Members of the House and when 706 came up, one of the questions that came up at passage time as I understand it hadn't came up before. Written in the 706, was the first time for anyone that I know in any piece of legislation here, was a provision tied to the Consumer Price Index which in fact wrote into law a cost of living increase of which we can't be certain what it will be relative to the premium of the prizes taken out of the dollars that are put into the Agriculture Premium Fund as I understand. And I just want to advise the Members that this is a companion Bill. I don't know who or what action that these people that will be this Advisory Committee will have with that, but I would like to know that and I think the Members realize that those people involved here if this is the group that will be administering 706, is the people that will be involved in the determination of increasing those rates by the cost of iliving provision that is embodied in House Bill

McBroom: "Well, Mr. Speaker, Members of the House, I can understand as chairman of the Appropriations Committee Representative Barnes concern and I'm sure that he's alluting to House Bill 708. Representative Barnes...



706. And I would oppose it."

Barnes: "That was the question that I asked you Representative I wasn't sure and I asked you a specific question. That's

what I was trying to get to."

McBroom: "Representative Barnes, number one, it's kind of noisy. Number two, I'm enjoying, I think, a little kabitsing on both sides of me and if you would repeat your question, I''l endeavor to answer it."

your question, I''l endeavor to answer it."

Barnes: "Thank you. I perhaps may be wrong and I wanted to be certain. I was asking if this Bill was tied to the Bill that we passed which was the appropriation Bill that related to increasing the rates relative to certain innidies from the, that's taken out of the fair, Agriculture Premiun Fund currently. Embodied in that Bill was a Consumer Price Index factor which was involved with the cost of living for future years.

Now this Bill does not relate to that. I have no questions about it at all."

McBroom: "It's an Advisory Commission and it's a separate inity entirely, Representative Barnes. I'm doing my best to answer your question. I don't know if I'm doing it. It's an Advisory Commission. It's not mandatory. The other Bill can float without this Bill. I earnestly the solicite support of the Members. It's not...

Barnes: "Well, then my follow up question is exactly what kind of impact would this Advisory Committee have?

As I understand the law, the areas that this Advisory Committee would address itself to, that those budgets in the prerequisits for spending for those agencies are set by the Burea of the Budget, so I want to know exactly what kind of impact would this one have? If any?"

McBroom: "Representative Barnes. I, like you, am not a farmer.

But I'm advised by people who do understand the procedure, that the agricultural community throughout the state has not had enough input in the past as to the



agricultural procedures in the state. I'm also advised, and I don't like to get into naming names or naming directors, or naming Governors, but I understand that in the past under all Governors that they did not sometimes receive the proper information from their people in the agricultural community. This Commission would be an effort to avoid that and give the Governor more information directly from the agriculture community throughout the state."

Barnes: "Well, one final question. Would this Commission that you're setting up then, in fact you serve the,

I wouldn't say the authority, but the perogative that has now hit a for been based in the Department of Agriculture and in its director?"

McBroom: "Absolutely not. It's Advisory in nature."

Barnes: "But they will be doing the same thing."

McBroom: "They'll be working with each other and it would be an opportunity for the farmers throughout the state to have some input to these various members that I just recited a minute ago. Broader based input, I feel Representative Barnes."

Barnes: "Well Mr. Speaker may I address the...

Speaker Redmond: "Proceed."

Barnes: "I don't see, and Mr. Speaker I don't want to belabor this, but I don't see that the Advisory Committee and gets fully what its responsibilities will be. As I understand, the Director of the Department of Labor now has the authority and has the perogative to sit down with the Governor and the Bureau of the Budget to discuss these kind of issues relative to spending as it relates to the agriculture community. Now, if this Advisory Committee and Representatives saying that it is purely adv'sory, it's not going to usert that authority with simply adding another layer for people that in fact will not do any more than what the current

Director of the Department of Agriculture is charged with



the responsibility of doing. Now, unless there is something there that I don't see, and that's what I was trying to get to, this is the way I see it and I still don't, I think this is an unnecessary exercise if this in fact is simply userping powers as now avested within the Department of Agriculture."

Speaker Redmond: "Representative Willer."

Willer: "Yes, would the sponsor yield?"

Speaker Redmond: "Yes, he will."

Willer: "Representative McBroom, I apologize. You may have

answered his question. It's pretty noisy around here.

McBroom: "None."

Willer: "It is none. There's...

McBroom: "Yes, Representative Willer, zero."

Willer: "Ok. Thank you."

Speaker Redmond: "Representative Matijevich.'

Matijevich: "Mr. Speaker and Ladies and Gentlemen of the House

I always find it very difficult to speak in any way against Representative McBroom's Bills and I've found through the years that the administration usually gives him some Bills because they know he's a good fellow and everybody hates to vote against his Bills. But, I only want to say this in regards to this Bill. First of all, I don't think it does anything because BOB is really going to tell you where the money's going to go anyhow. So it's not going to do anything. Secondly, and my seat mate, Representative Giorgi, often makes a joke out of the fact that there's some hipocrits with regard to gambling funds and racing funds and where it goes and people who always talk against gambling, and I'm not talking about Representatives, I'm talking about people, who speak against gambling are quick to use those moneys. And I think if we are going to have an Advisory Commission on horse receipts,

Speaker Redmond: "Representative Ewing. Ewing. Out of the record. 708."

Clerk O'Brien: "House Bill 708. A Bill for an Act making appropriation of the Department of Agriculture. Third Reading of the Bill."

Speaker Redmond: "Representative McBroom."

McBroom: "Mr. Speaker, Members of the House. This is the appropriation measure for the Bill that was, has been passed and it increases funding by 1.6 million."

Speaker Redmond: "Any discussion? Representative Bullock."

Bullock: "Mr. Speaker, will the Sponsor yield to a question?"

Speaker Redmond: "He will."

Bullock: "Representative McBroom...

McBroom: "Yes sir."

Bullock: "I'm quite certain that this Bill will take the



normal course of events that the other Bills did, but,
nonetheless, I have a question here. The funds that

are those funds distributed?"

Speaker Redmond: "Representative McBroom."

McBroom: "It goes 4-H, FAA, FFA, I mean. And McCormick placed

Bullock: "Well that's, I'm glad to hear you say that

Representative McBroom, because I have a general idea that there was some inequity in terms of the distribution formula for these funds and from time to time we do have worthy projects come up on the floor of the House that affect my community inChicago and I'm sorry that I allowed this Bill to get to Third Reading without some indication of concern and perhaps suggested a for Amendment. I don't know how you feel about the Bill but I would

like to work with you on possible Amendments to this or subsequent legislation to address the distribution formula. I'm not going to oppose your Bill at this point because I don't think it really would matter based on what I've seen take place earlier. Dunn: "Then why do we need this Bill?"

McBroom: "Well, it was done intentionally, Representative

Dunn, because when the Bill was drafted and introduced

I was not prevy to know what was in the budget."

Dunn: "Do you intend to amend the budget, to reduce the

Department of Agriculture budget by this amount if this

Bill becomes law?"

McBroom: "Yes. That's exactly right."

Dunn: "Alright. Then one other question. Is it true that the, that there is about a million six of the total of four million five in this Bill that comes about by reason of the, of House Bill 706, I guess it was?"

McBroom: "That's an increase over the budget of 1.6. You're correct Representative Dunn."

Dunn: "And that's 1.6 out of 4.5 million. I don't have a calculator here but that's a pretty hefty percentage increase with the Consumer Price Index tie in in this in this proposal. How much can we expect this to go up in the next year?"

McBroom: "About six to seven percent, Representative Dunn, but I'm advised that the, that the budget in the past, that the funding in the past, has been so meager that there's been a dimunition of young people that even get involved in 4-H. They can't afford it."

Dunn: "Can you, just one final question. What other state government program receives increased funding each year tied to the Consumer Price Index?"

McBroom: "I, I don't, I can't, I can't answer that Representative Dunn. It seemed like a logical approach to me."

Dunn: "Do you know if there are any?"

McBroom: "I can't, I truly cannot answer you yes or no. I do, I don't know."

Dunn: "I sure hope there are none. Thank you."

Speaker Redmond: "Representative McPike."

McPike: "Will the Sponsor yield?"



Speaker Redmond: "He will."

McPike: "What was the budget for this last year, Representative

McBroom?"

McBroom: "4.5, Representative Dunn, or McPike."

McPike: "Last year?"

McBroom: "Yeah."

McPike: "Your appropriating 4.5 this year."

McBroom: "No."

McPike: "What was it last year?"

McBroom: "2.9."

McPike: "You're going from 2.9 to 4.5."

McBroom: "Yes."

McPike: "That's an increase of, of over 50%. 55% in one year."

McBroom: "Well, you're right, Representative McPike. Except

that the increases for going back ten years to date have

been insignificant. Almost nill."

McPike: "The reason for this increase, I take it is...The

reason I take it for this increase would be the companion Bill 406 that everyone else is referring to that has tied this to the Consumer Price Index. And now you're starting. I don't have any more questions.

I'd like to speak to the Bill Mr. Speaker. Mr. Speaker

I'd like to address the Bill."

Speaker Redmond: "Representative McPike."

McPike: "Well I think everybody understands now exactly
what is happening. First of all, last week we addressed
ourselves to House Bill 706 which in the future ties
this program, unlike any other program in state government, it ties this program to the Consumer Price Index.
Not only that, before we tie it to the Consumer Price

Index, we're going to increase that base by 55% from the previous year. Now that's a pretty hefty increase.

And when you come, you know when you run for election

and yourstart talking about yourpriorities and say,

this year for economic purposes is education' I think



everybody should be realistic when you go back to the people that vote for you and say, 'What my pr&ority really was, was county fairs because not only did

I support a 55% increase in one year, but then I tied it to the Consumer Price Index. I wouldn't do that for school. I wouldn't do for schools. I

wouldn't do that for welfare. I wouldn't do that for mental health. I wouldn't do it for anything but I would do it for this. Absolutely. I would support building and promoting county fairs. It's the number

disgraceful concept. I think that there's no way

we could possibly justify a 55% increase in the base

and then on top of that tie it to the Consumer Price

Index. I hope you keep that in mind when you vote

one priority. Now I think this is a disgraceful,

Speaker Redmond: "Representative Matijevich. Representative

McBroom for what purpose...

Matijevich: "Mr. Speaker, Mr. Speaker."

McBroom: "Could I address a question to Representative McPike or Matijevich."

Speaker Redmond: "Yes."

McBroom: "Well."

Matijevich: "Mr. Speaker."

Speaker Redmond: "This is what is know as reverse recognition."

Speaker Redmond: "Representative McPike."

McBroom: "I have had enough Members on both sides of the aisle express concern about the cost of living. I would be happy to tell you Representative McPike and

Representative Matijevich and some of the Members over here who have expressed concern that I will see that that, the cost of living portion of 706 is removed if that would alay your concerns. I am also advised since Representative Dunn asked me a question, that

there's no other program in the state that has a cost of living increase in it and I'll be happy to see that

that's removed."

Speaker Redmond: "Representative Matijevich."

Matijevich: "Mr. Speaker and Ladies and Gentlemen of the
Assembly. I rise in support of McBrooms Bill because
I think it makes logic although as you know when we
passed House Bill 706 I rose on the floor and thought
we ought to wait so that the companion Bill be heard
at the same time. But I think it's just logical since
we passed the formula Bill, that we pass the appropriation
Bill that goes with it. Representative Dunn did make
sense in that we have here now the whole appropriation
for the county fairs, however; the Committee was aware
of that and we are going to delete that from the budget
so I think that this Bill now ought to passed out."

Speaker Redmond: "Representative Charles Campbell, the Gentleman from Vermillion."

Campbell: "Mr. Speaker I move the previous question."

Speaker Redmond: "Question is shall the main question be put? Those in favor indicate by saying 'aye' aye, oppose 'no'. The ayes have it. The motion carried.

Representative McBroom to close."

McBroom: "I'd appreciate a favorable Roll Call Mr. Speaker."

Speaker Redmond: "Question is shall this Bill pass? Those in favor vote aye, oppose vote no. Have all voted who

wish? Have all voted who wish? Representative Ropp."

Ropp: "Mr. Speaker and Members of the House. I'd just like to mention that I think that a lot of people have expressed concern that some of these programs are going up rather significantly. Might I point out that to the people who are involved in the 4-H program, this means \$10.50 from a \$5.50 so \$10.50 in comparison to the good and to the possibility that these young people will not be on public aid, mental health, or in corrections in a few years, I think is an exceptionally good point and if you can show me any other program in

the state government where we can only spend \$10.50 to do



as fine a job as we can get returns from 4-H and FFA then I'll put in with you. I urge more favorable votes on this particular Bill."

Speaker Redmond: "Representative Bullock to explain his vote."

Bullock: "Mr. Speaker, I'll be quite brief. I've listened to this debate and I had formulated an opinion prior to the Roll Call. I think that Representative McBroom has every intention of doing what's right, but I think that in order of fairness to this House and to the citizens of the State of Illinois, that we ought to hold this Bill and of course the only way we can do that is not get sufficient vote. Because I think we are obviously going to sustain what is obviously an unfair, unequitable basis at which this cost of living escalator and other programs are included. I'm going to vote no on this Bill, but I'm going to vote no in a ocnstructive manner because I hope Representative McBroom and others will help us work this obvious problem out."

Speaker Redmond: "Representative Borchers."

Borchers: "Well, as a Representative from a farming area,

I have observed many times the work of the young farmers, boys and girls in my area in our local county fairs and of course the State Fair. And I think it's a great help and value for the state to show the people of the State of Illinois this legislature to show their interest in the affairs and the education of our young people who will be the next farmers to give us the food we need. And I think we should certainly support this Bill. So I do ask that you give help in the financial line to the young people of our, of our state in the farming industry."

Speaker Redmond: "Have all voted who wish? Clerk will take the record. On this question there's 86 aye and 39 no. Representative McBroom."

McBroom: "Like to put it on postponed consideration."



Speaker Redmond: "Postponed consideration. 747."

Clerk O'Brien: "House Bill 747. A Bill for an Act to amend the Illinois Insurance Laws Study Commission. Third Reading of the Bill."

Speaker Redmond: "Representative Mautino."

Mautino: "Thank you Mr. Speaker and Ladies and Gentlemen of the House. This legislation, 747 does not increase the appropriation. According to statute, we must make line item changes within our existing appropriation and this is a change of \$1700 from line item for commodities to telecommunications so we can pay the phone bills and it must be done statutorally rather than a 2% transferability."

Speaker Redmond: "Any discussion? Question is shall this
Bill pass? Those in favor vote aye, oppose vote no.
Have all voted who wish? Have all voted who wish?
Clerk will take the record. On this question there's

Clerk O'Brien: "House Bill 806. A Bill for an Act making

appropriation the Department of Agriculture for repairing and replacing buildings of the LäSalle County Fair Association. Third Reading of the Bill."

Speaker Redmond: "Representative Breslin."

Breslin: "Mr. Speaker, Ladies and Gentlemen. This is an appropriation of \$38,380 to repair and replace buildings on the LaSalle County Fair Grounds that were destroyed by the snow of this past season. Representatives Hoxsey, Ewing, and Anderson are hyphenated co-sponsors. We would appreciate you favorable consideration as you have given to all other counties, county fair groups in the same situation. The appropriation is made from the Ag-Premium Fund. Thank you."

Speaker Redmond: "Is there any discussion? Representative ${\tt Tuerk."}$

Tuerk: "Would the ponsor y, ield to a question?"



Speaker Redmond: "She will."

Tuerk: "Well now this appropriation is amended into House

Bill 461 which is the Bill that has already passed

the House and is over in the Senate. What is the reason
for pursuing this Bill at this point?"

Breslin: "I had already introduced this Bill and Representative Hoxsey had placed this Bill as an Amendment on to your Bill so that it would have more support. So if, that's the only reason."

Speaker Redmond: "Question is shall this Bill pass? Those in favor vote aye, oppose vote no. Have all voted who wish? Clerk will take the record. On this question there's 115 aye and 28 no. The Bill having received the Constitutional Majority hereby declared passed. 39? 39."

Clerk O'Brien: "House Bill 39. A Bill for an Act to amend sections of the Paternity Act. Third Reading of the Bill."

Speaker Redmond: "Representative Terzich."

Terzich: "Yes Mr. Speaker, Ladies and Gentlemen of the House.

We are now coming down the home stretch with the law revision Bill. I beleive we only have four five much to the pleasure of Representative Van Duyne. Hous Bill 39 amends the Parternity Act. It excludes the two year period in which an action to establish paternity of a child may be initiated in any period of time when the accused conceals himself within the State. At the present time the time that the person hides himself or so on is excluded time from filing a parternity case. This would also include when he conceals himself within the state, the Bill would indirectly further the goal of forcing parents duties to support their children and I would urge support of House Bill 39."

Griesheimer: "In a non-jury trial after the plaintiff has
rested and there several motions pending, I was just
wondering what your opinion would be whether they should
stay the proceedings at that time or considering a final
judgment, or whether they should hold everything in
a bay pending determination whether dicovery has been
completed. Do you have an opinion on that Mr. Sponsor?"

Terzich: "I would like to yield to Representative DiPrima to answer that question."

Speaker Redmond: "Representative DiPrima." It's a motion in

Speaker Redmond: "Any further discussion? Question is shall this Bill pass? Those in favor vote aye, oppose vote no. Have all voted who wish? The Clerk will take the record. On this question there's 124 aye and 9 no.

Speaker Redmond: "Representative Barnes."

Barnes: "Thank you very much. Mr. Speaker, Members of the House. House Bill 164 is a product of both staffs and myself and members of the Department of Children and Family Services to attempt to update and change various parts of that Act to insure of providing better service toward neglected and abused children. The analysis of the Bill is correct and your, and your synopsis. Amendment number one in fact, if the Bill there was two other additional Amendments. Representative Pullen, Amendment number two which deleted the Appellate cause. Amendment number three which was worked out in conjunction with the House Bill Association to bring the Bill into conformity of a recent Supreme Court ruling and I would answer any questions relative to House Bill 164 and urge your support of the House."

Speaker Redmond: "Any discussion? Question is shall this
Bill pass? Those in favor vote aye, oppose vote no.
Have all voted who wish? Have all voted who wish?
Clerk will take the record. On this question there's
150 aye and 0 nay. The Bill having received the Constitutional Majority hereby declared passed? 180."

Clerk O'Brien: "House Bill 180. A Bill for an Act to amend

homes for the aged Act. Third Reading of the Bill."

Speaker Redmond: "Representative Borchers. 180."

Borchers: "This Bill, 180, is to have once each year in the downstate counties the publishing of the names of all the stockholders of a particular nursing home or any nursing home. Chicago is excluded because, becuase the numbers of population and the size and cost of the newspapers there. Now the first Amendment that was put on was merely to clarify the, how the newspapers, how the ads would put in the newspapers. The second

how the ads would put in the newspapers. The second Amendment was by suggestion of the Committee and it was to go along with what the present rules are that the ownership must be, must be given and brought up to date every six months but to the Department of Public Health...Department of Public Health and Safety. That was to conform so now is to be published once, twice a year, I mean publicized, excuse me, I mean put on the bulletin board or an area, a door, or whatever which is a prominent place in the nursing home. I've already mentioned about Amendment number three which was to

exclude Cook County. I'll appreciate the passage of the

Speaker Redmond: "Representative Freidrich."

Freidrich: "Would the sponsor yield?"

SpeakerRedmond: "He will."

Borchers: "Yes."

Bill."

Freidrich: "What would you accomplish with this Bill you wouldn't accomplish by making this information available to these homes for anyone who had a patient there inquired?"

Borchers: "Well, what is accomplished is if you've been reading the newpapers for the last many years, take a few
years ago in Lake County, take in our own county where
some terrible things have happened. We have for example
a scalding death in one of our nursing homes that was
just without any question pure negligence. And I feel



that by putting the names of the people that own the stock in a public place and publishing it twice a year, it will make the people that are stockholders when they have there stockholders meetings, be more careful and cautious. How the homes are managed and be more interested in seeing that all the money doesn't go in dividends to the stockholders instead of to the care of the old. If you go into the nursing homes like I have you will see often very terrible conditions. I've gone into see urine on the floor many times, lying in their own filth, water not within reach, and things of this nature may help put conscience in the hearts of the stockholders. I might tell you that there is an article in the Tribune about six eight months ago that said one of the finest places of investment today was in nursing homes."

had some money in nursing homes and I can tell you if you think it's a good investment, you know something I don't know. Because it isn't down in my area and I it'd take me long to get out of it from a financial standpoint. I think this is just another harrassment on small business and nursing homes mostly are small business. Sometimes family owned and so on and I think, I certainly don't object to anyone being able to find out who owns the home, particularly where its absentee ownership, but I think this is just another harrassment for business and I would have to oppose it."

Freidrich: "Well, let me just make a statement then. I have

Speaker Redmond: "Representative Wikoff."

Wikoff: "Will the Sponsor yield?"

Speaker Redmond: "He will."

Borchers: "I yield."

Wikoff: "Weber, is there a limitation on the amount of stock that must be owned before the names are published? And the reason I am asking that, there are some basically stock, national stock, or Bills that are listed on the National Board of Trade that do own nursing homes. I



mean, every person that owns some stock in Simco for instance which owns and controls the nursing homes that all ofthose stockholders have to be listed."

Borchers: "No, I'm sure you'd find that the stock of Amco Corporation, John X Corporation or whatever would be just 10,000 shares a 1,000 shares in the name of the corporation their holding company whatever, that's the only thing that would have to be listed unless it was you yourself owned the stock and then your name should be listed on the, in the former place in the nursing home."

Speaker Redmond: "Representative Kempiners?"

Kempiners: "Thank you Mr. Speaker, Ladies and Gentlemen of the House. On the surface this Bill appears to be good and necessary and I certainly have no objection as others have stated to require a nursing home to make available the names of the people who own stock in that home of who own that home. I think that there are several things wrong with this Bill however. The genesis of a problem is basically that people don't care about relatives who are in the nursing home. they did, abuse in nursing homes would not occur. they don't care enough to go to that nursing home to see if their relative is being abused, they are not going to care enough to look in the annual publication to see who owns that nursing home. Now even if you feel that some of things ought to be published, where ought they be published? Not downstate where communities tend to be smaller and people know one another, but in the urban areas where people tend to get lost in the system. An amendment to this Bill exempts the urban area, Cook County from the provisions of this Bill. If anything Cook County ought to be included and downstate excluded. Now, again, I join with others who have objected to this Bill with regard to the publication of these names. I just think you're adding an extra cost to the nursing



home. If the Bill required that these things be made available at the reception desk, I would be more than happy to stand up and support it, but the way it is now, I just thing it's an added cost to the operation of the home and I would urge you to vote no."

Speaker Redmond: "Representative Bowman."

"Thank you Mr. Speaker and Ladies and Gentlemen of the House. I serve on the House Human Resources Committee and I was a little dismayed to hear the minority spokesman on that Committee criticize the Bill on the grounds of the Cook County being excluded from the publication requirements. He know full well that the sponsor had that provision in the original Bill and at the request of the House Committee on Human Resources he amended it out. The Sponsor appeared before our Committee on a couple of occations. Showed every willingness to work with the Committee in drafting Amendments to get the Bill into shape. And it was very accomadating and the Sponsor in this case is being to task for decisions that were made by the House Human Resources Committee. The Committee did spend quite a bit of time working on this Bill and it's good legislation. I think, furthermore, the publication requirements are needed downstate because people do...."

Speaker Redmond: "Representative Totten, for what purpose do you rise?"

Totten: "Point of order Mr. Speaker. The Speaker is not speaking to the Bill at all. He's speaking to history and everything else. We're suppose to be debating the merit of the Bill. We got a lot of Bills to hear, let's just keep on the subject matter."

Speaker Redmond: "Consign your remarks to the Bill, Mr. Bowman."

Bowman: "If the Gentleman had been listening I think he would have understood that we are confining the remarks to the subject matter. The point is that the publication



requirements are perfectly legitimate downstate. A lot of people move away from the town in which they were born and raised. They have, you know, very good economic reasons for moving away. They get married and move away. They join the military and move away. They're parents or relatives remain behind in nursing homes. No matter what their intentions, their very best of intentions, they would not be able to visit their relatives in those homes on a regular and periodic basis. And yet they are in a posisition to subscribe to the local newspapers and they do. How many of you have friends that have moved away from you home town who've continued to subscribed to your local newpapers? In Chicago, my ward alone, I've got 15 nursing homes, almost 2,000 beds. My office is across the street from one, I live next door to one. I can walk into any home in a four block radius and find out who the nursing home owners are. So I think it's highly appropriate the Human Resources Committee did put a lot of time in on this Bill and I think it deserves our full consideration and our support. Thank you."

Speaker Redmond: "Representative Vinson."

Vinson: "Mr. Speaker and Mr. Sponsor. I think I got on this

Bill inadvertently as a co-sponsor. I think I though
I was co-sponsoring another Representative Borchers
Bill. Bills. And with leave of the House and the
Sponsor, I'd like to be removed as a co-sponsor...

Speaker Redmond: "Does the Gentleman have leave?"

Vinson: "If that's permitted then I would like...

Speaker Redmond: "I think you have to sign a sheet up here."

inson: "OK. If that's permitted, then I'd like to move

the previous question."

Speaker Redmond: "Well, I think you can't do both. Representative Harris."

Harris: "Thank you, Mr. Speaker. Will the Sponsor yield?" Speaker Redmond: "He will."



Harris: "Representative Borchers, since this information is already public information in the regional office buildings, what would be the cost of such publications and who would pay the cost?"

Borchers: "You mean in the downstate newspapers?"

Harris: "Throughout the area you're covering in your piece of legislation."

Borchers: "Well since the, each newspaper, I think the Decatur Herald would use three dollars a line, as I recollect. So if they had a hundred stockholders for which I would doubt would be that many, would be around nearly \$1000. And generally you take the small newspapers and weekly newspapers, it's about 10, 15 cents a line. I would doubt if there was any nursing that I know of that has more than eight or nine of five of six stockholders. I might mention as far as the cost of typewriting on a piece of paper twice a year and posting the stockholders on a bulletin board for example, would be practicly zero. It costs nothing except just : typing a list and putting it up there. If they sold some stock, someone sold some stock, they might have to change name or two in six months or a year. So insignificant I wouldn't even bother. Chicago though the cost of the :Tribune , The Daily News , and The Sun Times whatever, it's The Daily News I guess is stock, but the cost there would be a great deal and very few people will be reading it so that's why we excluded at the suggestion of the Committee, the Chicago newspapers. But downstate everyone reads the newspaper. Particularly the smaller towns. From cover to cover. Now this I can tell you so, If your all from a small town you know yourself. That that's what you do when you go home. so I see nothing wrong at all or take that this is not something that we should be concerned about. All it takes is twice a year, a typewritten list on a bulletin board."



Harris: "Mr., Mr. Speaker."

Speaker Redmond: "Representative Hoxsey."

Hoxsey: "Mr. Speaker, I move the previous question."

Speaker Redmond: "Question is shall the main quesiton be put?

Those in favor say 'aye' aye, oppose 'no'. The ayes have it the motion carried. Representative Borchers to close."

Borchers: "I' like to say that I have gone many times into nursing homes and inspected them. I've always seen many families, particularly on the weekends, Sunday in particular, visiting their relatives there. Now there's no doubt that there are some people are never visited by their families for reasons I don't know, but they do visit their families. So if you think this is a worthless abuses, you're wrong. If a patient or perons, old person, you might be one day in that nursing home, very possible. All you've got to do is go and look at that list and see who may be one that is cutting, helping cut down on the food you eat and you'd be surprised at the rake-off, one of the greatest rake-offs right now in the State of Illinois is on the food given to nursing homes for their patients. I have gone into a nursing home kitchen and by rule taken off of the wall the menu and walked right over to the table where there eating and I've seen perhaps on the menu, Swiss Steak, on the table was Bologna sandwiches. Now things like this that brought to the attention of the people who, the families, or to the nursing home patient himself and will help correct these kind of injustices and these kind of rake-offs. I might, I think I've covered in relation to the question on typing and publishing adequately so I want to appeal to what may be someday you're right to know who owns the nursing homes that millions and millions and millions of dollars of state money are being paid to them. Often completely, well I would say even unjustly. They don't



deserve what they get."

Speaker Redmond: "Question is shall this Bill pass? Those in favor vote aye, oppose vote no. Representative

Chapman to explain her vote."

Chapman: "Mr. Speaker and Members of the House. Representative Borchers is a knowledgable person in matters relating to long-term care. He has spent substantial hours in forming himself on problems. The Committee on Human Resources appreciated the expertise that he brought to us through this small Bill that would make a contribution to a real problem that most of us indicate we want to do something about. I'd ask you to show your support for solving problems relating to long-term care by voting yes."

Marovitz: "Thank you very much Mr. Speaker and Ladies and Gentlemen of the House. This is not a major Bill and it's not going to solve the problems of the nursing home industry, but it's a good Bill and it'll take a step, maybe a small step, but it will take a step towards solving some of the abuses in the nursing home industry and in that particular industry, any step in the right direction is a good step, and therefore; I'm going to vote aye and I would solicite some more green votes."

Speaker Redmond: "Represnetative Marovitz to explain his vote.

Speaker Redmond: "Have all voted who wish? Representative Pierce."

Pierce: "Mr. Speaker, I think the Gentleman may have a good idea here, perhaps he should extend it to the stockholders of Ramsville Companies, of garbage dumps, and of other operations that are endangering public health, as well as, as well as the nursing home and when he does that I think I'll be in a position to vote for it."

Speaker Redmond: "Have all voted who wish? Representative Borchers to explain his vote."

Borchers: "In explaining my vote, I'd like to say first that we have no stock in a land fill or a garbage dump. It's



true we own land and lease some land to some people that do have a land fill but not a garbage dump, but that's beside the point. The point here is old people. All you have to do is go yourself and look at the conditions in many of the homes in this state and as someone has always said in explaining their vote, it's a step in the right direction. This is not a big Bill. All it does is publish the names of the people that own the stock and if something horrible happens like this scalding death, you'll be able to know who owns the stock and who really is responsible for what happened to that scalding, that person who was scalded to death or whatever. We had some horrible things happen in this state. I've doubt very much if you realize, unless you yourselves go and look. So I would continue to solicite your support. I don't want to, I'm going to let it rise or fall. But let it be on your own conscience, whether you feel that you don't want to help a little bit to help these old people. Helpless, some confined in their bed, not even cleaned properly. In one nursing home I went Into, I found 52 incompetent old people on one of the floors and only two girls, not even nurses, taking care of them. And the stink was all over that particular floor. And when I finally forced a hearing on that particular nursing home, the state made them hire 27 more employees to comply with the law. All the rest of it was going in profits into the pockets of whoever owned it. Now just stop to think you may be that one day and it's about time to begin to pick your own interest and protect those :that are there now."

Speaker Redmond: "Matijevich."

Matijevich: "I just want to commend Representative Pierce.

I know that Repre... Borchers was seated throughout the whold presentation but he was quick to rise to his feet."

Speaker Redmond: "Representative Skinner."




Skinner: "Mr. Speaker, there are a lot of insensative people on this Bill who are voting in the way that they probably shouldn't be voting. Now most people know my friend, Weber, as sort of a right wing nut. And they don't understand that he probably does more for people in institutions in his district than any of you do in your districts. Now if you haven't a little talk with him about the employee that he has, and he puts it something like this, he says, "Well, I know people say she's crazy and she's a little old lady in tennis shoes. but she gets the information I want to get from nursing homes". And he's given this assistant of his a letter and the individual goes to a nursing home and will say, "We would like, I'm Representative Borchers representative, I would like to inspect your nursing home". Now if all of us did what he did we have the right to stand up here and ridicule his idea. And until we have, I really am ashamed of those of you who are making light of his attempt to get at something that really needs a solution. Now if you look in your digest if you're a Republican, take a look at who's supporting this. Department of Aging, in fact, former Department of Aging Director Josephine Oblinger is on the Committee and voted yes. Unfortunately she's sick today and so cannot add her voices to the, to the argument. The Illinois Nurses Association, The Illinois Association of Retarded Citizens, The United Way of Metropolitan Chicago, and the Department of Public Health. Now do you have any information available at the regional office is just great if you happen to live right across from the regional office. But if you don't live across from the regional office, it'll be very helpful to be able to, to know that information. Now think about the small towns some of the downstaters here that are voting against this Bill and tell me if peer pressure isn't a way to upgrade the care at local



nursing homes. What would happen if, if each church instead of going in and holding the hands of the patients at the nursing home and getting buddy buddy with the adiministrator and sort of saying, "Well, yeah, Mrs. So and So, she's not getting along to well anymore she doesn't know what she's talking about". What would happen if those church groups really took on a role of monitoring the nursing home? I would suggest to you there would be great improvement. That the Department of Public and Health inspectors will never be able to deliver. Now I guess what disturbs me more than anything else is an article that Weber didn't want to say anything about...

- Speaker Redmond: "Your one minute is coming to a close Representative Skinner."

In fact, according to our concurring there are many many legislators with interest in nursing homes that speak to him about nursing home interest and it seems to me that the people in a given
