Deuster: "Mr. Speaker, Ladies and Gentlemen of the House, in the last session we adopted a very comprehensive ... Marriage and Divorce Reform Act. One of the provisions of that Act was what was called by the Sponsors and the lawyers familiar with it as the Bifurcated Trial. The idea was where there was a contest over not only the grounds of divorce, but the other matters relating to child custody and property division, that in order to seperate these two subjects you had two trials. You first had a trial on the grounds and then automatically the case could not be heard for another 48 hours until you had the second half of the Bifurcated Trial. There was no discretion in the judge or the parties to waive that at all; they had to come back to court on another date. The net result of this mandatory Bifurcated Trial was that for folks who wanted to get the divorce and there was a contest over the grounds, they had to go to the courthouse and make two appearances with their lawyer. And quite often where the dockets are crowded they've come back a week or maybe 3 months later. And so it is spreaded out; it made it more difficult for the parties to accomplish the divorce and in many instances, the parties themselves, once the ruling had been made on the grounds, wanted to gd ahea and wrap it all up. They want to go out in the hallway and sit down and enter an agreed order and come back in, but they couldn't do that. So all this House Bill does is to allow the two parties, the petitioner and the respondant, if they want to to waive that Bifurcated Trial and complete their divorce proceeding on that one day. That's all the Bill does. I'll be happy to answer any questions

Act provides that that affidavit be filed in all adoptions by everyone involved in the adoption. We got into some questions in our area about who exactly was involved in an adoption and to what extreme was there a court reporter was involved in an adoption; whether an attorney representing one of the parties was involved in an adoption. This Bill will clean up that language and require that the affidavit first of all need not be filed in an adoption of a related child or of an adult. The public policy reasons for adoption do not appear to exist when the adopfiling that tion involves a related child or an adult so we are eliminating the provisions for the affidavit in those instances. In the other instances we are requiring that the affidavit be filed by each petitioner and everyone consenting to the adoption. That would seem to include everyone who would have received anything of value or have spent any cost, or made any contribution or paid any hospital bill or doctor bills or legal fees. I would be glad to answer any questions concerning this."
