That is not local, and there is plenty of funds available to do what those libraries may want to do in this state without us jeopardizing the fiscal resources of the state with this Bill, and I would recommend a 'no' vote on House Bill 3560."

Speaker Schneider: "Further discussion? Representative Madigan to close."

Madigan: "You sure there weren't other people who were seeking recognition?"

Speaker Schneider: "I see no lights. Oh, Representative Epton."

Epton: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. It's certainly true that the budgetary problems of the state are enormous. Equally true is the problem I alluded to yesterday, and that's the question of educating the children as well as the adults of our state. There are many areas where libraries just are not available...where library construction, although I personally have a bias against bricks and mortar, unfortunately, you just can't obtain library books from traveling vans or stagecoaches. We must enter the era of this century. This is the 1980's, and I think that an expenditure of this sort is essential for all of the residents of the State of Illinois, and I solicit... respectfully ask your approval of this vote."

Speaker Schneider: "Representative Leinenweber."

Leinenweber: "Thank you, Mr. Speaker. I'd have to disagree with the last speaker and agree with Representative Totten. This is...it's...I think everybody ought to pay attention, the authorization Bill. It got 50 'no' votes, and this Bill, of course, which actually spends the money, should get 100 'no' votes. This is not the year to come up with a vast new program such as this contemplates. This thing will grow like 'papsy'



and to...it's eight million now. It'll be 16 million and) 24 million and so forth, and eventually these bonds have to be paid back. Now, that...of course, that's the rub. This is easy. We borrow the money now. Then sometime down the pike our children, and when they pay taxes, they can pay these bonds back. We've been doing that for many, many years. It's...the time has come when we're going to have to take a closer look. I just cannot see with the state of the economy in such atrocious shape that how we can sit here today, particularly after voting for a billion dollars of tax relief, I think it was something like that last week, and then vote to spend eight million dollars in bonds which has to be paid back from general revenue funds. It's an atrocious idea. Fifty 'no' votes on the authorization is about half of what it deserves, and I certainly join with the Representative from Schaumburg in calling for defeat of this ill-timed, ill-conceived, and ill-considered Bill."

Speaker Schneider: "Representative Schlickman." Schlickman: "Mr. Speaker, Members of the House, I find myself somewhat uncomfortable in the company of the two individuals who objected to this Bill. However, I would suspect that the individual from Cook whose spoken for it...for it should likewise feel himself uncomfortable in joining with the Sponsor of this Bill. Mr. Speaker, Members of the House, we're talking here about an appropriation of state money for local projects. Now, traditionally, Mr. Speaker and Members of the House, local projects in the State of Illinois are funded by local funds. And, particularly for library construction through general obligation bonds authorized by a referendum so that the people within a community can determine the quality, the quantity of the facilities that they want for service to them. And, by referendum,



they can assure accountability and responsibility with respect to the expenditure of funds. Now, Mr. Speaker, Members of the House, I come from a community that has a library that serves the third highest number of subscribers followed...following only the City of Chicago and the City of Rockford. It's a very fine library facility. A facility that was funded 100% by local funds as a result of a referendum. Mr. Speaker, Members of the House, not only do I feel that this Bill is unprecedented in terms of state expenditures for local projects, contrary to the tradition of this state, not only do I feel that it is fiscally unsound on account of the already high bonding liability that we have, but, Mr. Speaker and Members of the House, I think it's inequitable to have people in this state who have already funded by themselves their library facilities and now we'll be confronted with the use of their tax dollars for the funding of library projects elsewhere. And, I urge a resounding 'no'."

Speaker Schneider: "Mr. Brummer from Effingham."

Brummer: "I move the previous question."

Speaker Schneider: "The Gentleman has moved the previous question. All those in favor say 'aye'. Any opposed?

There are none. The question has been moved, and now back to the Sponsor to close. Representative Madigan."

Madigan: "Mr. Speaker, Ladies and Gentlemen of the House, as I previously stated, the authorization language for this program has already been adopted by the House. It is true that the program is innovative, but certainly that should not dissuade us from moving the state into this vital area of service to the people of this state. I recommend an 'aye' vote."

Speaker Schneider: "The Gentleman has moved that House Bill 3560 be passed. All those in favor vote 'aye'. Those opposed vote 'no'. Representative Skinner."



Skinner: "I would have to disagree with the Sponsor of this Bill that the idea is innovative. There's nothing innovative against...about this. It was recommended by the House Revenue Subcommittee on library financing in 1974, but perhaps there is one innovative part of this Bill, and that's the sire . It's just plain greedy. We recommended two million dollars a year. Now, that's... that's a reasonable amount of money it seems to me to put out into local libraries. We put substantially much more...substantially more money than that into local sewer projects each year, but eight million dollars. That...that is a pile of money. If the Gentleman would like to take the authorization down and the appropriation down to two million dollars a year, I think I could support that. But, eight million. That's just a bit too much."

Speaker Schneider: "On explanation of votes, Representative Beatty."

Beatty: "Mr. Speaker, Members of the House, as the previous speaker has indicated, we have held hearings out of this matter, and I think that the hearings that were done on the state-wide basis and participated in by the Members of this House really take the place of any referendum. The cost of a referendum is quite high. We are representing our districts. We are speaking for them. We can vote, and we should vote. The program here divides the money fairly equally between the different areas of the state. With reference to the library in Chicago, this library in some ways serves the entire State of Illinois. I know that it has a program for the blind that works throughout the State of Illinois. There is a need for libraries both in Chicago and in the state, and I would think that while we have previously voted in this last Bill for a billion or two for highways, if we cannot see that we need libraries,



books for people, and we don't see the real need for that, I think then our society really is poor if we cannot afford libraries, and I would urge an 'aye' vote for this."

Speaker Schneider: "Representative Wolf."

Wolf: "Thank you, Mr. Speaker, Members of the House. I just wanted to point out that the state's not in construction grants, but at least construction grants should be the function of local government and not the State of Illinois, and the state does currently make available 19.2 million dollars in general support grants to library systems under the Illinois Library Systems Act, and I would urge a 'no' vote."

Speaker Schneider: "Representative Friedrich."

Friedrich: "Mr. Speaker and Members of the House, with all respect to the Minority...Majority Leader, this is not an innovative thing. This reminds me of the jail Bill that was floating around here a few years ago. Most of the counties in my area tax their people to build new jails and then somebody wanted to take a free ride and let the state build theirs. Now, in my area and in my town particularly we've spent thousands of dollars building a new library and now then we're closed out, and the money...taxpayers of my district are going to be taxed to build a library somewhere else. I think that library financing for operations is one thing...for construction is something else."

Speaker Schneider: "Representative Huskey."

Huskey: "Well, Mr. Speaker, you're comparing the libraries with the highways. We collect money on your gas and all your various uses of your motor vehicles for your motor vehicle funds. Each individual library district collects his own money. The libraries remind me of a famous saying that C. L. McCormick used to say on this floor, and I being a farm boy, too, can very well



remember it. Libraries are getting to be like hogs, and you can't flounder a hog."

Speaker Schneider: "Have all voted who wish? Have all voted who wish? The Clerk will take the record. Representative Totten has requested a verification should it reach 89. The Sponsor has asked for a poll of the absentees."

Clerk O'Brien: "Poll of the absentees. Alexander."

Speaker Schneider: "Alexander, 'aye'."

Clerk O'Brien: "Breslin. Bullock."

Speaker Schneider: "Breslin, 'no'."

Clerk O'Brien: "Darrow. Garmisa. Greiman. Emil Jones.

Kane. Katz. Laurino."

Speaker Schneider: "Excuse me, Mr. Clerk. Representative Greiman, 'aye'. Proceed."

Clerk O'Brien: "Leverenz. Matijevich. McAuliffe. Meyer.

Molloy. Peters. Ropp. Stearney. Telcser. White.

And, Williamson."

Speaker Schneider: "The official count, Mr. Clerk, is 83
 'ayes', 72 'no', 4 voting 'present', and this Bill
 having failed to receive a Constitutional Majority is
 hereby declared lost. Still on the Order of Third
 Reading...House Bills, Third Reading. Let's take a
 look at...this one passed, right? They all passed.
 Out of the record. Representative Richmond, would you
 like to go with...out of the record. 3299. Out of
 the record. 3210. Representative Younge. The Lady
 wishes to proceed on 3310."

Clerk O'Brien: "House Bill 3310. A Bill for an Act making an appropriation to the housing authority of the City of East St. Louis. Third Reading of the Bill."

Speaker Schneider: "Representative Younge."

Younge: "Yes, thank you, Mr. Speaker and Members of the House.

House Bill 3310 would appropriate to the housing
authority of East St. Louis the sum of \$200,000 to



rehabilitate and to acquire houses that are the subject matter of tax delinquent property and houses that are the subject matter of FHA vandalized foreclosures. There are located in East St. Louis about 8,000 pieces of property that have been turned back to the St. Clair County Board of Assessors for the non-payment of delinquent taxes. This means that there are in each block in the East St. Louis area two or three houses that are vandalized that were previously owned by the FHA...are...which were previously occupied that have sound structures on them that are not vacant and vandalized. What the East St. Louis Housing Authority proposes to do is to acquire about 25 of these units. These units would be the subject matter of a work write-up and a contract in reference to materials and labor, and each rehabilitation job they average would cost about \$8,000. So, for about \$8,000 per unit about 25 of these units could be rehabilitated, and, therefore, about 25 of these units would be put back into tax roles. These units would not be left as public housing, but they would be acquired under a... three program and turned into private ownership. That would mean that these units would then go back on the tax paying roles and would provide taxes. the passage of this Bill there would be a considerable amount of money earned by people who would do the rehabilitation work and also the materials that would be purchased. So, this appropriation would be an investment into a housing industry that is shut down in the southwestern area. There are about 3,500 people waiting as applicants with the public housing authority, and this small appropriation would somewhat ease the situation of no new construction going on by providing a very limited rehabilitation project, and I ask for your support."



Speaker Schneider: "All right. I would like to ask...I don't have the gavel up here, so I can't call your attention.

But, it's getting noisy, and Representative Younge is being interrupted by Roll Call chants. I'd appreciate it if you'd give her the courtesy of explaining her Bill. Now, she has concluded her remarks. Is there further discussion? Representative Borchers."

Borchers: "...yield? Will the Sponsor yield?"

Younge: "Yes."

Borchers: "I was curious in relation to \$100,000 of contin...

for ordinary and contingent expense. Now, is this

depressed area land use and community development

authority? How many people are employed by it?"

Younge: "That was the original wording of the Bill, Representative Borchers. The Bill has been amended."

Borchers: "I see that..."

Younge: "You want to look at Amendment #1, I believe."

Borchers: "Yes, I see."

Younge: "This appropriates to the East St. Louis Housing Authority."

Borchers: "Yes, I see the \$200,000, but I was curious, first, as to the type of...how many are on that Board and maybe their experience in building houses."

Younge: "Oh, yes, well, there are about seven Board members that are appointed to local housing authorities. These Board members have to be recommended by the Mayor of the municipality and have to be approved by the State Housing Board."

Borchers: "Are they paid?"

Younge: "No, they are not paid."

Borchers: "They're volunteers. Then, that leaves 200,000 to the housing authority to repair vandalized houses. Now, in...it's obvious that the houses have been returned to the FHA, and they're vandalized, they are an area of high risk in relation to vandalism. Now, we have a



small area in my community that if a person moves out of that area, within a week if you...re-rented and even less than a week, why, the plumbing's all stolen out, the bathtubs are out, broken up and sold for scraps, and I wonder if this isn't just throwing \$200,000, if it were all applied on the repair and the maintenance of houses that have been vandalized, that within a week period of time that we would have the same situation. All of the money would be lost because of the re-vandalizing of the houses. Now, when you have houses in this kind of an area, it's practically impossible to watch them and to protect them. I think this is money right down the drain, and I would..."

Younge: "Well, I thank you for asking that question, Representative Borchers. The housing authority has successfully rehabilitated around 100 units already. It has available a security force that would guard the houses when the work is not being done on it, and I agree with you rehabilitation is a very special specialty, and not only must the work be performed, but the units must be protected until people are moved in them, and what they do is on their regular security force, they guard the units until the family moves in and everything is safe and sound. Certainly, in areas ...in urban areas you cannot leave houses unattended, and because of the price assess of the housing authority in this area, I'm recommending that you take this action to permit them to use...they have..."

Speaker Schneider: "All right. Representative Younge, may I interrupt you a minute? The dialog that's going on is certainly significant. I would hope that the Members would be attentive. If you have time to chat, do it a little bit more quietly. Now, Representative Younge, if you'd comment and continue."

Younge: "Yes, I was going to say that the housing authority



has available about 100...what is called section 8 reservations from the Department of Housing and Urban Development, but it has no way to get the houses ready to use these federal subsidies. So, this is an excellent example for us to be a partnership to produce some housing in an area that will not have any new housing, except for this program."

Speaker Schneider: "All right. Thank you very much."

Borchers: "Well, I'm not through."

Speaker Schneider: "Oh, are you continuing? All right."

Borchers: "I'm not through. I was right off...right off I

would say that naming this kind of a project the

rehabilitation of houses a section 8 is very, very

appropriate. It just tickles me to hear section 8 used

for this purpose. However, how...do you know how many

of those hundred houses that are supposed to be

rehabilitated and re-rented...how many of them are

still in that condition...are still being used?"

Younge: "All of them are in that condition? All of them have new plumbing, new heating systems, new walls, and the housing authority does an excellent job in their rehabilitation work, and they're...all are rented and with very happy families in them."

Borchers: "Well, I would...I wouldn't want to question anyone, but knowing some of the areas along this type of area, I would say some of those hundred... hundred houses are already down the hill. However, in relation to security, do you...what you've told me means that, to me, that the minute the house is repaired, a guard is put into that house to see that it is not re-vandalized. Now, is that so?"

Younge: "No, what I said was during the whole course of the rehabilitation in order to see that the state's investment is protected during the whole course of the rehabilitation cycle there will be security."



Borchers: "Well..."

Younge: "And, that security will be there until the family moves in upon the completion of the work."

Borchers: "Well, Representative Younge, that again leads me to believe that the areas in which these houses are being repaired is such that it would be a very hazardous thing to expend state money on such a project. think that the people right down there who are interested in this would take care of their own area. We do in our area. I've helped in this kind of thing myself. But, in that area it looks to me that the people of East St. Louis should be the ones responsible and would be, therefore, interested in protecting their own property and promoting it and repairing it instead of expecting the state, which...which is really an offense, since we are the Legislature here far off from East St. Louis where they can say, 'I don't care. It doesn't matter to us. It's not our money.' Of course, it is our money, but most of the people don't look at it that way, and so by us assuming the responsibility means nothing to them. I remember seeing a few years ago a whole..."

Speaker Schneider: "Webber's about ready to tell a story.

I'd appreciate it if you'd be attentive. He remembers
a few years ago..."

Borchers: "I'll end it up right now, and I'd...and don't appreciate anything I do, because I'll completely..."

Speaker Schneider: "No, we want to hear the story. Go ahead."

Borchers: "All right. I well remember an eight or ten story tenement being blown up that had just been built by the Federal Government and completely came down. I'm sure many of you saw the dynamiting to get it out of the way of that vandalized building. Well, this is the same kind of thing, the same kind of people, the same type of accident that would probably, and I would bet



money, would happen right down there. We have no business in it."

Speaker Schneider: "Thank you, Representative Borchers."

Peters: "Move the previous question."

Younge: "Poll the absentees, please."

Speaker Schneider: "The Gentleman has moved the previous question. All in favor say 'aye'. Any opposed? There are none. The question is moved, and now the Sponsor, Representative Younge, to close."

Younge: "Thank you, Mr. Speaker. The housing authority of
East St. Louis has had a successful experience in
rehabilitation work. It has the crew to protect these
units, and this will not only provide shelter for 25
families, but it will give an input into a totally
depressed housing industry, and it...the money will
come back to the state in the form of taxes, and for
these reasons, because it will help the economy and
because it will provide shelter where it is badly needed.
I ask for your support in this matter."

Speaker Schneider: "Mrs. Younge has asked that House Bill
310 (sic) be passed. All those in favor vote 'aye'.

Any opposed vote 'no'. Have all voted who wish?

Have all voted who wish? Tony, you ready? The Clerk
will take the record. On this...Representative Younge."

Speaker Schneider: "In an effort to reach Postponed Consideration, I think the Sponsor has asked for a poll of the absentees. Representative...one at a time now.

Representative Domico, 'aye'. That's 69. Representative Kane, 'aye'. That's 70. Representative Greiman. 71.

Representative Leverenz. 72. Any further...Representative Younge, would you want to still persist on a poll of the absentees? You have 72. Did you have those four, Jack? Representative Getty, 'aye'. There were the five that just...Jack Williams votes 'aye'. Proceed with



- a poll of the absentees. Remember, Representative Younge, if this is on Postponed, the chances of your getting it heard today and passed are very slim. Do you still want to persist? All right. The Clerk will poll the absentees. All right. Further...Representative Stiehl, why are you waving?"

- Speaker Schneider: "Any further need for any of the Members



to be recognized for a vote? All right. Could we have the count, please? 78 'aye', 66 'no', and 3 voting 'present'. Representative Younge, where are you? This Bill having failed to receive a Constitutional Majority is hereby declared lost. I misunderstood the figure. We should do it verbally. She has asked for Postponed Consideration. I think there's leave for that. Bruce, 3317, out? 3324. Representative Younge. Out of the record. 3407. Representative Dawson.

Is Dawson around? 3554. Representative Vinson. Out of the record. Let's see. We're just about out of business, except for at least one item that I can see here. Dave, you want to...the rules change? On the Order of Senate Bills, Third Reading, the Sponsor, Representative Pierce, Senate Bill 1852. Mr. Pierce."

Speaker Schneider: "Any opposed? There are none. The Amendment is adopted. Further Amendments?"

Clerk Leone: "No further Amendments."

Speaker Schneider: "Third Reading. Representative Catania.

any discussion on that matter? There being no discussion the Sponsor has asked that the motion be adopted. Now, Mr. Brummer's up. Representative Brummer."

Brummer: "Yes, I'm wondering if we could have the identity of the executive order and the topic that it deals with and a summary of the reorganization?"

Speaker Schneider: "Summary from the Sponsor."

Kane: "It was the Governor's reorganization to create a

Department of Nuclear Safety taking two divisions from

the Department of Public Health and some functions from

EPA and the State Fire Marshal and putting it into a

new agency to be designated as the Department of Nuclear

Safety. The Committee on State Government and Reorganization held a number of hearings, and we are presenting to

the House House Bill 3614, which implements the

Governor's reorganization order and also adds a number

of other functions to the new Department. And, basically,

what the Committee is recommending that the Governor's

reorganization order be not disapproved, but that the

General Assembly go further than the Governor's request,

and we would do that by legislation rather than by

executive order."

Brummer: "Is it anticipated that there will be additional personnel hired as a result of this crea...the creation of this new agency or Department?"

Kane: "I believe that with the additional functions that the Committee is recommending go to the new Department and with the proposal that the Governor has made that there would be some additional personnel. Yes."

Brummer: "How many and what is the anticipated cost?"

Kane: "That hasn't been determined at the present time. I
think that a lot of the functions, at least with the
executive order, are now being performed by divisions
of existing agencies, and the executive order would



consolidate those divisions and increase them to Department level."

Brummer: "Well, doesn't the reorganization in the course of
the number of hearings that were held...weren't these
questions raised about the number of additional
personnel that were anticipated being hired and what
their expected salary levels were and what the anticipated
increased cost of government would be as a result of
the creation of this Department?"

Kane: "Some of those questions were raised. They weren't answered in a great deal of detail. The Director of the new Department as in the statute would be paid \$45,000 a year. There would be some additional costs."

Speaker Schneider: "Excuse me one minute. Representative Pullen has a point. Recognize Representative Pullen, please."

Pullen: "Mr. Speaker, has the report that we're talking about been printed, and I don't find on the Calendar where we are?"

Speaker Schneider: "Representative Kane on that matter."

Kane: "I opened my remarks by saying that that report was presently being printed. If...if it is the desire of the House that this motion be left until that report is distributed, that's...that's fine with the Committee.

Speaker Schneider: "All right. Representative Kane, is there a deadline?"

Kane: "There is a deadling of May 30th, but the deadline is for really a motion to disapprove. I do not think that there is...that there is any inclination to disapprove of the order, so really..."

Speaker Schneider: "All right. So..."

Kane: "...the question is moved."

Speaker Schneider: "...since we're not in a time constraint, perhaps we should wait till the report is distributed and on the Members' desks which can be Tuesday. So,



there's no real pressure for that, and we will withdraw
the Sponsor's motion and now to another Order of Business
if any. Representative Walsh, there's a quirk in the
system. We're winding down. Representative Hoffman."

Hoffman: "I thought it would be of interest to the Speaker
that Representative Pullen suggested that the quirk is
in the Chair with or without a tie."

Speaker Schneider: "Representative Lechowicz on a motion."

Lechowicz: "Thank you, Mr. Speaker and Ladies and Gentlemen of the House. I'd like to make a motion to suspend the posting rules giving the Committees the opportunity to post till tomorrow at noon based upon the Bills that were heard in the Rules Committee yesterday. It would affect the following Tuesday and Wednesday Committees for next week: Appropriations I, Cities and Villages, Elementary and Secondary Education, Financial Institutions, Judiciary II, Insurance and Transportation, which would be a Tuesday normal day. Wednesday would be Elections, Human Resources, Judiciary I, Public Utilities, Revenue, Counties and Townships, and Personnel and Pension."

Speaker Schneider: "All right. You've heard the Gentleman's motion to suspend the appropriate rules in order for Bills to be posted in the next week's Committees. This takes 107 votes. All in favor please vote 'aye'. Those opposed vote 'no'. Have all voted who wish? The Clerk will take the record. On this matter there are 137 'aye', 1 'no', none voting 'present', and the Gentleman's motion prevails. Representative Lechowicz."

Lechowicz: "Mr. Speaker, can we also do the recommendation by
the Committee on Rules on House Resolution 818?"

Speaker Schneider: "We did it."

Lechowicz: "Okay."

Speaker Schneider: "Representative Friedrich handled it.

Is there any further business from any of the Members?



This is your golden opportunity. Representative Younge.

Younge: "Thank you, Mr. Speaker. For the purpose of an introduction, in the upper right gallery are 25 students from the East St. Louis senior high school who have been brought to Springfield by Mr. Mitchum and Mr. Mack. These two are their chaperones, and these students are represented by Representatives Flinn, Steele, and Younge, and I ask you to please warmly receive them."

Speaker Schneider: "Welcome to Springfield. Any further announcements or anything of interest to the Membership?

Nothing of interest as usual from Mr. Walsh. Oh,

Agreed Resolutions. Give them to Ted. Agreed

Resolutions. Representative Lechowicz."

Lechowicz: "Thank you, Mr. Speaker, Ladies and Gentlemen of the House. House Resolution 819 by Representative Birchler commends the fact that the Illinois Commerce Commission adopts temporary rules on the termination of natural gas and electric service. House Resolution 820 by Representative Deuster commends Dolores Hope. House Resolution 821 by Representative Beatty commends Father Hubert O'Meara, and House Resolution 822 by Representative Younge...there's objections on 822."

Speaker Schneider: "822 is out."
Lechowicz: "Take it out."

Speaker Schneider: "The Gentleman has read the Agreed
Resolutions. All those in favor say 'aye'. Any
opposed? There are none. The Resolutions are
adopted. There being no further business this House
stands adjourned until..."

Clerk O'Brien: "Also, Senate Joint Resolution 106 on Agreed Resolutions."

Lechowicz: "Senate Joint Resolution 106 commends George

Latham, a distinguished educator and basketball coach,
and retiring after 44 years of service. I move for
its adoption."



Speaker Schneider: "All right. Any further business?"

Lechowicz: "Mr. Speaker, there was objections on 819 as well."

Speaker Schneider: "Was there?"

Lechwoicz: "That's 819 were objected to and 822, so we only have a couple of Agreed...820 and 821 and Senate

Joint Resolution 106."

Speaker Schneider: "The Sponsor moves the adoption...or Mr.

Lechowicz moves the adoption of the Senate Resolution.

All in favor say 'aye'. Any opposed? There are none.

The Resolution's adopted, and now further Resolutions."

Clerk O'Brien: "House Resolution 819, Birchler, and 822, Younge."

Speaker Schneider: "Committee on Assignment. Now, Mr.

Lechowicz for the adjournment. Representative Lechowicz

moves that the House stand adjourned until Tuesday at

twelve o'clock, and we need..."

Lechowicz: "Ten minutes perfunct."

Speaker Schneider: "Change of votes."

Clerk O'Brien: "Representative Pechous requests to vote 'no' on House Bill 3066. Are there objections? Representative Harris..."

Speaker Schneider: "None."

Clerk O'Brien: "...requests to vote 'aye' on House Bill
3201. Are there objections? Representative Sumner
requests to vote 'no' on House Bill 1484. Are there
objections? Representative Hoffman requests to vote
'aye' on Senate Bill 1647. Are there objections?
Representative Oblinger requests to vote 'aye' on
House Bill 3298. Are there objections? Representative
Karpiel requests to vote 'aye' on House Bill 3001...
3001. Are there objections? Representative Macdonald
requests to vote 'aye' on House Bill 3046. Are there
objections? Representative Christensen requests to vote

Lechowicz: "Mr. Speaker, I now move that the House stand adjourned till Tuesday at 10 a.m."

Speaker Schneider: "Twelve."

Lechowicz: "Twelve. OTwelve noon."

Speaker Schneider: "Okay. The Gentleman has moved the adoption (sic) Resolution, and we need what? Ten? The House stands adjourned until Tuesday at noon. We need a few minutes for perfunctory, Jack? No. No further need.

Okay. Twelve o'clock next Tuesday. All in favor say 'aye'. Any opposed? There are none. The House stands adjourned."
